1. CNEN WILL SEND ME LETTER REQUESTING ANOTHER
SHOWING IN BRAZIL BUT WITH LOCATION UNSPECIFIED. NO
QUESTION OF THEIR INTEREST AND DESIRE HAVE ANOTHER SHOWING.

2. IT QUITE CLEAR THAT CNEN PREFERENCE IS FOR NEXT SHOWING
IN PORTO ALEGRE. PRESENT ACTING CHAIRMAN ANDRADE RAMOS
(VERY FRIENDLY TO U. S.) FROM PERSONAL PAST EXPERIENCE
~~RECIFE QUESTIONS DESIRABILITY EXHIBIT THERE BECAUSE OF~~
~~CONSIDERABLE ANTI-AMERICAN SENTIMENT WHICH HE SAYS EXISTS.~~
OTHERS IN CNEN KNOWN FAVOR PORTO ALEGRE ARE BANDEIRA DE
MELLO (HEAD OF EDUCATION AND SCIENTIFIC INTERCHANGE) AND
LYGIA BAPTISTA (ATOMS IN ACTION COORDINATOR). EXPECT
CNEN CHAIRMAN COSTA RIBEIRO (WHO IS FROM RIO GRANDE DO
SUL) ALSO WOULD PREFER PORTO ALEGRE SHOWING IF ASKED.
LYGIA CLAIMS PORTO ALEGRE LARGER QUOTE CULTURAL CENTER
UNQUOTE THAN RECIFE.

3. CHANCE OF GETTING LETTER FROM FONOFF ON SUBJECT SO
REMOTE HAVE NOT BOTHERED TO TRY.

4. SCIREP CONTINUES TO THINK RECIFE PRESENTATION WOULD
GO OVER WELL IN VIEW SUCCESS OF EXHIBIT IN SUCH PLACES
AS CENTRAL AMERICA. POTENTIAL SECURITY PROBLEM IS FOOD
FOR SOME THOUGHT, HOWEVER. EMBASSY ON RECORD AS IN FAVOR
SHOWINGS BOTH PLACES IF FEASIBLE AND UNDERSTAND CONGEN
RECIFE CONTINUES SUPPORT EXHIBIT THERE.

5. WILL FORWARD CNEN LETTER AND TRANSLATION WHEN
RECEIVED. WOULD URGE YOU CONTINUE PUSH FOR FUNDS FOR
ANOTHER BRAZIL SHOWING BUT, IF POSSIBLE, LEAVE LOCATION
UNSPECIFIED AS OF THIS TIME.
