

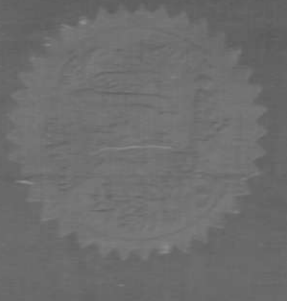
A todos los que las presentes vieren, salud!
