PLEASE TAKE NOTICE that pursuant to the provisions of Section 247 of the Immigration and Nationality Act, it is proposed to change your status from that of an alien lawfully admitted for permanent residence to that of a non-immigrant Government Employee as defined by Section 101(a) 15 of the Immigration and Nationality Act. Such action appears to be necessary on the basis of the following facts:

You are Government Official of Dominican Republic Embassy.

You are hereby granted a period of 10 days from the receipt of this notice to file at the address shown in the heading of the notice a written defense under oath or affirmation setting forth the reasons why the proposed adjustment of status should not be made. If you desire to appear in person in support or in lieu of your answer, before such immigration officer as may be designated for that purpose, request should be made within such ten day period. You may have the assistance of counsel, without expense to the Government of the United States, in the preparation of your answer or in connection with such personal appearance, and you will have the opportunity to examine, at this office, the evidence upon which it is proposed to base such adjustment.

In lieu of an answer, you may request permission to retain your status as a resident alien upon waiver of all rights, privileges, exemptions, and immunities under any law or executive order which would accrue to you by reason of such occupational status. The waiver must be executed in duplicate on Form I-508, copies of which are attached, and filed with this office within 10 days after receipt of this notice.
