- A. Whether another conference of foreign ministers is held soon is matter for this meeting to decide. It is my view that foreign ministers should meet often. It has been a long time since a meeting like this one has been held, and I doubt that we will be able to cover all items that we might usefully discuss during this conference. Also, if it is agreed that some changes should be made in Charter, then an Article 111 meeting will have to be convened to take this action. In any case, I would favor another chance to meet with my colleagues at early date to follow up on some of the things we talk about here during the next few days.

development in Brazil. On this occasion, apart from work of the Conference, we hope to be able to enjoy once again Rio's world famous beauty and to get at least some firsthand impression of the progress that has taken place in this dynamic and expanding nation.

When I said earlier that this is an historic Inter-American Conference, I meant that I have every expectation that it will lead to major measures to strengthen the inter-American system and increase its ability to meet the challenges of the last third of the twentieth century. It is important that the nations of this hemisphere through their leaders have a continuing exchange of views as they strive to coordinate their efforts to fulfill the legitimate desires of their peoples for a better life. The OAS has stood the test of time; it has shown that the nations of this hemisphere can settle differences peacefully among themselves and work together for the commen good. At this meeting of the supreme organ of the OAS it is my hope to join with my Latin American colleagues in improving our collective capacity to de both of these things.

Brazil has played a major role in the OAS since its foundation.

Recently it has contributed a great deal to the restoration of peace in the

During my stay in Rio de Janeiro I have been occupied almost exclusively with the affairs of the OAS Conference. A most fruitful part of this for me personally has been the opportunity to meet and talk with the Foreign Ministers of the American Republics. We do not often find ourselves gathered in one place and it has been especially gratifying to me to be able to confer at some length with my Latin American colleagues.

At this point I must add that the city of Rio de Janeiro has provided a beautiful backdrop for our labors. And I would like to take this opportunity to congratualte the people of Rio de Janeiro on the 400th anniversary of their city. We were happy to have been able to send several artistic groups to Rio this year to help the city celebrate this significant occasion.

We have covered a great deal of ground at the Conference so far in analyzing issues and problems which naturally arise within a living and growing system such as the OAS. And needless to say some of the problems
