SUBJ: PRESIDENT URGES MUNICIPAL ELECTIONS BE OPENED TO ALL ELIGIBLE CONTENDERS

1. PRESIDENT BALAGUER TOOK UNUSUAL STEP FEB 5 OF PUBLISHING OPEN LETTER TO HYPERSENSITIVE CENTRAL ELECTORAL BOARD (JCE) EXPRESSING HIS WISHES RE POLITICAL PARTICIPATION IN COMING MUNICIPAL ELECTION CAMPAIGN. HE PEGGED LETTER TO COMPLAINT OF MARIO READ VITTINI'S SMALL PDC, WHICH LAST WEEK DECLARED ITSELF IN OPPOSITION TO BALAGUER AND WITHDREW ITS REQUEST FOR RECOGNITION BY JCE, CHARGING IT HAMPERING PARTY'S PROSPECTS BY UNDULY DELAYING RECOGNITION.

2º BALAGUER WROTE AS FOLLOWS:

A. GUARANTEE OF NATIONAL DEMOCRACY AND DEFINITIVE PACIFICATION OF COUNTRY DEPEND IN GREAT PART UPON FREE MANIFESTATION PUBLIC OPINION IN PERIODIC ELECTIONS THROUGH

WHICH MAY BE CHOSEN, WITHOUT SLIGHTEST COERCION OR RESTRICTION,
THOSE WHO IN PUBLIC'S JUDGEMENT SHOULD OCCUPY
ELECTIVE OFFICES. PRESENT JCE MEMBERS ARE OF IRREPROACHABLE
CIVIC CONDUCT AND THEIR MORAL INTEGRITY CONSTITUTES
GUARANTEE ACKNOWLEDGED BY ALL DOMINICANS THAT FORTHCOMING
ELECTIONS, AS WELL AS THOSE PAST, WILL TAKE PLACE WITHIN
CLIMATE ABSOLUTE RESPECT OF VOTERS, WILL BUT IT OBVIOUS THAT
IT NOT SUFFICIENT THAT JCE MEMBERS ARE RESPECTED BY ALL.
FOR ELECTIONS TO BE GENUINE EXPRESSION POPULAR WILL, IT ALSO
NECESSARY THAT NO ONE BE RESTRICTED IN EXERCISE HIS CIVIC
RIGHTS AND THAT RIGHT TO SUFFRAGE BE OPENED TO ALL POLITICAL
GROUPINGS WHICH MEET CONDITIONS REQUIRED BY LAW AND WHOSE
LINES ARE COMPATIBLE WITH PRINCIPLES OF REPRESENTATIVE DEMOCRACY.

B. MEMBERS OF JCE ARE WITNESS TO FACT MY GOVERNMENT
HAS NEVER MADE SUGGESTIONS OR APPLIED PRESSURE THAT WOULD
IN ANY WAY RESTRICT ABSOLUTE INDEPENDENCE WITH WHICH THEY
PERFORMING FUNCTIONS VESTED IN THEM BY LAW. IN LIGHT THIS
FACT, WHICH MUST BE RECOGNIZED BY JCE AND PUBLIC OPINION,
"I PERMIT MYSELF RECOMMEND THAT JCE RECONSIDER CASE OF PD

AND THAT ALL NECESSARY FACILITIES BE EXTENDED THAT GROUP
SO THAT IT MAY PARTICIPATE IN COMING ELECTIONS AND THOSE
OF 1970. I HOPE THAT THIS SUGGESTION, MADE WITHOUT SLIGHTEST
INTENTION THAT IT BE INTERPRETED AS INTERFERENCE BY
EXECUTIVE BRANCH IN MATTERS OF YOUR EXCLUSIVE COMPETENCE, BE
RECEIVED FAVORABLY BY YOU, AS SUCCESS OF COMING ELECTIONS
AND CONSOLIDATION DEMOCRATIC REGIME IN DR DEPEND IN GREAT PART
ON ITS ACCEPTANCE".

3. JCE REPLIED IN OPEN LETTER PUBLISHED FEB 7. IT STATED ITS AGREEMENT THAT MUNICIPAL ELECTIONS SHOULD BE OPEN TO ALL GROUPS WHICH MEET LEGAL REQUIREMENTS AND ARE COMPTAIBLE WITH REPRESENTATIVE DEMOCRACY. RECALLED, HOWEVER, THAT LAW STATES SUCH GROUPS MUST PROVE MEMBERSHIP OF AT LEAST 3 PERCENT OF VOTE IN LAST ELECTIONS (SOME 41,000), AND THAT, IN CASE OF PDC, THOROUGH AND FAIR INVESTIGATION OF ITS CLAIMED MEMBERSHIP LIST BY JCE HAD FAILED CONFIRM PARTY'S CONTENTION IT MET THIS

REQUIREMENT. JCE THUS HAD NO ALTERNATIVE BUT TO REJECT PDC APPLICATION. BEFORE DOING SD, HOWEVER, PDC WITHDREW ITS APPLICATION AND CASE WAS CLOSED. "IT IT THUS NOT POSSIBLE RECONSIDER CASE OF PDC", JCE STATED, ADDING IT HAD TAKEN

DUE NOTE OF PRESIDENT'S DISCLAIMER OF INTERFERENCE IN ITS
AFFAIRS "AS IN NO CASE WILL BOARD ADMIT INTERFERENCES IN
EXERCISE ITS FUNCTIONS".

4. PDC, MEANWHILE, ISSUED STATEMENT ALSO PUBLISHED FEB 7
EXPRESSING ITS UNDERSTANDING THAT PRESIDENT S LETTER DEMONSTRATED
GOVT'S INTENTION CREATE "CONDITIONS ADEQUATE FOR SUCCESS
OF MUNICIPAL ELECTIONS", THAT IT CONCERNED "ALL GROUPINGS
WHICH MEET LEGAL REQUIREMENTS", AND THAT POC THUS EXPECTS
JCE TO TREAT IT WITH NEITHER MORE NOR LESS CONSIDERATION THAN
THAT GIVEN ALL OTHER ORGANIZATIONS WHOSE APPLICATIONS FOR
RECOGNITION ARE PENDING (IN OTHER WORDS, IT STATED ITS
EXPECTATION OF RECOGNITION ON BASIS PRESIDENT'S LETTER).

5. COMMENT: A. ONE POLITICAL INTERPRETATION PRESIDENT'S
LETTER (RE PDC) WAS ADVANCED IN SD-1710. BEYOND THAT,
BALAGUER WOULD SEEM HAVE INTENDED REPEAT GARCIA GODOY'S "OPEN
DOOR" POLICY TOWARDS 1966 ELECTIONS, IN WHICH ELIGIBILITY TO
PARTICIPATE WAS DECREED FOR ALL PARTIES PREVIOUSLY RECOGNIZED,
NOTWITHSTANDING FACT SOME HAD SUBSEQUENTLY LOST THEIR LEGAL
STATUS.

B. WE CAN ONLY SPECULATE, HOWEVER, ON WHY PRESIDENT

HAVE BEEN WELL ADVISED EITHER MAKE PRIVATE APPROACH OR TO
AVOID SPECIAL PLEA IN OTHERWISE WELL RECEIVED GENERAL STATEMENT

OF HIS DESIRES RE ELECTORAL PARTICIPATION. WOULD NOT SEEM THAT POLITICAL PROBLEM POSED BY PDC S DEFECTION IS OF MAGNITUDE SUFFICIENT TO WARRANT CONTROVERSY WITH JCE OVER BASIC ELECTORAL PROCEDURES -- CONTINUATION OF WHICH CONTROVERSY SEEMS ASSURED BY ALACRITY WITH WHICH PDC JUMPED INTO BREACH.

C. FURTHER, PDC WAS PLAYING POLITICS TO HILT IN
"QUITTING" ELECTIONS WITH MUCH FANFARE. JCE SECRETARY TOLD
US PDC TIMED WITHDRAWAL ITS APPLICATION FOR RECOGNTION TO
BEAT JCE ANNOUNCEMENT PARTY DID NOT MEET LEGAL REQUIREMENTS,
WHICH ANNOUNCEMENT (WHICH HURTS PARTY) WAS NOT MADE UNTIL
FORCED BY BALAGUER'S LETTER. NACIONAL FEB 7 REMINDED
READERS PDC OBTAINED ONLY 9,378 VOTES IN 1966.

D. BALAGUER'S LETTER MAY ALSO HAVE BEEN RESPONSE TO

PRESSURES FROM OTHER PARTIES WHICH FEEL JCE HAS UNDULY
DELAYED ACTION ON THEIR APPLICATIONS. PENDING BEFORE JCE
ARE APPLICATIONS OF UCN (16,152 VOTES IN 1966), PRSC
(30,660 VOTES IN 1966), PPDC (DID NOT PARTICIPATE INDEPENDENTLY
IN 1966), AND TWO NEW INDEPENDENT GROUPS: AGRUPACION
PROGRESISTA VEGANA INDEPENDIENTE OF LA VEGA AND MOVIMIENTO
INDEPENDIENTE CONCILIATORIO OF SANTIAGO. OF THESE UCN
HAS PUBLICLY AND PRSC AND PPDC HAVE PRIVATELY COMPLAINED
OF JCE'S ALLEGED DILATORINESS.
