REQUEST THAT PR DEFICIT BE ASSIGNED TO US CANE PRODUCERS FOR REMAINING DURATION OF PRESENT US SUGAR LAW, REFINERS! AND BEET PRODUCERS' LACK OF SUPPORT FOR REQUEST, AND LOWRY'S ASSESSMENT THAT GREAT UNCERTAINTY WILL PREVAIL IN SUGAR MARKET UNTIL PROBLEM OF ASSIGNING PR DEFICIT DEFINITIVELY RESOLVED.
