SUBJECT : Closing of Post - American Embassy, Aden, Southern Yemen

REF :

1. The American Embassy in Aden was closed on October 26, 1969 and until further notice no telegraphic or written communications should be addressed to the post.

2. The Government of the United Kingdom has agreed to act as protecting power for U.S. interests in Aden and the American Embassy in London will act as interchange for both written and telegraphic transmissions with the usual Department format.

3. Communications should be addressed to the American Embassy in London and telegrams captioned REPAD.

4. Telegraphic traffic must be on essential matters and held to the absolute minimum.

5. All consular files have been transferred to the Consulate General in Asmara. Inquiries and information concerning Consular matters, including visas, formerly in the Consular District of Aden, should be sent to Asmara.
