Dear Marshall:

Regarding the Dysart's interest in taking a servant to the United States the following applies:

First, she will have to qualify for an immigrant visa. To do so, she needs an approved labor certification. I am enclosing the new forms, parts A and B with instruction. We have not received part C yet; however, I have requested a supply from Rio and will send it on as soon as received. If the job offer is certified, it will be sent to this office which in turn will advise the person of the documents, etc required.

Because of the large number of qualified applicants and the annual quota limitation, there is a waiting list. At the present time we are issuing visas to those individuals who qualified on or before March 1, 1970. As you can see there is quite a wait.
