Enclosed is one copy of a Santos port information booklet published by Wilson, Sons S.A. The Consulate General is not certain whether this material is useful to the Department or other Washington agencies. If it should be, we should appreciate being informed, as we will transmit correction sheets which are issued from time to time to keep the material current.

In connection with the booklet as transmitted, Wilson, Sons notes that as from January 1966, the charges listed below were expected to be increased:

- a) Launch hire. Increase of 50% on the prices presently shown as from January 1, 1966.
- b) Telephone on board. Taxes will increase 52%.
- c) Centro de Navegação Transatlantica (Shipowners Association). The contribution per vessel's call will be increased from Cr\$6,000 to Cr\$12,000.
