SUBJECT

IN NEXT FEW DAYS TCO EXPECTS HAVE MEETING WITH DR. EXPEDITO AND SOME OTHER MEMBERS BRAZILIAN DELEGATION AT RECENT CIVIL AVIATION CONSULTATIONS IN US TO HEAR THEIR VERSION OF POINTS AT ISSUE. MEETING SUGGESTED BY BRIGADEIRO MARTINHO, DIRECTOR GENERAL OF CIVIL AVIATION DIRECTORATE (DAC) WHO INFORMED BY DAC LEGAL ADVISOR THAT ACCORDING TO WAY US MINUTES OF MEETINGS DRAFTED BRAZILIAN POSITION MAKES NO SENSE OR AT BEST IS VERY CONFUSING. EMBASSY DOES NOT KNOW HOW LEGAL ADVISOR OBTAINED THIS VIEW.

2. IT IS QUITE POSSIBLE, HOWEVER, THAT THERE ARE DIFFERENCES IN INTERPRETATION OF WHAT TRANSPIRED AT CONSULTATION AND SEEMS USEFUL ATTEMPT REMOVE ANY MISCONCEPTIONS WHICH MAY EXIST BEFORE CONSULTATIONS

ARE RESUMED. TO THIS END IT MIGHT BE USEFUL TO
