1. ELECTION RESULTS IN RECIFE CONSULAR DISTRICT CONTINUE COMING IN SLOWLY. PERNAMBUCO AND RIO GRANDE DO NORTE ELECTION COURTS INFORM CONGEN THAT OFFICIAL VOTE COUNT NOT TO BE COMPLETED UNTIL SOMETIME IN DECEMBER. PERNAMBUCO COURT ESTIMATES DECEMBER TWELVE. UNOFFICIAL AND CONFLICTING TOTALS FOR PERNAMBUCO APPEAR IN RECIFE PRESS BUT TOTALS FOR OTHER STATES REPORTED SPORADICALLY AND IN ABBREVIATED FORM.

2. IN PERNAMBUCO, ONLY FOUR CASES IMPUGNATION CANDIDATE REGISTRATION AND OF THESE ONLY ONE CASE SUSTAINED BY JUSTICA ELEITORAL, THAT OF EUFRASIO DALVA BARBOSA, MDB CANDIDATE FOR FEDERAL DEPUTY.

3. ONLY SIGNIFICANT CHANGE FROM PREVIOUS REPORTS IS OFFICIAL FIGURE FROM CEARA FOR FOUR YEAR SENATE RACE WHERE ARENA'S MENEZES PIMENTEL NOW TRAILING THREE MDB OPONENTS 81,165 TO 97,884 VOTES. NO OTHER RESULTS AVAILABLE. ROWELL.
