SUBJECT: ELECTION ASSESSMENT

1. AS CAMPAIGN FOR NOVEMBER 15 ELECTIONS ENTERS FINAL DAYS EVIDENCES OF CAMPAIGN ATMOSPHERE STILL MINIMAL AND ELIGIBILITY OF SOME OPPOSITION CANDIDATES IN GUANABARA STILL BEING LITIGATED.

2. NUMBER OF FACTORS IN SOMEWHAT UNNATURAL ELECTION PICTURE MAKE ACCURATE FORECASTS IMPOSSIBLE. ONE IMPORTANT UNKNOWN IS WHAT WILL BE PROPORTION OF SPOILED BALLOTS. NUMBER LIKELY TO BE LARGE, IN PART DUE TO CONSCIOUS PROTEST IN FORM OF BLANK BALLOTS (WHICH STUDENTS ADVOCATING BUT OPPOSITION TRYING TO DISCOURAGE) AND IN PART TO COMPLICATED BALLOTING SYSTEM.

3. AT THIS JUNCTURE SEEMS PROBABLE THAT GOVERNMENT'S ARENA PARTY WILL LOSE SOME SEATS, BUT WILL CONTINUE TO HACE MAJORITY IN SENATE, CHAMBER AND MOST STATE LEGISLATIVE ASSEMBLIES. OPPOSITION MDE GAINS IN SENATE MAY BE ON ORDER OF ABOUT 6 SEATS AND IN CHAMBER OF ABOUT 25 SEATS. PRINCIPAL MDB GAINS ARE EXPECTED TO BE IN GUANABARA, CITY OF SAO PAULO, AND POSSIBLY MINAS GERAIS AND RIO GRANDE DO SUL.

4. COMMENT: IF ELECTION RESULTS TAKE THESE DIMENSIONS, BELIEVE GOVERNMENT AND MILITARY FORCES SUPPORTING IT WILL ACCEPT THE RESULT WITH ONLY MINOR SURFACE MANIFESTATIONS OF DISCONTENT. ON THE ODD CHANCE THAT ARENA LOSSES WILL BE APPRECIABLY GREATER, MUST BE PREPARED FOR A MORE GIVOROUS REACTION. HOWEVER, SITUATION DIFFERS FROM THAT OF OCTOBER, 1965 IN THAT PRESIDENCY AND ALL GOVERNORSHIPS WILL CLEARLY BE IN ARENA OR UNAFFILIATED BUT DOMESTICATED HANDS FOR NEXT FOUR YEARS. TUTHILL BI
