FOLLOWING IS INFORMAL TRANSLATION TEXT OF RESOLUTION ON BIRTH CONTROL ADOPTED BY INTER-PRESBYTERIAN COUNCIL (CONSELHO INTER-PRESBITERIANO, C.I.P.) AT ITS REGUALR ANNUAL MEETING SELD IN CAMPINAS, STATE OF SAO PAULO, MAY 5, 1967. THOUGH DOUGHERTY STATED DECLARATION WAS RELEASED TO PRESS, CONGEN HAS NOTICED NO RPT NO PUBLICATION. QUOTE:
