1. INFORMATION FROM ARMY, NAVY AND ARMED FORCES TRAINING CENTER SOURCES INDICATE EX AF C/S LUNA FOUND UNITED FRONT OPPOSING HIM IN JAN 25 MEETING. TRIUMVIRATE HAD PREPARED DECREE DISCHARGING HIM FROM ARMED FORCES BUT RELENTED AND SIMPLY RELIEVED HIM AS C/S, LEAVING HIM TEMPORARILY ATTACHED TO OFFICE OF SEC STATE FOR ARMED FORCES PENDING DECISION AS TO FUTURE ASSIGNMENT
2. REACTION OF OTHER ARMED FORCES LEADERS UNANIMOUS RELIEF THAT CRISIS PASSED AND ENCOURAGED BY STRONG STAND OF SEC STATE FOR

3. TRIUMVIRATE CONSIDERING AMNESTY LAW WHICH WILL INCLUDE MOST POLITICAL PRISONERS AS WELL AS MILITARY PERSONNEL AGAINST WHOM NO LEGAL ACTION HAS BEEN INITIATED TO DATE. MILITARY OBJECTIONS TO INCLUSION OF COMMUNISTS IN AMNESTY HAS BEEN OVERCOME TO LARGE EXTENT

4. APPARENTLY WESSIN Y WESSIN NOT AT FIRST NOTIFIED OF SATURDAY MEETING. ARMY AND POLICE LEADERS INSISTED HE BE SUMMONED AND HE ARRIVED FOR LAST FEW MINUTES OF FORMA MEETING AND JOINED GROUP FOR LUNCH.

COMMENT: PASSAGE OF AMNESTY LAW IS KEY TO SOLUTION OF MAJOR REMAINING PROBLEM IN ARMED FORCES-DISPOSAL OF LARGE NUMBER OF OFFICERS WHO ARE DEAD WOOD. SURPRISINGLY, POLICE CHIEF, BRIGN GEN BELISARIO PEGUERO WON VERY FAVORABLE COMMENT FROM ARMY AND NVY LEADERS AS WELL AS THE TRIUMVIRATE FOR HIS STAUNCH SUPPORT OF THE PRESENT GOVERNMENT.
