A CONFIDENTIAL SOURCE WHO HAS FURNISHED RELIABLE INFORMATION IN THE PAST REPORTED THAT ANTONIO GUZMAN (SILVESTRE ANTONIO GUZMAN FERNANDEZ, PROPOSED PRESIDENT) CONTACTED JUAN BOSCH ON MAY TWENTY EIGHT, SIXTY FIVE.

GUZMAN STATED THEY ARE STILL INVOLVED IN NEGOTIATIONS. HE STATED A NOTE WAS SENT THIS MORNING TO OAS PROTESTING PAYMENTS TO PUBLIC EMPLOYEES. BOSCH STATED THAT "THEY" ARE MANUEVERING FOR OAS TO GOVERN COUNTRY AND THIS MUST BE DENOUNCED BEFORE UN AND AMERICAN COUNTRIES. BOSCH STATED "WE" MUST SEND CABLES OF PROTEST TO UN, OAS, AND ALL COUNTRIES OF AMERICA INCLUDING U.S. BOSCH INSTRUCTED GUZMAN NOT TO BACK UP EVEN ONE STEP.

BOSCH ALSO TALKED TO JOTTIN CURY (REBEL FOREIGN MINISTER) WHO WAS SICK WITH HIGH FEVER AND COLD. CURY STATED CABLES OF PROTEST WERE ALREADY SENT TO UN, OAS, AND U.S.

BOSCH STATED SPEECH BY PRESIDENT LYNDON B. JOHNSON WILL

PROBABLY BE PRINTED IN N.Y. TIMES "TOMORROW" AND CURY SHOULD TAKE COPY TO NEGOTIATIONS "TOMORROW", BOSCH STATED IF THINGS GO WRONG, SHOUT "NO, NO, NO, NO, WE CANNOT ACCEPT THIS BECAUSE PRESIDENT JOHNSON SAID SUCH AND SUCH". BOSCH SAID, "THIS WILL BE OUR POLITICS FROM NOW ON; LEAN ON THIS SPEECH OF PRESIDENT JOHNSON." BOSCH INSTRUCTED CURY TO HAVE SPEECH TRANSLATED AND GIVE COPY TO GUZMAN AND ALSO ADVISE CAAMANO (FRANCISCO CAAMANO DENO, PRESIDENT OF REBEL GOVERNMENT) WHAT "WE" ARE SCHEMING.

CURY MENTIONED THAT MANIFESTATIONS HAD BEEN GREAT SUCCESS EVEN THOUGH IT RAINED TERRIBLY HARD. CURY SAID THERE WERE ABOUT FIVE THOUSAND PERSONS.

BOSCH ASKED WHAT CURY KNEW ABOUT ONE MOLINA BREINA (PHONETIC). CURY STATED THAT MOLINA ACTED BADLY AND THERE ARE PERSONS WHO MIGHT TRY TO HARM HIM. CURY SAID HE HEARD A RUMOR THAT MOLINA WAS STILL PRETENDING TO BE PART OF NEGOTIATIONS.

BOSCH STATED ALL NEGOTIATIONS BEGIN WITH "ME" (BOSCH). BOSCH ALSO STATED THAT MORA (POSSIBLY JOSE ANTONIO MORA OTERO, SECRETARY GENERAL OF OAS) SAID THE SAFETY ZONE IS OPEN TO REFUGEES FROM BOTH SIDES. BOSCH CALLED MORA A CHARLATAN AND SAID

"WE ARE NOT PERSECUTING ANYONE AND THIS SHOULD BE MADE PUBLIC IN A STATEMENT TO HIM (MORA)." BOSCH SAID THEY SHOULD DEMAND THAT OAS REMOVE MORA.

ON MAY TWO EIGHT SIXTYFIVE ONE NYLSA (PHONETIC) CONTACTED JUAN BOSCH, ADVISING THAT JACOBO (PROBABLY JACOBO MAJLUTA, MINISTER OF FINANCE DURING THE BOSCH REGIME) HAD CALLED HERE AND SAID HE WAS GOING TO THE WHITE HOUSE. BOSCH ADVISED HE HAD NOT SPOKEN WITH JACOBO.
