SUGGESTED DISTRIBUTION

1. Treasury's Foreign Assets Control Regulations and Cuban Assets Control Regulations prohibit all persons subject to jurisdiction of U.S. from effecting unlicensed purchases abroad and/or importations into the U.S. of all goods of Communist Chinese, Cuban, North Korean or North Vietnamese origin. In addition, these Regulations prohibit all unlicensed dealings with nationals of those countries. The Regulations were issued under authority of the Trading with the Enemy Act.

2. The China Art Embroidery Company, 27-A Chatham Road, 1st Floor (Ocean View Court), Kowloon, Hong Kong, has been found to be a national of Communist China. Accordingly, all unlicensed dealings with China Art Embroidery Company by persons subject to the jurisdiction of the United States are prohibited.

3. Treasury has ascertained that China Art Embroidery Company sends its catalog to American personnel at many foreign service posts, as well as to military personnel at U.S. overseas installations.

4. Addressees are requested to inform all official personnel at addressee posts of the prohibition against dealing with China Art Embroidery Company. The same information should be laterally disseminated to U.S. military installations in the areas served by addressees, with a request that the information be brought to the attention of all U.S. military personnel and accompanying civilian personnel.
