SUBJ: FURTHER SUBSTANTIAL PUNITIVE ACTIONS AGAINST STUDENTS

1. MAY 9 PRESS CARRIES FOUR SEPARATE UNIVERSITY ANNOUNCEMENTS CITING TOTAL OF 835 RECIFE STUDENTS TO PRESENT DEFENSE AGAINST CHARGES OF SUBVERSIVE ACTIVITIES UNDER TERMS DECREE LAW 477.

2. ENTIRE STUDENT BODY OF ENGINEERING FACULTY OF FEDERAL UNIVERSITY, TOTALING 809, IS REQUIRED TO PRESENT DEFENSE. OTHERS CITED INCLUDE 21 FROM PHYSICS INSTITUTE OF FEDERAL UNIVERSITY, FOUR FROM BIO-SCIENCES INSTITUTE OF FEDERAL UNIVERSITY, AND ONE FROM VETERINARY FACULTY OF PERNAMBUCO RURAL UNIVERSITY.

3. ALTHOUGH ALL STUDENTS BEING PROCESSED UNDER SUMMARY PROCESS OF DL-477, THERE CONSIDERABLE DIFFERENCE IN BOTH WORDING AND CONTENT OF CITATIONS. STUDENTS FROM ENGINEERING FACULTY AND PHYSICS INSTITUTE MUST PRESENT WRITTEN DEFENSE
