Deputy Wilson Chedid, who is considered to be a leftist ultra-nationalist and is a member of the communist-dominated Paraná Bank Workers Union, told the Ultima Hora on January 30 that efforts have been begun to organize the Paraná workers, students and parliamentarians in a United Front for Popular Mobilization to support President Goulart's reform program. This organization will also inform the "people" what the President is trying to do to ameliorate the progress and well being of Brazilians.

The Deputy stated that the organization would bring such nationally prominent persons as João Pinheiro Neto, Vieira de Melo, Temperani Pereira, Alimino Afonso, San Thiago Dantas, Neiva Moreira and Paulo de Tarso to the principal Paraná cities to explain and discuss the principles of the Basic Reform (Reformas de Base).

These men will speak at both open and closed sessions with students, workers and the general public.

Deputy Chedid stated that contact has already been made with the leaders of the Bank Workers and Journalists Unions in Paraná. The Paraná Secondary and University Student Unions as well as all types of labor unions will be asked to join the state organization. He listed bank reform with monopoly of exchange, agrarian reform in every meaning of the term, tax reform and electoral reform as reforms
