Deliver following letter from President Kennedy to President Goulart:

"I received with pleasure your letters of March 3 and March 8th, which were delivered to me during the recent visit of your very able Minister of Finance. They were most helpful in clarifying the policies and objectives which you and your Government intend to pursue.

"Since the time when your letters were written, important/developments affecting both private and governmental economic relations between our two countries have taken place. I sincerely hope that these developments will lead to other positive measures affecting the private sector and will mark the beginning of a new phase of expanding and beneficial participation of private foreign capital in contributing ~~unrestrictedly~~ to the economic strength of ~~Brazil~~ Brazil, and the well-being of its people.
