The Consulate submits (Enclosure 1) a list of individuals in Paraná who have had electoral mandates cancelled and/or political rights suspended for ten years under terms of Article 10 of the Institutional Act. In accordance with the reference telegram the list does not include military figures or national political and labor leaders.

While most of those jailed have subsequently been released, they all still face possible criminal prosecution by the State of Paraná.

Information on Article 10 sanctions - Santa Catarina (the southern half of the Consular District), will be submitted when available.
