10 PRESIDENT COSTA E SILVA MET JAN 18 IN RIO WITH ARCHBISHOP AVELOR BRANDAD, WHO ACTING AS REPRESENTATIVE OF NATIONAL BISHOPS CONFERENCE . AFTERWARDS, BRANDAO ISSUED STATEMENT SAYING MEETING EXCELLENT AND COVERED WIDE RANGE OF SUBJECTS. SAID HE RECOMMENDED TO PRESIDENT

COUNTERPART. DECLARED CHURCH DID NOT WANT INTERFERE WITH ADMINISTRATION PROGRAMS BUT RATHER INTERPRET "SIGNS OF

TIMES" AND CONTRIBUTE TO "HARMONIOUS DEVELOPMENT." STATED HE AND PRESIDENT HAD AGREED THAT BISHOPS CONFERENCE AND CIVILIAN AND MILITARY AUTHORITIES WOULD TRY "ESTABLISH CONTACT" WHEN DIFFICULTIES AROSE.

20 IN SEPARATE BUT RELATED DEVELOPMENT, RECENT PRESS STORIES RE MISUSE BY NORTHEASTERN CHURCHMEN OF

FUNDS DONATED TO CHURCH BECOMING CAUSE CELEBRE IN NORTHEAST AND ATTRACTING NATIONAL ATTENTION. THOSE INVOLVED EVIDENTLY LOANED CHURCH MONEY AT HIGH INTEREST TO PERNAMBUCO "BUSINESSMAN" WHO ABSCONDED. ACCORDING CONSULATE RECIFE SOME POLITICIANS USING ISSUE TO ATTACK

3. AFTER MEETING PRIVATELY IN RECIFE JAN 18,

OF CAMPAIGN TO "INTIMIDATE" CHURCH IN ITS DEFENSE OF

ECONOMIC DEVELOPMENT IN NORTHEAST WHICH DENOUNCED "SLAVERY"
IN AREA AND AFFIRMED BISHOPS. DETERMINATION STRUGGLE FOR SOCIAL
JUSTICE DESPITE RISKS.
