HOSPITALS AND NURSING SCHOOLS FAILED DUE BUREAUCRATIC DIFFICULTIES
AND CERTAIN DIFFICULTIES COMMUNICATIONM

SISTER FRANCISCA NOGUEIRA SOARES, ACCOMPANIED BY TWO BRAZILIAN REGISTERD NURSES WHO ARE ALSO TEACHERS OF NURSING, WILL ATTEND 14TH INTERNATIONAL NURSING CONFRESS IN MONTREAL BETWEEN APPROXIMATELY 18-28 JUNE. HER TWO COMPANIONS ARE MISS MARIANA FERNANDES DE SOUZA AND MISS ROSA APARECIDA PIMENTA DE CASTRO. THEY WOULD LIKE TO SPEND ROUGHLY THE FIRST HALF OF JULY VISITING HOSPITALS AND MURSING SCHOOLS IN BOSTON AND/OR NEW YORK.

3. BECAUSE OF REQUIREMENT MENTIONED REFTEL THAT MOTHER PROVINCIAL HERE MUST INFORM CORRESPONDING MOTHERS PROVINCIAL IN NEW YORK CITY AND BOSTON, SISTER FRANCISCA WAS ASKED URGENTLY TO HAVE HER MOTHER PROVINCIAL SEND CORRESPONDING LETTERS.

4. CAN USPHS OR ANY OTHER USG AGENCY ASSIST THESE THREE LADIES TO ACHIEVE THEIR OBJECTIVE? SISTER FRANCISCA ASSURES THAT MOTHER HOUSES BOSTON AND NEW YORK WOULD PROVIDE INTERPRETERS IF NEEDED.
