1. AT CLOSE OF EXCLUSIVE INTERVIEW GRANTED BY PRESIDENT CASTELLO BRANCO TO HAL HENDRIX OF SCRIPPS HOWARD OCT. 19, THE PRESIDENT OPENED A FOLDER ON HIS DESK CONTAINING A LARGE STACK OF PAPERS MARKED SECRET

2. CASTELLO BRANCO TOLD HENDRIX HE HAD BEEN READING A REPORT FROM THE BRAZILIAN EMBASSY IN WASHINGTON WHICH DESCRIBED THE VIEWS OF "THE AMERICAN LABOR MOVEMENT, THE AFL-CIO." THE PRESIDENT SHOWED THE REPORT TO HENDRIX AND THE PRESS ATTACHE WHO WAS SERVING AS INTERPRETER WHERE HE HAD UNDERLINED LENGTHY PARTS OF THE REPORT. PRESIDENT CASTELLO BRANCO BEGAN READING FROM THE REPORT, SKIPPING OVER SOME WORDS WHICH IDENTIFIED BY WHOM IT WAS WRITTEN AND WHO

THE PERSON IN THE AFL-CIO WAS THAT HAD EXPRESSED THE VIEWS HE WAS
READING. THE PRESIDENT READ A PORTION WHICH SAID THE
BRAZILIAN GOVERNMENT HAD EXCESSIVE CONTROL OF THE UNIONS AND
THAT THE GOB HAD PUT OBSTACLE IN THE WAY OF THE EXECUTION OF A
LOWCOST HOUSING PROGE

(AM SPONSORED BY THE AMERICAN LABOR MOVEMENT IN BRAZIL. AT THIS POINT, THE PRESIDENT STOPPED, PAUSED, CHUCKLED AND HIS EYES FIXED ON HENDRIX AND HE SAID VERY SLOWLY: "THESE THINGS ARE NOT ALL TRUE. BUT I AM GLAD TO HAVE THIS REPORT FROM OUR FRIENDS (HE REPEATED THE WORD "FRIENDS") IN THE AMERICAN

LABOR MOVEMENT, I AM GOING TO CALL IN MY MINISTER OF LABOR AND SEND THIS TO ROBERTO CAMPOS TO FIND OUT IF THEY ARE (TRUE) AND WILL DISGUSS THEM WITH THE LABOR MINISTER."

- 3. THE PRESIDENT CLOSED THE FOLDER, REOPENEO IT AND POINTED TO THE WORD "SECRET" ON THE DOCUMENT AND SAID: "BUT THAT IS A SECRET."
- 4. THE PRESIDENT LAUGHED WHILE LOOKING AT HENDRIX AND ADDED: "SO YOU DON'S KNOW THIS."
- 5. HENDRIK TOLD THE PRESS ATTACHE HE DID NOT INTEND TO USE THE EXCHANGE OR TO MENTION THE INCIDENT SINCE HENDRIX DID NOT CONSIDER THE PRESIDENT SPOKE ON THE RECORD IN THAT INSTANCE.
- 6. THE PRESIDENT HAD A CORDIAL AND RELAXED SESSION WITH HENDRIX WHICH LASTED A BIT OVER 20 MINUTES, KEEPING THE MINISTER OF JUSTICE WAITING FOR THAT PERIOD OF TIME SINCE HENDRIX HAD BEEN FIFTEEN MINUTES LATE FOR HIS APPOINTMENT WITH THE PRESIDENT.

THE INTERVIEW WAS ARRANGED THROUGH ROBERTO CAMPOS. THE PRESIDENT SAID IN RESPONSE TO HENDRIX'S OPENING EXPRESSION OF APPRECIATION TO THE PRESIDENT FOR SEEING HIM DURING A BUSY TIME THAT HE HAD BEEN TRYING SINCE NOVEMBER TO SEE THE PRESIDENT. THE PRESIDENT SAID THIS WAS THE FIRST HE HAD HEARD OF THE REQUESTS. HENDRIX HAD PLACED HIS REQUESTS THROUGH THE PRESS SECRETARY TO THE PRESIDENT, WHICH INDICATES NOT ALL REQUESTS TO SEE THE PRESIDENT ARE DELIVERED BY THE PRESS SECR

(ETARY ALTHOUGH HE ASSURES NEWSMEN THAT IS THE CASE. PRESIDENT CASTELLO BRANCO ALSO ADDED HE IN ALWAYS HAPPY TO SEE FOREIGN NEWSMEN. "WE NEED TO CLARIFY OUR OBJECTIVES TO OTHERS," HE SAID.

- 3. COMMENT: IN REFTEL, I REPORTED THAT PIO CORREA STATED ALL OF MEANY'S SUGGESTIONS WERE "CONSTRUCTIVE." THERE WERE OTHERS AT THE MEETING. CASTELLO BRANCO MAY HAVE BEEN REFERRING NOT TO MEANY'S COMMENTS BUT TO THOSE OF OTHERS.

1. WHAT DO YOU CONSIDER THE PRINCIPAL ACCOMPLISHMENTS OF YOUR GOVERNMENT?

A. MY GOVERNMENT HAS NOT ONLY ATTACKED ON ONE FRONT. WE HAVE OPERATED ON SEVERAL FRONTS. THERE HAS BEEN NO DISPERSION OF OUR FORCES. IT WAS NECESSARY TO RE-ESTABLISH AND RECUPERATE IN MANY ZONES OF POLICY, POLITICS AND ADMINISTRATION.

WE TRIED TO ACHIEVE ORDER IN POLICY AND POLITICS, IN FINANCE, IN ECONOMICS AND IN PUBLIC LIFE.

A. POLICY OF GOVERNMENT (

THE INSTITUTIONS OF BRAZIL AND ELIMINATE THE COMMUNIST INCURSIONS.

B. FINANCES...WE DEDICATED OURSELVES TO FIGHT AGAINST INFLATION WITHOUT QUARTER. WE ALREADY HAVE ACRIEVED CONTROL OF FISCAL POLICY, MONETARY POLICY, SALARY POLICY AND CREDIT POLICY.

C. INSOFAR AS THE ECONOMIC SITUATION IS CONCERNED, WE HAVE 6STABLISHED THE BASIS FOR BEGINNING DEVELOPMENT AGAIN ON A REALISTIC BASIS..WE HAVE BEEN ABLE TO ACHTEVE ESTABLISHMENT OF CONDITIONS FOR RESSURGENCE OF DEVELOPMENT WITHOUT INFLATION. WE HAVE SOUGHT TO DESTROY THE ILLUSION OF DEVELOPMENT THROUGH (BASED ON) INFLATION.

D. PUBLIC

LIFE ... WE HAVE RE RESTABLISHED ORDER AND SECURITY FOR ALL

  - 2. DO YOU PERSONALLY, FEEL YOU HAVE HAD A CONSIDERABLE MEASURE OF SUCCESS?
  - A. OUR AIM WITHIN ALMOST THREE YEARS OF GOVERNMENT HAS BEEN TO ACHIEVE THE ESTABLISHMENT OF THE BEST CONDITIONS POSSIBLE FOR THE INSTALLATION AGAIN OF A NORMAL GOVERNMENT IN BRAZIL, WHICH WILL HAPPEN MARCH 15, 1967. THEREFORE, I WOULD SAY THERE HAS BEEN SUCCESS.
  - 3. WHEN DO YOU THINK THE BRAZILIAN REVOLUTION WILL BE OVER THE HUMP, DOING ALL IT SET OUT TO DO?
  - A. 1976 WILL BE THE GREAT YEAR OF BRAZIL. THE NEW POLITICAL INSTITUTIONS WILL HAVE BEEN EXPERIMENTED, WILL BE OPERATING, WILL BE UNDERSTOOD AND FIRMED...THE BAD EFFECTS OF INFLATION WILL HAVE BEEN OVERCOME. THE GREAT INVESTMENT, PRIVATE AND GOVERNMENT, NATIONAL AND FOREIGN. WILL BE PAYING OFF FULLY.
  - 4. HOW DO YOU FEEL ABOUT BEING THE TARGET OF A CONSIDERABLE AMOUNT OF CRITICISM FROM PEOPLE HERE, ESPECIALLY BECAUSE OF THE ECONOMIC PINCH?
  - A. THE ORIGINS OF THE CRITICISMS MUST BE CONSIDERED

## 6. WILL THERE BE MORE CASSATIONS?

A. TO ASSUME AN OBLIGATION EITHER NEGATIVE OR POSITIVE IS NOT POSSIBLE (MEANS HE CAN'T SAY "ES OR HC NOW). BY WAY OF ILLUSTRATION, HE SAID; A PENAL CODE EXISTS, UNFORTUNATELY. THE POWER TO CASSATE EXISTS, UNFORTUNATELY.
