1. You may assure GOB which now has under consideration A-37B, A-4M and K, F-5A, B, and E, and A7D that USG will favorably consider sale of any of above aircraft should GOB make purchase request. Such approval can be given immediately for purchase via commercial channels.

2. FMS cash purchase may be authorized provided purchases fit into whatever FMS ceiling for Latin America finally emerges from pending legislation. FYI: While we would certainly consider possibility of providing FMS credit, we would prefer not make this decision before legislation enacted. FMS credit purchase for some of above aircraft
