The article further stated that the situation had become so bad in commercial aviation Congress had to conduct an investigation in order to study the situation; the investigation is recorded in the records of the House of Representatives; it would certainly be hoove the present government to look at this investigation before it had decided to appoint subject officer to the position of Director General of Civil Aeronautics—a decision which they might regret.)
