1. (C/NOFORN) IN FURTHER REGARD TO SUPPORT BEING PROVIDED FICEURLANT ON UNITAS XXII EXERCISES, THIS OFFICE WOULD LIKE TO CONFIRM THE INCUMBENTS IN THE FOLLOWING POSITIONS AND THEIR PARTICIPATION IN UNITAS XXII:

A. (C/NOFORN) VICE ADM GABRIEL DE ARAUJO BASTOS -CHIEF OF STAFF TO THE COMMANDER OF NAVAL OPERATIONS AND NAVIGATION. THIS OFFICE NOTES FROM REF B. THAT ADMIRAL NEWTON BRAGA DE FARIA WAS APPOINTED COMMANDER OF NAVAL OPERATIONS EFFECTIVE 30 APRIL 1981. WILL VADM GABRIEL DE ARAUJO BASTOS, WHO HAS BEEN CHIEF OF STAFF SINCE APRIL 1979, CONTINUE IN THAT POSITION? IF NOT, PLEASE PROVIDE THE NAME OF THE NEW INCUMBENT AND INCLUDE APPLICABLE BIOGRAPHIC DATA.

B. (U) VICE ADMIRAL ALFREDO KARAM, COMMANDER OF THE FIRST NAVAL DISTRICT, SINCE APRIL 1979.
