JOSE FRANCISCO DE ALBUQUERQUE LINS, ASSIGNED HERE AS RESIDENT
BRAZILIAN NAVAL ATTACHE, ARRIVED APRIL 19 FROM RIO. HE
REPLACED CAPTAIN OCTAVIO JOSE SAMPAIO FERNANDEZ, WHO HERETO-
FORE ACCREDITED BOTH HERE AND BUENOS AIRES, BUT RESIDENT
BUENOS AIRES. ON 20TH INSPECTOR GENERAL URUGUAYAN NAVY
ACCEPTED ALBUQUERQUE LINS' CREDENTIALS. ACCORDING LIAISON
OFFICER, ALBUQUERQUE LINS ARRIVED WITHOUT USUAL AGREEMENT
REQUESTHAND WITHOUT FOREKNOWLEDGE URUGUAYAN NAVAL AUTHORITIES.

FURTHER, LIAISON OFFICER ASSUMES ALBUQUERQUE LINS IS PRESENT
GOB APPOINTEE AND THAT HE HERE TO KEEP EYE ON GOULART.
URUGUAYAN NAVY PLANNING ACCREDIT ATTACHE TO RIO, WHICH,
HOWEVER, REQUIRES NCG APPROVAL.

COMMENT: FACT THAT URUGUAYAN NAVAL AUTHORITIES OBVIOUSLY
WENT OUT OF WAY TO GRANT OFFICIAL ACCEPTANCE ALBUQUERQUE LINS
SUGGESTS NCG RECOGNITION OF GOB PROBABLY. ALUSNA BELIEVES
IT HIGHLY UNLIKELY NAVY WOULD HAVE ACCEPTED CREDENTIALS
WITHOUT GOB APPROVAL.
