- 3. At the outset, the minutes of the Meeting held on 23rd September, 2004 were confirmed.
- 4. The discussions commenced with the recommendations formulated in respect of the Health Sector which, inter alia, direct focus on a composite approach to Health Care in the rural and urban areas, the integration of vertical and horizontal programmes, effective measures to strengthen the delivery systems and the convergence of schemes in the areas of health, family welfare, nutrition, immunization, drinking water, sanitation and hygiene. A range of pertinent issues were raised and deliberated upon at length in the light of which it was agreed that the proposals in this behalf, which also envisage the setting up of a National Health Mission, should be forwarded to the Government of India at the earliest.
- 5. The Council next took up the Recommendations relating to Elementary Education and was apprised, in this context, of the issues which emerged at the Consultation Workshop on "Universalization of Elementary Education: Urgent Tasks and Long-term Perspectives" held on 15<sup>th</sup> October, 2004. It was recalled that several observations and suggestions were offered at that forum in respect of the Sarva Shiksha Abhiyan which had been kept in view in again placing the matter before the NAC. Following a detailed discussion, it was agreed that the Government of India should be addressed to consider urgent steps to activate the Sarva Shiksha Abhiyan Mission ( which was announced in early 2001 but has remained largely non-functional), outlining the other relevant aspects as well.

- 6. The Council were informed about the discussions which took place in the Planning Commission on 19<sup>th</sup> October, 2004 in regard to Watershed Development Programmes. This Item of the Agenda is to be discussed further in the NAC.
- 7. Presentations were made to the Council on the subject of Tribal Welfare and Development and on issues relating to a new National Policy for the Resettlement and Rehabilitation of project affected families, on problems pertaining to the "eviction of tribal communities from forest lands" and on the question of a proposed Commission on Displacement, Resettlement and Rehabilitation. It was agreed that discussions would continue in the Council on these matters.
- 8. A Press Release was issued and the Meeting concluded with expression of thanks to the Chairperson.

The Fifth Meeting of the National Advisory Council (NAC) was chaired by Smt. Sonia Gandhi on Thursday, 23<sup>rd</sup> September, 2004 at New Delhi. The following Members participated in the discussions:-

- 2. Shri Arun Bhatnagar, Secretary, Shri Pulok Chatterji, Joint Secretary, Smt. Jayanti S. Ravi, Deputy Secretary and Shri Dhiraj Srivastava, OSD were present.
- 3. The Council were first informed about the setting up of a Non-lapsable Fund (Prathmik Shiksha Kosh) exclusively for the Elementary Education Sector, including the Sarva Shiksha Abhiyan and the Mid-Day Meal Scheme. Note was taken of the current position in respect of processing of the draft Rural Employment Guarantee Bill and the draft Right to Information Bill.
- 4. It was recalled that a Consultation Workshop on Health had been sponsored by the NAC on 22<sup>nd</sup> September, 2004 in New Delhi at which key issues, including the convergence of Health, Family Welfare, Nutrition and other related Programmes, the urgent need to strengthen and improve the delivery systems, the preparation of Village and District Health Plans, the integration of

School Education and Health Care, rigorous monitoring of the Public Health system, Health Insurance for poor families (which, *inter alia*, forms part of the National Common Minimum Programme), the training of Health Workers, Sanitation and appropriate redesigning of Medical Education were deliberated upon in detail. At this stage, the Council were also apprised in regard to the various organizational, administrative, financial and legislative measures that need to be considered and addressed in depth in order to demonstrate tangible results in the functioning of the Health sector as a whole.

- 5. These issues were discussed further in the Council and views and opinions expressed by all the Members present, in the light of which it was agreed that the requisite proposals in respect of Health Insurance, Community Health Volunteers, Health Delivery systems, Public Health Infrastructure and Sanitation would be formulated for being taken up with the Government.
- 6. It was also noted that senior officials of the Department of Land Resources (Ministry of Rural Development) would separately be meeting with NAC Members to discuss watershed schemes and other programmes of the Department.
- 7. The Sixth Meeting of the Council was scheduled for Wednesday, 20<sup>th</sup> October, 2004 and the Seventh Meeting for Saturday, 27<sup>th</sup> November, 2004. In the meanwhile, a Consultation Workshop on "Universalization of Elementary Education: Urgent Tasks and Long-term Perspectives" is to be organized in conjunction with the Department of Elementary Education and Literacy (Ministry of Human Resource Development) at Shastri Bhawan, New Delhi. Discussions would also be arranged, in association with the Planning Commission, on Watershed Programmes, if possible before the next Meeting of the Council.

- 5. Presentations were made on the Health, Medical and Sanitation Sector and on "Universalization of Access to Quality Basic Education" in the country which subjects, it was agreed, may be discussed in the next Meeting scheduled for Saturday, 14<sup>th</sup> August, 2004 and for which the Agenda is to be circulated separately.

# Minority-related Provisions in UPA's Common Minimum Program

Comments and Suggestions

Professor Dr Tahir Mahmood Former Chairman, National Minorities Commission The United Progressive Alliance (UPA), now ruling at the Centre, has announced a Common Minimum Program (CMP). Certain significant provisions relating to the minorities of the country are included under this CMP. The Nation will indeed curiously watch how, when and to what extent these provisions are translated into concrete action. A properly edited version of these provisions is being offered below, along with some comments and suggestions for the consideration of the UPA and its Government.

### I. Text of Minority-related Provisions in the CMP

### A. Basic Principle

The CMP announces six Basic Principles for Governance. Principle 5 among these reads as follows:

"To provide for full equality of opportunity – particularly in education and employment – for Scheduled Castes, Scheduled Tribes, the OBCs and the *Religious Minorities*."

### B. Measures to be adopted for the Welfare of Minorities

- To enact a model comprehensive law to deal with communal violence and encourage the States to adopt it to generate faith and confidence in the minority communities.
- To amend the Constitution to establish a Commission for Minority Educational Institutions that will provide direct affiliation for minority professional institutions to central universities.
- To promote modern and technical education among *all* the minority communities social and economic empowerment of minorities through a more systematic attention to their education and employment to be a priority concern for the UPA.
- To establish a National Commission to see and report in six months on how best the welfare of the socially and economically backward sections among the religious and linguistic minorities, *including reservation in education and employment*, can be enhanced.
- To provide adequate funds to the National Minorities Development and Finance Corporation (NMDFC) to ensure its effective functioning.
- To examine the question of providing Constitutional status to the National Minorities Commission; and to strive for recognition and promotion of the Urdu language under Articles 345 and 347 of the Constitution.
- To restructure and revive the National Integration Council to meet at least twice a year so as to fulfil its original objectives.

### II. Demands of the Basic Principle

- 1. In Principle 5 of the Basic Principles of Governance "Religious Minorities" have been bracketed with the Schedule Castes, Scheduled Tribes and OBCs. By doing so the CMP *very rightly* recognizes that Religious Minorities like the SCs, STs and OBCs are *a weaker section of the society*.
- 2. A basic requirement in this context is that there must not be different yardsticks for safeguarding the interests of the various weaker sections of the society. In other words, for the Religious Minorities too the Government should adopt measures similar to those already in force, or proposed, for the other three weaker sections. This will be perfectly in accordance with the provisions of the Constitution.
- 3. The stress in Principle 5 is on providing "full equality of opportunity". Though such equality of opportunity is to be provided in general and in all matters whatsoever, special emphasis has been laid, very rightly, on providing equality to all the weaker sections including the Religious Minorities in respect of (a) education, and (b) employment.
- 4. As regards education, under the National Education Policy of 1986 the *Muslims and the neo-Buddhists* had been identified as the most backward communities in the country. Special measures are, therefore, to be urgently adopted particularly for these two groups of citizens.
- 5. As regards employment, it is an established fact that the largest minority of the country, the Muslims, are very much under-represented in all categories of employment. That their numbers in all these categories are wholly disproportionate to their national-level and State-level populations has been repeatedly pointed out in the reports of various bodies including the Gopal Singh Committee Report of 1983. Concrete measures are, therefore, to be adopted forthwith in this regard.

### III. Proposed Concrete Measures

### Measure 1: Model Law on Communal Violence

- (a) Several drafts of such a law have been prepared in the past. A special committee may be constituted to examine all these drafts and to quickly produce a Bill to be introduced in Parliament.
- (b) All those States which are under the rule of the Congress or its allies should be directed and not only 'encouraged' [as the CMP says] to adopt this model law when ready.

### Measure 2: Minorities Educational Institutions Commission

- (a) Establishing such a Commission *does not require* an amendment of the Constitution. It can be immediately set up by a Notification of the Government.
- (b) The scope of the proposed Commission's work should not be confined to professional institutions and must extend to all educational institutions, of all kinds and levels, established and maintained by the minorities.

### Measure 3: Promotion of technical education among the minorities

- (a) The UPA's concern in this regard is very gratifying. To translate this concern into concrete action special provisions will have to be introduced into the laws and regulations of all the official bodies regulating technical education in the country.
- (b) This matter may also be placed under the proposed Minorities Educational Institutions Commission, referred to under *Measure 2* above.

### Measure 4: National Commission on Minorities Welfare

- (a) This Commission should be constituted by a Government Notification without any delay.
- (b) It should consist only of experts having special knowledge or experience of the social and economic problems of the minorities and must be given all the necessary facilities for its assigned work.

### Measure 5: National Minorities Development and Finance Corporation

- (a) The NMDFC must be placed under a Chairman who is a distinguished expert in minority affairs.
- (b) It must have a Consultative Committee consisting of experts to advise it on its work.

### Measure 6: Status of National Commission for Minorities / Urdu

(a) There is no urgency to confer Constitutional status on the National Minorities Commission. Nor will it make any difference to the working of the Commission. Instead, the Commission's Parliamentary statute of 1992 should be amended to ensure that it is always managed by experts in minority affairs and faithfully carries out its mandate.

(b) The work of ensuring recognition and promotion of Urdu under the relevant provisions of the Constitution may be assigned to a Special Section to be set up for this purpose in the National Council for the Promotion of Urdu Language (NCPUL). This Special Section should be placed under an expert in the subject and must pursue a time-bound schedule to complete its assignment.

### Measure 7: National Integration Council (NIC)

- (a) The proposal for the revival and re-structuring of the NIC is very gratifying. It must be implemented without any delay.
- (b) The NIC must be given a legal framework and should have a restricted membership. Its proposals must be duly implemented by the Government.

### IV. Additional Suggestion

- (a) To oversee the implementation of all the minority-related provisions in the CMP the Government should consider setting up in the PMO a Special Cell under the charge of an Advisor on [or Commissioner for] Minority Affairs.
- (b) This Special Cell in the PMO may also be assigned the work of periodically examining and reporting on the working of all minority-related official bodies including the NCM, NMDFC, Maulana Azad Foundation and Central Wakf Council.

- Shri Arun Bhatnagar, Secretary, Shri Pulok Chatterji, Joint Secretary and 2. Shri Dhiraj Kumar Srivastava, OSD were also present.
- Initiating the discussions, the Chairperson, NAC highlighted the 3. importance of focussing on issues pertaining to the welfare of the poor and vulnerable sections, with particular emphasis on Employment, Agriculture, Education and Health and of time-bound implementation of the National

Common Minimum Programme (NCMP). After a Presentation was made by Shri Sam Pitroda, which outlined the basic parameters, the Chairperson invited the views and suggestions of the Members, including in regard to the subjects on the Agenda.

- All the eleven Members who were present participated in the ensuing 4. deliberations in which attention was, inter alia, drawn to the time-bound commitments reflected in the NCMP, the poor quality of implementation in such critical areas as the Sarva Siksha Abhiyan and the ICDS, the leakages and corruption obtaining in the field, the 'gap' in most States between the achievements being reported and the ground realities, the inefficiencies and weaknesses of the delivery systems, the adequacy (or otherwise) of financial provisions, performance-related releases of funds and the legislations relating to Employment Guarantee and Freedom of Information. In the light of their direct knowledge and experience of field conditions in different parts of the country, several Members raised specific issues in areas ranging from irrigation projects and administrative reforms on the one hand to SC/ST welfare, food security and science and technology on the other. Information was sought in respect of the on-going Irrigation Schemes which is to be obtained from the Planning Commission.
- 5. It seemed clear from Members' observations that monitoring and review mechanisms need to be strengthened and upgraded, all-round, and governance levels substantially improved for the intended benefits to reach the poor and the needy.
- 6. After further discussions, it was agreed, with the approval of the Chairperson, that, to begin with, the Members (mentioned below) be requested to quickly formulate Policy Papers on 10 identified areas, as follows:-

It was also agreed that the Papers would need to be as well-researched as possible and that a few Papers e.g. Employment Guarantee Act could be circulated in advance of the next Meeting of the Council which was scheduled for Saturday, 31<sup>st</sup> July, 2004 at 5 P.M. at 10, Janpath, New Delhi. Such Papers could then be taken up for detailed consideration and discussion in the NAC.
- 8. The Meeting ended with the Members expressing thanks to the Chairperson.

## NATIONAL ADVISORY COUNCIL

Subject:- Minutes of the Meeting of the National Advisory Council (NAC) held on Friday, 30<sup>th</sup> September, 2005 at New Delhi.

The Seventeenth Meeting of the NAC was chaired by Smt. Sonia Gandhi on Friday, 30<sup>th</sup> September, 2005. The following Members of the Council were present:-

- 2. Shri Arun Bhatnagar, Secretary, Shri Pulok Chatterji, Additional Secretary, Smt. Jayanti S. Ravi, Director and Shri Dhiraj Srivastava, OSD were also present.
- 3. The minutes of the Meeting held on 26<sup>th</sup> August, 2005 were confirmed.
- 4. The discussions commenced with a review of the Procedural Guidelines for the conduct of business in the NAC, on which the views of three Members were available on record. It was pointed out that certain "formal processes" were

necessary to ensure transparency in the Council's working, even as other aspects could be left to the "informal processes". It was felt that while it may seldom be practicable to specifically identify networks of peoples' movements and other such organizations and to arrange public debates in different parts of the country, appropriate Consultations could be arranged by the NAC in conjunction with all the Members (or the Members more directly connected with a particular subject) who could advise in regard to the individuals and groups, including experts and professionals, proposed to be invited in this regard. The Ministries and Departments concerned could also be suitably associated in this process.

- 5. It was indicated that the NAC Secretariat should expeditiously deal with the Petitions and Representations relating to the National Common Minimum Programme that are being received from time to time, interact with the Ministries and Departments, as and when required, and invariably apprise the Member(s) concerned in respect of the status of and the Action Taken in a matter as early as possible, including with reference to recommendations forwarded to the Government by the NAC. It was further agreed that the suggestions sent by the Members on the Agenda Items, the Minutes of the Meetings, Presentations to be made to the Council and other issues would be processed, in due time, and the orders of the Chairperson sought in this behalf.
- 6. The following suggestions were also made:-
- (i) Proposals for Agenda Items, if received from Members, would be processed by the NAC Secretariat which could then, with the approval of the Chairperson, circulate a projected Agenda for the next 3-6 months.
- (ii) The NAC Secretariat would continue to keep detailed records of discussions of the NAC meetings which could be viewed by Members or made available to them on demand. Such records would not be placed on the website.

- (iii) The website could continue to display Background Papers and Discussion Papers on NCMP subjects that may be received by the NAC with a clear notation that they do not necessarily reflect the NAC's views. Presentations made to the NAC by various Ministries/Departments would also be placed on the website with the consent of the concerned Ministry. Draft Bills received by the NAC could also be placed on the website with the consent of the administrative Ministry.
- (iv) The NAC Secretariat may obtain updated status reports on the NAC proposals and circulate them to the Members once in a Quarter.
- (v) Important and lengthy Presentations on Agenda Items could be made separately to the Members a day before the Meeting.
- 7 The Ministry of Health and Family Welfare offered a Presentation on the recently launched National Rural Health Mission (NRHM) after which the NAC Members especially highlighted the following:-
  - (i) The architecture of the Mission and its objectives should be more clearly defined, particularly in key areas such as Universal Health Care, Infrastructure Improvements, Risk-pooling Systems and effectively integrated, as also locally accountable, Service Delivery mechanisms,
  - (ii) Time-bound and quantifiable goals and specific Road Maps ought to be quickly determined, alongwith the health infrastructure linkages and provision of adequate financial allocations,
  - (iii) The Mission should strengthen a community-based Public Health System and move towards a National Health Service of acceptable standards with universal coverage.

- 8. In regard to the HIV/AIDS Control Programme, on which a Presentation was made by the National AIDS Control Organization (NACO), the NAC emphasized:-
- (i) Streamlining of data collection and collation and regular random sampling to bring about timely interventions,
- (ii) Development of capacities at the grassroots level (and integration with the Public Health Delivery system) are critical to successful implementation in Mission Mode,
- (iii) It is necessary to reach out to the vulnerable sections, including sexworkers and drug users,
- (iv) A central feature of the HIV/AIDS Control Programme should be the extensive use of condoms towards which a re-strategized. Programme needs to be directed, with sharp focus on the deliverable goals and full coverage of the vulnerable population.
- 9. It was decided that the observations of the NAC in regard to the two Presentations would be forwarded to the Ministry of Health and Family Welfare and NACO respectively and further Reports obtained after some time.
- 10. A brief Presentation entitled "Energy Policy, 2005" was made in the general background of the rising international oil prices; these discussions will continue in the next Meeting of the Council which was scheduled for Saturday, 29<sup>th</sup> October, 2005.
