1. (C) REQUIREMENTS:

- A. DETERMINE EXISTENCE OF ACTIVE AND/OR LATENT ANTI-US ATTITUDES AMONG KEY MEMBERS OF THE BRAZILIAN MILITARY ESTABLISHMENT.
- B. CAUSES FOR SUCH ANTI-US FEELINGS.
- C. IDENTIFY OFFICERS HOLDING SUCH ATTITUDES.

2. (C) GUIDANCE : HQ USSOUTHCOM HAS RECEIVED SEVERAL INDICATIONS OF LATENT AND ACTIVE ANTI-US FEELING WITHIN THE BRAZILIAN ARMED FORCES. IN ONE CASE THE COMUSMILGP REPORTED THAT CSA GEN ORLANDO GEISEL THOUGH OUTWARDLY FRIENDLY WAS INWARDLY "DIFFERENT". ANTI-US ATTITUDE IS NOT CONSISTENT WITH THE DIA BIOGRAPHY ON GEN GEISEL. CLARIFICATION OF GEN GEISEL'S ATTITUDE IS PARTICULARLY DESIRED. RECENT IAGS CORRESPONDENCE STATES ADM OSWALDO LINS, PRESIDENT OF MIXED CARTO COMMISSION, HAS TAKEN A STRONG STAND FOR REPOSSESSION OF ALL ORIGINAL MAPPING FILM PREVIOUSLY FLOWN BY US. THIS IS CONTRARY TO EXISTING CART AGREEMENT T AND SUCH ACTION WOULD BE UNACCEPTABLE TO US. REQUEST REPLY INCLUDE INFO ADDRESSEES THIS MSG. GP-3
