- (C) A law for early forceable retirement of some senior generals is about to be presented to Congress. This law will affect a number of senior officers including Generals Amaury KRUEL, CG, II Army; Joaquim Justino Alves BOSTOS, CG, III Army; Octacilio Terra URURAHY, CG, I Army and Hugo Panasco ALVIM, Chief of the Department of Production and Works.
- (C) An effort is being made to amend this law to take effect only in 1967. However, according to Source, the officers of the "revolutionary group" insist that it be applied immediately upon passage, thus forcing "untrustworthy" officers to lose their influence in the Armed Forces.
