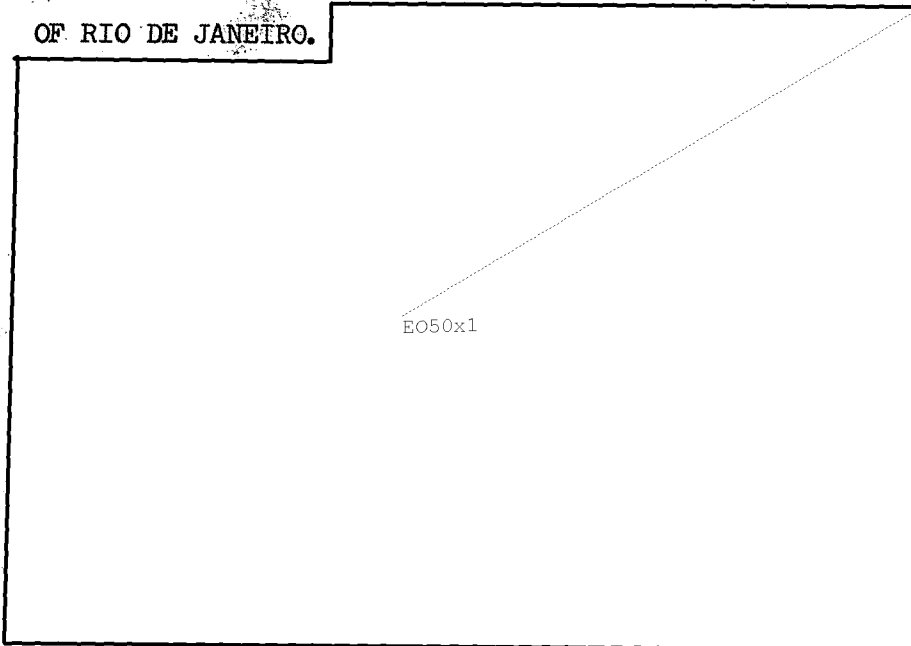

A. STATE DEPUTY NICANOR ABREU COMPANARIO: MDB, SECRETARY OF ASSEMBLY, LEADER OF ~~MOOR~~ MDB RADICAL WING. MEDICAL DOCTOR. WAS MEMBER OF FORMER LIBERATOR PARTY. SUPPORTED QUADROS AND VARGAS. ATTENDED 1961 RALLY IN NITEROI COMMEMORATING PCB ANNIVERSARY CHAIRED BY ~~PRESTES~~ PRESTES. GOVERNOR'S OFFICE CHARGED HE INVOLVED IN FRAUDULENT PURCHASE OF VEHICLES FOR STATE ASSEMBLY AND IN FOREIGN JUNKETS BY DEPUTIES.

B. ARY SCHIAVO: FORMER MDB MAYOR OF NOVA IGUAÇU IMPEACHED BY CITY COUNCIL IN 1967 ON CHARGES OF CORRUPTION AND MISUSE OF FUNDS. HE CLAIMED HE WAS REMOVED ON POLITICAL GROUNDS AS RESULT OF DIRECT MILITARY PRESSURE AND HAD BEEN CONDUCTING SUIT FOR REINSTATEMENT.

C. JOSE BARBOSA PORTO: FORMER MAYOR OF MAGE. REMOVED IN 1966 THROUGH FEDERAL INTERVENTION. ALLEGEDLY GUILTY OF CORRUPTION.

D. DORLY DIAS CURVELO: CITY COUNCIL MEMBER, SAO JOAO DE MERITI. GOVERNOR'S OFFICE SAID HE LINKED TO

NOTHING. NOW SUSPECTS HE WAS PUNISHED BECAUSE OF PAST

4. COMMENT: THAT SO MANY STATE OF RIO RESIDENTS, MOST
OF WHOM ARE VIRTUALLY UNKNOWN, APPEARED ON FEDERAL
CASSATION LIST MAY BE EXPLAINED IN PART BY RELATIVELY
HEAVY CONCENTRATION OF MILITARY UNITS IN STATE AND
TRADITIONAL INTEREST AND ROLE OF MILITARY IN STATE'S
LOCAL AFFAIRS.
