ON 28 JUL SAW ARMY G-2 COL NEWTON FARIA FERREIRA IN HIS OFFICE AT
HIS REQUEST. DURING CONVERSATION HE EXPRESSED FOLLOWING VIEWS:
1. BRAZ ARMY CONCERNED ABOUT SECURITY OF BRAZILIAN PERSONNEL
ASSIGNED TO BANK FOR INTERNATIONAL DEVELOPMENT. BRAZILIANS HAD
REASON TO BELIEVE NUMBER OF THEM PLANTED IN BANK BY CLEANTHO DE
PAIVA UNDER JOAO GOULART. BRAZILIANS WERE FOLLOWING SEVERAL LINES
IN WASHINGTON AND IF HE GOT ANY DEFINITE NAMES HE WOULD PASS THEM
TO ME.
2. COL NEWTON BELIEVED COSTA E SILVA WOULD BE BRAZIL'S NEXT
PRESIDENT AND FELT FOLLOWING APPOINTMENTS MIGHT BE MADE BY COSTA E
SILVA: GEN JAYME PORTELLA DE MELLO, HEAD OF MIL HOUSEHOLD OR HEAD
OF NATIONAL INTELLIGENCE SERV.; PIO CORREIA AS FOREIGN MINISTER;
GEN RODRIGO OTAVIO JORDAO RAMOS AS MINISTER OF TRANSPORTATION &
PUBLIC WORKS. HE ALSO FELT GEN RAMIRO TAVARES GONCALVES AND GEN
AFFONSO ALBUQUERQUE LIMA WOULD GET KEY JOBS. HE FOUND LATTER AS
SOMWHAT HARDLINE BUT INTELLIGENT AND HIGH-MINDED. SAID COL MARIO
ANDREAZZA HAD TOLD HIM HE EXPECTED TO GET COMMAND OF PRESIDENTIAL
GUARDS BN IN BRASILIA. ALSO FELT HELIO BELTRAO MIGHT GET P

ANNING

MINISTRY AS HE DID NOT FEEL ROBERTO CAMPOS WOULD BE KEPT ON BY
COSTA E SILVA.

3. SAID THEY HAD NO REAL CLUES ON RECIFE BOMBING. THEY HAD ARRESTED
NUMBER OF SUSPECTED EXTREMISTS AND HOPED SOMEONE WOULD TALK.
FELT ATTEMPT MAY HAVE BEEN CARRIED OUT BY BRAZILIAN BUT OUDER FOR IT
CAME FROM NON-BRAZILIAN. CITED VENEZUELAN TERRORIST PATTERN. FELT
ATTEMPT HAD HURT LEFTISTS IN THAT IT TOOK PUBLIC ATTENTION OF RIO
