SUBJ: 12TH MFM ON CUBAN SUBVERSION

REF: STATE CIRCULAR 202931

1. REPLIES TO REF CIRCULAR INDICATED LITTLE LIKELIHOOD OTHER GOVERNMENTS WOULD BE ABLE TO PREPARE DOCUMENTED CASES ON CUBAN SUBVERSION TO BE PRESENTED ALONG WITH VENEZUELAN CASE, NOR WOULD BE WILLING RECEIVE VISIT BY INVESTIGATING COMMITTEE. LATTER NOW CONFINED, WITH STRONG SUPPORT OF COLOMBIA, GUATEMALA AND BOLIVIA, TO LOOKING INTO EVENTS IN VENEZUELA (STATE CIRCULAR 212718).

POSSIBILITY STILL REMAINS THAT CERTAIN GOVERNMENTS WHO HAVE BEEN PARTICULAR TARGETS CUBAN SUBVERSION MIGHT BE WILLING SUBMIT DIRECTLY TO MFM (NOT TO COMMITTEE) SUCH STATEMENTS AS THEY BELIEVE APPROPRIATE ON CUBAN SUPPORT FOR SUBVERSION IN THEIR COUNTRIES, INCLUDING TRAINING, PROPAGANDA, HAVANA BROADCASTS, ETC. IN OUR VIEW SUCH STATEMENTS WOULD BE USEFUL ADDITION AND WOULD BE APPROPRIATE TO BROADER CONSIDERATION BY MFM OF SITUATION ARISING FROM CUBAN SUBVERSION IN "VARIOUS STATES" WITHIN CONTEXT OF MFM AGENDA.

3. REQUEST IN YOUR DISCRETION YOU DISCUSS THIS POSSIBILITY INFORMALLY WITH FOREIGN MINISTRY AND REPORT REACTION.

4. FOR SANTO DOMINGO: ALLEN RAISED WITH OAS REP DEL ROSARIO POSSIBILITY DR PRESENTING REPORT BASED ON DE LA ROSA DOCUMENTS. DEL ROSARIO PROMISED SEEK INSTRUCTIONS. SUGGEST EMBASSY FOLLOW-UP WITH FONOFF.
