SECRETARY GENERAL FONMINISTRY TOLD ME TODAY THAT MFM NOW PROBABLY WOULD BE HELD LATTER PART SEPTEMBER. WHEN I ASKED WHAT HAD HAPPENED TO AUGUST HE SAID UNABLE OBTAIN CONSENSUS AMONG MINISTERS TO MEET ANY TIME THIS MONTH. HAD BEEN SOME CONSIDERATION TO HOLDING MEETING MID-SEPTEMBER BUT NOW GENERAL CONSENSUS IS HE BELIEVED THAT MEETING IN WASHINGTON WILL FOLLOW OPENING STATEMENTS BY FONMINISTERS AT UNGA PROBABLY LATE SEPTEMBER OR EARLY OCTOBER. FROM PERU'S STANDPOINT HE SAID THIS PREFERABLE BECAUSE OF LIMITED BUDGET FONMINISTRY AND FINANCIAL SAVING RESULTING FROM ONLY ONE TRIP TO COVER BOTH UN A OAS MEETINGS AT MINISTERIAL LEVEL.

SECRETARY GENERAL FONMINISTRY TOLD ME TODAY THAT MFM NOW PROBABLY WOULD BE HELD LATTER PART SEPTEMBER.
