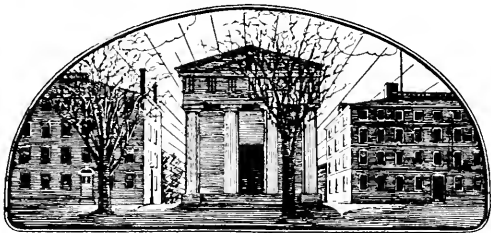

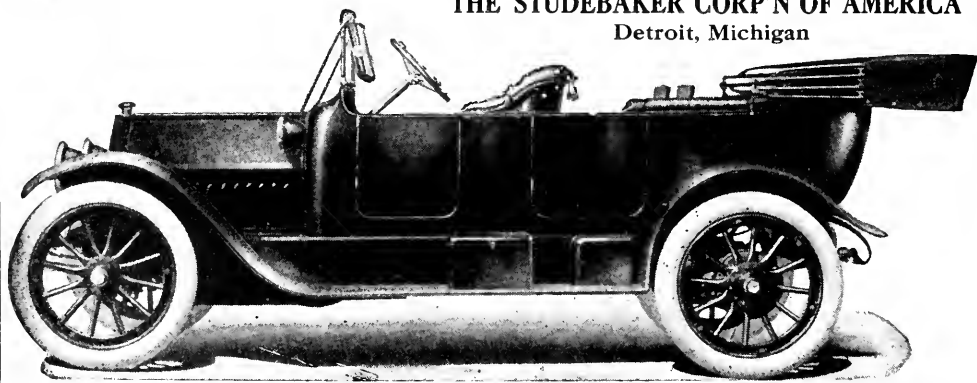

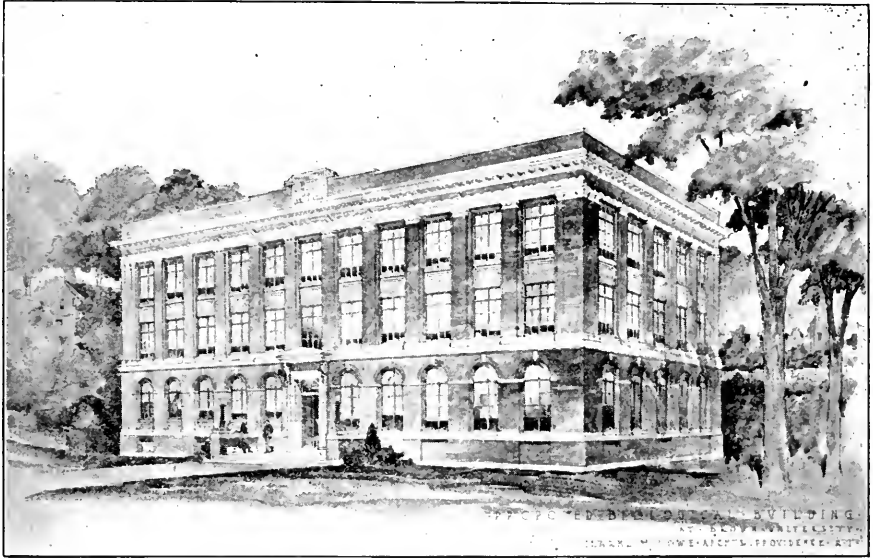

THE ARNOLD LABORATORY

THE NEW BIOLOGICAL LABORATORY

Ground has been broken for the Arnold Biological Laboratory. One house on Waterman street, the old refectory, has been pulled down. Two other wooden houses will be moved over to Manning street, one on the north side next to the Psi Upsilon chapter house, and the other on the south side. The new laboratory will be set fifty feet from Waterman street, so as to avoid the noise and jar of the street cars, and to avoid also the heavy shade of the great elms. The building will of course attempt nothing monumental like the John Hay Library, but will be simply serviceable and afford the finest opportunity for scientific investigation, both by individuals and by large classes.

There is something fascinating in the thought of Dr. Arnold's life, so retired

and obscure, thus blossoming into scientific investigation of the causes of health and disease and the processes by which all living things grow and multiply. When we think of him as a country doctor—his practice was chiefly in the rural regions around Providence—driving from patient to patient in his modest buggy; when we think of him fired with really scientific enthusiasm, dropping his practice here at home and putting himself under the very best medical instruction for two years in London, Vienna, Paris and Glasgow in the years 1883-85, (while Mrs. Arnold was studying Assyrian and several other Semitic tongues with German professors); when we think of him returning to Providence with knowledge which perhaps no other Providence physician at that time pos-

sessed, (and none suspected him of possessing it); when we think of him as forming the purpose, without suggestion from any human being, to give a laboratory to Brown, his Alma Mater—all this is the theme for a poem or a novel.

The Biological Department is, as usual, doing fine summer work. Professor Herbert E. Walter has gone to Cold Spring Harbor as Assistant Director of the Government laboratory there and as

Director in full charge for part of the summer, during the absence of the Director, Dr. Davenport, in Australia and New Zealand. Professor P. H. Mitchell has been appointed Director of the laboratory at Woods Hole under the United States Fisheries Commission. With each of these professors have gone a number of Brown Seniors and Graduate students for summer work.

 And His Truth can never die'.

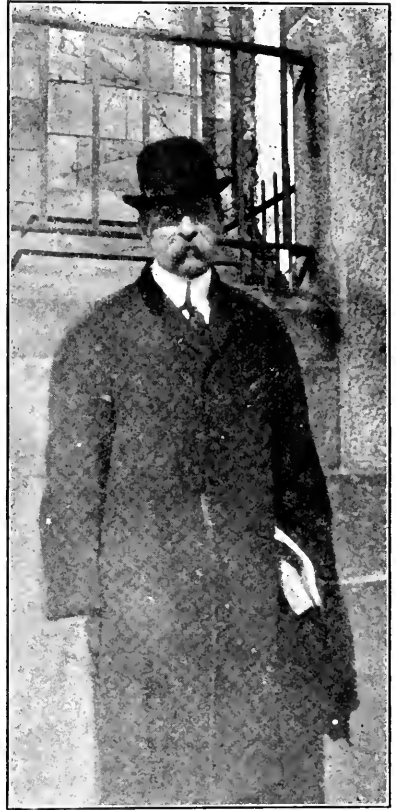

A CENTURY OF COLLEGE SERVICE

Davis, 40 years—Harkness, 25 years—Hill, 20 years—Faunce, 15 years

Just one hundred years of service have been rendered to Brown University by the professors whose names stand at the head of this article, the longest period beginning in 1874, the shortest in 1899. We are grateful for the excuse furnished by the close of a five year period for calling attention to the lives and work of these makers of the modern Brown.

Nathaniel French Davis was born in Laconia, N. H., June 11, 1847, the son of John and Rhoda French (Maxfield) Davis. He was fitted for college at the Williston Seminary, Easthampton, Mass. He received the degree of A. B. from Brown in 1870 and that of A. M. in

1873. He is a member of Phi Beta Kappa, Sigma Xi, and Delta Phi. He was connected with the engineering department of the Providence Water Works, 1870-71. For the following two years he was an instructor in River-view Military Academy, Poughkeepsie, N. Y., and during the following year he was vice-principal and professor of Mathematics and Physics in the Keystone State Normal School, Kutztown, Penn. In 1874 he was called back to the University as instructor in Mathematics; in 1879 he was made assistant professor, in 1889, associate professor, and, in 1890, professor of Pure Mathematics.

He is a member of the American Mathematical Society, the Association of Mathematical Teachers in New England, and the New England Association of Colleges and Preparatory Schools, and a fellow of the American Association for the Advancement of Science. He was for eleven years secretary of the New England College Entrance Certificate Board. Upon his resignation of his secretaryship in 1913, he was elected to the presidency, which office he now holds. He has been president of the Rhode Island Alpha of Phi Beta Kappa and of the Brown Chapter of Sigma Xi, of the Barnard Club, and of the Rhode Island Congregational Club. He was in 1898-99 a member of a committee appointed to investigate the public school system of the city of Providence. In 1892-93 he was abroad and studied at the University of Goettingen. In 1894 he received the degree of LL.D. from Colby. He married, Dec. 23, 1878, Lydia Martin Bellows of Providence. Their son, Harvey Nathaniel Davis, '01, is assistant professor of Physics at Harvard. Professor Davis has not only been a great teacher of mathematics and an able head of his department, but he has served the University in administrative ways to an extent hardly realized except by his colleagues and with a value to the institution that is simply beyond estimate.

Albert Granger Harkness was born in Providence Nov. 19, 1857, the son of Professor Albert and Maria Aldrich (Smith) Harkness. He was fitted for college at the University Grammar School and was graduated from Brown in 1879, receiving the degree of A. M. in 1882. After graduation he taught Classics in Peddie Institute, Hightstown, N. J., for two years, and then went to Germany for two years. He was professor of Latin and German in Madison, now Colgate University, Hamilton, N. Y., 1883-89. In the latter year he was called to Brown as associate professor of Latin, and in 1893 he was made profes-

sor of Roman Literature and History. In 1894-95 he spent a year in Europe, and in 1902-03 he was annual director of the American School of Classical Studies at Rome. He is a member of the American Philological Association and the Archaeological Institute of America. He has published various papers in the Transactions of the American Philological Association and in philological journals, and assisted in the revision of the Harkness series of Latin text-books. He is a member of Phi Beta Kappa and of Alpha Delta Phi. He received the degree of Litt. D. in 1909 from Colgate University. He married, Sept. 3, 1884, Katharine Margaret Beebe of Hamilton, N. Y. They have one son, Albert Harkness, 2nd, '09.

John Edward Hill was born in New York City, Nov. 9, 1864, the son of Edward and Harriet (Smith) Hill. His uncle, Thomas Hill, was President of Harvard. He received from Rutgers College the degree of Sc. B. in 1884, Sc. M. in 1887, C. E. in 1892 and Sc. D. in 1905, also that of M. C. E. from Cornell in 1895. From 1884 to 1890 he was engaged in the practical work of his profession with the definite purpose of preparing himself for teaching. He was an instructor in Civil Engineering at Cornell, 1890-94, and in the latter year was called to Brown to take up a similar position. The next year he was made associate professor and in 1898 full professor. He is a fellow of the American Association for the Advancement of Science, and a member of the American Society of Civil Engineers, the New England Water Works Association, and the Phi Beta Kappa and Sigma Xi societies. He was the Counsellor of the Brown Chapter of Sigma Xi, 1900-1905. He is the author of a text-book on *Shades, Shadows, and Perspective*, 1894. He married, Dec. 19, 1894, Jessie Louise Gould of Newark, N. J. They have four daughters.

We are reminded of the swift flight of time by the fact that, though President

Faunce came here after he had won a national reputation, he has already spent half of his professional career up to date as president of Brown University, 1899 being just halfway between 1884 and 1914.

William Herbert Perry Faunce was born in Worcester, Mass., Jan. 15, 1859, the son of Rev. Daniel Worcester Faunce and Mary Parkhurst (Perry) Faunce. He was fitted for college in the high schools of Concord, N. H., and Lynn, Mass. He was graduated from Brown in 1880. He is a member of Phi Beta Kappa and Delta Upsilon. A year later he returned as instructor in Mathematics, 1881-82. He then entered the Newton Theological Institution, from which he was graduated in 1884. In the same year he was ordained to the Baptist ministry and be-

came pastor of the State Street Baptist Church, Springfield, Mass., where he remained until 1889. During the next ten years he was pastor of the Fifth Avenue Baptist Church, New York City. He was a student at the University of Jena in 1895. He was resident preacher at Harvard, 1898-99. In 1899 he became president of Brown University. He was lecturer at the University of Chicago, 1897-98; Lyman Beecher lecturer at Yale, 1908; president of the department of higher education, National Educational Association, 1903-04; and president of the Religious Education Association, 1906-07. He spent the year 1912-13 in a journey around the world. He is a director of the American Institute of Sacred Literature, and a member of the Rhode Island Metropol-

itan Park Commission. He was for nine years a trustee of Rochester University and for five years a member of the executive board of the American Baptist Home Mission Society. He is a trustee of Newton Theological Institution, Worcester Academy, and the Rhode Island School of Design. He is author of *The Moral Factor in Education*, 1901; *Roger Williams and his Doctrine of Soul Liberty*, 1902; *The Educational Ideal in the Ministry*, 1908; *What Does Chris-*

tianity Mean? 1912; *Social Aspects of Foreign Missions*, 1914. He received the degree of A. M. from Brown in 1883; of D. D. from Brown in 1897, from Yale in 1901, and from Harvard in 1904; of LL. D. from Baylor in 1904, from Alabama in 1905, and from Dartmouth and Wesleyan in 1909. He married, June 18, 1884, Sarah Rogers Edson. They have one son, Perry Edson Faunce.

COMMENCEMENT ONE HUNDRED YEARS AGO

[Commencement in 1814 occurred on September 7, at a time when the country was still at war with Great Britain. The whole coast was blockaded. The battle of Lundy's Lane had been fought in July, Stonington had been bombarded by the British in August, and the Capitol at Washington had been burned by the invaders two weeks before Commencement. Four days later Macdonough was to win his famous battle on Lake Champlain, and six days later the British were to bombard Fort McHenry, at Baltimore, and Key was to write the Star Spangled Banner on the occasion. The class of 1814 numbered 47 men, of whom the longest lived was Joseph Joslen, who died in 1888 in his ninety-sixth year. He became President of the Rhode Island People's Constitutional Convention and was chosen State Treasurer under that constitution. He was also postmaster at Newport and was a newspaper editor in Providence and later in Newport. The first name to disappear from the roll was that of John Jay Sibley, who died six months after graduation. Five members of the class earned a place in the biographical dictionaries: Richard James Arnold, a merchant and cotton planter, who was a trustee of the University for 47 years; William Richmond, an Episcopal clergyman in New York City; Thomas Baldwin Ripley, a Baptist clergyman; Charles Foster Tillinghast, a Provi-

dence lawyer and member of the Rhode Island Constitutional Convention of 1843; George Hopkins Tillinghast, a Providence physician; and Shearjashub Bourne Townsend, who was a tutor at the University one year and afterwards became a Congregational clergyman. The following account of the exercises is taken from the Rhode Island American for September 9, 1814.]

COMMENCEMENT DAY

The 146th Commencement exercises of Brown University were held Wednesday, June 17. Degrees were awarded to 197 persons — 188 in course and 9 honorary.

President Faunce presented the diplomas to the graduates as they filed across the platform at the church amid much applause from the audience which filled the edifice.

The degree of Bachelor of Science in Civil Engineering was conferred by the university upon Edward A. Burlingame, Superintendent of Grounds and Buildings at Brown. Mr. Burlingame was formerly a student in Cornell University, but was compelled by illness to leave before completing all the work for his degree.

The customary procession from the college campus to the meeting house was held previous to the exercises. The program began with a musical selection followed by prayer.

Three orations were next delivered. Raymond Abner Preston of Danielson, Conn., spoke upon "The Unconventional Drama." Arthur William Cate of this city discussed "The Power of Suggestion in Teaching" and James Joseph McGovern of this city spoke upon "The Treaty Power of the United States." More music followed and then came the conferring of degrees in course, an-

nouncement of prizes and awarding of the honorary degrees. Benediction concluded the services in the church.

The parade as usual was under the direction of Major Henry V. A. Joslin and his corps of assistants. There are now 60 of these assistants.

The exercises at Sayles Hall in the afternoon were presided over by Rev. Thomas D. Anderson, D. D., '74. The speakers were Lieutenant Governor Burchard, President Faunce, President-emeritus Eliot of Harvard and Dr. Vernon P. Squires, '89, Dean of the University of North Dakota. There was the usual large attendance. Afterward the alumni in large numbers went to Andrews Field, where the gaily-attired reunion classes went through their "stunts" and the alumni nine defeated the "Varsity, 5 to 2.

On Thursday the Corporation held its regular meeting and transacted routine business. William V. Kellen was elected a member of the Board of Fellows to succeed John H. Stiness, deceased.

A report was received from the special committee on the inquiry from the alumni regarding the present condition of charter revision. The matter was referred to the original committee on the revision of the charter with instructions to report some final recommendation to the Corporation.

Three members of 1917 have been elected to associate editorship on the Herald board. They are Barney David Feinberg of Lake Placid, New York;

Edward Thomas Williams of New York City, and Clarence Henry Woodmansee of Providence. The elections were on the basis of points alone.

150TH ANNIVERSARY OF THE FOUNDING OF BROWN UNIVERSITY

October 11-15, 1914

The coming Celebration at Brown University marks the achievement of 150 years of ever widening influence in our comparatively young country. As a seat of learning, however, we have a great age in this land, being the sixth college in order of foundation, and our liberal charter, breadth of administration, honor roll of teachers and graduates, splendid and growing equipment, make the University an important one in educational life. What the Celebration is to be and how it is to draw the interest of our alumni is the purpose of this brief article.

The programme covers a series of events beginning on Sunday, Oct. 11th, with the University Sermon delivered by President Faunce in the historical Baptist Meeting House, and lasts through Thursday, Oct. 15th, the University Dinner to delegates and other guests at Churchill House closing the formal Programme. These several days are to be filled with a succession of activities appealing to varying interests of different graduates.

As all our undergraduate activities are grouped around the academic life of the University, so the Programme of the Celebration has been built around its academic features. Officially, the Celebration is an academic gathering to observe the completion of 150 years of academic history and achievement. The first formal academic occasion is on the morning of Wednesday, Oct. 14th, when occurs at the Meeting House the reception of delegates appointed by fellow institutions of learning situated in this country and abroad to represent them at our Celebration. After the formal reception there will be delivered the

Historical Address by the Hon. Charles E. Hughes, '81, Associate Justice of the Supreme Court of the United States, than whom there is none better known or more esteemed among the sons of Brown. On the following day (Thursday) occurs another session at the Meeting House, when the University Address will be delivered by Principal and Vice-Chancellor William Peterson of McGill University. While Justice Hughes will treat of the University from the point of view of an alumnus and a public man, Principal Peterson will approach the subject from the point of view of one who is among the prominent educators of the British Empire. Brown University is indeed most fortunate in contemplating him as its guest and orator on this occasion. The session will close with the conferring of degrees upon distinguished persons whose achievements mark them as worthy of being enrolled at this time among the sons of Alma Mater. Each of the formal academic occasions will be preceded by the usual procession from the front campus at which it is expected that academic costume will be worn.

These two days of formal academic exercises (Wednesday and Thursday) have other features appropriate to them. Upon returning to the campus on Wednesday occurs the University Luncheon at Rockefeller Hall and the Lyman Gymnasium, given to delegates, corporation, faculty and invited guests. Alumni who wish to attend should make application for tickets. On the same afternoon is to occur the University Reception at Sayles Hall. The same evening will be held at Infantry Hall the Concert by the Mendelssohn Club of New York, the most famous

men's choral association in the country, who will be guests of the University. This musical feature will be pleasing to many of our visitors, and obviously tickets will be given out following application.

Following the University Address on Thursday, the Women's College is to be the host at a Luncheon at Sayles Gymnasium given to the delegates and invited guests. That same evening the exercises of the Celebration will be concluded by the University Dinner at Churchill House, which will be the most formal social feature of the anniversary days.

While participation in these features—academic and social—will be of interest to the alumni, it is to certain other features of our Programme that attention may be properly directed.

Tuesday, the 13th, is looked upon as the real gathering day of the alumni. A definite time for Class Reunions is desirable, and is assigned for that afternoon, beginning with luncheons at hotel and club; various Class Secretaries are endeavoring to promote reunions at that time. In the afternoon at five o'clock will occur the Glee Clubs Reunion Concert on the terrace of Rockefeller Hall, to which every member of Clubs since 1885 has received a special invitation. Old college songs and popular glees will be rendered which cannot fail to stir the hearts of all graduates and rekindle memories of undergraduate life. That same evening at nine o'clock occurs the Torchlight Procession which is intended to be the most largely attended event of the Celebration.

At anniversaries of this sort, one event, at least, should have the participation of every undergraduate and every alumnus present. Considering various suggestions, the Committee in charge has chosen the Torchlight Procession as offering splendid opportunities for making an effective appearance and awaking the enthusiasm of all visitors. The Procession is intended to be of an orderly sort,

the various classes of undergraduates and sections of alumni marching in costumes especially designed for the occasion, each representing the attire or uniform of colonial wars or period. These costumes will be furnished to the alumni at a moderate price, particular information to be furnished at a later date. Beside the student body who will all participate, and a very large number of the alumni which we expect will attend, the National Guard of Rhode Island will be invited to attend in a body, also several of the uniformed independent military companies of the state, most of whose charters antedate that of any Rhode Island college. The procession thus planned will be suitably reviewed en route, and terminate its march on the Campus, where an illumination will be held followed by as large a Freshman bon-fire as the enthusiasm of the incoming class and the caution of the authorities will permit.

Dramatics have always been a favorite form of expression in undergraduate life, and this fall at Brown we are fortunate in having a play which will have a special appropriateness. The theatre is a comparatively new institution in America, the Colonies showing it little favor down to the time of the Revolution. Shortly before the founding of the College, a band of players, encouraged by their reception in Newport, ventured to Providence, and there gave plays in a small structure on Meeting street above Benefit street almost in the shadow of the old Court House where the Assembly was accustomed to meet. "The Provoked Husband," from the best information attainable, was one of the plays performed, as it soon transpired, to the great disturbance of many "godly" people in Providence. The tradition is that John Brown, most famous of the four brothers, whose nephew, Nicholas Brown, gave his name to the University, ventured to plant a cannon in front of the improvised theatre to keep off a possible mob of people who threatened to interfere. However, while the plays were

being performed, the General Assembly was heeding the voice of the disturbed people, and at the close of one performance the Sheriff asserted his authority to prohibit their continuance. "The Provoked Husband" will have three performances at the Opera House—on the evening of Monday and the afternoons of Tuesday and Wednesday. It will be reproduced by students and younger alumni under the direction of Prof. Thomas Crosby of the English Department, assisted by Mr. Henry A. Barker, '93, whose talents need no introduction to Brown men. With the play itself will be included a representation of scenes accompanying the early performance in Providence, including the old Court House near by, the good people of Providence, John Brown and his cannon, and the Sheriff of Providence, well known to every Brown man at graduation, as he attends the Commencement Exercises to keep order among the assembled crowd.

Chartered by the Assembly of the State, and always sympathetic with every thing that pertains to the welfare of State and city, the University owes much to the co-operation of the community, and takes pride in its place as acknowledged head of its system of education. It has seemed desirable in some way to effect the participation of a large group of school children in this 150th Celebration, many of whom will in time pass through the College halls as undergraduates and all of whose parents cannot but fail to be impressed by their taking part. Accordingly in the afternoon of Thursday, the 15th, the exercises at Andrews Field will include appropriate features, such as pageantry by grammar school children and relay races by pupils of the high schools. Later there will be intercollegiate relay races, and, as a closing event, a football game between Brown and Wesleyan. Every alumnus returning in the fall contemplates taking in a football game, and Wesleyan usually proves a good opponent. During all these various events at Andrews Field the Boy

Scouts will be used for patrol duty.

The exercises on Monday will be in commemoration of the religious history of the University. Our College achieved its beginnings through the endeavors of one denomination, and has been fostered by representatives of four denominations who act as the Corporation of the University. Then, too, through seventy-five years of its history graduates of the institution largely devoted themselves to the ministerial profession. The exercises on this day will have the participation of leading representatives of the four denominations referred to, all of the speakers being of national reputation in their respective churches.

On Tuesday will be held exercises at Warren at the church with which Brown University was associated during its earliest years and of which its first President was minister. The historical address on this occasion will be delivered by Dr. W. W. Keen of Philadelphia, a Fellow of the Corporation. At Warren also will be given a Pageant in honor of the anniversary of the University which many visitors will wish to attend.

Most of what has been said here is but an amplification of the Programme as printed. It remains to say something of our guests. The President of the United States has indicated a hope of attending, and his presence, if assured, will be on Thursday, the 15th. The Governor and General Assembly have been invited, and in response have accepted, congratulating the University on the achievement of 150 years of history. All the recognized Universities of the world have been invited to send delegates and the more prominent ones of this country are accepting as well as certain institutions in foreign countries. Many distinguished persons in public, professional, diplomatic and administrative life have been invited. These distinguished delegates and guests are to be entertained at the homes of alumni and friends of the University. Among ac-

ceptances are to be noted those of ex-President Taft, Mr. Andrew Carnegie, the Presidents of Columbia, Yale, Princeton and other leading Universities, Robert Cooper Smith, Esq., K. C., a leading member of the Canadian bar, Senor Romulo S. Naon, Minister for Argentina, Professor James Seth, formerly Professor in Brown University and delegate from the University of Edinburgh, and, lastly, I would name E. Benjamin Andrews, who hopes to be able to attend. Every alumnus would wish to greet "Benny," if he can be present.

After describing the Celebration as planned, I wish to say a few words about the attendance of alumni. We are hoping that hundreds of alumni will arrange to come back to the old College, and are making our plans to welcome them and secure accommodations while they are in Providence. We wish all to be a part of this Celebration when we shall welcome delegates from sister universities and distinguished guests; for this is the Sesquicentennial Birthday of the College, at which the alumni are to be the hosts. We have not only urged their attendance by formal invitation, which was

sent out weeks ago, but have appointed a special committee on the Participation of Alumni of which Mr. Archibald C. Matteson, '93, is Chairman. This Committee is planning to urge all alumni to attend, and will see that they secure accommodations at a reasonable price while they are in attendance. Manifestly our hotels are painfully inadequate to accommodate all who will wish to attend. The alumni must inform this Committee whether or not they wish accommodations and on what days. Accurate information as to intention of the alumni will assist the various committees in charge, and will greatly convenience the returning graduate himself, who will arrive to find all arrangements made for him.

Lastly, on June 1st each alumnus was sent a notice requesting information as to particular events in which he would wish to participate. Everyone should indicate his intention on the blanks furnished; but if these blanks have been laid aside by any interested alumnus, further correspondence with the Chairman of the Alumni Committee will supply any information necessary.

COMMENCEMENT ANECDOTES

In his remarks at Sayles Hall on Commencement afternoon, President Faunce told of a ponderous lecturer at Shanghai who, in addressing a Chinese audience, made some such statement as this: "There are two methods of searching for truth—one demands the absolute truth and the other is satisfied with the relative." This was too much for the interpreter, who, after a momentary hesitation, said: "The gentleman says he is very glad to be here to-night."

Dr. Faunce also told of a sign he saw in Tokio: "Fresh milk, food from the cow, each day, by hygienics."

Lieutenant Governor Burchard had a story about a youth who took his law examinations after having crammed, on

the advice of his friends, on the statutes, to the neglect of the common law. The result was that the boy failed miserably when the examination centred wholly on the latter. "Please try me on the statutes," he begged. One of the examiners said to him dryly: "The legislature may meet and repeal all you know."

Another of Governor Burchard's stories was about a lazy boy who found employment in a logging camp. He was put at work on one end of a long saw, but "sojered" there, so that the man at the other end finally exclaimed: "Say, sonny, I haven't any objection to your riding on this saw, but will you please keep your feet off the ground?"

CHARTER CHANGE

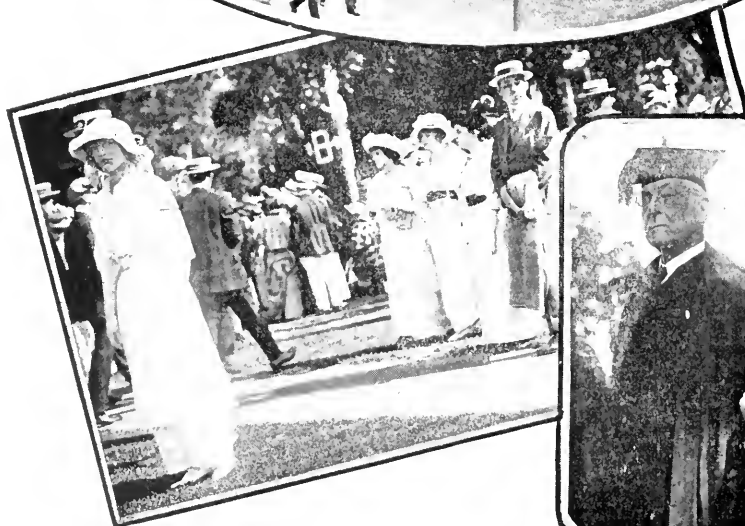
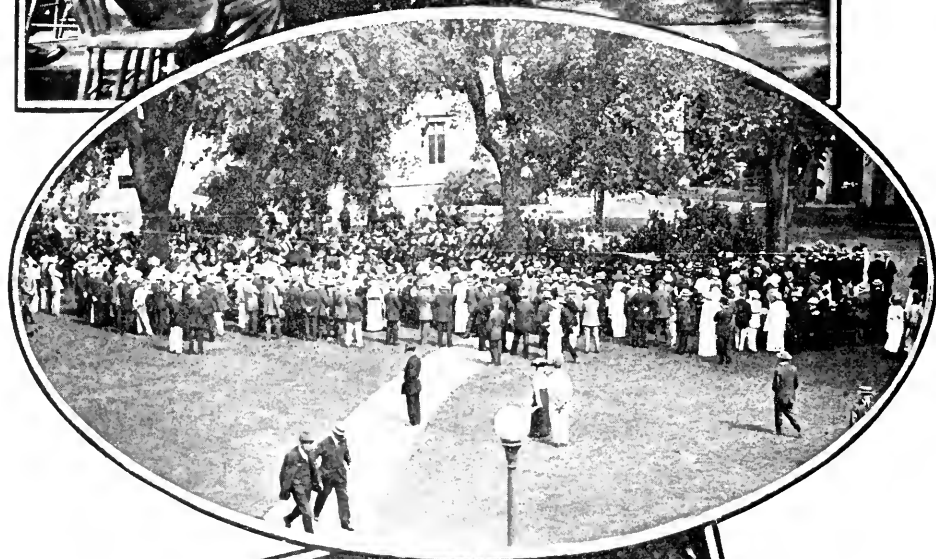
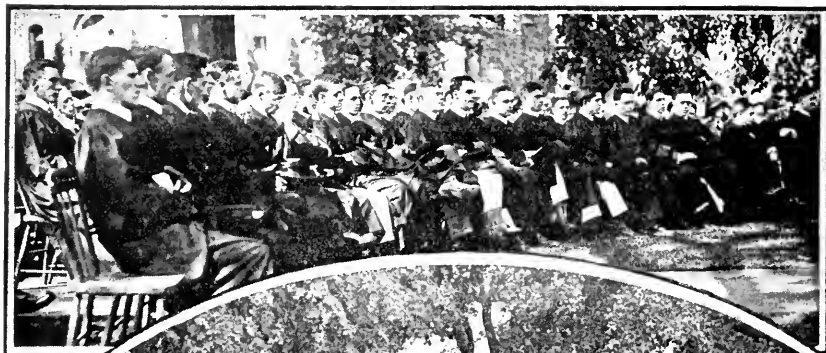
The action of the Corporation, at its meeting on the day after Commencement, in requesting from the special committee on charter revision a final statement as to the status of the committee's inquiry is a matter of profound interest to every graduate of Brown. The question has been in abeyance for the last two or three years, but it cannot remain so indefinitely. The sentiment of the alumni body is unmistakable; a poll under the auspices of this magazine showed more than 2000 against the present system of sectarian control and only 200 in favor of it. It is obvious that the graduates of Brown are dissatisfied with the existing arrangement.

It is desirable that whatever is done shall be by common consent. A prolonged debate, with its inevitable heat and friction, would be unfortunate, yet the prosperity of Brown is bound to be affected by the continuance of any plan of government with which the overwhelming majority of its graduates are out of sympathy.

popularity among students and alumni so that, with increased support, it will be possible to put it on a sound business basis and continue the publication of a periodical worthy of the college.

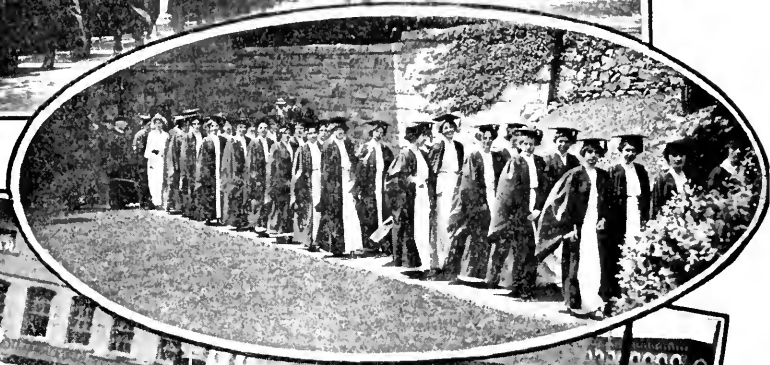
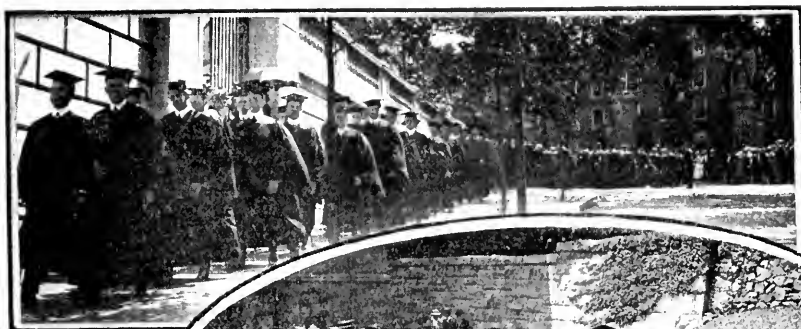

RECIPIENTS OF HONORARY DEGREES

Brown University conferred the following honorary degrees on Commencement Day:

RICHARD BORDEN COMSTOCK, A. M.

Richard Borden Comstock was born in Jersey City, N. J., Feb. 15, 1854. He prepared for college at Mowry & Goff's English and Classical School, Providence, and graduated from Brown University in 1876. After graduating from Brown he took up the study of law and was admitted to the bar of the Supreme Court of Rhode Island in 1878, and to that of the United States Circuit Court two years later. He began practice in partnership with Elisha C. Mowry, and later was associated with Rathbone Gardner in a new firm. This, too, dissolved, and he then went into partnership with John E. Canning in 1905. He has specialized in corporation law and is looked upon as an authority upon it.

MRS. GUSTAV RADEKE, A. M.

Mrs. Gustav Radeke (Miss Eliza G. Metcalf) was graduated from Vassar College in 1876. She has served as a trustee of the Rhode Island School of Design for 25 years, and at the present time is President of the corporation. Mrs. Radeke is a member of the advisory council of the Women's College in Brown University, a trustee of the Rhode Island Society for the Collegiate Education of Women and a member of the board of directors of the National Federation of Arts. She was one of the founders and the first head of the Rhode Island chapter of the American Association of Collegiate Alumnae. Mrs. Radeke is a daughter of the late Jesse and Helen Metcalf of this city and a sister of Stephen O. and Jesse H. Metcalf of this city, Manton B. Metcalf of New York and Mrs. William C. Baker of California.

THOMAS ROBERTS SLICER, D. D.

Thomas Roberts Slicer was born in

Washington, D. C., April 16, 1847, the son of Rev. Henry Slicer, D. D., Chaplain of the United States Senate under Presidents Franklin Pierce and James Buchanan. He became pastor of the First Congregational Church (Unitarian), Providence, in 1881, remaining there nine years. In 1890 he took charge of the Church of Our Father, Buffalo, and seven years later was called to All Souls Church, New York, where he is at present. He is a trustee of the People's Institute, Cooper Union; President of the National Association for Prison Reform, chairman of the National Committee of the Censorship of Moving Pictures, and has been active in reform and educational matters. He has the degree of A. M. from Dickinson College.

WILLIAM EDWARD GARDNER, D. D.

William Edward Gardner was born in 1872, and was graduated from Brown University in 1895, being one of the Commencement speakers. He prepared for the ministry at Cambridge Theological School and was ordained a deacon in 1898. His first parish was at the Church of the Holy Name, Swampscott, Mass. After four years at that place, he became rector of Christ Church, Quincy, Mass., and later of St. James Church, Cambridge. In 1910, Mr. Gardner was made leader of the department of New England missions of the Episcopal Church, and two years later, when the church decided to centralize its educational interests under the direction of the General Board of Religious Education, he was made its administrative officer.

HERMAN WILLIAM WATJEN, D. D.

Herman William Watjen was born in Germany, coming to this country in 1872. He was graduated from Colby Academy in 1886, and from Brown University in 1890, being one of the speakers at the Commencement exercises. During his college years he was acting

pastor of the Sayles Memorial Church at Saylesville. He was graduated from Newton Theological Institution in 1893, and at once became pastor of the First Baptist Church at Warren, where he has remained since. He has been Chaplain of the Warren Artillery for 20 years and a member of the school board of the town for 21 years. Since 1907 he has been President of the Rhode Island Baptist Education Society.

LUTHER EMMETT HOLT, SC. D.

Luther Emmett Holt was born in Webster, N. Y., March 4, 1855, and was graduated from the University of Rochester in 1875, receiving the degree of A. M. three years later. He was awarded the degree of M. D. by the College of Physicians and Surgeons of Columbia University in 1886. He was professor of the diseases of children at New York Polyclinic from 1890 to 1891 and then made clinical professor as well, which post he still retains. Since 1902 he has been Carpentier professor at the College of Physicians and Surgeons. He is attending physician at the Babies' and the New York Foundlings' Hospitals, Secretary of the Rockefeller Institute of Medical Research and a trustee of the University of Rochester. He is author of several books on the treatment of children's diseases.

VERNON PURINTON SQUIRES, LITT. D.

Vernon Purinton Squires was born Nov. 4, 1866, at Cortland, N. Y., and received the degree of A. B. from Brown University in 1889. He was teacher of chemistry and physics at Worcester Academy the year following his graduation, after which he became professor of Greek and Latin in the New York State Normal School at Oneonta. After four years at the University of Chicago, he became, in 1897, professor of English in the University of North Dakota, where he remained until 1901. For a year he

taught at Kalamazoo College, and then returned to North Dakota to his former work. This year he was made Dean of the College of Liberal Arts there. He has written several literary articles and acted as editor for various publications.

HENRY ROBINSON PALMER, LITT. D.

Henry Robinson Palmer was born at Stonington, Conn., Oct. 15, 1867, and was graduated from Brown University with the degree of A. B. in 1890, being class poet and a Commencement speaker. He immediately became, and has been continuously since, a member of the editorial staff of the Providence Journal. For two years, 1903-05, he was editor of the Sunday Journal, and at present he is at the head of the editorial department of the Journal and the Evening Bulletin. He has been a contributor to magazines and other periodicals and editor of the Brown Alumni Monthly since its establishment in 1900. He has published a book of verse and a local history, and in 1909 Brown University gave him the degree of A. M. on examination.

CHARLES WILLIAM ELIOT, LL. D.

Charles William Eliot was born in Boston, March 20, 1834, and was graduated from Harvard with the degree of A. B. in 1853. In 1857 he received the degree of A. M. from Harvard and in 1869 was made Doctor of Laws by Williams College and also by Princeton. Later he received the same degree from Yale, Johns Hopkins, Tulane University, University of Missouri, Dartmouth and Harvard. Dr. Eliot taught chemistry at Harvard and later at the Massachusetts Institute of Technology. He was made President of Harvard in 1869, and held that post until 1909, when he was made President Emeritus. He is widely known as an educator and has written many books on various subjects. He is a member of a number of educational societies.

DR. HALE'S TRIBUTE

In the preface of his religious Utopia "Ten Times One is Ten," published in 1870, Edward Everett Hale paid the following remarkable tribute to President Wayland:

"This little book would never have been written, I suppose, but for the persuasion of my kind friend, the late Dr. Wayland, the President of Brown University. It is nearly fifteen years ago that I told him the plan of this story, if it may be called a story, expressing the wish that some of the masters would undertake to illustrate the lessons involved in it. Everyone who knew him—and there are who knew him enough to love him—will remember how practical and how personal was every notion of the religious life, of Christian labor, and of missionary triumph, in his mind. What

he thought the practical and personal character of my little sketch pleased him; and he was kind enough to urge me once and again to enlarge it, and to print it. I think it is because he wished it that I have tried to do so.

GIFTS TO THE UNIVERSITY

The University has recently received from Miss Mabel Adaline White of Chicopee, Mass., the sum of \$1000 "to establish a scholarship in memory of her father, the Honorable Luther White of the class of 1864, the income to be given to deserving students to be selected by the college authorities, but preference to be given always to male and female descendants of members of the class of 1864."

The class of 1894 presented to the University at Commencement time "the

Class of 1894 fund, the income to be used for the purchase of books for the English Department, it being the expressed wish of the class that such expenditure be under the direction of our fellow member, Professor Thomas Crosby, during his connection with that Department."

He lectured at Mount Holyoke College, April 25, on "Mathematical Instruction in France."

1852

Mary A. Thayer Goldthwait, wife of N. E. Goldthwait, '52, and mother of S. G. Goldthwait, '90, died at her home in Boone, Iowa, Jan. 12. She and her husband both came from Uxbridge, Mass., and were married in Worcester Aug. 25, 1852.

1855

David W. Hoyt for more than 50 years principal of the Providence English high school has tendered his resignation in the following letter: "I hereby tender my resignation as principal of the English high school of this city, to take effect in June, at the close of this school year. During recent years the duties and responsibilities of my position have greatly increased, and I am convinced that a younger man should be asked to discharge those duties and bear those responsibilities. I have now served continuously more than 50 years as a teacher in the high schools of Providence, having entered upon my duties as 'Teacher in the Senior Class of Boys, English Department' of the Providence high school, Feb. 22, 1861. During that half-century the number of high school pupils in this city has

increased more than tenfold, though the population has increased less than fivefold. During that period I have served under five school superintendents and nine presidents of the school committee, and I wish to acknowledge the uniform courtesy which has been accorded me by the officials, the school committee and the citizens of Providence." Mr. Frost in commenting on the resignation said: "Mr. Hoyt, although past 80 years of age, is still physically vigorous and mentally alert. He clearly understands that there is not the slightest desire on the part of the school committee, the superintendent or the citizens of Providence that he should take this action. But, as much as the school and the department will miss his great talents both as a teacher and an executive, I feel that if any man has earned the right to rest that man is David W. Hoyt."

1858

Mrs. Clara Stone Hay, widow of John Hay, the late Secretary of State, died suddenly, April 25, at the home of her daughter, Mrs. Payne Whitney, in New York city. Mrs. Hay was the daughter of Amasa Stone of Cleveland, one of the richest men in Ohio at the time of his death. Two sons and two daughters were born to Mr. and Mrs. Hay.

Hon. Louis A. Coolidge, former Assistant Secretary of the Treasury, in a recent address before the Boston City Club on the prominent public men he had known during his twenty-five years in Washington, spoke thus of John Hay: "Of all the public men whom I have known, I think John Hay possessed the greatest charm. He was a wit, a scholar and a gentleman, a poet, a linguist and a diplomat. He had a marvellous acquaintance with interesting people of many nationalities and all degrees, dating from Lincoln's day. No one could ask a more delightful privilege than to listen to his rippling comment on the ever-changing business which came before him day by day, or to his whimsical delineation of those who tickled his fancy or tried his patience."

1859

"The last day of President Lincoln's life and the incidents therewith connected" is the subject of a lecture of absorbing interest, frequently given by Dr. George L. Porter. It is a story of personal experiences, told by one who, nearly a half century ago, was personally acquainted with President Lincoln and was on duty at the Old Penitentiary in Washington, where the conspirators were imprisoned. Dr. Porter, of Bridgeport, Conn., was a medical officer of the Regular Army, stationed at Washington Arsenal from 1864 to 1867, and there frequently had the opportunity to meet President Lincoln, who found at this military post relief from politics and office seekers. After the assassination, the Old Penitentiary building on the Arsenal grounds was fitted up as a prison for the conspirators, and a court-room for the Military Commission, under the command of General Hartranft. Dr. Porter was detailed for duty upon his staff, and had medical charge of the prisoners; was present at the execution of some, and accompanied others to Fort Jefferson at Dry Tortugas, Florida.

1861

Rev. Henry S. Burrage is spending the summer in England. His address is care of Champ-lin Burrage, 28 Portland road, Oxford.

L'Economiste of Paris contains an appreciative review in French of Amasa M. Eaton's book "Free Trade vs. Protection." Mr. Eaton has also received a complimentary letter from Yves Guyot, the leading French economist and one of the editors of that paper. The book is published by A. C. McClurg & Co. of Chicago.

1865

Edward Richmond Blanchard, manager of the Glenlyon Dye Works at Phillipsdale, one-time champion chess player of New England, died April 27 at his home in Providence, of a cerebral hemorrhage. He was born in Charlestown, Mass., July 3, 1843, the son of Francis Henry and Sarah Manning (Richmond) Blanchard. He received his early education in the public schools of that town and after graduating from the Waltham high school he entered Harvard. At the outbreak of the Civil War he left college and enlisted in a cavalry regiment. After a brief period of service he enlisted in the Forty-fourth Massachusetts Volunteer Infantry and saw active service in the North Carolina campaign for two years. He entered Brown as a Junior in 1864, and was graduated the following year. His first business was in New York city, 1871-82, where he manufactured buttons. In 1883 he went to Boston to become President of the Lexington Print Works. He came to Rhode Island in 1900 to assume the management of the Glenlyon Dye Works, a position which he held till his death. Mr. Blanchard married Miss Anna Winifred Quincy of Boston, five children being born to them, three of whom, with Mrs. Blanchard, survive him. They are Miss Grace H. and Miss Edith R. Blanchard of Providence and Rev. F. Q. Blanchard, a Congregational minister at East Orange, N. J. His grandfather, Edward Richmond, was graduated from Brown in 1789 and received the degree of D. D. in 1815. Mr. Blanchard was a member of the Economic Club, Psi Upsilon, the Harvard Club of Rhode Island, Wannamoisett Country Club, the Providence Art Club, the Squantum Association, the University Club, the Providence Chamber of Commerce, the Arkwright Club, the New York Club, the Rhode Island School of Design, and the Rhode Island Historical Society.

1866

On Sunday, May 31, a tablet was unveiled at the Broadway Baptist church, as a memorial to Rev. J. V. Osterhout, who was for more than a quarter of a century the pastor of that church.

Rev. William H. Spencer, D. D., of Cambridge, addressed the Boston Baptist ministers' meeting in Chipman Hall, Tremont Temple, recently, on "Some Phases and Memories of the Civil War." Dr. Spencer attained the rank of major of the Sixty-first New York Volunteers and lost a leg at the Battle of Glendale. While lying thus helpless, Major Spencer was captured and taken to Libby Prison, Richmond.

1870

Rev. Peter Benton Shiere died at his home in Somerville, Mass., May 1, after an illness of two days. He was born in Havre, France, Jan. 7, 1841. He was fitted for college at the Kimball Union Academy, Meriden, N. H. His course at Brown was interrupted by a year and a half of military service. He was graduated from the Hartford Theological Institute in 1873, and was ordained to the Congregational ministry at Maynard, Mass., in 1874. He was pastor there, 1874-76, and at Chatham, Mass., 1877-79. He held no pastorate since that last date. For many years he traveled through the South and West, having his residence in Somerville. He was chaplain of the Willard C. Kingsley G. A. R. Post. He is survived by a widow and four sons.

1873

George L. Collins, M. D., has removed his office, from 223 Benefit St., to his residence, 22 Angell St., Providence.

William E. Foster has issued his thirty-sixth annual report as librarian of the Providence Public Library. The Library now contains over 170,000 volumes.

1876

Clarkson A. Collins, ex-President of the Brown Club of New York, was the Brown delegate to the centennial celebration of Mount Pleasant Academy, Ossining-on-the-Hudson, New York, June 11.

Erwin James France died April 1, after a very brief illness. He was born at Mt. Pleasant, Burrillville, R. I., the son of James E. and Susan Phillips France. He attended the public schools of Burrillville and North Smithfield, and was fitted for college at the Friends' School, Providence. He received the degree of LL. B. from Boston University in 1881, and was admitted to the bar in 1882. He was in the practice of law in Woonsocket from 1885 to the time of his death. He was a member of the town council of Burrillville, 1884-86; state senator from Burrillville, 1885-87; member and secretary of the school committee of Woonsocket, 1890-98; member of R. I. House of Representatives from Woonsocket, 1896-1900; and city solicitor of Woonsocket, 1898-1914. He married Oct. 10, 1888, Emma F. Spring, by whom he had a daughter, Helen Sayles France.

1877

Joseph D. Milne, 77, and Frank S. Ahuy, who have long been connected with the Fall River Daily News, took over the publication of this prosperous paper upon the retirement of John C. Milne, May 18, on his 90th birthday. The elder Mr. Milne was one of two men who founded the News 69 years ago.

1878

Isaac O. Winslow has been re-elected Superintendent of Schools of Providence for an indefinite term, and his salary increased \$1000 a year to \$5000.

1880

Walter F. Angell of Providence, who has been in Europe since last fall, recently wrote friends at home from Budapest, which he said was the

most distant point he intended to visit.

At the seventy-fifth anniversary of the founding of the University of Missouri, celebrated on Wednesday, June 3, Brown was represented by Augustus L. Abbott of St. Louis, one of the Brown Trustees.

1881

Miss Fannie Louise Jackson was married April 27, to Canon William Sheafe Chase, rector of Christ Church, Brooklyn, the ceremony taking place in St. John's Methodist Episcopal Church. The bride, who is the daughter of Mr. and Mrs. John Jackson, was given away by her brother, Mr. Edward Everett Jackson. After the ceremony there was a reception in the parlors of the church. Later a supper was served for the bridal party and immediate relatives of the bride and bridegroom at the Hanover Club.

1882

William H. Tohman, Ph. D., is author of "Hygiene for the Worker," published by the American Book Co.

Dr. William H. Pomeroy died at his home in Springfield, Mass., June 10, after a short illness. He was the son of Dr. Stephen F. and Joanna L. (Watrous) Pomeroy. His father was one of the old-time practitioners in Springfield. He was born at Staffordville, Ct., August 19, 1857. He went to Springfield when quite young and attended the public schools, graduating from the central high school. Following his graduation from Brown he entered Harvard medical school, graduating with the class of 1886. He completed his study of medicine abroad, spending one year at the University of Vienna. He then began the practice of medicine in Springfield. In 1883 he was elected the visiting physician of the Home for the Friendless. In 1898 he was the visiting physician at the Springfield Hospital. He was the post surgeon at the local United States army barracks, 1899-1902. Until his death he was the contract surgeon for the United States army, and since 1902, the examining surgeon for the Springfield recruiting station. In 1903 he was appointed chief medical examiner for the New York Life Insurance company in Hampden county, holding the position at the time of his death. 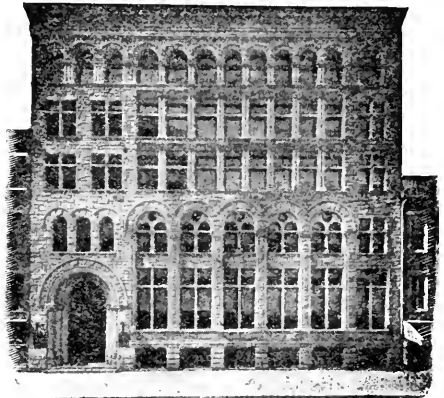
