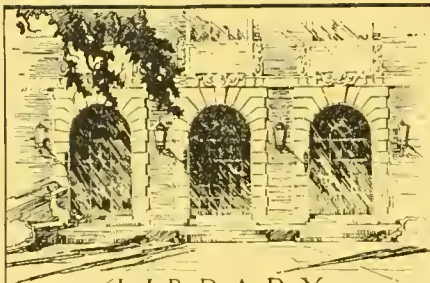

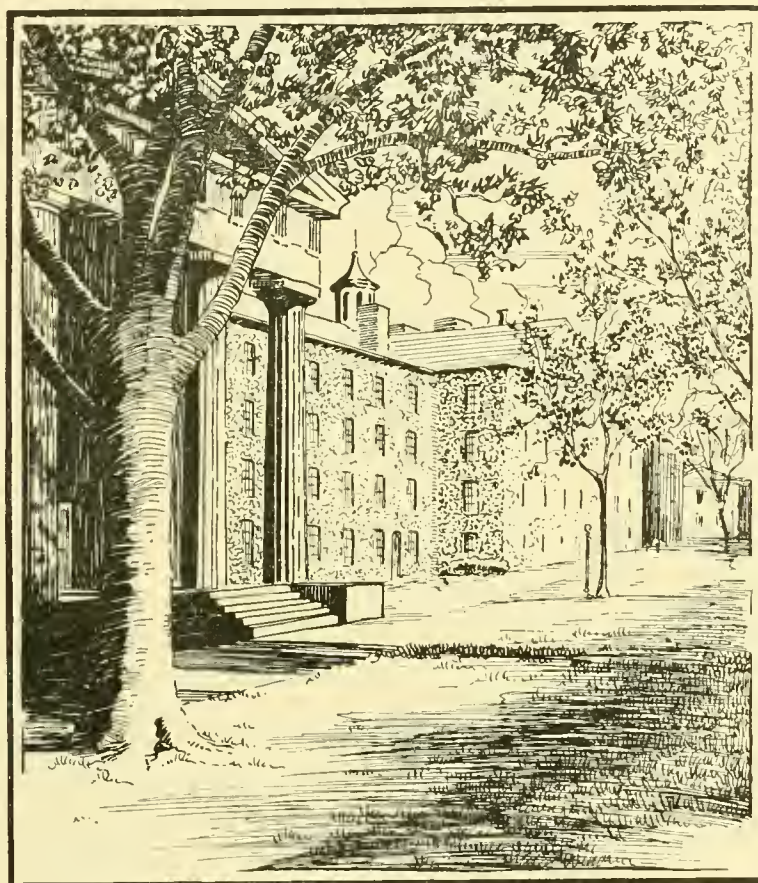

On the Hill

Dr. Mead Recovers

WE REJOICE in the steady recovery of Vice President Mead of Brown University. His health is not yet complete, but he has made good progress in recent weeks after a long and tedious illness at the Jane Brown Hospital in this city, following a painful abdominal attack and serious operation. He is now "out and around."

Dr. Mead has made a place for himself at Brown during his years of university administrative work — to say nothing for the moment of his teaching and direction in the Department of Biology. He has brought to this larger task qualities that no one in the history of the institution has possessed in just the same degree, and much of our advancement in the last five years is due to his tactful and judicious leadership.

We rejoice in his return to health and wish him many years of continued service and happiness.

Condensed Language

ON FEBRUARY 4, 1929, Professor John Howard Appleton remarked to a little group of friends at a lunch table at the University Club in Providence: "I think of mathematics as a most condensed form of language." The talk had been about Einstein; who besides Professor Appleton contributed to it we do not recall; nor so far as we know is there any fragment of the conversation extant except the one we have just given. We found it, the other evening on the back of a luncheon card, on a littered desk at home, where it has reposed more than two years.

The description of mathematics as a highly condensed form of language strikes us as a good illustration of the working of Professor Appleton's clear

mind. We only wish we had preserved more of his wise and pithy sayings. We had the privilege of lunching with him on literally thousands of occasions — the record extended over perhaps twenty years at the rate of possibly 250 noons each year; but unfortunately neither we nor anyone else in that long time constituted himself the Professor's voluntary amanuensis.

It is a pity that somebody does not put down on paper an account of the lunch table group of which Professor Appleton was the undisputed head. In the long course of time the group has changed, but so gradually that it has seemed to keep a certain measure of identity. Among those who formerly composed it we recall at the moment, Judge John T. Blodgett, Robert P. Brown, President Faunce, John R. Gladding (who has lately passed away), Prescott O. Clarke, William R. Tillinghast, and Judge Walter B. Vincent (who still survive), Walter F. Angell (who rarely joins it nowadays), Nathaniel T. Bacon of Peace Dale; occasionally his son, Leonard Bacon, poet and professor; Charles C. Mumford, Chief Justice Parkhurst, and a great company of others. Its topics of conversation, if not as many as the stars in the heavens or as various as the waves of the sea, have approximated the innumerable, and an extraordinary absence of untoward emotion has characterized it. There have been sharp differences of opinion but an overwhelming tolerance and an abundant good will. We do not remember a single instance of embarrassing controversy, that is of controversy carried to the extent of bitterness. Professor Appleton himself had a happy formula for use at moments of strain, when it seemed as if the temperature of debate might rise a trifle too high. He would mildly observe: "How about the Balkans?" and at this familiar reminder the give-and-

take would promptly return to normal. And during these years of cheerful and sometimes brilliant discussion, occurred such controversial events as the World War and the enactment of the Eighteenth Amendment.

Home of Modern Languages

WE ARE glad to print the following letter, which we had been forewarned was coming.

Inadvertently we omitted to include in our title line under the cover cut of the Alumni Monthly in February any recognition of the fact that the Germanic Department is one of those that are housed in Marston Hall on Manning street. It was an oversight and we offer our sincere apologies to all concerned.

Incidentally, although Marston Hall is "dedicated to the study of modern languages and literatures," one very important such language has its quarters elsewhere—namely the English language. If we are going to be finicky, should we not say that Marston Hall is dedicated to the study of modern foreign languages and literatures? But here is the letter:

Editor Brown Alumni Monthly:

At the request of the visiting committee of the Germanic Department, Brown University, I am writing a line about something that may create misunderstanding. The statement under the picture of Marston Hall on the cover of the February issue of the Brown Alumni Monthly might lead the reader to conclude that the Romance Department is the sole occupant of our Modern Language Building.

You, of course, and all who know the situation will recall that the Germanic Department and the Romance Department, according to the announcement, entered the building up-

on equal terms. We understand that it would be correct if we should say, 'Marston Hall, Home of the Germanic Department,' for both departments occupy the hall "Dedicated to the study of Modern Languages and Literatures."

Six men are giving instruction in German subjects, and five hundred students are enrolled in our classes. I think it is right for us to say that we have a strong and systematic course of study.

If this magazine did not go to remote corners of our country, and also far beyond, we might not think that misunderstanding could easily arise.

I want to thank you for attention which you have given us in the past, which we certainly do not overlook, and I hope that this letter is not out of place.

Death of Mrs. Radeke

BROWN UNIVERSITY suffers the loss of a loyal friend in the death, on March 17, of Mrs. Eliza Greene Radeke, a graduate of Vassar in the class of 1876 and an honorary graduate of Brown in 1914. Mrs. Radeke was for eighteen years president of the Rhode Island School of Design, to which institution she literally gave her life, planning and working for it, spending a large part of her waking hours within its walls, contributing generously to it from her financial resources and exercising over its welfare a wise and prudent watch care.

Mrs. Radeke was a remarkable woman, with exceptional administrative ability. To this she added a talent for the adjustment of difficulties and the smoothing out of friction and rancor by the employment of fairmindedness and consideration. Her artistic taste was cultivated by wide travel and study. She was a constant reader of current art volumes and magazines. She kept in close touch with the art trade and her gifts of art in many forms to the School of Design constitute a large proportion of the treasures of its museum today.

In a very true sense she was the

creator of the School as it exists at the present time. It was founded by her parents, Jesse and Helen Rowe Metcalf, and her labors in its behalf were dictated in part by a filial devotion to their memory. But aside from this, her genuine interest in art—for its own sake and in its manifold relations to industry—dedicated her to what became a continuous and ardent task. She was a member of the board of directors of the School as early as 1886 and in 1913 succeeded to the presidency.

Mrs. Radeke saw the institution grow from small resources and a modest number of students to one of the greatest establishments of its kind in the world. It has nearly two thousand students and in its various departments runs a wide gamut of artistic instruction. These departments include Drawing and Painting, Decorative Design, Modeling, Architect-

ure, Interior Decoration, Mechanical Design, Textiles, Jewelry and Silver-smithing, Normal Art and Saturday Classes. The School sustains a high reputation on both sides of the Atlantic, and to no one does it owe so vast a debt of gratitude as to Eliza Greene Radeke, its extraordinary executive.

Mrs. Radeke was a sister of Stephen O. Metcalf, '78, and United States Senator Jesse H. Metcalf, (hon.), both of Providence. Under her administration of the School of Design its relationship to Brown became increasingly intimate, and at the present time there is in force a reciprocal arrangement by which students in either institution may pursue courses at the other in furtherance of their graduation.

To the bereft School Brown University offers its sincere condolences on the death of its beloved and devoted president.

The School Master Retires

Brown Interests of All Sorts

Summary of Winter Sports

ONCE AGAIN Spring is in the offing, and once again the various and sundry Brown Varsity and Freshmen teams have completed their winter indoor schedules. If one were to take their performances as a whole he might easily be disappointed, for the final tally stands as follows: Wins, 43; losses, 39, ties, 3. However, if one were to delve into the actual facts he could find a few bright spots.

The records of these teams is about the same as usual, with a couple of the outfits finishing the season with excellent records behind them. The Bruin hockey team was excellent, winning nine of its ten games, losing only to Dartmouth in two overtime periods; the Freshmen tracksters were undefeated in five meets; the yearling swimmers won six of their eight contests, the 1934 hockey team won three, lost two and tied one, and the 'varsity track team won two of its three meets. On the debit side we find the Varsity swimmers won four while losing six; the wrestlers won two, lost three and tied two; the basketball team won nine and lost ten, and the first year grapplers failed to win any of their six meets. Aside from the dual encounters, the matmen placed third in the New England Intercollegiates, the swimmers were nosed out by Springfield, 24½-23 in the Swimming championships held at Middletown, while the Freshmen sprang a surprise by scoring 24 points to place second to Harvard in the freshman division of the wrestling meet.

The hockey team was, of course, outstanding, and the forward line of Moulton, Crane and Ahern was second to none in New England, Bob Hutton, serving his first year in front of the nets, allowed only 19 goals to be scored against him, and five of these came in the Dartmouth game. Crane was Brown's leading goal-getter, scoring 15 of the forty-four made by the team, while Moulton was a close second with thirteen. Capt. Walls, bril-

liant and steady defense man, as well as the entire forward line will be lost by graduation, but Hutton, Hargrove, (the other members of the first team) Paige, Hunt, Scott, Johnson and Flynn will form a nucleus for next year, with Capt. Legge and Ray Chace coming up from the yearlings.

The basketball team, after winning its first eight games, lost the next eight, rallied brilliantly to beat R. I. State, 40-35 before 2500 people, and lost its final contest to Holy Cross, 59-14. Capt. Paul Snyder, who scored nearly two hundred points, Joe Schein, and Bud Hemelright will graduate, leaving Jack Caulkins, Harris, Mantell, Sawyer, Bradshaw and Skinner available next season.

Outstanding men on other varsity teams were Capt. Ray Hall and Frank White of the swimmers; Capt. Walter "Cy" Wentworth, Stanley Woodward and George Tietz of the wrestlers; and Capt. Wes Huse, Tom Gilbane, Minor Patton, Tom Sawyer and Rolland Brown of the trackmen. Of the yearlings, Johnny Balmer and Joe Buananno, tracksters; Capt. Dick Legge and Ray Chace of the hockey team; Capt. Bill Lewis and Stanton of the swimmers; Capt. Hammer, Strand and Mau of the basketball five and Capt. Affinito and Hay of the grapplers were stellar performers.

New Marks Set

We have already spoken of the record set by Tom Gilbane in the shot put, and since that time several other existing marks have been shattered by Bruin performers. Although placing second in the N. E. I. C. Swimming, Brown was credited with three New England records. Capt. Ray Hall swam the hundred in 56 4-5 seconds, compared with the old mark of 57 1-5, Frank White broke the 150-yard backstroke record twice, the new time being 1:44 2-5, while the relay team swam the distance, 160 yds. in 1:17 1-5, 2-5 of a second faster than the former mark. Capt. Bill Lewis

of the 1934 team was credited with the M.I.T. pool record in the 100-yd. dash when he swam the distance in 55 4-5 seconds.

Captain Walter Wentworth proved himself to be second to none in the 165-pound class by going through the entire season without losing a bout. In his sophomore year, wrestling in the 155-pound division, "Cy" won nine of his ten bouts, losing only to Kaufmann of Yale, the sole blot on his collegiate wrestling career. Last year he won the three bouts in which he participated before being declared ineligible while this year he has yet to taste defeat. In the New England I.W.A.A. bouts held at Brown Gym on March 13 and 14 he won the 165-pound championship, the only Brown man to win in the finals. Twenty victories in twenty-one matches, his only loss on a decision, and you have his record in a nutshell—truly a remarkable one, and one which is deserving of recognition.

Rehearsals are well under way for the Sock and Buskin Alumni production of "Uncle Tom's Cabin" which was announced in last month's issue. The play will be presented in Rockefeller Hall on April 21-22-23-24-25.

Professor B. W. Brown will play the leading role of Uncle Tom and will be assisted by W. B. Farnsworth

as Shelby; Charles K. Baker as Marks; Frederick B. Weiner as Haley; Rufus C. Fuller as St. Claire; Leslie T. Chase as Phineas Fletcher; Rusesell W. Richmond as Loker; Nelson B. Jones as Sambo; Theodore L. Sweet as Legree; and Robert Bergh as George Harris and young Shelby.

Miss Esther Brintzenhoff will appear as Eliza and also as Cassy; Mrs. Leslie T. Chase as Eva; Mrs. Hazel Brown Goodwin as Topsy; Mrs. Zenas R. Bliss as Marie, the mother of Eva; Miss Dorothy Hackney as Aunt Ophelia; and Mrs. Samuel T. Arnold, wife of Dean Aruold, as Marie, the slave girl.

The play is being directed by Rufus C. Fuller assisted by Leslie T. Chase, and is being staged by Francis Arnington.

As far as we know this is the first revival of this famous play. The original run closed only last spring after more than seventy-five years.

The last production of the play in Providence was over fifteen years ago.

More about Busses

In a recent issue we commented at length on The Daily Herald's agitation for a bus line from the campus to Brown Gymnasium, a distance of nearly two miles. The Herald contended that it was a grave injustice to the athletes to force them to pay carfare in order to try out for the teams, and also stated that the student body as a whole, if given the opportunity to voice its opinion, would agree that the only solution to the problem would be the instigation of a bus line. Now the Herald can crow to its heart's content.

Under its sponsorship, and with the co-operation of the Cammarian Club, each class was given the opportunity to vote on the subject at chapel. The result was an overwhelming majority in favor of the establishing of a bus line. The two lower classes voted 509-49, and the Juniors and Seniors 243-8 for the Herald's suggestion. All in all, the outcome is really not so startling, as the entire campaign

has been an issue between the students and an imaginary rival, for aside from the protest from Dr. Marvel, no one has objected to the scheme. However, now that the attitude of the students has been definitely recorded, the proposition can be placed before the Athletic Council for further action. Let us hope that some sort of an agreement satisfactory to both sides can be made, and that by the time another winter sports season rolls around everyone—including the Herald—will be happy.

Romeo and Juliet

When the curtain rose on the opening performance of Will Shakespear's "Romeo and Juliet" at Rockefeller Hall on March 11 it marked the opening of the 109th production of the Sock and Buskin. For the first time in its long history, the leading feminine roles were taken by women, two guest artists, and one a member of the Komians, Pembroke dramatic society. The Sock and Buskin recently announced its intention of using guest artists to fill all feminine roles in future productions.

Under the able direction of Professor Ben Brown—we admire his patience and willingness year after year—the production was a distinct success. Besides the novelty of having women in the play, the way in which it was staged was extremely interesting. Simplicity was the keynote, the sets being done in deep shades of blue and maroon with unusual lighting effects, which proved a success from both an artistic and mechanical standpoint. Assisting Professor Brown were Professor Thomas Crosby, Jr., who adapted the play, and Powel M. Dawley, former Sock and Buskin actor. Joseph E. Cadden, 1931 as Romeo, Miss Rosa Reisner of Pembroke as Juliet and Mrs. Alice A. Fuller as Lady Capulet were the chief actors.

Track Schedule

One of the most attractive track

schedules ever arranged for a Brown team was recently announced by Dr. F. W. Marvel. Featuring the announcement is a three-year contract for triangular meets with Dartmouth and Columbia. The first of these will be held in New York this year, with the one in 1932 in Providence and the third in Hanover in 1933. In addition, Colgate, a newcomer, will invade Providence on May 16, and with track prospects extremely bright, the season promises to be an interesting one for track followers on the Hill.

University team: April 25, R. I. State, Providence; April 29, Univ. of New Hampshire, Providence; May 9, Dartmouth and Columbia, New York; May 16, Colgate, Providence; May 22-23, New England Intercollegiates, Lewiston, Me.; May 29-30, I.C.A.A.A.A., Philadelphia.

Freshman team: April 24, Moses Brown School at Brown Field; May 1, R. I. 1934, at Providence; May 8, Holy Cross 1934 at Providence; May 15, Univ. of New Hampshire 1934 at Providence; May 22, open.

Thermionic Tubes Shown

During recent weeks, F. N. Tomkins, Associate Professor of Electrical Engineering, has been giving considerable publicity to some recent developments in the use of vacuum tubes such as are used in radio communication but more particularly the vapor filled tubes that have already been found to furnish numerous engineering applications, with promise of exceedingly more extended utility in the near future. Both varieties of such devices are now denoted as "Thermionic Tubes." On Tuesday evening, March 3, he gave a lecture with demonstrations, in the Engineering Building, before the Brown Chapter of the Society of the Sigma Xi, then again on the following evening before his Extension Class. On Tuesday eve-

ning, March 10, he gave it to the Providence Section of the American Institute of Electrical Engineers, to which the Providence Engineering Society as a whole was invited. The audience more than filled the Engineering lecture room. On the following Thursday afternoon he gave it to the visiting classes of scientific students from the city and neighboring high schools. On Friday morning, March 13, he gave it before the combined engineering students of the university, numbering about 150 men in all.

The demonstrations require an extended array of apparatus, with careful preparation and adjustments, so the close repetitions economized time as well as accentuated the interest in these remarkable novelties in electrical devices and methods.

Senior Class Vote

In the results of the annual Senior class vote conducted by the *Liber Brunensis* which were announced recently, five undergraduates carried off the major share of the honors. These men, Joseph A. O'Neill of Providence, Paul A. M. Snyder of Franklin, Pa., W. Lincoln Fogarty of Flushing, L. I., Lee Marshall of New York city, and Douglas M. Stewart of Providence, have all been prominent in campus activities. O'Neill was voted the best all-round man outside of athletes, the most likely to succeed, as having done the most for Brown, and the busiest man in the class. His activities in college have included managing the football team, and acting as Editor-in-chief of the *Liber*. Snyder, President of the Cammarian Club and for two years captain of the basketball team, was elected the most popular, best all-round man, second best worker, and second most respected.

Of the other three, Fogarty was captain of the football team last fall, has been on the track team for two years, and has been prominent in non-athletic activities, while Marshall is also a football player. Stewart has been outstanding scholastically, having been elected to Phi Beta Kappa and Sigma Xi in his Junior Year.

Fogarty was chosen as the best all-round athlete, the second most popular and laziest, and possessor of the biggest drag with the faculty; Marshall was voted the most respected, and the most thorough gentleman; while Stewart was voted the most scholarly and brilliant, as well as the best all-round non-athlete.

Seventy of the graduating class would not marry for money, sixty would, while twenty-three say "maybe." In answer to the question "Do you drink?" 106 answered yes, while forty-nine replied in the negative. Twenty-two are engaged to be married, 117 have never been turned down, and fifteen have once, while eleven admitted they had been refused "plenty." The questions "Have you ever been out with a Pembroker?" and "Do you go out much with Pembrokers?" brought out the fact that 124 out of 150 had, but that 128 didn't (and probably wouldn't if they could help it!) as a regular thing.

Although in some cases the answers were, at best, facetious, the questionnaire as a whole brought out fair replies, and, as in past years, occasioned a great deal of interest. It is the one time during an undergraduate's career when he can express himself freely, and he is not slow to take a crack

at his classmates and at conditions which seem unfair to him. Hence, it is really a good tradition, and as everyone takes it in the right spirit, no one's feelings are hurt. This year's list of questions was about twice the size of previous ones, and is far more comprehensive, and for sake of brevity we have quoted only the more pointed queries.

Spring Day Speaker

Willard V. Thompson of Oklahoma City has been chosen to give the annual Spring Day speech at a meeting of the committee held recently. Thompson, a member of Psi Upsilon, is an associate editor of the *Daily Herald*, a member of the Sphinx Club, and an honor student in English.

The date for Spring Day, although not definitely decided upon, will probably be May 14. On this day the Seniors will appear for the first time in their caps and gowns, and class pipes and canes will be distributed at the same time.

It has been traditional for years for the speaker on Spring Day to address the Seniors on the steps of the John Carter Brown Library. The speech, usually satirical and given in a burlesque manner, pokes fun at various customs existing on the Hill, and at its close the speaker unveils a mascot symbolizing his theme.

A Gift to the Library

Dr. James Hosmer Penniman of Philadelphia has made a substantial gift to the John Hay Library. Dr. Penniman is the founder of the Maria Hosmer Penniman Memorial Library of Education, which is the Department Library of the School of Education, at the University of Pennsylvania, and of the Penniman Memorial Library of Education in Yale and in Brown. He has now transmitted to Brown University certain securities, in part immediately available to the University and the remainder to be available as to income after his life use. The books bought with the income from the Penniman Fund are to be incorporated with other books on

Education already in the possession of the Library, where this does not conflict with the wishes of other donors or terms of other gifts, and the collection as a whole is to be called the "Penniman Memorial Library." This gift has been gratefully received and acknowledged.

It is interesting to know that Dr. Penniman suggested the plan to recognize the two hundredth anniversary of the birth of Washington in 1932 by the construction of the "Highway of the Thirteen Original States" from Washington to Mount Vernon, the proposal being that each of the original States shall contribute the cost of one mile.

Thirty-five men made the annual spring trip of the Brown Musical Clubs held during the spring recess. As mentioned before, the itinerary of the clubs included Washington, Asbury Park, Philadelphia, as well as a joint concert with Princeton in New York and a concert in Boston.

Wearing the colors of the Boston A.A., John S. Collier, 1929, star Brown hurdler, making his first appearance in nearly two years, easily won the 60-yard high hurdles at the annual Knights of Columbus games held in New York March 14.

Franklin M. White, Jr., 1933, the sole University entrant in the Intercollegiate Swimming Championships held in New York, March 21, placed second to Joseph Wohl of Syracuse, defending champion, in the finals of

the 150-yard backstroke. Wohl's time was 1:44:35. The Brown 1934 team, composed of Hickey, Stanton, Gross and Lewis placed third, finishing behind Princeton and Dartmouth in the final, in which the Tiger cubs broke the record.

Through the generosity of the Providence Brown Club a new Philco radio has been installed in the infirmary, much to the enjoyment of its inmates.

Joe Paders, 1932, of Brooklyn, N. Y., winner of the novice boxing matches held at the University, won the Senior New England Championship in the heavyweight class at Boston, March 16, when he knocked out Howard Range of Northeastern in the first round.

The recently formed Brown Polo Club has been admitted to full membership in the Indoor Polo Association. Although new this year in active competition, the team has already given a good account of itself and should do even better another season.

The Advisory Council Sets the Pace

AS A progressive cross section of the alumni, the new Advisory Council of the Associated Alumni easily came up to the expectations as it met at the Faculty Club, Providence, Feb. 22 and 23. This was the first meeting since the revised constitution, approved in June, 1930, made the make-up of the Council more coherent than that of the old Advisory Board.

Answering the roll call were delegates from as far West as Denver and as far South as Washington, presidents of most of the Brown Clubs or their special representatives, Alumni Trustees, members of the Board of Directors and the officers of the Associated Alumni. In addition, the guests included President Barbour and other administrative officers of the University and members of the Faculty and the undergraduate body.

The program went off without a hitch, thus testifying to its careful preparation and to the able way in which President Schwartz handled the proceedings. The deep, underlying note of it was belief in Brown and Brown's progress; and though there was some verbal crepe hanging, as one visitor forcefully expressed it afterward, the opinion is that the note of healthy optimism made a genuine and prevailing impression.

The outstanding acts of the Council were to adopt a more definite plan of procedure with regard to the nomination of Alumni Trustees than has been the rule heretofore; to approve the report of the committee on the transfer of the Alumni Monthly to the Associated Alumni in May; to change the name of the Brown Alumni Loyalty Fund to the Brown Alumni Fund; and to nominate candidates for Alumni Trustee, member of the Athletic Council and officers of the association.

Before the Council was called to order by President Schwartz, the Executive Committee held a short meeting. Then the Board of Directors met to hear the reports of the commit-

tees on the Alumni Monthly and on the agreement between the Associated Alumni and the Corporation with regard to the nomination of Alumni Trustees, and to approve the acts of the Executive Committee during the year. After supper, at which the association was host, and next morning, the roll call brought the following responses:

The Alumni Secretary reported that he had heard from every club and from every member of the Council, with two exceptions. Three members were unable to attend because of illness.

Evening Session

In his opening remarks, President Schwartz described briefly the work of the Executive Committee, the meeting of the Board of Directors in New York the night before the Brown-Princeton football game, and told the story of the work in connection with the Alumni Monthly, the Regional Plan and the Loyalty Fund. He read a letter from the Advisory and Executive Committee of the Corporation expressing "appreciation of the progress which has been made by the Advisory Council of the Associated Alumni in its consideration of the problems of the University and of its contribution toward their solution." He read, also, a letter from President Barbour, announcing the appointment of Dr. H. C. Bumpus as alumni relations officer and introduced Dr. Bumpus as the first speaker.

Dr. Bumpus spoke intimately of affairs at the University. He dealt with University personnel, the student body and the question of raising the quality of that body, and the gradual strengthening of the Faculty under Dr. Mead's direction. He illustrated by a graph the scholastic standing of the undergraduates after the last semester examinations, and there was great interest in his figures and his comments. He closed with the statement that the Faculty had more to do with the policy of Brown than the

Corporation had, and that the alumni would do well to tie up more closely with the Alumni Trustees.

Dean Arnold, speaking on "Undergraduate Affairs," paid high tribute to the late Dean Mason and to Dean Emeritus Randall. He praised the work being done by Professor Currier, acting director of admissions, and discussed frankly some of the problems confronting him as Dean. He said: "Brown knows where she is going. And her standards are improving. The fact is, as we improve our material, we tend to raise our standards." He referred to the low standing of the fraternities and added that there were three objectives on which there could be hearty agreement: (1) Improvement of the student body. (2) Raising the morale of the student body. (3) The betterment of scholarship, particularly fraternity scholarship.

Prof. Robert H. George of the Department of History, with "The Faculty" as his topic, said that he would point out "what is right with Brown." He held that there was a better spirit, a better feeling among the Faculty and among the students than there had been for many years. He felt that the relations between Faculty and students were more friendly than they were at many of the colleges in the East, and he gave statements to clinch the point. He cited the close contact between the administrative officers and members of the Faculty and ended with the comment that in the development of interest on the part of the students in things academic "there is a leaven working that is bound to get results."

Paul A. M. Snyder, president of the Cammarian Club, and Robert V. Cronan, editor-in-chief of the Brown Daily Herald, discussing "Undergraduate Viewpoints," made a fine impression. Mr. Snyder spoke of the affection of the students for President Barbour, praised Dean Arnold for his fairness, and discussed topics of present interest to the undergraduates—busses to the new gymnasium, chapel and convocations, and publicity. Mr. Cronan commended the report of the Committee on Survey, asserted that the new Brown curriculum would em-

phasize the individual, held that at Brown there was a proper relation between athletics and other phases of college life, and pointed out the two mediums by which people might know more about Brown—through the alumni and through publicity. He asked for a publicity bureau on a sound, modern basis.

After the Alumni Secretary had read his report, which is printed elsewhere in the Alumni Monthly, President Schwartz called upon Clinton C. White to make report of the work done by Mr. White's committee to develop a more definite plan of procedure on the part of the alumni in their selection of nominees for Alumni Trustee vacancies. Mr. White, after explaining that the report had been read to the Board of Directors in full and had been approved, sketched the high lights of it and offered the following vote:

"That the Advisory Council in session February 22, 1931, recommend to the Corporation of Brown University, that the Arrangements for Election of Alumni Trustees as Agreed Upon October 15, 1920, and Adopted by the Corporation be amended to provide 'that each Alumni Trustee will resign at the sixth annual meeting of the Corporation after the Commencement Day on which he was nominated, his resignation to take effect' upon adjournment of the June meeting of the Corporation following the next Commencement Day; that this provision apply to present incumbents as well as to future appointees; and further that the Secretary of the Associated Alumni in transmitting this recommendation to the Secretary of the Corporation advise why recommendation is made and also that he file with the Secretary of the Corporation copy of Report of Committee on Election of Alumni Trustees."

The main object of this vote is to enable an Alumni Trustee whose term is expiring to attend the meeting of the Corporation the day after Commencement. He cannot do so under a strict interpretation of the present agreement. The vote offered by Mr. White was passed unanimously.

The Alumni Secretary then read the list of Alumni Trustee nomina-

tions approved by the Executive Committee as a nominating committee, and the list of nominations for the Athletic Council. After President Schwartz said that the balloting would take place next morning, there was discussion and endorsement of each candidate by members of the Council. Alexander Graham spoke on behalf of John C. Hennessy '10 as a candidate for the Athletic Council. It was agreed that the Executive Committee should consider the question of adding Mr. Hennessy's name to the list. The Council adjourned at 10:25, and the out-of-town members were taken care of by the Hospitality Committee of the Brown Club of Providence, W. B. Farnsworth, chairman.

Morning Session

With President Barbour present, the morning session was called to order at 9:15. President Schwartz asked for the report of the Committee on the Alumni Monthly, which was given in skeleton form by Henry S. Chafee. President Schwartz complimented the committee for its efficient work and praised the self-sacrificing efforts of Henry R. Palmer, editor, and Professor Currier, business manager, to keep the Alumni Monthly going through the years. He said that Mr. Chafee's committee had the matter of the transfer of the Monthly to the Associated Alumni well in hand and that the association had a great opportunity to make the Alumni Monthly even better than it had been. Mr. Chafee's report was accepted.

Henry G. Clark, chairman of the Loyalty Fund Trustees, told of the appointment of W. B. Farnsworth as secretary of the Fund and discussed in detail the accomplishments and problems of the Fund. After he had spoken of similar funds at other colleges, he offered the following recommendation, which was voted:

"In order to consolidate more completely under one head the various gifts which inure to the University each year from its alumni, the Trustees of the Brown Alumni Loyalty Fund recommend that the name of this Fund be changed to Brown Alumni Fund."

Mr. Farnsworth explained the work already done through Dr. Bumpus's office to develop interest in the Alumni Fund. He also told of the projects undertaken and under way to acquaint the alumni with Brown affairs and to bring the alumni closer to the University. During the discussion, Mr. Graham suggested that the alumni be encouraged to give the Alumni Fund information about gifts to Brown outside the Fund channels.

President Barbour got a hearty reception as President Schwartz introduced him. He dealt in his wholesome way with the topics of chapel, contacts with public groups, contacts in schools, alumni gatherings, size of the student body, geographical distribution of students and the survey, which he again emphasized as one of the important events of Brown history. He was very frank in his comment on the low scholarship of the fraternities and he asked for alumni aid in meeting this problem. He likewise asked the alumni to remember Brown in the matter of the Alumni Fund, and concluded: "In the matter of the student body, in the matter of getting sons of Brown men for Brown, in the matter of interesting boys from homes of education and culture in Brown, and in the matter of finance, I come to you this morning to say that you can render a service beyond all praise."

The Committee on Resolutions, Messrs. MacNair, Allen and Clifford, read resolutions on the approaching

retirement of Prof. Walter Ballou Jacobs, the death of Dean Kenneth O. Mason and the work of Henry R. Palmer as editor of the Alumni Monthly, and letters felicitating Dr. A. D. Mead, vice president of the University, and Dr. W. W. Keen '59, of Philadelphia, the oldest living graduate of Brown in point of class.

The reports of the Regional Vice Presidents followed. They were given by C. Henry Smith for the Western District; Thomas P. Appleget for the Atlantic Midland District; Dr. Edwin A. Locke for the New England District; and Alfred B. Lemon for the Rhode Island District. The Secretary read the report of Sherman M. Strong '15 of the Central District, and the President read a letter from E. A. Adams '12 of the Western District, giving account of the work he was doing to bring the alumni nearer together in the wide western spaces. Mr. Smith's talk was of real interest; and Mr. Lemon's rapid-fire survey of the work of the Brown Club of Providence was closely followed. So was Mr. Appleget's summary of the doings of the clubs in the Atlantic-Midland District. Mr. Graham described the revival of interest in the Brown Club in New York and praised the excellent work of President O'Brien. Messrs. Forster, Josselyn, Stockwell also spoke.

Then the balloting began, the Council nominating three candidates for the Alumni Trustee vacancy (the names are not published until the qualifications are approved by the Cor-

poration committee on vacancies) and three candidates for the Athletic Council vacancy, namely, George S. Burgess, '12, Mian Gulian '23 and John C. Hennessy '10. It also named Dr. Edwin A. Locke '96 and James S. Allen '98 as candidates for president of the Associated Alumni, and E. K. Aldrich, Jr., '02 to succeed himself as treasurer. The following Trustees of the Alumni Fund were elected: Chester A. Cook '91, and Dennis F. O'Brien '98, two years; Henry G. Clark '07 and Thomas B. Appleget '17, three years; Dr. H. C. Bumpus '84 and Hunter S. Marston '08, four years. For directors-at-large on the Board of Directors, Wardwell C. Leonard '18, Wiley H. Marble '12 and Victor A. Schwartz '07 were chosen. Their terms will begin in September.

The Council thanked President Schwartz and other officers for their work, and expressed its appreciation of the thoughtfulness of the Brown Club of Providence in providing hospitality for out-of-town members. Prof. George Grafton Wilson, commending the survey, said that Brown was the only university in the United States willing to have everything exposed to public investigation, and he felt that this attitude was one in which every Brown man and every friend of Brown could take pride. President Schwartz, in his brief farewell, said that it was heartening to have so many clubs represented and such interest shown in the affairs of the alumni and of the University.

Report of the Alumni Secretary To the Advisory Council

February 22, 1931.

Gentlemen: I have the honor to submit my ninth annual report as Alumni Secretary.

The year has seen two important changes. One is the adoption of the Regional Plan, first proposed at Chicago in 1929, and approved by the Associated Alumni in June, 1930. The other is the relief of the Alumni Sec-

retary as Secretary of the Loyalty Fund. This also took place last June.

The work of putting the Regional Plan into effect began immediately after Commencement. Active Brown Club leaders in each of the five regions, or districts, were asked to call special meetings to elect a vice president and two regional directors. Organization was practically complete

when the new Board of Directors met in New York the night before the Brown-Princeton football game to choose an executive committee and discuss ways of bringing the Alumni and the University into closer touch.

The Regional Plan has added to the work of the Alumni Office. It has increased correspondence. It has meant preparing and mailing to each member of the Board of Directors a

copy of the minutes of the meetings of the Executive Committee. It has meant more lists of alumni to run off on the addressing machine or to copy on the typewriter in special instances. And all of this extra work has been done in the face of the fact that since last October the Alumni Office has not had the valuable occasional aid of the assistant secretary of the Loyalty Fund, who is giving her whole time exclusively to the Fund.

The Regional Plan is a sound one. It will succeed if the vice presidents and the regional directors will study the Constitution, learn the objectives clearly set forth therein, and go to work. As some of them already know, they can have the help of the Alumni Office in anything of a constructive nature that they may start. After the preliminary details, the initiative must be largely theirs. Otherwise one may be doubtful of the interest in the work to be done.

Alumni Records

The number of alumni and former students is growing fast. During the year, 2,210 new stencils have been ordered. A new stencil means a change of address; and a change of address means that the change must be typed on three separate cards, alphabetical, class and geographical. What with the regular work of the Alumni Office and the activity of Dr. Bumpus's new office, the circulation of the whole body of alumni and former students is becoming more frequent. Each circulation spells more work than one secretary-stenographer-typist, no matter how energetic and efficient, can do.

There is real need for another assistant in the Alumni Office. I recommend that an assistant be engaged for the year beginning July 1, next. This individual could do much of the necessary typing, aid in filing clippings and be useful in other ways.

The Alumni Office records are in daily use. Alumni unfamiliar with the work of the office do not realize the requests made to the office. Writers for the Dictionary of National Biography are asking regularly for material. So are the Congressional Library, historical societies and genealogists. Lists for checking come in

from the Athletic Office, the Brown Clubs, the Brown Union, and other centres of Brown activities. It is the practice of the office to answer cheerfully and as quickly as possible all reasonable and legitimate requests.

In other days preparation of the necrology was done by one or more members of the Faculty. In recent years this work has been performed solely by the Alumni Office. It is becoming a major task in itself that requires time, painstaking care and patience. All reports of deaths are checked carefully and followed up with consideration and tact.

Academic Publicity

According to recent definition, one of the duties of the Alumni Secretary is "cooperation in Brown University academic publicity but not its direction." This means that the actual work continues to be done by the Alumni Secretary. The most important piece of publicity during the year was the story of the report of the Committee on Survey. Given a copy of the report a week in advance of its publication, I made a digest of it which met the hearty approval of my co-workers, Professor James P. Adams and Dean Arnold, and sent this digest to fifty leading newspapers. Copies were mailed also to educational papers and to editorial writers. The result was altogether pleasing to the University authorities.

Not long ago I heard it said that the mechanics of getting wide newspaper publicity do not count. As a newspaper man who has been through the mill I maintain that they do count and that to observe them seriously will give Brown the kind of publicity that the alumni want the college to have.

For the visit of Dr. Mead, Dean Arnold and Professor Adams to the Middle West during the Christmas recess, I sent advance stories to the club secretaries in Cleveland, Chicago and Detroit for distribution to the newspapers of those cities. Everett Marten in Cleveland did an excellent job. The results in the other cities were less apparent. Secretaries can be of actual service by going to city editors in person with stories sent

them. They will find that city editors are not as hard-boiled as dramatists make them. And they will be putting the name of Brown forward in a thoroughly legitimate way.

The Alumni Secretary writes the advertisements and the advance stories for all lectures of a public nature on the Hill, handles the publicity for the extension courses, supplies news to the Brown Daily Herald and aids the Herald staff in mailing to preparatory and high schools the post cards which report achievements at Brown of graduates of those schools. On receipt of one of these cards last month the head master of a private school in Maryland wrote: "Your idea is a splendid one. We appreciate it tremendously."

Besides the story of the report of the Committee on Survey, the press associations have received and sent out stories about the centennial of Rhode Island Alpha, Phi Beta Kappa, the Kendall K. Smith and Michael J. Lynch Scholarships, appointments of new members of the Faculty and similar academic material. The facts from which W. O. McGeehan of the New York Herald-Tribune last fall wrote his syndicated story about Brown were supplied by the Alumni Secretary.

To Robert V. Cronan, editor-in-chief of the Brown Daily Herald, is due most of the excellent sports publicity from Providence that has appeared in the New York World and The Sun in the past year. Mr. Cronan has collaborated with the Alumni Secretary in sending out stories to home town newspapers about undergraduates and undergraduate affairs, has kept the Press Club alive and has shown an all-around interest and enthusiasm in Brown publicity that compels admiration. He might well receive scholastic credit for the fine extra-curricular work that he is doing for the University.

Another duty of the Alumni Secretary is to furnish alumni notes and news to the Alumni Monthly. I have fulfilled this to the best of my ability and time. I have written each month an average of forty pages about alumni, members of the Faculty and the Brown Clubs. Henry R. Palmer

merits the thanks and praise of every Brown man for his work as editor of the Alumni Monthly since 1900. I hope that the new editor will be as sane in his views and as constructive in his criticism as Mr. Palmer has been through the years.

The Brown Clubs

During the year I have been at meetings of the Brown Clubs of New York, Boston, Providence, New Bedford, Hartford, Springfield, Rochester, the Merrimack Valley, Portland, Me., and New Haven. On two occasions I have been the guest of the Brown Engineering Association and enjoy the pleasure of being an honorary member of the Association. The meeting in New Haven, the first ever attended by President Barbour in that city, was a memorable one. It would be a great thing for Brown if there could be one like it annually in every city in which Brown alumni gather.

Dr. Barbour continues to be an able and willing visitor to alumni groups. He has more engagements than any man I know, yet he always manages to accept a date suggested to him. He is giving appreciated time to alumni matters, at home as well as abroad. I wish it might be possible for him so to arrange his schedule as to visit every Brown centre once a year.

Dr. Mead, Dean Arnold, Dean Richardson, Professor Adams, Professor Horatio Smith, Professor Kenerson and Professor Kraus have been a real aid in carrying the story of the University to the alumni. Dr. Kraus, who went from here to the Pacific Coast for the American Chemical Society, said that he would be willing to speak before Brown groups where it was possible to do so. The upshot was that he met with Brown men in

Pittsburgh, St. Louis, Denver, Los Angeles, Chicago and Akron. He enjoyed the meetings, and the Brown men enjoyed him. At Denver he was met at the train and whisked away to speak before five hundred junior and senior high school students at 8:30 a.m. Of his talk in Los Angeles a correspondent wrote: "It was heartening to hear him so enthusiastic about Brown policies and prospects, especially since, as he said, his opinion is uncolored by sentiment."

Dean Richardson also made a fine impression in Los Angeles and Chicago. The cry of the western alumni is to send more speakers from College Hill. Answer the cry, and it is my belief that the interest of the alumni in the Middle West and Far West will quicken, and the result will be more boys coming to Brown from that part of the United States.

The death of Dean Kenneth O. Mason was a loss to the alumni as well as to the University. Dean Mason knew the alumni. He could talk with them and to them, inspire them and have them cooperate with him to the fullest extent. His frankness was a winning quality; his zest and his friendliness made work with him a joy.

Some of the Brown Clubs ask for one or more letters a year from the Alumni Secretary so that they may have the latest news from the Hill. These letters are written willingly. They will be sent to any club or group at any time. They could be developed very easily into a bulletin which would give the luncheon groups in New York and Chicago in particular an incentive to get together.

Other Activities

The Alumni Office still tries to do

what it can to help Seniors and young alumni find employment. In the survey report one of the items "related to further developments under consideration" is the organization and operation of a placement bureau. Until such a bureau is established, the Alumni Office will presumably carry on, accepting praise and blame alike and trying to keep everybody, Seniors and visiting personnel men, interested and hopeful.

Last May I represented Brown at the 17th annual conference of the American Alumni Council at Amherst, and in October I attended at Williams the yearly meeting of District One of the Council, which includes New England and the Maritime Provinces. Miss Himes, Keeper of the Graduate Records, visited Yale last fall to study the way in which the Yale alumni records are kept. Her interest and loyalty remain high, but, as I said earlier, the work is becoming too heavy for one woman to do alone. Miss Nickerson gave efficient assistance until she was taken over for full time on the Loyalty Fund.

Present plans call for a set of offices for the Associated Alumni in the new part of Faunce House. The eight years that I have been in the present offices in the John Hay Library have been mostly pleasant ones. In none of them, certainly, have I had more earnest and constant support from the officers than President Schwartz and the members of the Executive Committee have given me during their terms, and especially in this last year.

Newport

President Barbour and the Rev. Dr. Arthur Rogers '86, lately returned to Rhode Island after years spent in the Middle West, conspired to give zest and interest to the annual meeting and dinner of the Brown Club of Newport, held at the La Forge Cot-

Whitaker put both time and energy into the arrangements, and the Alumni Office is grateful for his work. So are President Barbour and Mr. Farnsworth. President Barbour in his talk outlined the needs of the University and gave graphic account of what is being done to develop the Faculty, the undergraduate body, and to raise the standards of scholarship and build a stronger Brown in every respect. Mr. Farnsworth described the work being done to bring alumni and the University closer together. M. Louis B. Sweatt '98 presided.

Connecticut Valley

Under the guidance of Elliot H. Bosworth '16, president, and Ralph A. Armstrong '17, secretary, the annual meeting and dinner of the Connecticut Valley Brown Club at the Hotel Stonehaven, Springfield, Mass., Feb. 27, was a successful one in every respect. Excellent talks by Dean Arnold and Professor James P. Adams on academic subjects and Paul F. Mackesey '32, captain of the football team for next fall on football prospects; good singing with Harold A. Rice '14 as leader and Burpee Shaw '28n at the piano; and introductions all around at the beginning contributed to a happy evening. There were also short talks by the Alumni Secretary and W. B. Farnsworth '17, secretary of the Alumni Fund.

Wesley E. Monk '96 was elected president of the club for the current year, with Ralph C. Richards '17 as vice president and Ralph Armstrong as secretary-treasurer. Boston

New York

The number attending the luncheons ranges from 45 to a hundred. Prominent speakers have included President Barbour and President George B. Cullen of Colgate.

The New York club has made arrangements with the Hotel Wentworth, which is owned and operated by Brown men, for special rates for out-of-town Brunonians. The club has the advantage of having quarters with use of the complete facilities of a modern hotel. The Wentworth is right in the centre of things. The club has become so popular now that you can have lunch or dinner at the

Wentworth any day and find a group of Brown men either in one of the dining rooms or in the club itself.

For some time past the club has been giving earnest attention to employment and is glad to report that it has been able to help a considerable number of Brunonians make fruitful contacts in these difficult times. The club has put out a bulletin urging Brown men in the district to advise of present or prospective openings for men who will be graduated in June.

On March 14 the Board of Governors graciously turned over the club quarters to the Brown Alumnae Club of New York, which gave a tea on that day in honor of President Barbour. The annual concert and dance was put on this year at the Ritz-Carlton. And there must be a word (more, we hope, in the next number of the Monthly) of the dinner party held March 18 at the American Museum of Natural History under the joint auspices of the Brown Club of New York and the Brown Engineering Association. It was a genuinely enjoyable affair.

Rochester

Rev. Dr. Antonio Mangano '99 of the Faculty of the Colgate-Rochester Divinity School, who will go back to his old pastorate in Brooklyn, N. Y., in a short time, gave an interesting account of the work and conditions at the church and the community centre, which is part of it, at the luncheon of the Brown Club of Rochester on March 4. Regret was expressed that there was no report of the meeting of the Advisory Council, at which the club had been represented regularly until this year. Some of the members of the club enjoyed seeing "Daddy Jim" Coombs '97, when Coombs was in Rochester with Roxy and his gang.

New Haven

Brown men from western Connecticut met at the Union League Club, New Haven, for the annual dinner of the Brown Club of New Haven on

Monday, March 2; and they certainly showed that the club is on the Brown map in capital letters. There is a great spirit prevalent in the shadow of Yale; and it is always a pleasure to go to New Haven, to meet the alumni and to enjoy the hospitality of Louis F. Horvath, manager of the Union League Club and honorary member of the Brown group. The speakers at the dinner were President Barbour, Judge John L. Gilson, Yale '99, president of the Union League Club, Leon Whitney of the Eugenics Society, and the Alumni Secretary. Harry R. Westcott '11, introduced by Victor A. Hedberg, Jr., '22, president, was again the felicitous toastmaster; and the singing was first rate. Altogether a lively and enlivening evening.

Judge Gilson prefaced his remarks with some local history of absorbing interest. The spot on which the Union League Club stood, he said, was where Roger Sherman's house stood in colonial days. And it was in Roger Sherman's house in March, 1775, that the Second Company of the Governor's Foot Guards was formed. He recounted the famous names on the roster of the company and gave a vivid picture of those days of import to the colonists. "The patriots who met here on that night in 1775," he said, "left us a heritage which we must follow and live up to as Brown men and as Yale men."

President Barbour told the story of Brown as he has known it since he came to College Hill in June, 1929. In commenting on the survey, he said significantly: "We know exactly what we want. We know where we are going and what we are doing." He described the progress on Faunce House, spoke of the pressing need of an infirmary and an addition to the John Hay Library, and discussed Faculty changes and undergraduate scholarship. He paid his tribute to the growth of Yale and said: "Every good thing that comes to Yale—and Harvard, too—helps us."

John Russell Gladding, business man and sportsman and friend of all

members of the class, died suddenly at the Jane Brown Memorial Hospital, Providence, on March 7, 1931. He was born in Providence, June 8,

1858, the son of Samuel and Nancy Boradel (Williams) Gladding. He prepared at the Providence High School, where he took the classical course; and since his graduation he had been engaged actively in business in Providence. His fraternal connections were with the Knights of Pythias and the Odd Fellows, in both of which lodges he held high offices. He was married May 21, 1873, to Martha Emily Lawton, who died in 1917. He is survived by one son, Robert L. Bowen '02. Bowen was a loyal alumnus and a fine type of gentleman of the old school.

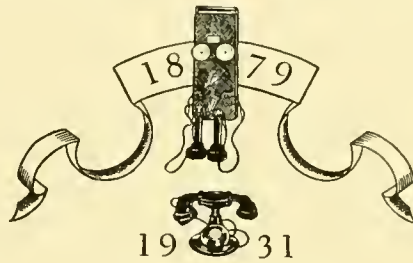

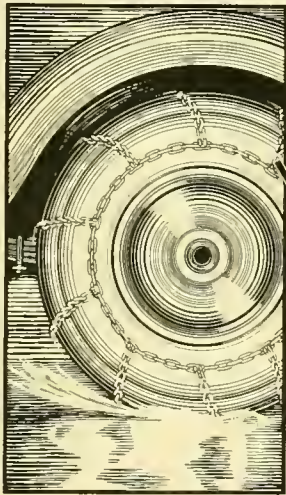
