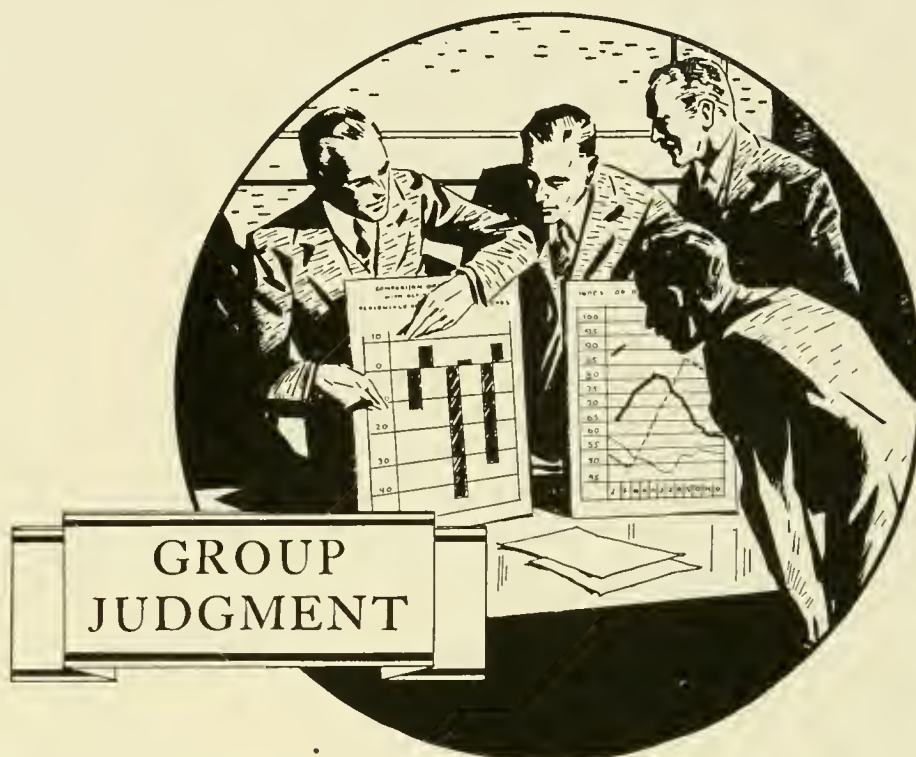

The University's 167th Commencement

DIPLOMA in hand, the Class of 1935 has gone into the world with Brown University's voucher that they are educated men all. The University's 167th annual Commencement is over, her sons have returned to their homes inspired anew by the associations under the elms, and a summer's peace has invaded the campus once again.

It was a good Commencement, the alumni seemed to agree. On Class Night the campus had never looked lovelier, with a full moon and other appropriate decorations enhanced by the particularly rich foliage of this year. It was a gay evening, for all its touch of sadness to the Seniors, and a bright picture many hearts will preserve.

For the reunions alumni from amazingly great distances joined with others nearer at hand with such a readiness as almost to hint of better times abroad. For Brunoniâns who could not return, there was the link with the campus over the radio, which through 85 stations of a national hook-up brought the choicest of the Sayles Hall messages. The Commencement procession was reported by observing journalists to be the longest in many years, partly due to the mustering of appreciable delegations from the younger classes. On all sides loyalties seemed stronger.

IN addition to awarding baccalaureate degrees for 241 men and 106 women in the class of 1935 on June 17, Brown summoned to the historic First Baptist Meeting House 11 men on whom she conferred honorary degrees for their eminence in their chosen fields. They were:

Richard Aldrich of New York, music critic for the *New York Times*, Master of Arts.

Charles E. Goodspeed of Boston, historian, antiquarian and specialist on rare and early editions, friend of the John Hay and John Carter Brown libraries, Master of Arts.

Royal B. Farnum of Providence, educational director of the Rhode Island School of Design, Doctor of Art.

Rev. Eugene C. Carder '07 of New York, associate pastor of The Riverside Church, Doctor of Divinity.

Rev. John A. Foote '09, missionary and educational leader in Japan for the American Baptist Mission Society, Doctor of Divinity.

Dr. Henry J. Cody of Toronto, Canada, president of the University of Toronto, Doctor of Laws.

Prof. Walter G. Everett '85, of Providence, professor-emeritus of philosophy at Brown University, Doctor of Laws.

Dr. John Hope '94, of Atlanta, Ga., president of Atlanta University, Doctor of Laws.

Dr. Arthur H. Compton of Chicago, professor of physics at The University of Chicago and 1927 Nobel Prize winner, Doctor of Science.

Dr. Ernest E. Tyzzer '97 of Wakefield, Mass., professor of comparative pathology at Harvard University, Doctor of Science.

Dr. John H. Williams '12 of Cambridge, Mass., professor of economics at Harvard University and economist for the Federal Reserve Bank of New York, Doctor of Science.

IN addition, the University signally honored Dr. Charles V. Chapin '76, superintendent of health of the city of Providence for nearly half a century and world famous for his contributions to the science of public health, by awarding him the Susan Colver Rosenberger Medal in recognition of his distinguished service to humanity.

The award, the highest in the University's power, has been bestowed only three times heretofore: on the late Dr. W. W. Keen '59, on Chief Justice Charles Evans Hughes '81, and on John D. Rockefeller, Jr., '97. When President Barbour read the citation of Dr. Chapin's career, the congregation in the meeting house broke into a prolonged storm of applause, standing the while. Dr. Chapin was visibly affected as he walked to the dais where he had received his Bachelor of Arts degree 59 years before.

The University's striking fortune with regard to weather held again as the alumni formed on the Middle Campus for their annual descent of the Hill. They were marshalled by Clinton C. White '00, singled out for this distinction on the 35th anniversary of his graduation. Martin S. Fanning '91 was again Chief of Staff, with the following Aides to the Chief Marshal: Archibald C. Matteson '93, John D. E. Jones '93, Byron S. Watson '97, John A. Gammons '98, E. Tudor Gross '01, Fred A. Otis '03, Chauncey E. Wheeler '09, Frederick A. Ballou, Jr. '16, Dennison W. Greene '24, Kent F. Matteson '28.

CHANGES indicative of Rhode Island's "bloodless revolution" in politics were to be seen in the presence of Philip E. Quinn, the new High Sheriff, who supplanted that fixture of 200 Commencements, Jonathan Andrews. New, too, were most of the faces of the Judges of the Courts. The American Band was once more one of the two organizations which furnished the traditional music of the Commencement March. Martin S. Smith '67 was the oldest grad in line, continuing his record of not having missed a Commencement since 1871 when he was in Montana.

ALUMNI and other friends of Brown crowded Sayles Hall for the annual Commencement meeting at which President Henry J. Cody of the University of Toronto and Arthur H. Compton, Nobel prize-winner and cosmic-ray investigator, were the principal speakers. The new alumni of the class of 1935 were welcomed by their seniors, and many of the afternoon's remarks were addressed to them.

Rev. M. Joseph Twomey '00 was witty and graceful as the presiding officer, while Governor Theodore Francis Green '87 and President Barbour were other speakers. Also on the platform were Vice President Mead, Chancellor Sharpe, and Henry S. Chafee '09, retiring President of the Associated Alumni. Among the ovations was that accorded Professor Walter G. Everett, whose entrance was applauded in token of the 50th anniversary of his graduation and of his honorary doctorship received that morning.

Just returned from a year at Oxford, Dr. Compton chose to contrast that medieval college town with the highly mechanistic Chicago which is his home. He said he was daring to say things he would not dare in either of those communities.

Major interests of mankind will dwell less and less on science and technology, he asserted, and other American universities must look to the East for spiritual leadership. The eastern ideal of education represented by Oxford and the extreme American development of culture "are approaching by different routes toward the more satisfactory adjustment of life to a world in which man, using the tools of science, is empowered to shape his worlds as he will." "Our Chicagos," he said, "must look for spiritual leadership to universities whose men are themselves a part of the machine age, but have learned to take into their own lives the legacies transmitted by old cultures. . . . If the severity of the demands of mechanized life are not felt quite so strongly along the Atlantic coast, the great educational institutions there located have the advantage of a closer contact with the legacy of Europe." Brown men interpreted his remarks in this vein as distinctly complimentary to their Alma Mater.

DR. CODY also stressed the spiritual and cultural functions of a university. He reminded Brown men of their University's history and its liberal, classical traditions. "As one of the oldest institutions in western civilization, the university," he said, "is not a seat of self-centered culture but a place where knowledge, culture, wisdom, and discipline are prepared for the service of mankind." In speaking of true patriotism, he made a plea for still closer friendship between the British Empire and the United States in the cause of peace.

In his brief remarks Governor Green acknowledged the dedication of the 1935 *Liber* to him and emphasized the need of a non-political staff of college-trained bureaucrats in government today.

Following the Sayles Hall meeting the administration officers tendered an informal reception to the recipients of honorary degrees and other guests of the University.

Commencement ended with the President's Reception in Alumnae Hall, with hundreds of friends of Brown attending. In the receiving line were President and Mrs. Barbour, Vice-President and Mrs. Mead, Vice-President and Mrs. Adams, and Dean Morriss. Fred B. Perkins '19 was head usher. His aides were Roger T. Clapp '19, John W. Haley '19, Mark R. Flather '24, Kent Matteson '28, Louis B. Palmer '28, and Ronald C. Green, Jr. '31.

The Baccalaureate Message

ALIVING FAITH was urged on Brown Seniors at the annual Baccalaureate Service in the First Baptist Meeting House. It was the final counsel given by President Barbour to them as undergraduates, and he warned them against the "blind faith" of dogma. "Religion wants to shut no man's eyes," he said, "its mission is to open them."

"To live a rich, full life," he went on, "a man must make room somewhere in him for a believing heart of trust. . . . The most credulous heart is the unbelieving heart; the only man who is careful about truth, the only man who is rightly cautious about what he accepts, is the man who has a believing heart. It shuts us out from a thousand follies.

"Believe. Believe in your friends, believe in your country, believe in yourself, believe in your God. The believing heart is at the centre of the life of gladness and joy and peace."

ROYAL W. LEITH '12 of Boston is the new president of the Associated Alumni, succeeding Henry S. Chafee '09. His election by the alumni at large was announced at the Alumni Meeting in Sayles Hall Commencement Day, and President Barbour said that Mr. Leith's term would end in June, 1937.

The new president is an investment banker, partner in the firm of Burgess & Leith. He has served as treasurer and vice president of the Brown Club of Boston, as a regional vice president of the Associated Alumni and as a member of the Executive Committee. He is also on the Executive Committee of the Phillips Exeter Alumni of New England. He brings to the office, therefore, a valuable experience.

Branch '07, Boston, former president of the Brown Club of Boston; Rhode Island—Sidney Clifford '15, member of the Executive Committee of the Associated Alumni and former president of the Brown Club of Providence; Atlantic-Midland—Hunter S. Marston '08, New York City, retiring president of the Brown University Club in New York; Central—Ralph G. Johnson '05, who has been a leader in the Brown Club of Chicago; and Western—Edward A. Adams '12, president of the Brown Club of Los Angeles.

The new directors are James S. Eastham '18, Andover, Mass.; Edward T. Richards '27, Providence; Theodore W. Gordon '06, Schenectady, N. Y.; R. A. Gillis '15, Cleveland; and Joseph E. Cook '14, Denver.

Henry S. Chafee '09 retired as president of the Associated Alumni at the end of June after having made a noteworthy record of achievement while in office. He will continue active in alumni work as a member of the Executive Committee for 1935-36.

In one of the closest elections in history, George S. Burgess '12 was named by the alumni last month to take the place of William C. Giles '11 on the Brown University Athletic Council as alumni member. Thus Mr. Burgess returns to the Council on which he served from 1931 to 1933.

The Fourth Generation Elected

JOHN NICHOLAS BROWN of Providence was elected a member of the Board of Fellows of Brown University at the meeting of the Corporation on June 18. Mr. Brown has been a member of the Board of Trustees of Brown University since 1930 and relinquished his membership in the Board of Trustees upon his election to the Board of Fellows.

Mr. Brown is the fourth member of his direct line to serve as a member of the Corporation of Brown University. His great great grandfather, Nicholas Brown, was one of the incorporators of the College in 1764 until his death in 1791. His great grandfather, Nicholas Brown, a member of the Class of 1786, served as a member of the Board of Trustees from 1791 to 1825 and as a member of the Board of Fellows from 1825 until his death in 1841. He was also Treasurer of the College for 29 years, from 1796 to 1825 and it was in connection with his notable benefactions to the College

At Other Commencements

ON other campuses than their own Brown University alumni played important roles at Commencement time, either as recipients of honorary degrees or as active participants in the exercises.

Dr. Allen K. Krause '01, president of the Desert Sanatorium of Southern Arizona and one of the foremost authorities on tuberculosis in the United States, gave the Commencement address at Norwich University, Northfield, Vt., June 10, and had the honorary degree of Litt.D. conferred upon him. Krause also delivered the oration at Saranac Lake, June 24, at the 50th anniversary celebration of the founding of Dr. Trudeau's sanatorium.

Governor Theodore Francis Green '87, received the honorary degree of LL.D. from Rhode Island State College and Providence College last month. President Raymond G. Bressler of Rhode Island State cited him particularly for his "sincere and tireless work for the cause of higher education as reflected on the campus of the State College."

Rev. Benjamin T. Livingston '97 received the honorary degree of Doctor of Divinity at the Commencement of the Eastern Baptist Theological Seminary in Philadelphia last month. He is spending the summer in Osterville, Mass.

Senator Jesse H. Metcalf was also the recipient of an honorary LL.D. from Providence College, while Yale conferred its accolade upon Rufus M. Jones, University Trustee, with an honorary D.D.

Lieut. Governor Robert E. Quinn '15 of Rhode Island was much in demand last month as speaker at Commencement exercises. His most important out-of-State engagement was the Commencement address to the Senior Class of Manhattan College, New York City.

Rev. Albert C. Thomas, D.D., '08, pastor of the First Baptist Church of Fall River, gave the baccalaureate address at Northeastern University, Providence, Sunday, June 9. His subject was "The Graduate in a Socializing World."

William H. Edwards '19 was elected a member of the Board of Trustees of Vassar College.

Installment Sales Boom

J. ANTON HAGIOS '27, manager of the Credit Management Division of the National Retail Dry Goods Credit Association, in an interview in the *New York Herald* late in May, said there was a tremendous increase in installment sales in stores throughout the country in the last 16 months. "More buying on the deferred payment plan is being done now than even in the boom pre-depression days," he went on, saying that customers with lowered salaries and wages found it "more advantageous to do their purchasing on the part-payment plan."

College—a School's Eye View

THE great majority of prospective college students this year appears to regard a college course as a short-cut to a job, and not necessarily a well paid job, Dr. Bruce M. Bigelow, Director of Admissions at Brown University, said on his return from his last major tour of visiting high and preparatory schools in a score of States.

During his trip, visiting 150 schools from Maine to Missouri, Dr. Bigelow interviewed hundreds of boys who are planning to enter college this fall. The great majority of them, he said, want to start taking specialized courses immediately, and are impatient when told they must, in addition to specialized training, obtain a broad cultural and educational background.

"Boys want to start courses immediately in journalism, foreign trade, medicine or law," Dr. Bigelow said, "and they can't seem to understand the necessity also for taking such subjects as history, literature, art or other courses not definitely within the comparatively narrow scope of their chosen field."

Slightly more boys than in former years are evincing interest in an education which will fit them for politics, Dr. Bigelow said, while a great increase in the number seeking to obtain newspaper positions, attributable in great degree to motion pictures showing the exciting life of fictional reporters, has been noted. The majority, however, want to enter some field of business, with increased interest manifest in aviation, both in the engineering and business ends.

"And in spite of the keen competition for admission to medical schools," Dr. Bigelow said, "there are just as many boys keen to enter this profession. Here again, however, is found the attitude toward specialization in purely pre-medical subjects to the disregard of other courses."

DESPITE "excellent vocational guidance facilities from the junior high schools upward" in most of our cities, Dr. Bigelow said, the average secondary school student has only the most vague idea of the vocation or profession for which he is fitted.

"For instance," Dr. Bigelow said, "a boy may express a preference for engineering simply because he likes to take a carburetor apart, or because he has seen a highly romanticized motion picture version of the life of an engineer commanding the construction of a bridge or building, and incidentally commanding the heart of a Greta Garbo. Such a boy, in many cases, fails to realize that mathematics, for instance, are imperatively necessary."

Vocational guidance in secondary schools should be extended, Dr. Bigelow declared, to include not only the students, but also the parents of the students.

Applications for admission to the Brown freshman class of next fall are about 20 per cent. greater in number than those received up to this time a year ago, Dr. Bigelow said. He said, however, that the percentage of applicants seeking some sort of financial assistance to enable them to carry on their college course is just as great as in former years.

Loyalty in Tangible Form

A Larger Alumni Fund

CONTRIBUTIONS totalling \$17,770.30, an increase of more than \$2000 over 1934, were announced by the Alumni Fund this June, and that sum was transferred to the University at Commencement time, for student aid in the coming academic year. Not only was the amount larger than last year, but the number of individual contributors also mounted, to the satisfaction of the Fund Trustees, who had made a particularly strong appeal during recent months. At the Sayles Hall meeting President Barbour bestowed high praise on these Trustees for their efforts.

Particularly commendable was the work in interesting members of the class of 1935, 201 having already made pledges to the fund for next year. The number is 83 per cent of the class. A new policy of education in alumniship, tried with the seniors this spring for the first time, resulted in this fine record, which alumni in Sayles Hall applauded with delight.

W. G. Meader '05 is chairman of the Alumni Fund Trustees. The others in this hard-working group of volunteers are: Edward K. Aldrich, Jr., '02, President Clarence A. Barbour '88, Henry S. Chafee '09, William B. Farnsworth '17, Charles J. Hill '16, Lawrence Lanpher '23, Hunter S. Marston '08, and Arthur L. Philbrick '03.

The Advisory and Executive Committee of the Corporation passed a resolution expressing its appreciation of "the constructive effort of Mr. W. Granville Meader and his associates of the Alumni Fund Trustees in connection with the Alumni Fund campaign for the present year and particularly in the development of long time plans for the future which will increase the importance of the Alumni Fund as a source of annual income to the University."

While it was the hope of the Alumni Fund Trustees to reach a far larger financial goal, there is some satisfaction in the fact that a larger group of alumni contributed to this Fund this year than did last year. The total number of contributors for the year 1933-34 was 1057 and this year the total number of 1388 or 13.65% of the living alumni, all of whom were solicited through letters sent out from the Alumni Fund headquarters. The gifts of 169 people who gave to the Fund last year, but who have not been heard from this year, have been offset by 548 new contributors who were not on the lists a year ago. The following brief statistics give the highlights of the Alumni Fund as the current year closes:

Amount turned over to the University to June 24, 1935—the sum of \$17,770.30; total number of alumni solicited, 10,163; largest contribution, \$2,500.00; smallest contribution, \$1.00; number of classes solicited, 70 (1864 through 1934); classes having highest percentage of contributors: 1864—100%, 1868—100%, 1879—64%, 1884—65%, 1885—61%. Classes having largest number of contributors: 1907—46, 1912—46, 1902—37, 1909—37, 1898—36, 1916—36, 1925—36. Classes contributing largest total amounts: 1897—\$2,825, 1881—\$737.50, 1894—\$674, 1907—\$511.15, 1898—\$406. Classes having largest number of new contributors whose names were not on the lists last year: 1934—27, 1928—25, 1931—25, 1933—20, 1923—19.

Classes having 100% of members contributing: 1864,

The Fate of College Hill

THE fate of College Hill is a matter of sentimental importance to every Brown man, and it is splendid news that the architectural future of that hill is now assured. Through the benefaction of Stephen O. Metcalf '78 and his children, the Rhode Island School of Design is to have a new building which will flank the hill, climbing in steps all the way from Market Square to Benefit Street and enhancing the beauty of its neighborhood in no mean fashion.

According to the architect's plans existing buildings in the block to which most historical sentiment attaches will be preserved. For example, the old Franklin Hotel on Market Square, landmark of the 1820's, will be incorporated in the new; and they will retain the old archway through which the stage-coaches used to enter the courtyard at the end of their day's journey from Boston.

The architect has further sought to make the new building a good companion, by faithfully reflecting the architectural spirit of its neighborhood. Its treatment will be sympathetic with the new Georgian style Providence County Courthouse, whose architects, Jackson, Robertson and Adams of Providence, also have the new School of Design commission.

The Athenæum and the Beckwith House, home of the Handicraft Club, are other notable members of the College Hill community. With the Beckwith House the upper part of the new School of Design structure will harmonize, even to the extent of having a monitor style roof like that on the venerable mansion.

Tradition says that the old residence of President Manning of Brown is one of the row on College Hill to be affected by the new construction. Frederick T. Guild '90, Registrar of Brown; Norman M. Isham '86, eminent antiquarian; and others are at the moment engaged in research destined to identify this building more adequately. If this house, said to be the third down from Benefit Street, is the one, it was the scene of many a University function in the early days of Brown. Anything of historical or sentimental value will be salvaged from the building.

Brunonia Plays the Game

BRIGHT spots and sombre ones will be obvious to the alumnus who looks back at the record of Brunonians in athletics during the year just filed away. In some instances there was "normal expectancy," while disappointment attended others; there were unprecedented depths and heights as well.

In an even 200 contests, varsity and freshman, 557 players took part in 26 sports. Allowing for duplication there were 341 actual participants, the second highest total in Brown history. The balance of victory was slightly in the Bear's favor, since 98 victories matched 95 defeats. The varsity won 58, lost 56; the first year teams won 40, lost 39.

Freshman tennis was conspicuous in winning each of its engagements, while only a single defeat prevented a perfect record in varsity soccer, varsity fencing, freshman golf, and freshman track (indoors and outdoors). The varsity basketball quintet, probably the best on any Brown court, had the outstanding season, next to soccer. Varsity baseball lived up to little of its early season promise, losing nine of its last ten games. Grand stand quarterbacks found little satisfaction in the football schedule until the Colgate game, and varsity track and freshman lacrosse had no victory to reward their hard work. The swimming team added another New England Intercollegiate championship to its sequence, and there was other success in similar intercollegiate and open meets.

JOE NUTTER '24, director of athletic publicity, recalled some of the high spots in one of his good stories, as follows:

"Quite aside from statistics were certain events that stand out ahead of all others. The stand of a much-beaten football eleven against Colgate in the final encounter; the driving finish of the swimming team on the strength of Fred Lee's anchor leg on the relay to defeat Dartmouth; the varsity nine's stirring victory over the Intercollegiate League title nine, Dartmouth; the sustained drive of the varsity soccer team playing its first schedule in the newly organized N. E. Intercollegiate Soccer League; the work of a crippled varsity wrestling team that could muster fight enough to tie Army, and the strong finish of a hockey team that was buffeted by fate, were incidents that rise as highpoints in the year.

"In many respects the victory over Dartmouth in swimming by a single point is the most single monumental effort of the year. No person who witnessed Capt. Fred Lee's surge through the 100 yards of his anchor leg in 51 seconds to tie the great Green swimmer, Crouse, will ever forget that bit of individual excellence that turned impending defeat to victory.

"And the stirring team stand of the varsity basketball team, with the great individual work of Kenneth Kennedy, was another epoch-marker of the year. (Nutter might have cited the extraordinarily good scholarship of this squad, which lost no one through ineligibility.)

"It has been a year of no untoward incidents at a time when intercollegiate sport in general has been confronted with problems that rival anything in the long period of its existence. Financial support has been withdrawn from the golf teams, but both carried on with characteristic Bruin spirit. In general, the average both in the records of contests and the number of participants bespeaks the sound manner in which every unit of the Brown sports organization is

moving along. The undergraduates are not lessening their interest in any phase of the sports program."

Loss of their batting eye and their keenness in the field brought a complete reversal of form for the baseball players, who had won eight of their first eleven contests, including one with a Dartmouth nine that went on to win the Eastern Intercollegiate championship.

At Yale the team saw their early lead slip away in the eighth inning when two close decisions and balk-caller Skelly contributed to a four-run rally. Frankie Brown's homer and Captain Slader's triple had figured in a three-run splurge for the Bruins in the fourth, and the final score was Yale 6, Brown 4.

A solitary run in their first time at bat gave Colby's tourists a slim victory. Brown could get but three hits during the afternoon, and tried hard to come through in the ninth. She filled the bases, but crippled Appleyard couldn't run out what would ordinarily have been a hit.

The Brunonians made more errors than they did hits against Harvard in the traditional Memorial Day encounter. There were six miscues in the field. At bat Brown had only one safe hit aside from a fourth inning rally in which three successive singles went for naught. Harvard, a 3-0 winner, did all its scoring in the sixth inning, starting when the Brunonian catcher dropped the ball at the plate. The return game in Cambridge in June also went to the Crimson, this time by a 5-2 score. Brown, having lost an initial lead, filled the bases in the seventh with none out, scored once on a base on balls and then saw three batsmen fan.

THE team seemed to recover its batting power against Tufts, winning 5-0 while Bob Dye was receiving splendid support and granting only three hits. Butler got three hits of Brown's eleven.

The extra-inning game with Virginia was a thriller, marked by heavy hitting. The Bruins tied the score with four runs in the ninth only to lose 12-8 in the 13th. Brown, Butler, Henshaw, and O'Reilly were Brown's best hitters that day, but three pitchers were as generous to the Cavaliers.

Holy Cross had an easier game than it did in the first meeting in Worcester, although Brown looked strong at the start. Her one run came in the first inning on Elrod's triple. A strange second inning changed the complexion, however, when the Purple's turn at bat included a presentation, a home run in response, a 30-minute thunder shower and three runs. Brown retaliated by filling the bases with none out, but there were no runs. From that point Brown didn't threaten until the seventh when she filled the bases after two were out. Twice in Holy Cross games Charlie Butler has come to bat in just such a situation and twice knocked home runs. This time his hard hit seemed about to triplicate the stunt, only to be robbed by a spectacular catch deep in center field. "Mud" Hart celebrated his last college game by handling eight put-outs in left field.

Ambrose Murray, ace of the pitching staff, lost some heart-breaking games in the latter half of the schedule. He gave Colby only six hits, Harvard five in one game and eight in the other, striking out 11 batters in the last of these. He will have another year when his team-mates may give him more help.

While the catching post remained weak all season, Coach Kelleher finally seemed to find a capable shortstop after making two other unsuccessful experiments. Burbank, his choice in the last four games, played errorless ball and got seven hits, including three against Holy Cross. By graduation the team loses one outfielder, Henry C. Hart, Jr., two infield alternates, Henshaw and Levinson, and Captain Slader, pitcher and outfielder.

In track only three seniors were graduated: Captain Bernard Lewis, whose injuries kept him on the sidelines this year; Mayhew, miler; and Harry Spinney, dash man. Three representatives in the New England Intercollegiates placed Brown about midway in the field of 20, and Spinney probably could have added material to the total of 6 1/3 points. Pearce was third in the 880 after winning his qualifying heat, Burgess took fourth in the javelin after placing higher in the preliminaries, and McShane tied for top honors in the pole vault at 12 feet 3/4 inches.

The freshmen closed a good season by beating New Hampshire freshmen 77 1/2 to 48 1/2. Singen brought in 21 points, with firsts in high and low hurdles and broad jump, a tie for first in the high jump, and a second in the javelin. Syren set a new Brown freshman record by racing the mile in 4:35. It was the second time he had run the event. The first-year squad lost only to the strong Rhode Island State contingent, beating Worcester Academy and M. I. T. freshmen.

Two drubbings from Springfield ended the lacrosse year. The freshmen, with only two experienced players in the line-up, won no games, but the varsity did well to win two of its seven matches.

While the tennis varsity lost to the skilled clubs from Dartmouth, Harvard, Amherst, and Wesleyan, it acquitted itself well in beating Providence College, Lehigh, Tufts, Holy Cross, and Springfield. The last scores were 9-0 and 6-3. The freshmen went through a six-game schedule undefeated.

Golfers, playing unofficially, had a good season. The freshmen, who lost only one match all spring, beat Andover 7½-1½ and the Brown varsity 4-2. The varsity had the edge on Amherst, while a combined team lost to New Bedford Country Club 6-3. There is real promise of a better varsity next year than Brown has ever had.

Prominent among the stars graduated are Fred M. Lee, captain of swimming and rated Brown's greatest all-around swimmer of all-time; Henry Tolman, 2nd, All-American soccer player; C. Howard Floren, captain of the finest Bear basketball team in years; Joseph J. Lyman, undefeated in New England Intercollegiate diving in three years; Frederick R. Avis, captain, manager and organizer of Brown's fencing team; and Robert B. Chapin, Jr., captain of hockey.

An Upset at the Interscholastics

WITH 45 schools contending for track honors in the 31st annual Brown Interscholastics, New Rochelle upset the predictions on Memorial Day with a hard-earned victory. The closeness of the competition is indicated by the fact that 24 schools shared in the points, and the winner's total of 17½ points was the lowest ever. Worcester Academy was second with 17 and Moses Brown third with 16½.

Glickman of James Madison high in New York established a new Brown field record when he sprinted the 100 in 9.8 seconds. Eric Schwarz of Moses Brown broke the meet's high hurdle mark with a time of 15.2 and saw his record-tying time of 24.6 in the low hurdles disallowed because of the breeze's aid. Blount of Providence Classical tied the broad jump distance at 23 feet, while Dave Wilson of Newark Prep equalled the meet mark of 21.8 in the 220 and Foster of Worcester Academy that of 51 seconds in the quarter-mile.

Behind the three leaders the other schools finished in this order: Roxbury School, Newark Prep, Providence Classical, Brookline, Hope Street of Providence, Trinity School of New York, Dean Academy, Brooklyn Tech, Bulkeley School of New London, Fairhaven High, James Madison, Manual Training of Brooklyn, New Hampton, La Salle of Providence, Bridgeport Central, Burrillville, Rogers of Newport, Warwick, Framingham, Lynn Classical, Wakefield High (Mass.), and the non-scorers: Brown and Nichols, Bridgton Academy, Boston College High, Cranston, East Greenwich Academy, East Providence, Gloucester High, Manchester Central, New Bedford Vocational, Northbridge Central, North Kingstown, Pawtucket, St. Mark's, South Kingstown, Walpole High, Waterman High, Worcester High of Commerce, and Worcester South High.

Tennessee's Forest Checkerboards

JAMES O. HAZARD, '08, State forester of Tennessee, was the subject of a feature article in the *Knoxville Sentinel* one Sunday in May as a result of his plans to develop and improve Tennessee forest lands. "Hazard," the writer said, "is technically trained for the gigantic task ahead of him," and then proceeded to give the fine record in forestry that Hazard (Hap, as most of us remember him on the football field and off) has made since he left the Yale Forestry School. One of Hazard's plans for Tennessee, according to the article, is to "checkerboard the State with 10,000-acre forests, 20 miles apart." He is also arranging for better fire protection, for two thousand miles of woods roads, permanent extension of erosion control work, and intensive development of parks for the public's playgrounds.

Dr. Locke and Williams

DR. EDWIN A. LOCKE, '96, is going to do the thing that he has wanted to do for many years. Next fall he will become director of health, physical education and the athletic program at Williams College. He has accepted this most important post on the Faculty—a post similar to the one Professor F. W. Marvel holds here at Brown—at the personal invitation of Dr. Tyler Dennett, the new President of Williams.

"Dr. Locke," a news statement from Williamstown said, "will be directly responsible to the Administration for the infirmary, the dispensary, physical education activities, and intramural and intercollegiate athletics. . . . He will join the Faculty with full professorial rank."

Since the announcement from Williamstown, which came as a great surprise to Dr. Locke's many friends and medical associates, Dr. Locke has visited Dr. Alexander M. Burgess '06 of the Brown Department of Health and chairmen of similar departments in neighboring universities to learn first hand some of the details of the work. He has also been spending week ends in Williamstown, getting acquainted with the men and the situation there, and will be ready by fall to begin his new duties with something of a helpful background.

Dr. Locke goes to Williams after having made a national reputation in the medical profession. He has been chief of staff of the Boston Sanitarium, visiting physician at the Boston City Hospital, and Clinical Professor of Medicine at Harvard Medical School. He is president of the Harvard Medical School Alumni Association, and he has done valuable work for the Associated Alumni of Brown University.

The *Providence Journal* echoed the sentiment of many Brown men when it said editorially: "We congratulate Williams on its president's foresight and on his ability to draw Dr. Locke out of an environment in which he has long enjoyed such enviable recognition."

Four Decades at George Washington

DEAN WILLIAM WILBUR '88 was a central figure at the 1935 Commencement of George Washington University, President Cloyd H. Marvin specially honoring him as Dean Wilbur retired to become Professor Emeritus after 40 years of active service on the George Washington Faculty. Since 1928 he has held the office of Provost at the University, and since 1897 he has occupied the chair of English literature. His classes in English rhetoric, in Shakespeare and in Browning have been attended by many Washington residents in addition to the students who have found in the teacher and his courses "inspiration and intellectual stimulus."

"How many of these former pupils there must be!" The *Washington Star* said in an editorial. "Forty years, forty ranks of them, pausing briefly in his presence before marching out into the world. He was more than teacher to them. He was wise counselor, interested friend, a dependable guide who knew something about the different roads which lay beyond his sheltered class room. . . . Among the builders of the foundations Dean Wilbur has labored. His hands have placed many stones, not only in the University which will honor him, but in the cultural and religious life of his adopted city."

Mona Lisa and a Detective

ISABELLA D'ESTE, one of the famous women of the Renaissance, was the model for the painting "Mona Lisa," Dr. Raymond S. Stites, '20, Professor of Esthetics at Antioch College, declared last month in a special story which the Associated Press reported. Standard books of reference have identified the original of "Mona Lisa" as Madonna Lisa, Neapolitan wife of Zanobi, or Francisco del Giocondo.

"Identification of the model for 'Mona Lisa' was regarded by Dr. Stites's associates at Antioch as one of the most valuable pieces of archeological detective work this year," the story said. "It followed years of research in the libraries and art galleries of Europe.

"Dr. Stites got his first clew to the identity of the model in the letters of da Vinci. He said he found a profile study of Isabella by da Vinci in the Imperial Museum at Vienna and another impressed in the painter's signet ring, which is in the royal archives of Mantua. . . . He said that during his research he obtained evidence to show that the painter often had corresponded with Isabella and had been in love with Cecelia Gallerani, Countess Bergamio, but that she had married another."

Dean of Town Treasurers

JAMES M. PENDLETON '85, Brown University Trustee, was cited in a survey of the City Managers' Association, as a Town Treasurer with a longer period of service than any other municipal treasurer in the United States. He has been Town Treasurer of Westerly for 43 years. One of his Westerly predecessors, in the 18th century, left a record of 60 years' service in that office as a challenge for him. Mr. Pendleton's sister has recently tendered her resignation as President of Wellesley College.

Friendships were kept in repair, reminiscences came buoyantly to the surface, and the infinite variety of reunion comradeship brought its abundant rewards. While for most, it was the awing magic of a round-numbered anniversary which served as a special lure, many of the classes continued to show their vitality by keeping intact an annual sequence of reunions, anniversary or no. Except for a brief storm the week-end was weather-blest.

It was the first year that the reunion committees had the benefit of common experience pooled and made available under a special committee of the Associated Alumni. Under the chairmanship of Lawrence Lanpher '23, this committee, without attempting to turn reunions out of the same standard pattern, nevertheless did have some valuable suggestions to pass on and was helpful in certain routine matters that are essential. Archibald of the Department of Mathematics, and Professor Leland M. Goodrich of the Department of Political Science and Sociology, all for the second semester.

On sabbatic leave this year, and returning to Brown in the Fall, are Professor Charles A. Robinson, Jr., of the Department of Greek and Latin Classics; Professor Sharon Brown of the Department of English; and

Professor Thomas Crève will have a major role in "Treasure of the Wells," as revived by the Theatre-by-the-Sea, Matamoras, this summer.

Professor Will S. Taylor of the Department of Art.

During the first semester of 1935-36 Professor Grose will be preparing a book on the friendship between Emerson and Thoreau, with particular emphasis on the ways each of them may have influenced the literary work of others. A detailed study of Emerson as a young man will be included.

Professor Killough will work on a study of recent international trade policies in European countries for part VII of a book he is writing on international trade, and will be in Europe to gather material from sources untapped by American writers, such as government records and statistics from the League of Nations archives. He will also interview other authorities in this field. The book, to be published in 1937, will be written more from the viewpoint of national policy than from the viewpoint of business procedure.

Manuscript for a new book on the poetry and drama related to mathematicians will be written by Professor Archibald, who will be in Europe looking for unknown material. His volume will contain the poetry and drama in which there is reference to mathematicians, and also poetry and drama which mathematicians have written. He read a paper on this subject before a recent meeting of the Brown Philological Club. While he is in Europe, Professor Archibald will attend the International Congress of Mathematicians.

Professor Goodrich will spend most of his leave and the summer of 1936 in Geneva, Switzerland, studying the organization and work of the League of Nations, particularly certain special aspects of the League's organization and work connected with the peaceful settlement of international disputes.

The Coming of Dr. Wach

DR. JOACHIM WACH of the University of Leipzig, prominent German authority on the philosophy and sociology of religion, has been appointed visiting professor of Biblical Literature at Brown University for next year.

Coming to the United States for his first appointment in an American university, Dr. Wach has been engaged by Brown to teach three courses. One will be the sociology of religion, a field in which Dr. Wach is a pioneer. This course will include a study of the influence of religious theories upon social institutions and the effects of social customs and practices upon development of theology. The other courses which Dr. Wach will teach will be religious philosophies of the Orient, and the nature and principles of religious development.

Dr. Wach who is now professor of the history and philosophy of religion at the University of Leipzig, is a descendant of the composer and philosopher Mendelssohn. His grandfather was the distinguished judge and professor of law at Leipzig, Adolph Wach, one of the most outstanding figures in German law during the past generation.

After receiving his Ph.D. degree from the University of Leipzig, Dr. Wach was awarded his Th.D. degree by Heidelberg

in 1928 where he studied under the sociologist, Professor Max Weber, and others.

Before beginning his extensive writings in his field, Dr. Wach travelled and studied throughout the Orient. His most important book is a philosophical interpretation of history. Dr. Wach has also written a comparative study of the ideas of Saviour in different religions, and a study of the Master-Disciple relationship in religions. His other writings include numerous articles and treatises.

Changes in the Romance Dept.

PROFESSOR LOUIS LANDRÉ of the Department of Romance Languages and Literatures at Brown University, and Professor Germaine Landré of Pembroke College, have presented their resignations to become effective at the end of the present academic year.

The office of the vice-presidents also announces the appointment of Dr. Jean Albert Bede of Princeton University and Franc Paul Gaston Thénaut of Swarthmore College to fill the vacancies. Professor Bede's appointment is for associate professor of French literature, and the appointment of M. Thénaut is for instructor in French, effective with the beginning of 1935-36.

Professor Bede has studied and written widely in his field. A native of France, he was educated at the University of Paris, where he received degrees in the classics in 1922 and in English in 1925. He completed his formal training at the École Normale Supérieure, the Paris institution which prepares men for college and university teaching. He also studied at the École des Sciences Politiques, and received a degree in that field in 1929.

He began teaching as Professeur de Première at the Lycée de Clermont-Ferrand the same year, and came to Princeton in the fall of 1929, where he has been instructor and assistant professor in French. During the summer of 1931 Professor Bede was a visiting professor in French at the summer session of Stanford University.

Professor Bede's writing has included numerous articles, reviews and other publications including textbooks, which have appeared in French. Professor Bede's chief interests are in modern French literature and in comparative literature. He is the author of numerous learned articles and reviews of learned books, and also of a work on Anatole France, a study on the teaching of comparative literature, and a study related to present day education in France. He now has in preparation two books to be published in the United States, one by Henry Holt and Co. and the other by Charles Scribner.

M. Thénaut, also a native of France, has studied at the University of Bordeaux, where he received his bachelor's degree; at the University of Lyon, which awarded him a graduate Licence en Droit degree; and at the University of Illinois, where he was awarded an M.A. degree. For the past four years he has been studying at Johns Hopkins University for a Ph.D. degree. M. Thénaut also spent three years of study in Mainz, Heidelberg and Vienna.

His academic appointments have been at the American University of Beirut, Syria, at Illinois, at George Washington University, and at Swarthmore.

Graduate School Awards

FORTY-ONE fellowships and scholarships have been awarded by the Graduate School of Brown University for the academic year 1935-36, according to Dean Roland G. D. Richardson. Fellowship stipends range in value from \$500 to \$1,200 in addition to tuition. Scholarships cover tuition in the Graduate School. Those receiving fellowships and scholarships are graduates of 31 different colleges and universities, and come from 19 states. Six Brown graduates will be among the recipients.

Among the awards for next year is a new fellowship in the Department of Psychology made possible by the department's Visiting Day Committee.

Research Quests in Biology

PROBLEMS related to heredity, disease, growth and special functions of the body are among the research projects with which scientists in the biological laboratories of Brown University were busy this spring in an effort to shed new light on their field of knowledge.

Many of the research projects, when the results have been weighed, will have immediate practical value, according to Professor Philip H. Mitchell, chairman of the department. Other projects are being carried on in the belief that results will prove to be stepping-stones to further discoveries which can be utilized for mankind's benefit.

Student contact with research work is being encouraged at Brown through arrangements with members of the faculty who are in charge of various projects. The scope, significance and aims of the researches are explained in informal conferences. Selected advanced students are given opportunity to work out aspects of the projects, in some cases for credit. Graduate students carry on research of their own with faculty cooperation.

Typical of the major projects are Professor Charles A. Stuart's work on causes of the common cold, the investigation by Professor J. Walter Wilson into the minute structures of the kidney, the experiments of Dr. Paul B. Sawin on hereditary transmission of bone structures, the tests of Professor Arthur M. Banta on length of life, and Professor Ivon R. Taylor's project concerning the physiology of insect change from larva to the moth.

In studying the causes of the common cold, Professor Stuart and his associates are working on the theory that two or more types of bacteria may be involved in infection. In one test, one species of bacteria was unable to multiply until the other had reached a maximum growth. This and other experiments hint that a double bacteria growth under special conditions may be responsible for colds.

As part of a project to study minute structures of living cells in general, Professor Wilson and his advanced students have built a new and elaborate apparatus with which they are attempting to keep a kidney functioning normally outside the body with an artificial fluid circulating in place of blood. By modifying the artificial blood, they expect to discover more than is now

known concerning the role of various types full of cells and their structures in the kidney.

DR. SAWIN sees the possibility for breeding cattle, sheep and swine with extra ribs, and consequently with more steaks and chops, if he can discover the reasons why and how he has been successful in breeding rabbits with 13 ribs instead of the usual 12. As a contribution to pure science, this study and others on heredity at Brown are directly concerned with the architecture of the germ-plasm.

Support for the old adage that "we dig our graves with our teeth" has been found in preliminary results of the experiments of Dr. Banta and Lester Ingle, research associate, with daphnia longispina, or waterfleas. It has been found that the tiny animals live approximately 50 percent longer on a restricted diet than on an ample diet. The work is being continued.

Bearing directly on problems associated with the breakdown and growth of tissues in general, a study is being pushed by Professor Taylor and Dr. Frederick Crescitelli on the physiological changes which take place when the bee-moth turns from a worm-like larva to the moth. Delicate apparatus has been built which can measure how much heat the insect gives off while it is in the pupal stage.

Professor Stuart and Professor Wilson are also busy with experiments related to immunization, fertility, and the reproductive cycle. Recently Professor Stuart perfected a way for diagnosing accurately the disease infectious mononucleosis.

"It was purely a vacation. I return thoroughly uninteresting and uninformed. I've had a little cold and stayed in most of the time on the voyage over. I'm sorry not to be a better prospect, but I'm not faking—I just don't know a thing to tell you."

T. Edward Owens, chairman of the Department of Mathematics, Tuskegee Institute, and a member of the Tuskegee Faculty for the past 32 years, retired at the end of the academic year in June. He will continue to live in Tuskegee for the time being.

T. Elliott Tolson's second son, Alfred B. Tolson, received his bachelor's degree from Williams College last month.

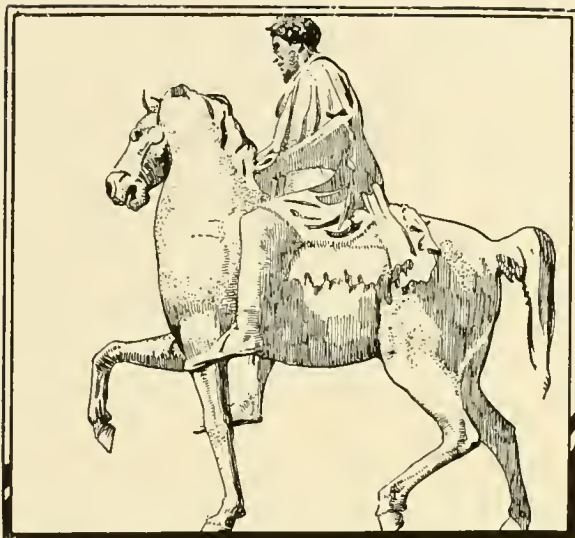

1874

REV. EDWARD WILCOX BABCOCK, D.D., rector of the Church of the Holy Cross, Troy, N. Y., since 1896, died in Troy, June 16, 1935. He had observed his 83rd birthday only a few days before his death.

A native of Westerly, R. I., where he was born June 6, 1852, the son of Edward W. and Martha C. Babcock, he had been a priest of the Protestant Episcopal Church since 1880. He prepared at Phillips Academy, Andover, made excellent record as an undergraduate at Brown and began studying for the ministry shortly after his graduation. Ordained deacon in 1879 and priest in 1880, he was identified with Episcopal churches in Meriden, New Haven, and Stonington, Conn., and with the Church of the Heavenly Rest, New York City, before going to Troy.

He was principal of the Mary Warren Free Institute as well as rector of the Church of the Holy Cross, which is the chapel of the Institute and which Mary Bouton Warren founded in 1844. The Church of the Holy Cross is said to be the first in this country to introduce the Choral Service. An able and inspiring rector and principal, he also became in his community "the beloved priest of affairs," and his reputation for a tolerant attitude, a kindly sympathy for all classes and conditions of people, and a courageous spirit was a sustaining one.

"Teacher and guide of youth and of age," President Barbour said in conferring upon him in 1931 the honorary degree of D.D., "seeking no reward save that of the divine approval, held in the high honor and affection of his fellow men."

Dr. Babcock was a former president of the Upper Hudson Valley Association of Phi Beta Kappa, and a member of Alpha Delta Phi. He was married Oct. 9, 1890, to Fannie Ball Starr, who survives.

1876

EDMUND WOOD, Trustee of the University since 1918 and one of the influential and public-spirited citizens of New Bedford, Mass., died at his home in New Bedford, May 25, 1935. President Barbour, Chancellor Henry D. Sharpe, Dr. A. D. Mead, Professor James P. Adams, and Comptroller E. A. Burlingame represented the University at the funeral.

Of Quaker stock and training, Edmund Wood was born in New Bedford, Dec. 2, 1854, the son of Henry Taber and Anna Greene (Russell) Wood. He prepared at what is now Moses Brown School, and after graduation from Brown made a voyage to the Azores in the whaling ship Eliza Adams, Capt. John W. Cornell. On his return home he began work for Greene & Wood, lumber merchants, and continued with that firm, in which his father was a partner, for the rest of his life. He was also senior member of the Wood Lumber Co., established at Falmouth, Mass.

In 1882 he entered New Bedford politics as a candidate for the Common Council, won the election, and sat on the Council from 1883 through 1886. He was president in 1885 and 1886. For years he was active on the Republican City Committee, being first its secretary and then its chairman. His great service to the city, however, was as a member of the New Bedford Water Supply

Those We Mourn

Faculty

DR. WALTER KIEN, Assistant Professor of German, died suddenly in Providence, May 25, 1935. He had been ill, but his condition was not regarded as serious.

He was a native of Vienna, Austria, where he was born Oct. 22, 1900, and where he was educated. After graduation from the University of Vienna he taught at the University of Puerto Rico, the National Institute of Panama, and New York University before coming to Brown in 1930 as instructor. He became Assistant Professor in 1932. Dr. Kien was a member of the Germanic Society, the Modern Language Association, and the Modern Humanities Research Association.

1869

HENRY NEWELL CADY, marine painter and author, died in Warren, R. I., May 15, 1935. He exhibited his paintings at the World's Fair in Chicago in 1893; at the St. Louis Exposition in 1904; and privately in many cities.

Born in Warren, July 8, 1849, the son of Isaac Foote and Clementine (Lee) Cady, he prepared at Warren High School, of which his father was principal for 20 years. Since his graduation from Brown he had given his whole time to painting and writing. As a young man he went to Maine to make marine sketches there, but he soon came back to the shores of Narragansett Bay, where he found inspiration and where he spent the happiest years of his life.

In addition to his paintings, he drew illustrations for books and magazines, composed music, of which he made piano records, and wrote two books for boys, "One Week Afloat" and "Down the Bay," which were published under a pen name. For many years he had been unable to participate in public and university gatherings because of extreme deafness. But his interest in Brown was always deep.

He was married Dec. 25, 1872, to Miss Annie Cole, who died in 1911. With his wife he collaborated on a history to which they gave the title, "The American Continent Before Columbus." Surviving are

for six years, during which the present water supply was extended and improved.

His civic and social interests were broad. He was president of the Old Dartmouth Historical Society, for which he wrote articles on early Dartmouth history; the Board of Commerce, 1920-22; the New Bedford Chapter, Sons of the American Revolution; and the New Bedford Art Club. He was chairman of the Board of Trustees of the Swain School of Design; former chairman of the Advisory Board of the Associated Alumni and former president of the Brown Club of New Bedford; and treasurer of the New Bedford Welfare Federation, which raised \$1,500,000 for the cause of the Allies in the World War, and the Community Chest, its successor.

He was president and moving spirit of the New Bedford Whaling Film Corporation which made the picture, "Down to the Sea in Ships," to preserve for future generations something of the whaling industry that made New Bedford famous; and he had an abiding faith in the future of New Bedford as a port. As head of the New Bedford Forestry Association he was instrumental in setting out thousands of trees in New Bedford streets. He was a trustee of the New Bedford Institution for Savings, director of the New Bedford Protecting Society, and a member of the Mayflower Descendants, Massachusetts Retail Lumber Dealers' Association and similar trade groups, and Delta Kappa Epsilon.

He was married Oct. 15, 1895, to Miss Margaret Collins Earle of Worcester, Mass. His second marriage took place Dec. 10, 1924, to Helen Eaton Millar of Plymouth, Mass., who survives. One of Mr. Wood's brothers was Professor Augustus Wood '78, who died in Japan in 1912.

1882

JOHN STIMSON GREENE, inventor of the photostat now in world wide use, died in Rochester, N. Y., June 12, 1935. During his undergraduate days at Brown, he was a pitcher on the Brown baseball nine.

He was born in Providence, Jan. 22, 1860, the son of Samuel Stillman Greene, 1837, Professor of Mathematics and Civil Engineering and later Professor of Astronomy and Natural Philosophy, and Mary Adelaide (Bailey) Greene. He was obliged to leave college a month before completing his course; and in June, 1900, the Board of Fellows awarded him the A.B. degree with his class.

His first employment was with Wyckoff, Seamans & Benedict, pioneer typewriter manufacturers; he continued with that firm for many years as manager of the Philadelphia and other branch offices. Then he went with the Eastman Kodak Company. As inventor and developer of photostatic processes he had a wide reputation in the field of modern photography. He was a vice president of the Photostat Corporation, of which he was an organizer, and a member of Alpha Delta Phi. A bachelor, he is survived by a sister, Mrs. Richard B. Comstock of Providence.

1883

FREDERICK ELLSWORTH WHITEMORE, who retired in June, 1931, after having been superintendent of schools of South Hadley and Granby, Mass., for 27 years, died at his home in North Weymouth, Mass., June 10, 1935. He was a leader in educational, church and civic work.

Born in Bolton, Mass., March 25, 1861, the son of Thomas J. and Louisa M. (Rice) Whittemore, he was a descendant of Jonathan Maynard whose name was a well known one in the early history of Framingham, Mass. He came to Brown from Ashland, Mass., High School, returned to the school as principal after graduation from Brown, and in 1886-87 was with the New West Education Commission in Albuquerque, N. M. He was principal of schools in Weston, South Hadley, and Reading, Mass., from 1889 to 1903, and superintendent of schools in South Hadley and Granby from 1904 to his retirement.

During his long service in South Hadley he developed the school system along progressive lines, contributed articles to the local newspapers on educational topics,

and had a prominent part in civic and church activities. He was married June 22, 1892, to Miss Lillian Edith Easterbrook, who survives, with two sons, Arthur E. Whittemore, Boston lawyer, and Alfred L. Whittemore '22, musician; and two daughters, Mrs. Louisa A. Miller, Yokohama, Japan, and Miss Miriam M. Whittemore, teacher in Springfield, Mass.

He was a member of the Hampden County Teachers' Association, Mount Holyoke Lodge of Masons, Iona Lodge of Odd Fellows, and the South Hadley Grange. He did post-graduate work in education at Harvard in 1903-04.

1887

REV. WILLIAM WALTER WAKEMAN died suddenly May 19, 1935, at the home of Dr. Charles L. White, his classmate, in Hampton Falls, N. H., where he had gone for a class reunion. At his funeral in Weymouth, Mass., the service was led by Dr. White. Members of the class present were Dr. E. D. Chesebro, Dr. George H. Crooker, Dr. Arthur I. Connell, Irving C. Hicks, and Dr. Clarence A. Carr, Class Secretary.

William Walter Wakeman was born in Moodus, Conn., July 29, 1860, the son of George and Virginia (Bulkeley) Wakeman, and was a descendant of John Wakeman who settled in Massachusetts in 1640. He prepared at Peddie School and after graduation from Brown entered Newton Theological Institution, from which he received a diploma in 1890. During summer vacations he was minister of the Baptist church, Bethel, Me. He was ordained at Hampton Falls in June, 1890, and was minister of the Baptist church there and at Seabrook until April, 1897.

After serving as missionary of the Boston Baptist Sunday School Association, he organized a Baptist church in South Medford, Mass., and was its minister for two years and three months. He held subsequent pastorates in Reading, New Braintree, Medway, Ashland, Bellingham, and Westwood, Mass. At Westwood he was the active minister from 1916 to his retirement in 1928. He was the author of "New Hampshire in Missions," 1902, and co-author of "The Baptists of New Hampshire."

He was married June 26, 1900, to Miss Lucia J. Howe, who survives, with a daughter, Miss L. Virginia Wakeman, Weymouth, and a son, Reginald L. Wakeman, Buffalo, N. Y., and two half sisters, Miss Mary V. Wakeman and Miss V. M. Wakeman, Greenwich, Conn. His fraternity was Delta Upsilon.

1889

THE Alumni Office has confirmed the death of Percy Dinsmore Smith Slocum in Pasadena, Calif., Feb. 16, 1935. A heart attack was the cause.

Born in Glocester, R. I., Sept. 15, 1863, the son of Abram and Lydia (Aldrich) Smith, he changed his name to Slocum as a young man. He prepared at Nichols Academy, Dudley, Mass., was a student at Williams for two years, and transferred to Brown in September, 1887. In May, 1889, he was elected to the Rhode Island House of Representatives on the Democratic ticket from Glocester. He served in the House until 1894; was clerk in the office of Edwin D. McGuinness, Secretary of State, 1890-91; and was a member of the State Board of Education and the Woonsocket and Pascoag Railroad Commission.

In Gloucester he was Town Moderator, member of the school committee, and superintendent of schools. He also practiced law in Providence until his removal to Southern California about 30 years ago. During the World War he was active in war work in Pasadena, taking part in Liberty Bond and similar campaigns. For his services he received Government recognition. He was married April 1, 1895, to Miss Helen Burgoon. His only immediate survivor is a brother, Charles S. Slocum of Providence. His fraternity was Chi Phi, now Sigma Chi.

1895

WILLIAM ARTHUR BURT, who died in Providence, April 3, 1935, was a direct descendant of Samuel Gorton, one of the early settlers of Rhode Island, and a native of Providence, where he was born, Dec. 6, 1871, the son of Millens and Susan J. (Gorton) Burt. He had been ill for nearly two years before his death.

He came to Brown from the Providence High School and after graduation joined the sales staff of the Preston & Rounds Co., booksellers and stationers. He was associated for a time with Tilden-Thurber Co. and with the sales staffs of Corey & Reynolds, T. Quayle & Co., and other manufacturing jewelers with factories in Providence. He also engaged in the real estate business in Providence and in New York City. Tennis was his favorite sport, and as a member of a tennis club in New York he won a number of cups in club and local competition. He had no other outside interests except the Masons in which he had attained the 32nd degree.

Surviving are a widow, who was Miss Marie I. St. Germaine of New York; a brother, L. Millens Burt '00 of Forest Hills, N. Y.; and a sister, Mrs. Arthur B. Bradshaw of Providence.

1896

CHARLES BALDWIN BACON, minister and college professor, died suddenly on his farm in Sullivan, Ind., Feb. 21, 1935. A native of Chelsea, Mass., and a graduate of Peddie School, he spent his Freshman year at Brown and then entered Newton Theological Institution, from which he received a diploma in 1896. Ordained as a Baptist minister in Chelsea immediately after the left Newton, he went to Northern California to take charge of two missions there.

After a short pastorate in Salem, Ore., he resumed his studies at Columbian, now George Washington University, won his A.B. in 1899, and enrolled at Harvard Divinity School. He took his A.M. degree at Harvard in 1900, carried on graduate work for two more years and then joined the Faculty of the State Normal School, Stevens Point, Wis., his subjects being English and public speaking.

He was on the Faculty of the State Normal School, Terre Haute, Ind., 1909-24, and from 1924 to his retirement in 1933 chairman of the English and Public Speaking Departments, University of Detroit. His book, "Rules of Spoken English," was published in 1924. He was married Sept. 11, 1911, to Miss Adalene Helen Gates, who survives, with two sons, Francis N. and John G. Bacon. His fraternity was Zeta Psi.

1897

HARRY LODOWICK SHIPPEE, member of the class for three years with mechanical engineering and architecture as his special subjects, died in Apponaug, R. I., March 30, 1935.

Born in East Greenwich, May 5, 1874, the son of Lodowick C. and Anna J. (Smith) Shippee, he prepared at East Greenwich Academy and left Brown at the end of the second term in Junior year to go to work as carpenter and builder. He continued as a contractor until his last illness. In 1915 he bought the private water supply which takes care of the Greenwood section of the town of Warwick and had operated it since that time.

He was married Sept. 11, 1898, to Miss Esther C. Fry, who survives, with his father; a son, Lodowick H. Shippee; a brother and three sisters. Another brother was the late John S. Shippee '94. Mr. Shippee was a member of King Solomon Lodge of Masons of East Greenwich.

1902

FRANK ERNEST FASH, instructor in physics and chemistry at the Plymouth, Mass., High School, was found dead at his desk, May 13, 1935, the victim of a heart attack. He had returned from lunch with the principal, Wayne M. Shipman, shortly before he was stricken.

A native of Fall River, where he was born Oct. 27, 1878, the son of Jacob S. and Jennette (Works) Fash, he prepared at B. M. C. Durfee High School and after graduation from Brown returned to Fall River as principal of one of the city grammar schools. He was principal of the Sutton, Mass., High School, 1910-11; vice principal and teacher of science and mathematics, Spencer, Mass., High School, 1912-13; and a teacher in the high schools of Millis, Mass., Ocean Grove and Red Bank, N. J., and in the Franklin School, New York City, from 1913 to 1922, when he went to Plymouth. He received his A.M. in mathematics at Columbia after a year's study at Teachers' College.

He was a member of the New England Physics and Chemistry Teachers' Association; Narragansett Lodge of Masons; Friendly Union Lodge of Odd Fellows, of which he was Past Grand; the First Baptist Church of Plymouth; the Plymouth's Men's Glee Club; and several teachers' groups in Fall River and Plymouth. A bachelor, his only immediate survivor is a sister, Miss Alice M. Fash of Fall River.

1918

OGDEN RICHARDSON LINDSLEY was killed and Mrs. Lindsley was seriously hurt when the motor car in which they were driving to Boston was struck by another car on the Boston Post Road in Wrentham, Mass., May 20, 1935.

Born in Pawtucket, March 4, 1897, the son of James O. and Carrie E. (Richardson) Lindsley, Ogden Lindsley prepared at Pawtucket High School and at Brown was a member of the Brown Glee Club, Brown Mandolin Club, the Sphinx and the chess team, of which he was captain in his Senior year. He also served on his class debating committee and was a leader in Phi Gamma Delta, his fraternity.

Graduated from Harvard Law School with the degree of LL.B. in 1921, he was admitted to the Rhode Island bar in that year and from 1921 to 1929 was associated with Edwards & Angell. He left his law practice in 1929 to become vice president of Everett & Barron, manufacturers of shoe polishes, and was vice president and sales manager at the time of his death.

He maintained his interest in Phi Gamma Delta throughout his life and was an incentive to the successive delegations of that fraternity to do their best possible work as undergraduates. He was president of the Phi Gamma Delta Alumni Association, chairman of the Foreign Trade Committee of the Providence Chamber of Commerce, and a member of the Rhode Island Bar Association and the Providence Chess Club. He was married June 18, 1921, to Miss Mildred Flagg Monroe, who survives, with two sons, Ogden R. Lindsley, Jr., and Bradford M. Lindsley, and his parents.

1932

HARVEY BROOKES RIGGS, JR., died as the motor car which he was driving through the fog on the Cheshire road near Waterbury, Conn., skidded and turned over on him in the early morning hours of April 23, 1935. For an hour and a half he lay pinned beneath the car before a rescue party arrived.

He was born in Waterbury, Nov. 14, 1909, the son of Harvey B. and Carrie A. (Webb) Riggs. He prepared at Crosby High School, Waterbury, and worked for a year for the Scovill Manufacturing Company before entering Brown. As an undergraduate he played on the Freshman football, basketball, and lacrosse teams and on the Brown lacrosse team in Sophomore and Senior years.

After graduation he became a salesman with the Chase Copper and Brass Company. In 1933 and 1934 he was a training course student at the Scovill plant, and at the time of his death was in the purchasing department of the company. He belonged to the Waterbury Y.M.C.A., and Beta Theta Pi. Surviving are his parents, a brother, George C. Riggs, and a sister, Miss Virginia L. Riggs. Another brother, Donald M. Riggs '26, also died tragically a short time after he was graduated.

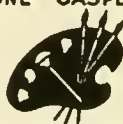
