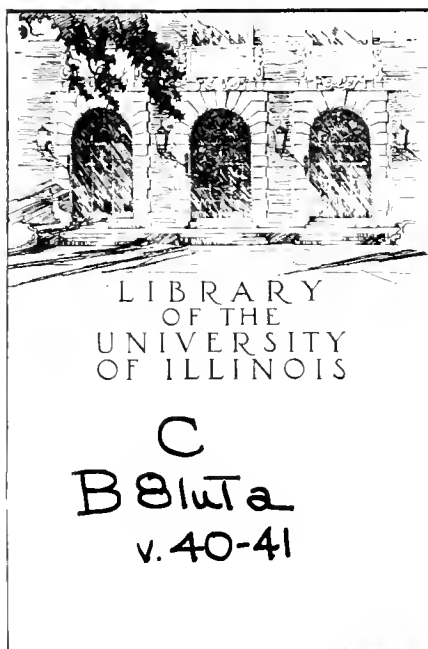
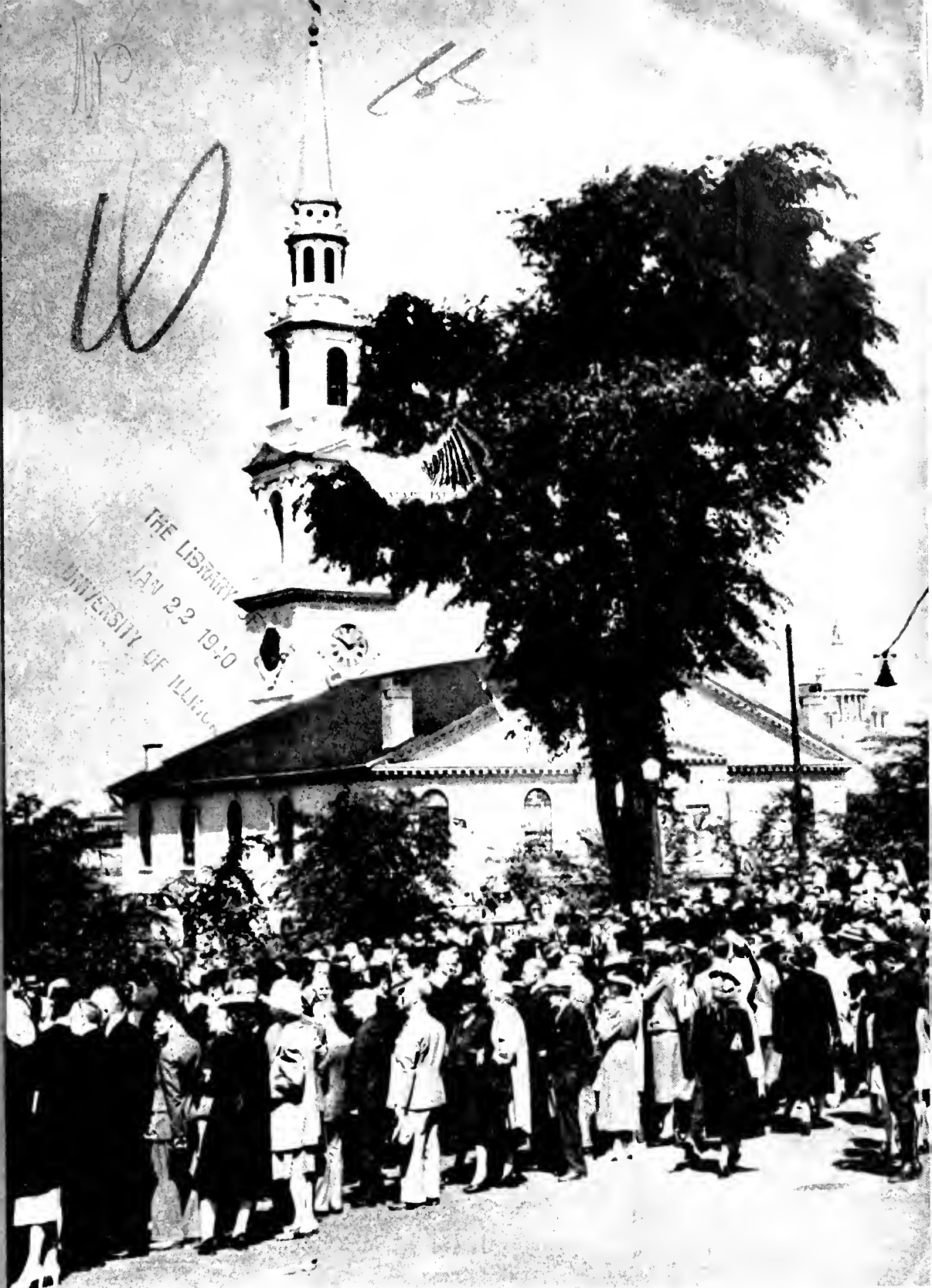

TAXES

► ► Commencement Meed and Fellowship

► ► FOR the 171st time Brown University bestowed its meed upon a graduating class when 379 academic degrees were awarded at Commencement exercises in the First Baptist Meeting House on Monday morning, June 19th. For 262 men and 117 women it was the accolade for four undergraduate years of study. To nine persons prominent in the nation's life it meant the further distinction of honorary recognition by the old University. And for hundreds of sons of Brown, in more classes than ever before at a single time, it meant the climax of days and nights of reunion fellowship, to share in which they were drawn back to Rhode Island from far and near.

It has become the community's festival, too, and thousands watched the pageantry of the Commencement procession as it passed through the out-swinging Van Wickel Gates and down the Hill over the route that more than a century of tradition had prescribed. Longer than ever, it seemed, was the line of marchers as they made the four traverses of the campus on the Middle Campus and past University Hall, where workers were so soon to undertake their task of restoration. Some of the procession had gone out of sight before the end of the line had started to move.

Continuing the custom renewed last year, scores of undergraduates were included in the march. Behind them came elder generations of Brown men, graduation for some of whom had taken place more than 60 years previous.

► FIRST down the Hill was Irving H. Hall, Jr., Senior class marshal, followed by the American Band, which for years has played the fair, familiar monotonies of the Commencement March. Next came the chief marshal, Edward H. Rathbun, of the 50-year class, with Chief of Staff E. Tudor Gross '01 and their ladies. Alumni, undergraduates, faculty, invited guests, Trustees and Fellows, justices of the Rhode Island Courts and State and city officials were in their places, reversing the line at the portal of the church so that the new high sheriff, John Kelly, was first to enter. Wearing sword, high hat, and full dress attire, he was alert to quell with a smile any breaches of decorum or order that might occur, a picturesque presence commanded by custom.

After music by Professor Arthur B. Hitchcock and the invocation by Rev. Arthur L. Washburn, resident councillor, the Senior orators were heard: John K. McIntyre, son of Eugene L. McIntyre '04 of Milwaukee, and Arthur L. Brown, son of Aylsworth Brown '06 of Providence. Then, sitting in the so-called Manning Chair, which has been used for more than a century for the purpose, President Wriston handed to each Senior his diploma: bachelor of arts degrees to 226 men and 111 women, science degrees in chemistry or engineering to 36 men and 6 women.

► THREE Brown men were among those cited for honorary degrees:

ERIC C. WENDELIN '29, foreign service officer who distinguished himself by assuming the whole burden of carrying on the United States Embassy in Madrid during the first six months of the Spanish civil war. Master of Arts.

REV. C. IVAR HELLSTROM, assistant minister at the Riverside Church, New York City. Doctor of Divinity.

HALSEY W. WILSON, publisher of such bibliographical indexes as the "Readers' Guide to Periodical Literature" and the "United States Catalogue." Doctor of Letters.

DR. WILLIAM SETCHELL LEARNED '97, staff member of the Carnegie Foundation for the Advancement of Learning, noted for his studies of educational problems. Doctor of Letters.

DR. VANNEVAR BUSH, new president of the Carnegie Institution, a distinguished electrical engineer. Doctor of Laws.

HELEN M. DANFORTH, president of the Rhode Island School of Design for the past eight years. Doctor of Laws.

DR. ALBERT D. MEAD, vice president emeritus of Brown. Doctor of Laws. His citation was notable for the fact that he was escorted to the platform by his successor, Vice President Adams.

SUMNER WELLES, Undersecretary of State. Doctor of Laws.

ASSOCIATE JUSTICE OWEN J. ROBERTS, of the United States Supreme Court. Doctor of Laws.

An innovation for the hundreds unable to enter the church for the graduation exercises was the arranging of conducted tours about some of the new University properties. At the same time, the Friends of the Brown University Library were meeting informally in the John Hay Library, where a special exhibition had been arranged for it. There was open house in Faunce House, the John Carter Brown, the University Club, the Faculty Club and elsewhere on the Hill as well.

► GIFTS to Brown totalling \$824,782 were announced in Sayles Hall after the ringing of the chapel bell had summoned the alumni for their annual meeting. They resoundingly applauded notable benefactions which contributed to that total, among them the record-breaking accomplishment of the Alumni Fund, to which Vice-President Adams called particular attention. Their applause was warm, too, for the other speakers: Justice Roberts, Mr. Welles, President Wriston and Governor William H. Vanderbilt, all presided by Chauncey E. Wheeler '09. Traditional Commencement hymns were sung under the leadership of Earle M. Pearce '17.

The program of Commencement Week began on Friday, June 16, with the exercises "under the elms" of the Middle Campus, followed by the Senior Tea. The Seniors returned later in the evening for the Class Night festivities under ideal weather conditions, and the campus has seldom looked lovelier. It was a matter of general comment that it was perhaps the best of recent Class Nights in many respects as hundreds of townspeople, members of many reunion classes and other friends of Brown joined in the dancing outdoors and in Sayles Hall. On the stroke of midnight the Seniors massed themselves on the steps of Sayles Hall to fill the air with their last songs as undergraduates.

Cool, fair weather continued to bless the whole program: the Graduate School Convocation, where 60 received ad-

vanced degrees; the Baccalaureate Service, with Dr. Rufus M. Jones, University Trustee, as the preacher; the Senior Reception; the President's Reception; and the Tuesday meeting of the Corporation with which the weekend terminated.

Election Returns

▶ ALFRED B. MEACHAM '96, New York City investment banker, and Arthur L. Philbrick '03 of Providence, new chairman of Alumni Fund trustees, were chosen by Brown alumni as their representatives on the University Corporation. Mr. Meacham succeeds to the Baptist vacancy on the Board of Trustees, following the expiration of the second term of Clifford S. Anderson '00 of Worcester. Mr. Philbrick, an Episcopalian, succeeds Henry C. Hart '01 of Providence.

Walter Hoving '20, New York department store president, was elected president of the Associated Alumni, it was also announced on Commencement Day. He succeeds Sidney Clifford '15, Providence lawyer, who has completed two progressive and fruitful years. Alton C. Chick '19 of Providence was re-elected treasurer of the association.

As an alumni member on the University Athletic Council, Frederick Schwinn '05 of Attleboro, Mass., was named in the balloting to succeed Dr. Joshua H. Weeks '19 of New Bedford.

Into the State's Service

▶ ▶ RHODE ISLAND State Director of Co-ordination and Finance is the imposing title that Preston F. Arnold '13 now holds as the key man of the State government "under the reorganization plan adopted by the Legislature early this year." According to the *Providence Journal*, "his function is to prepare the annual budget, to operate accounting systems, and to exercise budgetary and financial control over the operations of the State. He is also to maintain a centralized purchasing system over the purchase of all supplies, materials and equipment, and to administer the State's tax program."

Governor William H. Vanderbilt took Arnold from the Rhode Island Hospital Trust Company, where since 1936 he has been trust officer, with inheritance and income taxation and corporate trusts as his field. Arnold's only other public office during his career has been chairman of the Barrington School Board.

One of his first official acts was the appointment of Samuel A. Place '24 as State Controller. Place, who specialized in economics at Brown, was formerly Chief Field Auditor for the Rhode Island Unemployment Relief Commission. For four years regional examiner for the WPA, he was last winter named Chairman Regional Examiner for Region 1 with the responsibility of supervising all financial functions of the WPA in New England.

A Record Alumni Fund

▶ ▶ HIGH compliment to W. Granville Meader '05, retiring chairman of the Alumni Fund Trustees, and his aides was paid by Vice-President J. P. Adams when he announced on Commencement Day that the Fund totals for 1938-39 had passed all previous records for that day. When the books were closed at the end of the Fund year on June 30, a total of \$35,502.59 had been received from 3,161 contributors, an amount substantially larger than any ever raised before by the Alumni Fund.

Speaking at the Alumni Meeting in Sayles Hall, Dr. Adams said: "In 1937-38, 3,104 alumni contributed a total of \$33,368.68 through the Alumni Fund. This noon, the Alumni Fund Trustees notified us that 3,125 alumni, representing all classes and in all parts of the country have contributed \$35,051.00 for the present academic year. The number of contributors and the amount subscribed are in excess of the figures announced at this time last year. The Trustees are confident that when certain unpaid pledges and additional contributions are received, the total of the Alumni Fund for the fiscal year ending June 30 will be substantially larger than any amount ever raised before by the Alumni Fund. (They were—Ed.) Again, may I remind you of its importance in the financial structure of the University by saying that, in the present state of the investment market, it represents the equivalent of an added million dollars of endowment.

"This splendid achievement is a manifestation of loyalty, interest and understanding on the part of more than 3,000 alumni. It is the result of the conscientious effort of more than a hundred class agents. It is also an evidence of wise planning and vigorous action on the part of the Alumni Fund Trustees: Arthur L. Philbrick, '03; Preston F. Arnold '13; George R. Ashbey '21; Alton C. Chick '19; Sidney Clifford '15; William B. Farnsworth '17; Thomas F. Gilbane '33; Robert H. Goff '24; Henry C. Hart '01; George Hurley '07; George T. Metcalf '13; Ralph M. Palmer '10; Albert L. Parks '26; Richard Thorndike '25; under the splendid leadership of W. Granville Meader of the Class of 1905.

"May I accept this opportunity to announce that, with the close of the present academic year, Mr. Meader retires from the Chairmanship of the Alumni Fund Trustees. Speaking in the name of the University, I express to Mr. Meader our deep appreciation of the breadth of vision and vigor of personal effort which he has given to his important project during the past five years. He has earned the profound gratitude of his Alma Mater and I acknowledge it publicly at this time. I am sure that, on your behalf, I can pledge the loyal support of the Alumni of the University to his successor, Mr. Arthur L. Philbrick of the Class of 1903.

"Again at this time, I am pleased to announce that the members of the Class of 1939, 270 in all, have pledged a total of \$1,163.85 to the Alumni Fund for the academic year 1939-40. This represents a 100% subscription from this Class for the first year following their graduation."

New Director at Princeton

▶ PROFESSOR DANA G. MUNRO '12 will become director of the school of public and international affairs at Princeton University next September as a result of the resignation last month of Professor DeWitt C. Poole, who will come to Providence to enter business. Munro has been Professor of Latin American History and Affairs at Princeton since 1932, and is an authority on matters pertaining to the countries of Central and South America.

► ► Gifts That Manifest a Faith

► ► **BENEFACTIONS** totalling \$824,782.00 since the previous June were acknowledged by Brown University on Commencement Day when Dr. James P. Adams, Vice President, rose before the Alumni Meeting in Sayles Hall.

Largest of the gifts announced was one of \$313,852.06 from the Estate of Mary E. Davol, to establish a fund in her name for the University's general purposes. But many a "major" gift was represented by smaller sums from donors who thus, according to their individual means, were also giving a token of their loyalty to Brown and their faith in her station and intentions.

In recent years the list of gifts and bequests has been read in full from the Sayles Hall platform by either the President or the Vice President. There was never doubt of alumni interest in such a reading, and Dr. Wriston said last year, "We will gladly devote more time on any occasion of this sort if we can hear of such gifts to this ancient foundation."

But this June the alumni were given advance proofs of pages in the July **ALUMNI MONTHLY** which enumerated the gifts in a simple listing. Dr. Adams called attention to some items which merited special comment in the course of his address to the gathering, and expressed the deep gratitude of the University for each benefaction, large and small. While slighting no gift, the experimental procedure did serve to abridge time materially and profitably.

Chosen for a Carnegie Project

► DR. BRUCE M. BIGELOW, director of admission at Brown University, has received a special grant from the Carnegie Foundation, New York, to visit other colleges and universities throughout the country during the coming academic year and study their methods of administration. He will be on leave of absence from Brown from Oct. 15 to Mar 1, 1940.

Among the colleges which Dr. Bigelow will visit in the North and East are McGill, Dartmouth, Haverford, Swarthmore, and St. John's College, Annapolis; in the South, Duke and the University of North Carolina; in the Middle West and Southwest, the University of Chicago, the University of Texas and Hendrix College in Arkansas; and in California, the University of California at Berkeley, Scripps, Pomona, Stanford, and Bakersfield and Pasadena Junior Colleges.

Similar grants have been made to administrative officers at seven other colleges and universities. These men will visit various other institutions and pool their findings. ◀

News for "Al" Gurney ◀

▶▶ WHEN Alfred H. Gurney '07, Alumni Secretary at Brown University for the last 17 years, picked up the paper one day last month, he got his three cents' worth of news. He read that he had been nominated for the important post of Jury Commissioner for the State of Rhode Island.

When his telephone rang and reporters began to ask questions, Mr. Gurney could only say that it was a surprise to him, too. But it was evident that it had been a pleasant one for a week later he accepted the appointment and submitted his resignation to the Associated Alumni of Brown.

Mr. Gurney's new duties, which he assumed on July 10, will occupy his full time, for he will have the responsibility of preparing jury rolls and selecting jurors for all courts in the State. His term will expire Feb. 1, 1942, appointment then being made triennially. But it is the intention of a new law and procedure to remove the office from politics and political interference, just as the bench is freed.

▶ GOVERNOR WILLIAM H. VANDERBILT, who did the unusual thing of nominating his candidate without first approaching him, said he believed Mr. Gurney the best man available for the job. He submitted the name to the judges of the Superior Court for the approval they unanimously gave. Mr. Gurney's wide circle of friends on the bench and in the bar, together with his wide acquaintanceship with Rhode Islanders, made him an ideal choice.

Brown men, while regretting his departure from the University's official family, compliment him on his opportunity for service to the commonwealth. His post on the campus will be hard to fill, for he has held it with conscientious distinction since 1922.

He was, as the *Providence Journal* remarked, the sole link that many alumni had with their University. By visiting, by lengthy correspondence, by friendly interest he built up a gigantic acquaintanceship in the company of Brown men. He helped organize them in Brown Clubs, helped keep those organizations vital. He wrote of all their personal milestones for the columns of this magazine, where his contributions were acknowledged the backbone of each issue. No one could have been a more faithful collaborator.

▶ In the Alumni Office he had had many duties, most of them now grown too large for a single individual to cope with: University publicity, alumni fund direction, maintenance of graduate biographical files, placement work, complication of the yearly necrology. He was loyal to his own class of 1907, but he worked for all classes. He was the career man in the secretariat, providing continuity in much alumni work done by volunteers. His outstanding work was recognized by his fellow professionals in the American Alumni Council, which gave him a number of high offices and duties.

Having been so closely identified with the University, he could hardly cut himself wholly loose from its activities, and he is certain to hold a lively place in the alumni organization as an amateur once more. The best wishes of a host of his friends follow him into his new work. ◀◀

Advanced Degrees to 60

▶▶ DR. ALBERT D. MEAD gave one more assignment to advanced scholars at Brown. Speaking at the annual Convocation of the University's Graduate School on June 17, the emeritus professor of biology and former Vice-President urged candidates for advanced degrees to attack one of the world's central problems—that of directing the world's cultural evolution into a coherent pattern.

His address, "The Species Complex in Biology and Education," preceded the awarding of 60 advanced degrees by President Henry Merritt Wriston in Sayles Hall. Thirteen received the degree of Doctor of Philosophy. Master of Arts degrees were awarded to 33 candidates and 14 others received the degree of Master of Science. The candidates were presented by Dean Roland G. D. Richardson.

A number of Brown graduates were included in the company of those receiving advanced degrees: *Master of Arts*—Horace Richard Booth '36, Romance Languages; Frank Fletcher '37, English; Paul Francis Gleeson '32, Education and History; Frederick Annis Hellman '37, English; Charles Moir Kenyon '37, English; Vincent Andrew McKivergan '31, Education and History; John Wood Manchester '37, Economics; William Joseph Sullivan '33, Education and Political Science; John Anthony Waters '32, Education and English; *Master of Science*—Walter Varian Brown '37, Botany; *Doctor of Philosophy*—Victor Meyer Emmel '35, Biology.

Other institutions represented by the masters and doctors include: Hamburg, Columbia, Cornell, Western Reserve, Bates, Middlebury, Oberlin, California Tech, Oxford, Oregon State, Linfield, Wisconsin, Wabash, Seton Hall, Hobart, Radcliffe, Colby, North Central, Albright, Wells, Hamline, Colgate, Michigan State, Yale, Vermont, R. I. College of Education, Swarthmore, American College at Istanbul, Wellesley, Pennsylvania, Mount Holyoke,

Minnesota, Toronto, Carnegie Tech, Massachusetts State, Haverford, Arizona and Providence. The graduates were residents of 16 states and 3 foreign countries.

Dr. Mead pointed out that human cultures, like animal and plant species, undergo the effects of evolution, and that today the barriers which have kept these cultures apart are being broken down with unprecedented swiftness and thoroughness.

"The consequent complete, world-wide comingling of cultural species will be, I venture to say, the central problem of your generation, even taking precedence over the problem of the vanishing frontiers," he told his audience. "Not America but the world is becoming the melting pot of cultural ideas."

"It seems inevitable that the present cultural species, including systems of government, economics, morals, customs, religions and philosophies, cannot remain themselves unmodified in the new conditions, but that from them new species will arise."

"The species problem for the future is how, by conscious effort, to direct the course of this inevitable cultural evolution so that it will include the finest elements which experience can contribute from all quarters of the world."

"None should be better qualified to attack the problem," he said, "than those prospective scholars, and laymen also, whose complex of impelling motives, powers of discernment and discrimination, and constructive imagination it is the privilege of the American college and university to educate." ◀◀

"Dangerous" Democracy

▶▶ OUR job, President Henry M. Wriston told Brown alumni on Commencement Day, is not to "train" youth for democracy, but to "educate" it. Training, he feared, produced only skill; it took education to produce wisdom.

Granting that democracy is a dangerous trade, as Chesterton charged, he showed its goal to be the "realization of the fullest potentiality of each citizen—not merely his most convenient use by the state." Preparation for it involved perspective, disciplined emotion, and hard work. ("There is more danger in mistaking laziness for stupidity than of overworking the feeble mind.")

"Talk in a world of action is dangerous; to guarantee freedom of expression to thoughts we hate is dangerous. To permit vigorous opposition in a world of blood purges, political assassinations and concentration camps is dangerous."

"But that course of action, with all its dangers, is the price of democracy. Safety first is an idea corrosive of democracy. Safety is not the goal, but the realization of the dignity of mankind. That requires the pursuit of many ideals, which is always and inherently dangerous, but to set safety above them ends the pursuit before it is fairly started."

"It is therefore no accident that an age which has made 'social security' a fetish, an age which seeks to escape the hazards of life, has not been effective educationally in forwarding the democratic ideal."

"Democracy is a great human adventure, and only the adventurous spirit makes it possible." ◀◀

Sports and Sportsmen ◀

▶▶ It cannot be said that Brown baseball in 1939 lived up to the high promise of the first stages of the season. Having won five of the first six games—and rather impressively—the nine went into a hitting slump that meant eight defeats in the next eleven encounters. The season that started out with a .833 average ended with one of .471, eight games won, nine lost.

Yet the year had many bright spots, notably the pitching of Sophomore Walter Juszczyk and the hitting of Dave Redford, which figured in the three major victories—over Harvard, Yale, and Dartmouth. Several of the lopsided games were not decided until the late innings.

Major mystery was how a team that was averaging 6½ runs in its first six games should lose its power at the plate as the spring warmed up. In the summary of the schedule, Redford's .377 was the only batting mark above .300, and only five others were above .200. The team hit only .208. Redford, who incidentally had a perfect fielding record, hit 23 times in 61 official times at bat, scored six of Brown's 60 runs and batted in 23 others, accounting for nearly half the scoring.

To win ball games under this offensive handicap, the defence had to be tight, and in a number of sparkling games it was. The pitching had four shutouts to its credit, the infield looked sound on many occasions, and the team never stopped trying. Toughest games to lose were the second Rhode Island game where Juszczyk lost a 3-1 decision after allowing only three hits up to the 12th inning; and the Wesleyan finale where his teammates could produce no runs to match his seven-hit performance on the mound.

▶ HITS when they counted and flawless fielding behind Juszczyk's six-hit pitching enabled Brown to beat Harvard 4-0 in the traditional Memorial Day encounter in Providence. Six of Brown's eight hits contributed toward the scoring, which was spread over four innings. Redford pumped timely singles to bring in two of the runs, while Arrendell and Tourigny were the hitters on the other occasions. Juszczyk held his mastery over the Crimson to the end, being in trouble in only two sessions. In the second with the bases loaded, the threat was abruptly ended by a brisk killing at the plate as start of a double play.

Juszczyk added 11 more scoreless innings to his credit when he shut out Tufts 1-0 with four hits. This time his support was shakier but none of the four errors did any harm. Again a double play got him out of his bad inning when, in the first, he allowed a hit and walked two batters. His Tufts rival, Hatch, was also pitching beautiful ball and only Redford had hit for Brown up to the 11th, when Arrendell's single paved the way for the lone run. It

was manufactured further from a sacrifice bunt, an intentional walk, a hit batsman and Harkins' sacrifice fly.

Holy Cross jumped away to an early lead before Juszczyk could settle down in the return game between the Crusaders and the Bear. Sigloch got three of Brown's five hits, as the Cross won 5-1.

Trying to make it two straight over Harvard, Brown pounded out three runs in the first inning, lost the lead in the third, and tied it again in the fifth only to have the Crimson mass its guns in the seventh for the big push that won 9-4. Nash and Lally each seemed to be working along nicely on the mound until the explosions in the third and seventh. For Brown Redford was the big sticker with four hits to show for four appearances at the plate. Harvard went on to defeat Yale twice and tie for the championship of the Eastern Intercollegiate League.

With an even split in its previous 16 games, Brown lost the rubber when it journeyed to Middletown and faced Wesleyan's pitching ace Cotter. This gentleman allowed only three hits, two of them coming together in the seventh when a close play at the plate killed the most menacing rally. Juszczyk, in the meantime, had been pitching well enough to win most games, but Wesleyan scored single runs in two innings to win 2-0.

▶ DAVID G. REDFORD, hard-hitting outfielder from New London, will captain the nine in 1940. Of the year's 15 letter men only two were in the graduating class—Captain Danny Hicks, infielder and prospective Army aviator, and Cad Arrendell, Oklahoma boy who played both outfield and infield.

Other letter men of the 1939 campaign are: Pitchers Juszczyk, Cheever, McCulloch, and Lally; Catchers Kelly and Sigloch; Infielders Sheehan, Marsolini, and Platt; Outfielders Pietrusza, Harkins, and Tourigny. Although the freshmen failed to win a game, a couple of players have varsity promise.

Wearers of the "B"

▶ FIFTY-ONE senior wearers of the varsity "B" were singled out at Brown's 1939 Class Day exercises and received certificates of their honors from Athletic Director T. W. Taylor. Larry Atwell, who won five letters in three sports, was the most versatile athlete, while Danny Hicks and Sherry Kapstein had five in two sports. Others who figured in two sports were Victor Bernstein, George Larkowich and Foster Davis.

Football suffers the heaviest loss of the several teams with nine letter wearers listed in the graduating class. The men who have

played their final football game include Irving Hall, Larry Atwell, Tom Carey, George Larkowich, Gale Wisbach, Homer Tolivaiva, Sherwin Kapstein, Dick Goodby and Victor Bernstein. Capt. George Truman is the only member of this year's basketball team who will be lost.

An Unbelievable Meet

▶▶ WITH a demonstration of power never before seen in the 35 runnings of the Brown Interscholastic track and field meet, Seton Hall Prep dominated the Memorial Day games in the Brown Field stadium from start to finish. Established as pre-meet favorites with a full team of 24 men and 54 event entries, the Jersey school outscored the combined talent of 325 other boys from 37 schools. Seton Hall athletes scored in every event except the pole vault and hammer, and there were five events in which they placed three men.

Seton Hall amassed the unbelievable total of 70 points, with first places in the 100, 880, mile, high and low hurdles, broad jump, and shot. Doolan and Hartner were double winners, as her boys ran 1-2-3 in the low hurdles, 1-2-4 in the high hurdles and mile, 1-3-4 in the 880, and 2-3-4 in the 220. Back in an eighth place tie was Hope street, whose 19 2/3 points last year had been sufficient to win her the team honors. This year she had 4½, Worcester Academy, usually a factor and often a winner, was held to a single point.

But it was a topnotch meet, for all the one-sidedness of the totals, probably attracting more class in every event than in any previous meet. There were four record performances: Kochler of Ridgewood High, (N. J.) set a new mark of 49.4 in the 440 that displaced the previous best, 50.2 sec-

onds by Lyford of Worcester Academy last year. Collado of Seton Hall ran the 880 in 1:56.3, beating one of the oldest marks on the Brown record book, that of Gorton of Moses Brown, whose time of 1:56.8 has lasted since 1915. Morcom of Braintree High set a new height in the pole vault at 12:7-9/16, replacing the five-year old mark of 12:6-7/8 by Thomas of Choate. Rogers of La Salle Military sped through the 220 in 21.8, which equalled the record jointly held by Lane of Worcester Academy and Wilson of Newark Prep. Only defending champion in the meet was Seton Hall's Bova who won the mile for the second successive year, this time with the fine (though not record-breaking) time of 4:23.7.

► MISS SUSAN E. HILL, recorder of the college at Brown University, retired last month after having served the University successively as secretary, assistant registrar and recorder during the past 37 years.

A native of the village of Economy, Nova Scotia, Miss Hill was appointed secretary to Dean Alexander Meiklejohn, and to Frederick A. Guild, registrar, in 1902. She became assistant registrar in 1917 and recorder of the college after Mr. Guild's retirement last June.

When Miss Hill came to Brown, the undergraduate enrollment was only 650 as compared with 1,387 today. During her 37 years in the registrar's office she estimates that she has worked with the records of close to 10,000 students—their registration cards, reports, and examination schedules.

One of two founders of the Rumford company was George Francis Wilson, who gave Brown University the \$100,000 with which Wilson Hall was built and equipped.

A pioneer in science, who visioned uninhabited fertile areas beyond the ranges of knowledge, journeyed thither, and cleared the land."

Chief Justice Fred T. Field '00 of the Supreme Judicial Court of Massachusetts had the honorary degree of LL.D. conferred upon him by Williams College at the 1939 Commencement. President James P. Baxter of Williams cited Judge Field as "a graduate of Brown University, on whose governing boards he has served with distinction for nearly twenty years. A learned scholar and wise administrator of the law, he 'deals with Trojan and Tyrian alike' as Chief Justice of the Commonwealth of Massachusetts." Judge Field was recently named to the board of trustees of Vermont Academy, where he prepared for Brown.

▶ ▶ It was a remarkable year for reunions, the Alumni Office reported shortly after Commencement when returns from the shore and country resorts bore out advance predictions that the gatherings would be numerous and well attended. According to alumni officials, there were more reunions this year than ever before, and the individual classes all had enthusiastic words about the success of their ventures. The yields in good fellowship and good humor were high, as the classes worked up to the climax of Commencement Day itself.

Classes whose reunion reports reached the ALUMNI MONTHLY ranged from the extraordinary class of 1879, 60 years out and its reunion history unbroken except for a single year in all that time, down to the baby reunion of 1938. A Legacy of 50 Years Ago

► A BEQUEST of \$116,500 will come to Brown University in the distribution of a third of the estate of the Rev. Alexander Gardner Mercer, it was announced last month by A. ► WHEN Frederick T. Guild '90 retired as registrar and secretary of the Brown faculty last year, he didn't retire very far away, as a newspaper reporter took occasion to observe this June. It was a happy thing Mr. Guild was nearby, for the University called on him to come and arrange diplomas for its graduates once again as he had done for 48 years. Never once in all that time did he make a mistake and permit a graduate to receive a sheepskin not intended for him.

► MRS. METCALF's gift to the John Carter Brown had made possible the purchase of a rare Peruvian manuscript, of which the Vice-President said only one other known copy is in existence. Dr. Adams mentioned this "second significant gift by Mrs. Metcalf specifically because it represents a broadening of interest in this great library resource of the University which, heretofore, has been most exclusively the result of the interest and effort on the part of a single family.

"Last year," the Vice-President continued, "I announced that, from an anonymous friend of the University, not an Alumnus, \$100,000 had been made available for the restoration of University Hall. I indicated at that time that an additional sum of approximately \$100,000 would be

► JUDGE HARRY H. ATWOOD in Worcester, Mass., Probate Court last month gave Rev. necessary for this purpose and expressed the hope that these additional funds might soon be made available. I am pleased to announce that an additional gift of \$100,000 has been received from the same generous friend and that plans are almost complete for the inauguration of the project. I am sure that no gift to the University could have received a warmer response in the hearts of all Brown men.

"It is our hope and expectation that University Hall, fully restored in a manner which will serve the University for generations to come, will already be devoted to its new uses and will be ready for your inspection on Commencement Day, 1940—170 years after its corner stone was laid by John Brown in the neighborhood of the town on a hill high above the river.

► "From the Class of 1909 comes a gift of \$3,000 as an addition to the Class of 1909 Fund. This represents the sixth consecutive year in which this Class has made a gift to the University. It established the Class of 1909 Fund at its 25th reunion in 1934 by a gift of \$5,000. In each of the next four years it added \$1,000 to this Fund and this year it has brought the total to \$12,000. It is my understanding that the Class plans to make successive gifts during the next few years until the Fund in hand reaches a total of \$15,000. This, together with a fund of \$10,000 provided through insurance policies carried by the Class will bring the total of the Class of 1909 Fund to the \$25,000 which has been set as its goal.

"From the Estate of Michael F. Dooley, a bequest of \$1,000 in memory of Dr. William Herbert Perry Faunce—a deeply appreciated gift from a man who was prominent in the life of this community who had no official connection with the University itself, whose interest in the University was an expression of his personal friendship and admiration for one who held a distinguished place in the life of the University and in the hearts of all Brown men.

► "FROM the Rockefeller Foundation two grants totalling \$55,500; from the Carnegie Corporation a grant of \$6,000; and from the Emergency Committee in aid of Displaced Foreign Scholars a grant of \$1,000—in all \$62,500 for the Department of Mathematics—for use during the next five years in connection with plans for the development of the library and the publication of an international journal of mathematical abstracts. You will be interested to know that this journal which is to be published at Brown University under the auspices of the American Mathematical Society and under the editorship of Professors Tamarkin and Neugebauer of the Department of Mathematics, has received the generous support of the Foundations through grants amounting in total to \$72,000 which have been made to the American Mathematical Society.

"From Mrs. Frances Knowles Warren, \$5,000 as an addition to the George Eddy Warren Scholarship Fund. By this generous gift the George Eddy Warren Scholarship becomes the largest endowed scholarship specifically designated for award to a single student.

"From a Trust Estate established under the will of Mary E. Davol, a residuary bequest of \$313,852.06. I mention this bequest not alone because of its size but more especially because of the fact that it represents an interest in Brown University expressed more than twenty years ago, by a

woman who had no official association with the University itself but who resided in the community in which the University has carried on its work. It represents an interest which she cherished in her own heart and mind and did not reveal to the University itself until it became the beneficiary of her generous regard upon the death of persons to whom she gave life interests in the trust. What a magnificent evidence of faith in the future of the University and in the integrity of its purposes by a citizen of this community.

► "At this time we desire to make known the identity of the donors of the special gift of \$50,000 for Andrews House which was announced anonymously last year. This generous gift for this very important purpose was an expression of the thoughtful interest of a young alumnus and an undergraduate who, but for illness, would have been a member of this year's graduating class, Lyman Gustave Bloomingdale of the Class of 1935 and Alfred Schiffer Bloomingdale of the Class of 1939.

"From Dr. Charles Henry Hare of the Class of 1885 a gift of \$15,000 as an addition to the Charles Henry Hare Fund for the construction and endowment of Andrews House—a second supplement to an already magnificent benefaction from a generous alumnus who has seen the dream of many years come true on the campus of the Alma Mater to which he has been so deeply devoted.

"There are others—many of them gifts and bequests from alumni and friends of the University, some of them in memory of persons who have shared its life as teachers,

as students, as alumni and alumnae, some of them representing the continuing interest of men and women who have lived within the community circle of its cultural influence—some of them manifesting faith in the benefits to mankind which flow from the pursuit of truth in the libraries and laboratories on College Hill. There are grants from educational foundations; gifts from alumni classes, gifts from alumni and alumnae clubs, gifts from old friends, gifts from new friends.

"Again the Alumni, the Alumnae, and the many friends of Brown have spoken in a language which is unmistakably clear. They have manifested their faith in this collegiate foundation, in the future of privately endowed education, in the successive generations of young men and women who will come to College Hill through the years and in the continuing future of American democracy in which institutions such as this and all the things for which they stand will continue to be a part of the essential structure of American life." ◀ ◀

\$10,000 from 1912 in 1962

► At Commencement in 1962, when the class of 1912 will have been graduated 50 years, Brown University will be the beneficiary of a \$10,000 endowment policy covering the lives of ten members of that class and payable at that time. George S. Burgess, who notified the University of the class's intention, says that Kenneth J. Tanner, also of 1912, will be the financial representative of the class and will handle the arrangements. Mr. Tanner is an officer of the Rhode Island Hospital Trust Company. ◀

In Mr. Wilkinson's Will

► BROWN UNIVERSITY will eventually receive a sum estimated to exceed \$83,000 under the will of Edward S. Wilkinson '00 of North Adams, Mass., who was president of the Sand Springs Corporation until his death. Under the testament filed for probate in Pittsfield last month, the estate was said to be more than \$500,000, which will be held in trust for certain individuals for the present. On the death of the beneficiaries, the principal will be divided, one-half to the North Adams Hospital and the other half divided among Brown University, Williams College and Smith College, for the establishment of the Edward S. Wilkinson Scholarship Funds. ◀

Closer to the College

► CLOSER relationship between the college and the alumni association was the main theme of the 25th Annual Conference of the American Alumni Council at the New Ocean House, Swampscott, Mass., June 27-30. President E. K. Hibshman of Pennsylvania State College emphasized it in his opening address, and speakers embellished it during the three days of the conference.

Brown and Pembroke College were prominent on the program, Dean Margaret Shove Morriss being the only speaker at the formal dinner the night of June 29, the Alumni Secretary Gurney reading a paper on "Class Units in Alumni Organization" at the afternoon session of June 28. Then, too, Dean Theodore A. Distler of Lafayette, who began his college career at Brown with the Class of 1922, thrilled his hearers by his pointed talk on "The Durability and Quality of the Impression Made on the Undergraduates by the Faculty."

Dean Morriss' subject was "The Future of Higher Education." She noted the trends most evident today, commented on them,

and showed her faith in a liberal education such as Brown has stood for from the beginning. Higher education would progress, she said, provided that educators were able to experiment and test with the freedom characteristic of the American way of life.

A fact impressed upon the alumni workers is that changes in the set-up of alumni associations to bring them into closer contact with their college and university administrations are going on throughout the country. The statement made by President McConaughy of Wesleyan two years ago that the time is coming when the alumni office will be a department of the college or university and the alumni secretary will be a member of the administration appears to have in it more truth than was admitted by alumni and alumnae secretaries in 1937.

Topics under discussion included many phases of alumni work—alumni clubs, funds, magazines, biographical files, lost addresses, office equipment, direct mail programs, and even athletics. The session for men on athletics under the direction of Robert Sibley of the University of California was a lively one—so lively and intimate that reporters were barred and no statement regarding it was given out.

Two hundred alumni workers and members of their families registered at the conference and read their names in "Composite Alma Mater," official publication of which Carl Stephens of the University of Illinois was editor. They came from every section of the United States and Canada. Some of them were visiting New England for the first time. The long distance travelers were Mr. Sibley and Lewis K. Gough of the University of Southern California. Mrs. Gertrude Allen McConnell '10 and Mrs. John H. Williams '12, former president of the Alumnae Association, represented Pembroke College. ◀

It was before the electric light, snapshot photos, films, etc. Edison's use of the Zoetrope is told in Meadowcroft's "Boy's Life of Edison." Mr. Lincoln still has a duplicate of his patent office model.—Ed.)

► ► DR. HOWARD B. GROSE, father of Professor Howard B. Grose '03 and Laurence R. Grose '07 and former editor of "Missions," publication of the American Baptist Home Mission Society, died in Waltham, Mass., May 19, 1939. Brown conferred the honorary degree of D.D. upon him in 1907.

Dr. Vahan S. Babasjian, recipient of the A.M. degree in 1903 and the Ph.D. degree in 1906, and instructor in chemistry at Brown from 1903 to 1906, died in Bethlehem, Pa., May 24, 1939. He had been a member of the Lehigh Faculty since leaving Brown and Professor of Organic Chemistry since 1922. He came to this country from Armenia, where he won his first degree, and was a student at Hartford Theological Seminary before enrolling at Brown. "I have lived an eventful life and I am leaving it with a grateful heart," he wrote while he was in hospital.

A Library's Tribute

► THE 45 years during which Professor Henry B. Gardner served the Providence Public Library as a Trustee were memorialized in the publication of that institution last month soon after the death of the emeritus professor of Political Economy in Brown. In his passing the Library "lost one of its dearest friends and most ardent supporters."

Said the eulogy further:

"He had been a member of the Board of Trustees since 1894 and was President of the Board from 1903 until 1929, when he declined re-election, urging the choice of a younger man. Until rather recently when his health prevented his attendance at meetings, he was devoted to the development of the Library, giving its affairs his constant, unstinted attention. Among the many features of the Library's growth, the success of which were due to his support and leadership, were the building of the present Central Library, the system of neighborhood branch libraries, the Business Branch, higher educational and professional standards in library personnel, and a retirement plan with pensions for librarians." ◀

1874

► DR. FORREST GREENWOOD EDDY, dean of Rhode Island dentists with a record of 62 years of practice, died at his home in Buttonwoods, May 17, 1939. He was born in Providence, Sept. 8, 1853, the son of Thomas W. and Sarah M. G. (Smith) Eddy.

Leaving Brown at the end of Sophomore year he entered Harvard Dental School, won the D.M.D. degree in 1875, and continued his association with the school for

35 years as instructor and Assistant Professor of Operative Dentistry. He commenced practice in Providence, went to Lancaster, Pa., for two years and then returned to his native city.

Dr. Eddy was a former president of the Rhode Island Dental Society and the Harvard Odontological Society, and vice president and president of the American Academy of Dental Science. He had also been president of the Rhode Island Board of Registration in Dentistry, and was a Fellow of the American College of Dentists and a member of the New York Academy of Dentists and other professional societies. He was treasurer of the Buttonwoods Beach Association and held membership in the Squantum Association and the Sons of the American Revolution. In 1907 the Brown Corporation gave him the A.B. degree by special vote; in 1923 he received the medal awarded by the Rhode Island Dental Society to men of eminence and distinction in the profession.

He was married Dec. 29, 1875, to Ellenora Frances Greene of Providence, who survives, with a daughter, Mrs. S. Harold Greene, widow of S. Harold Greene '01.

1880

► "HE was a good citizen, in that he was quietly but thoroughly alive to civic and political questions in and out of Newport, and through membership and holding office in a number of organizations in Newport he gave of his broad knowledge."

So one has written of Benjamin Franklin Thurston, newspaper editor and prominent layman of the Methodist Episcopal Church in New England, who died at the Newport Hospital, May 9, 1939, of a heart affliction and complications. He had been managing editor of the *Newport Daily News* from 1897 to 1935.

Born in Newport, July 22, 1858, the son of Parker H. and Louisa M. (Rawson) Thurston, he was of the eighth generation in direct descent from Edward Thurston, who settled in Newport in 1647. A good student at Brown, he won election to Phi Beta Kappa in Senior year and was a member of Beta Theta Pi. He began work on the editorial staff of the *Daily News* and resigned in 1881 to become librarian of Redwood Library. From 1884 to 1886 he was principal of Barrington High School, and between 1886 and 1887, when he took over as managing editor of the *Daily News*, he engaged in business and in newspaper work in Newport.

For 52 years he had been a member of the First Methodist Episcopal Church, now St. Paul's, serving it as treasurer, senior stew-

ard, chairman of the finance committee, Sunday School teacher, and historian. In 1913 he organized the Laymen's Association, first body of its kind in the New England Southern Conference, and was its president four years. He was a vigorous figure in all regular and special lay electoral conferences, first president of the Lay Conference which now sits on equal terms with the Annual Conference of Ministers, and a delegate to four General Conferences of the Methodist Church in which he was active on major committees.

Mr. Thurston was a former president of Rogers High School Alumni Association, Brown Club of Newport, and the Newport Methodist Social Union, vice president and director of the Newport Y. M. C. A., and member of Coronet Council, Royal Arcanum. Under the title, "Brown University-Newport," he compiled a record of all persons identified with Brown who have been connected with Newport, and he also contributed prose and verse to *Zion's Herald* and other publications. He was married March 6, 1884, to Mary Elizabeth Banning, who died in January, 1902, leaving a son, Donald P. Thurston. His second marriage took place May 16, 1907, to Gertrude Allen, who survives, with the son and four grandchildren. His brother was the late Charles R. Thurston '82.

1883

▶ ELIAS FASSETT DUNLEVY, who visited Colorado as a young man and found the mountain country so attractive that he went there to live after graduation from Brown, died at his home in Denver, Colo., May 10, 1939. He was a court clerk before he retired many years ago.

Born in Granville, O., Sept. 11, 1861, the son of Francis and Amanda (Fassett) Dunlevy, he came to Brown from the preparatory school connected with Denison University. From Brown he removed to Colorado and in 1884 became clerk of the County Court, Arapahoe County. He also served as deputy and then as clerk of the District Court of the same county. In 1902 he went to Phoenix, Arizona, where he took office as clerk of the United States and Territorial District Courts of the Third District.

On his return to Denver he was persuaded to accept appointment as clerk of the Denver District Court. During the World War and after he was honorary chairman of the American Red Cross in Colorado. He was a former member of the University Club of Denver, and belonged to the Denver Club, Denver County Club, and Delta Kappa Epsilon. Mr. Dunlevy was married Oct. 4, 1911, to Mrs. Katharine M. S. Rogers Rublee, who survives, with a daughter and two stepchildren.

1883

▶ CHARLES BALDWIN WOOD, lawyer in Chicago 55 years and a summer resident of Lyme, Conn., all his life, died in Chicago, May 27, 1939, after an illness of three weeks. He had been ailing for many years, but kept cheerfully going until his final illness.

Born in Onarga, Ill., Oct. 12, 1860, the son of Charles H. Wood '56 and Julia (Baldwin) Wood, he entered Brown from Hyde Park, Ill., High School, and left at the end of two years to study at Union College of Law, now a part of Northwestern University. He won the LL.B. degree in 1883, became a member of the Illinois bar, and was an associate of his father until Judge Wood's death in 1890.

Thereafter he was a member of the firm of Ball, Wood & Oakley and then for 40 years of Wood & Oakley. The death of his partner, Horace S. Oakley, in 1931, was a great blow. Mr. Wood was a charter member of Lake Zurich Golf Club and a member of the Chicago Bar Association, Hartford Yacht Club, and the Dauntless Club of Essex, Conn. He kept up his father's home, Glenwood, in Lyme, spending three to four months each year there, and his associations in the East were "very dear to him." Surviving are four sisters, Julia Lee and Alice Wood, who lived with him, Mrs. Everett Masten, and Mrs. Frederick L. Jewett of Old Lyme, and a grandson, who is also a lawyer.

1884

▶ PETER SCHENCK CONOVER, retired business man and public official, born Holmdel, N. J., Sept. 10, 1860, the son of John W. and Mary (Schenck) Conover; died in South Orange, N. J., May 22, 1939. Before retiring ten years ago he was head of Peter S. Conover Company, contractors' supplies, and president of the Atlantic Highlands National Bank.

During his one year at Brown he played football and participated in rowing and track. After he left College Hill he worked two years as purser on the Sandy Hook steamers of the Central Railroad of New Jersey and then became a member of the hardware firm of Hendrickson, Applegate & Conover in Red Bank, N. J. From 1887 until retirement he headed the Peter S. Conover Company, and was a partner in the Conover Lumber Company, Orange, N. J.

While he was a resident of Atlantic Highlands he served as Councilman, Mayor and Postmaster, and was an important factor in the development of the community. He was a member of the Board of Trustees of Atlantic Highlands High School 23 years, a director of Atlantic Highlands Casino, and a leader of various civic and social groups. He was married Dec. 25, 1883, to Shelly Craig Bedle, who survives, with three sons and two daughters. His fraternity was Delta Kappa Epsilon.

1886

▶ CHARLES WESLEY BOARDMAN, mechanical and production engineer who died in Pawtucket, March 10, 1939, retired in 1933 because of failing health and during the past six years had spent his time between his Pawtucket home and his summer house in Cowesett.

Born in Pawtucket, Aug. 5, 1864, the son of Charles T. and Sarah G. (Bayley) Boardman, he came to Brown from Pawtucket High School and as undergraduate was a member of the *Liber Brunensis* board in Senior year and of other college organizations. After graduation he worked for a while as draughtsman at the Rhode Island Locomotive Works, Providence. Then he went to work for Remington & Henthorne, mechanical engineers, until the fall of 1893 when he started out for himself as a mechanical engineer with offices in Providence.

He continued in this line of work until 1912, in which year he joined the Fales & Jenks Machine Company of Pawtucket, serving as production engineer until 1931. For a short time before his retirement he was with the Whitin Machine Works at Whitinsville, Mass. Mr. Boardman is survived by a sister, Miss Sara Adele Boardman of Pawtucket. His fraternity was Chi Phi, now Sigma Chi.

1922

▶ HERBERT ABRAHAM GOURSE, head of the Gorsart Company, men's clothing, died in New York City, May 1, 1939, after undergoing a second operation to find the cause of severe headaches from which he suffered after receiving a blow on the head while on a steamer trip to the South.

Born in Fall River, Nov. 24, 1898, the son of Simon and Ethel (Smolensky) Gourse, he entered Brown in September, 1918, as a member of the Naval Training Unit and remained during the academic year. In 1921 he and Lou J. Balatow '20 formed a partnership in the men's clothing business in New York City. After Mr. Balatow withdrew in 1925, Mr. Gourse continued the business in association with his brother, S. Norman Gourse '24.

Mr. Gourse was a member of the New York Athletic Club, and Pi Lambda Phi, and was First Lieutenant, U. S. Naval Reserve. Besides his brother Norman, he leaves three brothers and three sisters.

1929

▶ ROBERT ELLSWORTH VAN WICKLE, M.D., born Matawan, N. J., May 15, 1907, the son of Daniel E. and Florine B. (Smith) Van Wickle; died suddenly of a heart attack in St. Louis, Mo., May 14, 1939.

At Brown, Bob was a member of the hockey team, Brown Glee Club, Owl and Ring, and was chairman of the Junior Week Committee. From Brown he went to the life insurance agency of Mellor & Allen, Inc., Philadelphia, as a salesman and at the same time took courses at Temple University Law School.

After three years as an independent insurance broker he entered the Medical School, University of Pennsylvania, received the M.D. degree in 1936, and was interne at University Hospital, Philadelphia, and Bryn Mawr Hospital before beginning last January a three-year residency in obstetrics and gynecology at St. Louis Maternity and Barnes Hospitals. He was married Nov. 22, 1930, to Sallye Louise Holman of Wayne, Pa., and a daughter, Dana B. Van Wickle, was born to them. His second marriage took place April 20, 1935, to Mary Frances Vastine, M.D., who survives, with his mother, Mrs. Frank E. Taylor of Germantown, Pa. Bob was a member of Zeta Psi.

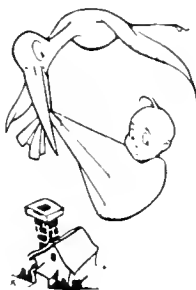
