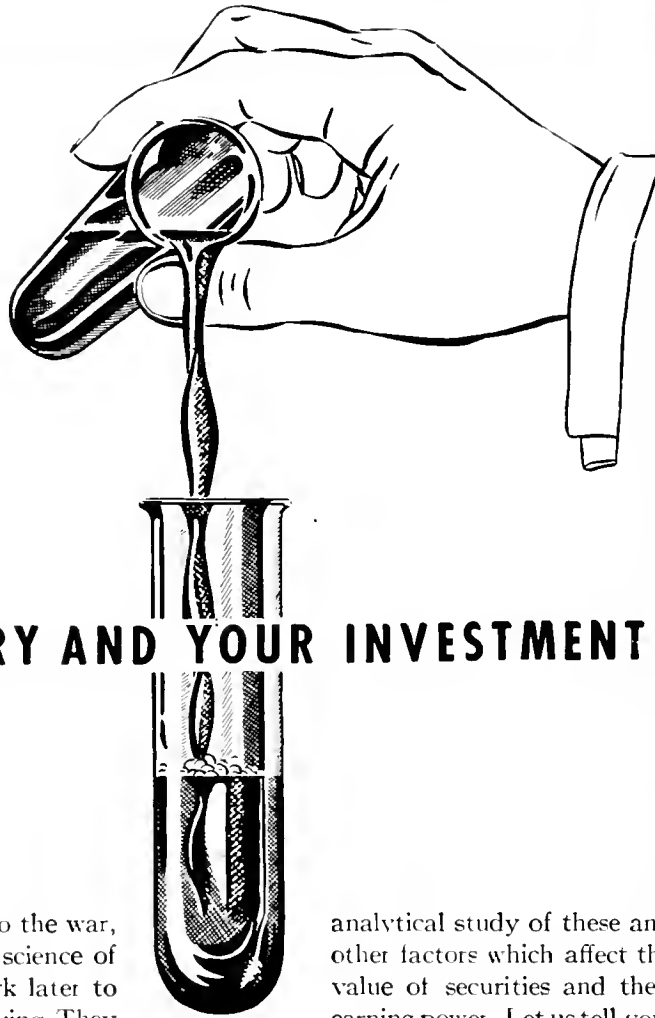

►► Under the Heading of Commencement

►► WE DID NOT SING Professor Everett's hymn "Commencement" this year in June. We did not remark that "from every State the sons of Brown who bear her torch aflame, return today to this dear shrine, the gift of youth to claim." As Charles E. Hughes, Jr., '09, the presiding officer at the Alumni Meeting in Sayles Hall, pointed out, the statement was hardly accurate nor the sentiment appropriate: the hymn had gone into reverse. Never have Brown men been so scattered over the face of the earth.

But it was a memorable Commencement for all that, even because of that. It was more than a run-through for tradition's sake. It had body—the alumni who came back "to pledge new love and zeal" made up no overwhelming crowd, far from that. But it had substance of thought, reminiscence, and utterance, too. And spirit. The spirit was deep, on the solemn side, humble, and very honest—like the Chaplain's prayer for the men overseas and over here in preparation. Sentimentalist or no, you were moved by this 176th annual Commencement for Brown University.

► THE RANKS of alumni and graduates were cut sharply, but there was the procession to the Meeting House, between showers. There were two Senior orations, one of which was reprinted in the *New York Times* magazine for July 16. In them, too, the war was reflected, for Carlton H. Gregory '44 spoke to the text written by an RCAF flyer, now dead: "We have cleared the site and laid the foundation. You build." And Nathaniel Davis '45, of a famous Brown family, also stirring proclaimed the "Ideals We Fight For,"—one of them "to fashion a law under which nations can be free."

There were degrees for graduates, many of them *in absentia*, men in classes from 1942 to 1945. There were certificates to two other groups: 1. students leaving to continue their studies in medical school, USNR Midshipman's School, or Supply Corps school. 2. civilian students withdrawn from College to enter the armed services of their country and honored with this token of "academic achievement and patriotic devotion." There were in all degrees for 55 Brown Seniors and 51 Pembroke Seniors, for one Ph.D. candidate, and 11 other graduate students.

► FIVE THOUSAND Brown men, in the armed services, were too busy for reunions this year, but those at home who were near at hand carried out this gracious act of friendship in simple fashion that suited the time and the opportunity. There were not a half-dozen large reunions among the 25 reported, but even where they were only "token" affairs they were worth the holding. Major interest centred in the Classes of 1879—65 years out, the 60-year Class of 1884, 1894, 1899, 1919, and 1924, although the following should also be included in any reunion roll call for June, 1944: 1890, 1891, 1893, 1900, 1902, 1903, 1904, 1905, 1906, 1907, 1908, 1909, 1910, 1913, 1914, 1916, 1923, 1934, 1939. Details are given on pages 31-33.

An innovation which proved welcome was the opening of two guest houses for alumni—Horace Mann dormitory and Warren House. Both were well employed by out of town men attracted by the various reunions, all in or near Providence this year.

NEW SEMESTER, NEW SEAMAN: July 1 saw the campus starting on its third summer semester of the war. Replacements arrived for the Naval Unit, as well as 100 new civilian Freshmen.

Except for the special review of the Brown Naval unit Saturday morning on the Middle Campus, the Baccalaureate service on Sunday afternoon, and the President's reception which followed on the lawn before Faunce House, the principal parts of Commencement were consolidated in the morning of June 19. There was room for the alumni in the Church this year, and after the graduating exercises they climbed the Hill again for the Sayles Hall meeting held before lunch.

The Alumni Meeting, only a short business session a year ago, proved a very rewarding session. It began with the National Anthem, a robust singing. Henry C. Hart '01, President of the Associated Alumni, announced the alumni election results and introduced Mr. Hughes. The Vice-President announced gifts to Brown of more than \$400,000. The Governor of the State brought a graceful greeting to the alumni and to Arthur Hays Sulzberger, one of the speakers. Mr. McGrath's good-humored reference to the autumn election brought a friendly laugh. Then we sang Henry R. Palmer's "Mother Dear, Brunonia," with C. LeRoy Grinnell '08 playing the organ in the loft which was familiar to him as an undergraduate. And behind the platform, hanging over the east window, was a new service flag for the University. The gold star represented 63, the blue star stood for 5041.

► WHAT DOES Brown University intend to do for the service man when he returns? President Wriston spoke to that point. The question could be answered briefly, he said: Don't exploit the returned veterans; educate them.

They were not to be used as educational guinea pigs, employed principally as a promotional device for a college, any more than they should be pandered to politically or exploited financially. Some of them were already back, and we were already helping them. We had discovered—as we knew we would—that they have been citizen soldiers. “Their citizenship is the foundation of their soldiery. Their citizenship, not their soldiery, is the permanent aspect of their lives. . . . When their part of the war is over, most of them hope their soldiering will be over, too.”

The boys and 40 of our Faculty went away to war without bombast or parade. “They will return in the same manner. Each will come back as an individual.” Returned soldiers will be taught, in part, by returned soldiers, too. These veterans teaching veterans will understand them, for they have shared experiences. We will have equipment for testing and counseling that will be of great assistance, “for Brown has never thought in terms of mass education” . . . rather, in individuation. (“It is well to remember that this

University has the longest record of educational testing and measurement of any institution in the country. . . . We have used them as a basis for guidance, but have not tolerated their abuse as a substitute for informed judgment.”)

There will be opportunity for refresher courses, for the trained whose “technical experience and specialized skills have been short-circuited by their war service.” In a new Department of Medical Sciences, advanced training can be given to those unable to return to medical schools but who wish to mature in their specialties. Similar opportunity, President Wriston hoped, would be available for other professions so that there would be facilities open to persons who “may come for credit, for academic recognition, for intensive review, for knowledge of new developments, or for more solid professional advancement.” Situated as Brown is, we have an opportunity and a responsibility. “We shall not let precedent or custom offer barriers to service.”

► “OUR GREATEST SERVICE,” the President continued, “will be in the field of liberal education. Upon that rock this institution was founded; it remains upon the same foundation. . . . After their military life is over, the men will find themselves faced with the complexities of civilian life. They will no longer have to take orders, no longer be faced with a chain of responsibility which can be passed either upwards or downwards. . . . They will be in the paradoxical position of having vindicated the democratic thesis without having experienced it. . . .

“Comprehension is the function of the liberal arts, for they deal with man in all his relationships, at all times, and in all places. They grapple with fundamental human problems if they are honest and competent. The returning soldier will not want us to pretend to teach the liberal arts and then prostitute them to contemporaneity or distort them by emphasis primarily on training. Nor will the soldier want a liberal arts program to seek escape from the modern world. We do not need to choose between the new and the old; we can, and must, have both. . . .

“This is the great objective. It must come before all else in our program. The mastery of that task requires teachers with emotional balance, cultural awareness, intellectual alertness; they must have perspective, a profound respect for the ways of others both in time and space. The faculty must have courage to make changes but an equal readiness to cleave fast to that which is good. It is no extemporized ideal, no jerry-built program. To those ends this faculty has long been working; to those ends they must rededicate themselves in the future.” (The complete text of Dr. Wriston’s address is available on request at the News Bureau at Brown.)

► MR. SULZBERGER, the first speaker, made a deep impression on his audience at the Alumni Meeting. He offered three formulae for a lasting peace, for “more than an interim between wars”: Universal military training; more interest by the press and the schools in the ends for which we fight; and more attention to our teachers. “I would not limit any freedom of study,” he said, “but I think we are warranted in teaching our own democratic faith and history before we turn to the isms with which they are now at war.”

The pre-war period was one of debunking—to become a cynic was thought to be growing up. Men abandoned their ideals and forgot the fault lay in the men. The new generation, he said, the soldiers are the heirs to our disillusionment, but both generations must jointly retain their basic faith in the American heritage of fair play and decency, pity and understanding, the Ten Commandments, Magna Carta, our Bill of Rights. We must “determine how best to avoid a

High Enough for the Gurkas

► IAN FORMAN ’46, who has been in the thick of the fighting in Burma as a member of the A.F.S. ambulance corps, tells this one to fortify the fame of the Gurkas and suggest their disciplined courage:

Some Gurkas who were going to become paratroopers were told by their British sergeant that the first day they would all go up in a plane and jump 1000 feet. First the captain would jump, then the sergeant, and the rest would all follow in their turn. The little mountaineers went into a huddle, a great deal of chattering ensued, but they finally agreed that everything was all right. The second day they would all go up again, this time to jump from 2000 feet. Again the huddle, with more chattering on a higher pitch, but they agreed again to follow their officers. The sergeant continued: On the third day they would climb to 3000 feet before jumping.

There was great confusion following this announcement, and even after a great deal of discussion the Gurkas could not reach a decision. At last one of their number stepped forward and told the sergeant that they would jump from 1000 feet or even 2000 feet, but they were sorry—they could not jump from 3000 feet. The sergeant, quite taken aback, made the inevitable reply: “But the captain will jump from 3000 feet, and I shall jump from 3000 feet . . .”

renewal of the distrust between generations." He proposed to concentrate "on developing the co-operation we now have rather than on creating the machinery for co-operation."

Brown's Highest Compliment

► ONLY five times before had the Susan Colver Rosenberger Medal been conferred. The award, "for specially notable beneficial achievement," is within the power of the Brown Faculty to make, and it has come to be regarded as the highest compliment which the University can bestow. Henry D. Sharpe, Chancellor of the University since 1932, received it this June, during the graduation exercises. The citation was thus addressed:

"Today you are completing 50 years as an Alumnus of the University, four decades as a Trustee, and 12 years as its Chancellor. In these relationships you have consistently exhibited the temper and qualities of a scholar, the impulses and habits of a philanthropist. With unflinching zeal for the strengthening of this institution, you have been a staunch defender of academic freedom, the most sensitive manifestation of a really free society.

"Therefore the Faculty of Brown University confers upon you its most distinguished award for specially notable and beneficial achievement, and I have the honor, on its behalf, to present to you the Susan Colver Rosenberger Medal."

Previous recipients of the award were the late Dr. Charles V. Chapin '76, for his pioneer service in public health work; Chief Justice Fred T. Field '00, of the Massachusetts Supreme Court; John D. Rockefeller, Jr., '97; Charles Evans Hughes '81, retired Chief Justice of the United States Supreme Court, and Mary Emma Woolley of Mount Holyoke College, a member of the class of '94 at Pembroke.

Mr. Sharpe is President and Treasurer of the Brown and Sharpe Manufacturing Co. of Providence, whose affairs he has directed for 45 years. He holds offices and directorships in many other Rhode Island enterprises, civic and commercial both. He was the leading spirit at the time the Providence-Cranston Community Fund was set up and is permanent chairman of its board of directors. He has twice been President of the New England Council. To Brown University his services and benefactions have been manifold.

Honorary Degree Citations

► THREE honorary degrees were conferred at the exercises in the Meeting House this June, to the Treasurer of the University, Harold C. Field '94; to Dr. Moses L. Crossley '09, Director of Research for the American Cyanamid Co.; and to Arthur Hays Sulzberger, publisher and president of the *New York Times*. The citations which accompanied them were as follows:

HAROLD CRINS FIELD, *Master of Arts*. For ten years you have made a gift of your full-time service as the Treasurer of the University. The discharge of those responsible duties has been a daily and tangible manifestation of the love you bear the college from which you graduated half a century ago. With industry and persistence, with humor and shrewdness, with thoughtfulness and wisdom, you have conserved and increased the material resources vital to its educational program. In honoring you we seek to express our deep sense of obligation and, even more, our warm affection.

MOSES LEVEROCK CROSSLEY, *Doctor of Science*. In the universal drama of the modern world nothing exhibits the international character of the scientific spirit more fully than the development of the sulfa drugs. Your significant

contribution to that thrilling accomplishment is merely one example of the wealth of your imagination, the discipline of your skill, the eagerness of your search for the bases of healthier living. For originality and leadership, we are happy to do you honor, and to the three degrees in course earned upon this campus, we now add a fourth, as well and truly earned in the wider school of experience.

ARTHUR HAYS SULZBERGER, *Doctor of Letters*. Capital and labor; government and private enterprise; local and state, national and international impacts; objective impartiality and considered opinion; intensely human and infinitely mechanical; the modern metropolitan newspaper epitomizes in its own organization and reflects in its columns the marvelous diversity, the vast complexity, every tension, and every paradox of the modern world. The administration of such a trust in the spirit of statesmanship, with a mind singled to the public interest, and with devotion to the welfare of humanity, deserves acclaim.

Ten Houses Deeded to Brown

► TEN of the Brown fraternities had deeded their chapter houses to the University at Commencement time when the Corporation unanimously adopted a resolution approving policy and procedure in its proposal to the fraternities. At the end of the meeting the following statement was issued by Claude R. Branch '07, member of the Board of Fellows designated to speak for the Corporation:

"An extended discussion of the problem of housing undergraduates, and particularly of the fraternity house matter, took place this afternoon at a meeting of the Corporation of Brown University. The meeting was largely attended, 37 members out of a total membership of 49 being present. A number of questions were asked and approval of the project, formally launched by a vote of the corporation at its meeting last October, was expressed by all who spoke.

"Members of the advisory and executive committee of 13, which had given particular attention to this matter, pointed out that the request for gifts of the chapter houses was but part of a larger plan for solving the housing problem in a manner best calculated to insure the future of the fraternity system. A full report was made of what the committee had done, and the corporation unanimously passed a vote approving of the steps which had been taken and directed the committee to continue its efforts.

"A vote was also passed expressing thanks to the 10 fraternities which have thus far deeded their chapter houses to the university and it was the unanimous opinion of those present that all the other fraternities should follow their example."

The 10 fraternities which have thus far accepted the University proposal are: Alpha Delta Phi, Beta Theta Pi, Delta Phi, Delta Tau Delta, Delta Upsilon, Kappa Sigma, Phi Gamma Delta, Phi Kappa Psi, Sigma Nu, and Theta Delta Chi. The other six property-owning fraternities are: Delta Kappa Epsilon, Lambda Chi Alpha, Phi Delta Theta, Psi Upsilon, Sigma Chi, and Zeta Psi, three of which are definitely listed in opposition to the proposal.

Plates Out of Stock; Reordered

► MOST OF THE CENTRES are out of stock in our supply of Brown University plates by Wedgwood, according to John Hutchins Cady '03, chairman of the alumni Memento Committee. Although a new order has been placed, production and shipping delays make it unlikely that delivery can be made before winter.

\$66,000 for the Fund ◀

▶ NEARLY 4500 BROWN MEN, many of them in the uniforms of the United Nations, sent back \$66,011.30 to the University through the 1944 Alumni Fund. The campaign, which closed June 30, established new records for number of contributors, the dollar total and the per capita gift, according to Arthur L. Philbrick '03 of Providence, chairman of the Brown Alumni Fund Trustees and leader of the nation-wide volunteer organization of 350.

The 1944 dollar total was \$9,630.70 above the previous all-time record of \$56,370.60 set a year ago. The per capita gift went up from \$12.95 to \$14.68, while the number of givers—4497—was an increase of 143.

"This accomplishment demonstrates the regard Brown men hold for their Alma Mater," Mr. Philbrick said in announcing the final figures. "The alumni gave 17 per cent more than in any other year, in spite of tax demands, patriotic investments, and other undeniable wartime appeals. The alumni knew that Brown was committed to war service more directly and more fully than ever before in her history. On the other hand, they knew that her income was sharply reduced. Alumni giving has therefore done double duty, helping to make Brown's role today an effective one and preserving her solvency for important years to come. All credit for the success of our campaign goes to alumni understanding and loyalty.

"As was the case a year ago, new contributors took the place of several hundred who were preoccupied with military duties. Nevertheless an amazing response came from the men in the armed forces, or their families. All branches of the service, all active theatres, and most training centres were represented.

"We turn this \$66,000. over to the University as a gift of free money for its current uses without restriction."

In addition, the Brown Alumni Fund this year received contributions of \$1,505.19 to the Alumni Endowment, which permits giving to the capital fund of the University as distinct from giving to current income. The Alumni Endowment, created 17 months ago, now stands at \$3,580.02 and added \$150. to the 1944 Alumni Fund as income on its capital.

A daily average of \$590 for the last 20 days of the campaign enabled the Fund to reach its \$66,000 mark. ◀

In Honor of His 25 Years

▶ DR. HARRY W. ROCKWELL '03, President of the Buffalo State Teachers College, has completed 25 years of service in this position. On this Anniversary, his faculty and Alumni Association both presented him with gifts in appreciation of his quarter of a century of service. The City Council of the City of Buffalo has just voted an addition of 42 acres to the State Teachers College campus, which will provide ample facilities for a new Library, an Industrial Arts building, a Home Management house, and two new Dormitories. This building program is to be undertaken upon the completion of the war.

Dr. Rockwell is acting President of the Brown Club in Buffalo. ◀

Red Randall Succeeds Tuss

▶ CAPT. ROY E. RANDALL '28, backfield star in Iron Man days, is the new Athletic Officer at Parris Island, where his Marine baseball team won 20 of 23 baseball games this season, including a stretch of 15 straight victories. Dr. Belkin's Inauguration

▶ ONE OF THE YOUNGEST men to be elected as President of an American college is Dr. Samuel Belkin, 33 years of age, who took a Ph.D. degree at Brown University in Biblical Literature in 1935. His inauguration as president of Yeshiva College took place on May 23.

Dr. Belkin studied in Poland, taking the first degree at Grodno in 1928, came to this country soon thereafter, attended Yeshiva College 1929-31, and then came to Brown. He was a student at this University 1931-35, during part of which period he attended also some courses at Harvard and Yale. While at Brown he studied under Professors Fowler, Burrows, Murphy and Casey. His thesis was published in the Harvard Semitics Series as a monograph under the title "Philo and the Oral Law".

Dean R. G. D. Richardson, of the Graduate School, represented Dr. Belkin's Alma Mater and spoke briefly on behalf of Brown University. ◀

Dr. Hill's Half-Century

▶ FOLLOWING the graduation exercises of Classical High School, Springfield, Massachusetts, on June 14, 1944, Dr. William C. Hill, Principal, Brown, 1894, was tendered a reception by the Parent-Teacher-Student Association of the school in the Mahogany Room of the Municipal Auditorium in honor of his 50 years of service to secondary education in New England.

Many prominent citizens and parents, together with hundreds of pupils and former students, assembled to congratulate Dr. Hill on his long record of continuous and outstanding service to the cause of education. Incidentally, he continues as Principal inasmuch as the Massachusetts legislature has passed a law permitting, for the duration, reappointments beyond retirement age.

The Springfield Chapter of the American Red Cross has named him as its chairman. ◀

The Rolcall of Reunions ◀ ◀

►► 1879—TWO WEEKS before the other reunions, the Class of 1879 held its 65th annual gathering on June 4. Dr. Stephen A. Welch entertained at his home, with William Ely and Judge Willard B. Tanner attending and posing for the *Bulletin* photographer drinking a toast to their Alma Mater. Edward S. Adams of Fall River was unable to be present.

► 1884—SIXTY YEARS out of College, the Class observed its anniversary with a week-end on the campus with headquarters in the Alumni Guest House set up in Horace Mann dormitory during the Commencement season. A feature was the reunion dinner at the Narragansett on the night of June 19, with seven of the 15 living members present (60 were graduated, according to Col. William M. P. Bowen's record). The group at dinner, which voted another gathering in 1949, chose the following officers: President—Rev. Charles R. Upton of Portland, Me., succeeding Prof. L. Raymond Higgins of Maplewood, N. J.; Vice-President—Augustus L. Holmes of St. Petersburg, Fla.; Secretary—Col. Bowen, re-elected. Col. Albert A. Baker, Edwin C. Gammage, and Theodore F. Tillinghast were also present.

► 1890—THREE MEMBERS of the Class lunched at the University Club on Commencement Day: Dr. Harry L. Grant of Providence, who had sent his customary blithe June letter to all the members, Walter W. Presbrey of Providence, and Rev. Hamilton E. Chapman. The Class will be saddened to note that Mr. Presbrey died July 14.

► 1891—A MEMORIAL SERVICE at the Class Fence on June 19 opened the reunion in the traditional manner, as a compliment to Fred W. Woodcock of Ashburnham, Mass., and Arthur H. Colby of Montclair, N. J., who died during the previous year. The group then joined the Commencement procession for the march to the Meeting House and lunched at the Hope Club after the Alumni Meeting. The following were present: Joseph N. Ashton of Andover, Mass.; Edwin A. Barrows, Frank L. Hinckley, President George J. Holden, Rev. Charles A. Meader, William Howard Paine, Rt. Rev. James DeWolf Perry, D.D., (honorary member), Dr. James L. Wheaton of Pawtucket, and Everett Cook of Chicago, son of Chester A. Cook. Messages were received from absent members: Dr. Arthur L. Beals of Brockton, Mass.; Prof. Edward B. Birge of Bloomington, Ind.; Rev. Charles D. Burrows of Jamestown; Mr. Cook; Clarence C. Converse of Englewood, N. J.; Rev. Frank G. Cressey of Granville, O.; Herbert L. Dunn of New London, Conn.; Martin S. Fanning; Elbert O. Hull of Bridgeport, Conn.; and Rev. Leo Boone Thomas of Framingham, Mass.

► 1893—A CLAMBAKE at the Squantum Club on June 18 was the feature of '93's 51st reunion, with President Edward B. Aldrich as host. Charles M. Poor of Clermont, Fla., and 15 others were present, including Edward H. Weeks, Robert M. Brown, John L. Casey, Robert Cushman, Rev. Edwin B. Dolan, Daniel Howard, Edgar M. Johnson, J. D. E. Jones, Stephen A. Hopkins, Daniel C. Snow, Rev. Elliott F.

Studley, George W. Perkins, Dr. William H. Magill, and Thomas P. Corcoran. On exhibition was the Alumni Fund bowl, won by the class in the 1942-1943 campaign. Mr. Weeks, class agent, reported, as did Secretary Brown.

► 1894—THE GOLDEN ANNIVERSARY attracted a fine gathering of the Class for the Commencement week-end, centering about the dinner at Agawam Hunt June 17 and luncheon at Chancellor Henry D. Sharpe's the following day. Mr. Sharpe, reunion chairman, received many compliments on the successful anniversary observance. A marine painting by the late Col. H. Anthony Dyer was presented to the Class by his widow and became the possession of Jay S. Fox as the result of a drawing at the Agawam dinner. The Vice-President of the University, Dr. James P. Adams, was a guest of the Class and spoke to all reunion groups at the Agawam that night.

Among those back for the 50th were: Harold C. Field, Fred Tenney, William T. Dorrance, Dr. Israel Strauss, David B. Pike, Prof. Harold D. Hazeltine, Daniel F. George, Herbert D. Casey, Walter D. ► OUR LEAD ARTICLE last month described "palm inspection" for the B-24s with which Sgt. E. T. Wilcox '43 had had his training in this country. It has a sequel in word this month that his bomber had been forced down in Switzerland on one of its first raids, and the former football manager is now interned in that country.

In his July Fourth cartoon, Frank Lanning of the Providence *Evening Bulletin* quoted under the heading of "The Independent Man" from a letter received from Ted by Maj. Edgar J. Lanpher:

"I don't think a person loses his individuality in the Army at all. If he has one, it is as a buck private that he finds it. What is lost in the ranks is the outward manifestation of individuality. To make ourselves individuals in the undergraduate mass, we become Cam Club presidents and football heroes. But in reality that proves

nothing of the individuality and self-reliance of soul, for the keys, rings and charms are only proofs that we are individuals in the eyes of others . . . I am almost glad I'm private ASN 11096201. I'm glad that the past is dead. I'm anxious to see myself pass the test. Even at Brown I had a good high school record behind me, a Brown Club scholarship, then a strong fraternity. Here I have nothing but myself. I have nothing to prove to anyone except myself.

"I think I have passed the first lap, at least temporarily. I find a great deal of enjoyment in marching down the road one man in hundreds, with a hundred men behind me, a hundred ahead, a half-dozen on each side—flanked by humanity and all alone. It's a warm, comfortable feeling. It fosters a self-consciousness born of an effort not to become one of the sheep. It's a real triumph to be able to walk by yourself . . . and watch . . . and think." ◀

Modern Idolatry

▶ PRESIDENT WRISTON drew upon the story of the golden calf for his text in speaking at the Baccalaureate Service, Sunday afternoon, June 18. Modern forms of idolatry, as foolish and fanatical as that of the Israelites, thrive in worship of the state under fascism, emperor worship in Japan, and worship of the machine as it threatens America. "It is in moments of

desperate reaction after high adventure . . . when spiritual elevation gives place to moral fatigue that men do things both futile and silly," he said. The worship of the golden calf "occurred close to four millenniums ago; yet we live in the midst of the same stupid sin."

"But the machine does not dominate this age," he continued. "Man is in control unless terror or stupidity destroys his capacity to function rationally—or to function at all. Then he falls into idolatry. . . . The way to the Promised Land is not through the leadership of the molten calf." Progress can be found only in the reality that "men are the children of God."

The Chaplain of the University, Dr. Arthur L. Washburn, and Dr. Albert C. Thomas, the Pastor of the Church, also took part in the service. It was followed by the President's Reception on the Middle Campus before Faunce House.

Dr. Strauss and Hillside ◀ ◀

▶ ▶ IN THE COMPLIMENTS received by New York's Hillside Hospital on its 25th anniversary last month, Dr. Israel Strauss '94 rightfully shared in large measure. "His was the idea of providing the proper type of institution to care for the curable mentally ill person in poor or very modest economic circumstances. The community was sorely in need of just such an institution. No such hospital existed."

As President of the Society of the Hillside Hospital since its inception, Dr. Strauss has seen, first, the campaign of education necessary at a time when mental health was not to be discussed in the open; then the establishment of mental clinics at Beth Israel and Lebanon Hospitals, followed by the first acquisition of property at Hastings-on-the-Hudson, and finally the construction on a 50-acre tract on the old Vanderbilt estate in Queens at Union Turnpike and 263rd St. The hospital is non-sectarian and non-profit, with a record of never having discriminated be-

tween the paying and non-paying patient's treatment.

Messages of congratulation to Dr. Strauss were received for the anniversary dinner at the Waldorf Astoria on June 7 from President Roosevelt; Dr. George S. Stevenson of the National Committee for Mental Hygiene, and others. Governor Thomas E. Dewey said, "It is heart-warming to learn that the faculty of Hillside Hospital has cured and returned to their normal place in society more than 2000 people." He also pointed out "how much its faculty have added to the progress of psychiatry, since it was one of the first places where electric shock therapy, insulin, and metrazol were tried." Dr. Stevenson said: "We have had many opportunities to refer to this as a model, warranting the attention of mental hospitals throughout the country." A fine portrait of Dr. Strauss provided the frontispiece of a souvenir book.

▶ ▶ An Outstanding Success in Track

▶ ▶ THIS third wartime spring season brought two Bruin teams varying success. The trackmen enjoyed their best season in many a year while the baseball nine compiled a record of four wins and nine losses.

During the winter months Coach R. K. "Rollie" Brown '33, now on duty with the naval reserve, laid the foundation for the Brown success in spring track. When "Rollie" left for active service, he tossed the ball to the Bruin coach-of-all-work Charles A. "Rip" Engle, who guided the destinies of the squad during the recently completed campaign.

The first meet in which Brown took part was the Greater Boston Intercollegiates which were held at Harvard Stadium on May 6. On that occasion, in the words of Joe Nutter '24, "Brown gained one of its most inspiring track triumphs of modern annals and the best in five long years or since the days of Kenny Clapp, John McLaughry & Co. . . ." When the smoke of battle had lifted from the Stadium's historic track it was clear that Brown had spread-eagled the field. The final totals gave the Bruins 75 1/10 points and Tufts their nearest rival had garnered only 39 1/10 points. Tufts, it is only fair to note, was seriously handicapped by the absence of some of its best men who were prevented from participating because of a student prank. Back in the ruck behind the two leaders came Harvard, Exeter, Boston College, Holy Cross and Northeastern, in that order. At this meet 14 members of the Bruin team scored. Dick Crossley, ace hurdler, with 11 points, and Bob Lowe, 1944 football captain, with 10, were the two leading point-makers. Brown men took first places in six out of the 14 events.

One week later at M. I. T. the 57th revival of the New England Intercollegiates was held. Here Brown came in third with 25 points trailing M. I. T. and Tufts who had 32 1/2 and 32 points respectively. Dick Crossley was again the outstanding Bruin performer with a first in the high hurdles, second in the broad jump, and third in the

low hurdles for a total of 10 points. A week later at Medford the Bruins secured revenge at the expense of Tufts when they nosed out the Jumbos in a dual meet 64-62. Dick Crossley once more the individual star with two firsts in hurdles and a second in the broad jump. Dick was closely pressed by Charlie Tiedemann who rang up a first in the 440 (this was the first time he had competed in that event), a first in the 100 and a third in the broad jump.

The 1944 Bruin track season came to a close on June 3 when Brown swamped W. P. I. 76 1/2 to 49 1/2 at Providence. Charlie Tiedemann, Dick Crossley and Stan Lewis of Brown and Hugo Norrge of the visitors were the stars of this meet, Tiedemann being high scorer with 13 points. Dick Crossley, the Cranston boy who now has been transferred to Trinity under the Navy V-12 program, was the outstanding member of this well balanced spring team. Dick scored a total of 46 points in four meets and was undefeated in the high hurdles.

While the Englemen were enjoying this great success, the baseball team was running into difficulties. Eddie Eayrs '16, coach of the nine, was faced with many problems. From the beginning of the season the squad was woefully weak in hitting, there were only two veteran infielders, and a general lack of capable substitutes.

With the situation as it was Eddie did well. The Bruin schedule consisted of 13 games—eight with college clubs and five with service outfits. The Bruins broke even in intercollegiate competition, winning from Bates, Trinity (twice), and Holy Cross, while losing to W. P. I., Harvard, Yale and Holy Cross. There was much stiffer competition from the service teams, many of which numbered on their rosters experienced professional and semi-pro players. The Bruins won none of these games, losing to Camp Endicott, U. S. C. G. of Boston, Camp Thomas (twice), and Camp Miles Standish.

►► "HIGH SCHOOL administrators would take pride in the fact that this year's New England high school basketball tournament was held within the confines of an educational institution—Brown University," said a recent *Bulletin* of the Connecticut Interscholastic Athletic Conference. "Whatever the huge gymnasium may have lacked in seating capacity for the unusually large group which sought admission was more than compensated by the fact that the games were being conducted in a building dedicated 'to symbolize those qualities of strength, courage and endurance which go far to make men invincible.' Thus reads the bronze tablet beneath the huge bronze bear on a pedestal in front of the building.

"At the dedication of the Brown Gymnasium, Dr. W. H. P. Faunce said, in part: 'Man is not made of mind and body; he is mind in body. And when we make better bodies we are making better minds. This building is just as great a part of our equipment as our John Hay Library. Physical well-being is essential to mental progress.'

"Neither players nor spectators knew of these prophetic words, but, in retrospect, we find our convictions as to the value of high school sports, especially during these days of stress and strain, wonderfully strengthened by the words of President Faunce."

First-Hand Opinion on India

►► "I've acquired much respect for the British as administrators and business men," writes Lt. Milton Korb '31, MC, in India with one section of the Rhode Island Hospital unit. "The tea garden hospitals run by the British for the coolies are often better than our large municipal hospitals and certainly better than most of our State institutions. They've found that it's not only philanthropic but also economic to keep the coolies in good health. Public health measures, such as anti-malarial work, are usually well done, and they look after the pregnant women and the infants. The Indian owned and operated gardens are not nearly as efficient, and coolie welfare is usually neglected. It seems whatever there is good in this country was brought in by the British."

It would hinder, not aid, the war effort. The Indians are not yet able to govern themselves, the mass of them are easily led by any demagogue willing to play on racial prejudice. As it is now, it is only the British who now keep them from jumping at each other's throats."

Lt. Frank S. Williams, Jr., AAF, back from 10 months of flying and fighting in southern and eastern Europe, "has declared a personal war on Rhode Island lobsters," said an illustrated story in the *Providence Evening Bulletin*, June 16. And there was Frank's picture with a big lobster on the table, all ready for demolishing. "He had a cold boiled lobster before he went to bed last night," the story went on. "He had lobster for lunch today. He said he intends to have broiled lobster for dinner tonight." Pork chops came next after lobster. Between meals, Frank admitted to having been on 50 missions, some of them "pretty rough," and to having had the daylight scares out of him the first time he saw rockets from the German-rocket launching planes. He took a crack at the Romanian oil fields, bombed targets in Austria, and hit Munich and other enemy centres. He wears the Air Medal with six Oak Leaf Clusters. After his 21-day leave, he reported to Atlantic City for rest and then for re-assignment.

Ray Comyn is an Ensign in the USNR, with his home and present mail address, 3 Banham Ave., Quaker Hill, Conn.

Duncan W. Cleaves is still with the Chile Exploration Co. at Chuquicamata, Chile, working at the mine there which is probably the largest single copper-ore body in the world and one of the largest copper producers. The mining town is 10,000 feet high in the north Chilean Stacama Desert near the nitrate fields of Marie Elena and at the edge of the Andes. A few months before the United States entered the war, Duncan signed a three-year contract as chemical engineer with the Chile Exploration Co., a subsidiary of Anaconda. In Chuquicamata he met and married Sara Lazarte Vince on June 6, 1942.

Since Peter DeNyse Brown, born Feb. 12 to Ens. and Mrs. Frederick D. Brown, has had a total of eight forbears at Brown, the father hopes "we'll see him at Brown in the Class of '66." Fred was at the Navy's Diesel Engineering School at Cornell when he wrote but by now may be seeing sea duty.

Air Corps. Myself, I just keep watching those caissons go rolling along." (As a Captain.)

Jewett's Favorite Story

► LT. WILLIAM A. JEWETT '41, USNR, is CO of a converted minesweeper, one of the few vessels with Navy personnel operating in the Greenland Patrol. Martin Sheridan, former Providence newspaperman and now a free lance war correspondent, had chow with Bill not long ago, and wrote about it for the *Providence Sunday Journal*.

On the 26th of January we had gone together, as always, on an attack of a Japanese stronghold and to my (and his) delight he shot down four Jap planes for sure. For this action, which gave him a chance to show what an expert pilot he really was, he will be recommended for decoration. On the afternoon of the 30th, we had a hurry-up call for fighters, and Douglas volunteered to go with me to help foray the escort for the bombers, although he had already completed one dangerous mission that day. We were safely home and all but ready for supper when the tragedy struck."
