Equipping Brown's large football squads this year was a headache for Trainer Jack McKinnon. The first turnout just about exhausted his war-diminished stock of shoes and other gear. One of Brown's most loyal alumni paid for the outfitting of the team anew, and uniforms will possess far more color than ever before. Paul Swaffield '16, alumni representative on the Athletic Council, designed them.

The 1946 squad has the best spirit he's ever seen, Coach Engle says. Such enthusiasm, both on and off the field, can often compensate for other deficiencies, he believes. Still, he was worried as opening day drew near, for Canisius had the bene-

► ► It Will Be a Triumphant Year, If . . .

► ► IN A WORLD OF CRISES—political, economic, diplomatic—none is more acute than the educational. The situation is critical at both ends, demand and supply. The demand for college training surpasses all previous records. This was to be expected after the war. It arises from two factors, one temporary and one permanent. A temporary surge was sure because there are many who planned to be in college, but were in the armed forces instead. As the war lengthened their number multiplied. The speed of demobilization delivered that huge pent-up demand all at once, or nearly so. Those boys are in a hurry. They feel that war service has made them two, three, or four years late in the civilian race. They want to waste no time, and the idea of waiting another year is naturally and properly distasteful.

The permanent increase in demand arises partly from the war and partly from forces already at work. The acceleration of demand has been almost continuous for 30 years. Earnestness about the democratic ideal, a disturbed labor market, eagerness to "get ahead," and mere social convention combined to stimulate attendance at college. All these forces were greatly intensified by the war. Democracy now embraces, even more than before, the ideas of social and economic as well as political equality of opportunity. Veterans rightly feel the "trained" mind has a better chance for a good job. Finally as more go to college, still more follow the crowd. When government pays part of the cost the rush is overwhelming.

► SUPPLY is the other prong of the crisis—and a very sharp one. Larger numbers require more space in classrooms; laboratories, libraries, dormitories, and dining rooms. But war restrictions forbade expanding facilities to meet the clearly foreseen need. Postwar shortages of materials, exorbitant costs, and slow rate of construction make it difficult if not impossible promptly to supply deficiencies.

Larger numbers require more equipment—books, microscopes, chemicals, and literally hundreds of other items. During the war the normal wear and tear continued; indeed it increased because of the year-round continuous program; meanwhile replacements were unavailable. There is less usable equipment now than before the war. Most needed items are in short supply, deliveries are long delayed, and costs are high. Often essential teaching materials are not obtainable at all.

Larger numbers require new programs of study to meet the varying capacities and interests of the students. More programs for more students require more teachers. And teachers constitute the most critical shortage of all. During the war new instructors were not being trained; there is, therefore, no reservoir upon which to draw. The available number has been lessened by the normal number of deaths and retirements; it was reduced even further and even faster by the recruitment of personnel for government and industry from among the professors—the largest body of experts available, and the most poorly paid.

That is the situation—more students than ever, no more space, inadequate equipment, and a famine of teachers. To meet the crisis every facility is being stretched to its limits, emergency measures are being adopted.

► BROWN WAS READY with its new curriculum, postwar planning in that respect was well advanced. Ever since V-J Day the search for new faculty has been pressed with unrelenting vigor; in a highly competitive market many more new appointments have been made than in any year in Brown's history—and some of the most distinguished. Emergency housing is at last under way, and a new classroom building is going up in record time. A permanent dormitory for Pembroke is under construction and Brown housing plans await enough gifts and adequate materials. To take care of as many students as possible historic policy has been jettisoned and late afternoon and evening classes have been provided for veterans so that they may earn their degrees even though not eligible for the regular courses.

In short everything is being done which can humanly be attempted to fulfill the hopes of youth and the expectations of the public. The year will be a triumph for education if there is understanding public support and unwearied patience to match the energy and resourcefulness of the faculty.

► Preview and Apology

► ► AS THIS IS WRITTEN, twelve days before the beginning of Freshman Week, the entering class is 764 strong. This is by far the largest new class Brown has ever had—nearly twice the size of the average pre-war class. At the same time it is the most highly selective group that ever entered Brown, for these men were chosen from nearly 5,000 bona fide applicants.

In the next issue of the ALUMNI MONTHLY I hope to make a complete report on all aspects of the group. However, the bare figures given above may suggest how great a turmoil the Admission Office has been in since the first of the year, and it is because of this turmoil that we have been unable to give alumni and friends of the University the service to which they are entitled. Letters have gone unanswered for weeks; telephone calls have failed to reach us; admission materials have been mislaid; in many ways we have fallen down. For these things I extend abject apologies.

However, some additional facts should be presented. We will receive over 100,000 pieces of mail in the Admission Office this year; on many days the total was over 500. Every one of the nearly 5,000 applications involved at least five exchanges of mail; some required twenty or more. Telephone calls have come in at the rate of over 100 a day; some days it was twice that. As many as 50 people have called personally at the office in one day. Filing became an unbelievably complicated problem, with tens of thousands of letters and credentials to be handled.

Superhuman effort was not enough. We have worked an average of 65 hours a week; many weeks we put in 80 hours. Secretarial help was hired as fast as it could be found. Still we could not keep up.

I offer these facts only in the hope that the situation that faced us will be better understood. These are not excuses but explanations. We deeply appreciate the extensive interest alumni have shown in the class. We are sincerely sorry for those occasions when we failed to live up to that interest. And we particularly regret that there was no place at Brown for so many good applicants in whom our understanding alumni had special interest.

Working It Out ◀

▶▶ **LONG BEFORE** Sept. 25, the date on which the Van Wickle Gates were to swing inward for the start of Brown's 182nd academic year, it was apparent that there were acute problems in connection with the double-size College and University. The overwhelming Freshman class of 800 men was expected the previous week, with the population of the College estimated at 2650, as compared with the pre-war class figures of 400 and total student body of 1400. To the north, Pembroke was experiencing a similar growth, begun during the war, and registration was expected to hit 825; a Graduate School of 400 students was indicated. On top of all this, the new Veterans Extension Division, with courses of college standard and for college credit, will be over 450. The grand total is 4325.

Of the Freshmen, roughly 55% will be veterans of military service, the balance coming directly from high school or prep school. Emery R. Walker, Dean of Admission, has described the entering group as the strongest in University history from an academic point of view, because of the extraordinary competition among applicants and the degree of selection exercised as the result. Probably 4000 boys were denied admission. The volume of activity in the Admission Office is reported elsewhere by Dean Walker and is shown in the fact that its staff has grown from one officer and three secretaries to four men and 11 secretaries. Two hundred phone calls a day, 500 letters a day, and 100,000 pieces of mail in a year suggest the pressure, which has been met by 80-hour weeks in that office.

▶ **THIRTY-SIX STATES** are represented in the Freshman class, as well as Hawaii, and nine foreign students from seven countries—in addition to those 111 other members of the Class of 1950 who had started their studies in the summer session. New undergraduates include those from Canada, Greece, Italy, China, Norway, Guatemala, and the Dominican Republic, with others applying from India, Germany, Turkey, Poland, Hungary, France, and several Central and South American countries.

A housing dilemma, solved as described on another page, complicated the admissions problem. Among efforts to cope with the inadequate facilities was the contemplated rental of summer hotels in Wickford and Narragansett. A wonderful public response opened private homes to Brown students, saving the situation for several hundred of them, and no one was without housing for more than a couple of days, during which time cots in the Marvel Gym gave a place to sleep until they located something from among rooms listed with the Emergency Housing office in Faunce House. Tender of a Brown and Sharpe apprentices' dormitory eased the problem for 27.

With the start of the new curriculum at Brown, another factor enters the necessary planning, but there will be no full basis for schedules until registration. How do you predict book demands? Past percentages and distributions provide no positive guide, since course offerings are so differently accented, and the usual early registration was out

of the question. Counselors, who expected to work from 9 a. m. to 10 p. m. in Freshman week, found early that Biology 1 would be over-registered, for example. Between 40 and 50 sections will be necessary to handle more than 1100 men taking Freshman English, according to another early estimate. You can imagine the problem the Registrar faced in having to work out assignments of men to the limited classroom space under the circumstances, and the department heads' figuring to provide the instruction. Whitehall, the new classroom building behind Marston Hall on Brook St., is going up with what would be fair speed even in normal times, but its provision for 900 lecture auditors will not ease the load until the semester is a few weeks old.

▶ **IN PLANNING** for the Convocation to open College, Acting Vice-President Arnold realized that no more than 1000 students would be able to enter Sayles Hall. The balance will hear President Wriston's speech through amplifiers outdoors. Once College starts, there will be three chapels a week in order to provide a service for each student once a week.

Supplying books in an impossible market, handling veterans' finances, regulating library use, distribution of mail, speeding delivery of desks, lockers for off-campus students, feeding the large College—these will be some of the questions. The Purchasing Department, tackling problems that range from refrigerators to football uniforms; the Stenographic Bureau, with vast orders of mimeographing and mailing to be done in a hurry; Buildings and Grounds, with the whole readying of the physical property to worry about—the pressure passed no one by. The thing to marvel at was the good spirit, the understanding, and the patience on every hand.

The Freshmen will be greeted by a rigorous academic schedule and elaborate social program. The newcomers encounter a week of placement, aptitude, and distribution tests; conferences with advisors, orientation lectures, and other official and unofficial advice; physical examinations required of all, swimming tests, and the whole introduction to Brunonia. As usual, a student committee of the BCA will help the newly arrived to find their way, a service more important than ever this year. The social side of the week will start with a supper, preliminary to a meeting in Sayles Hall where representatives of the Faculty, student body, and alumni will welcome them. An athletic night, a Freshman dance at Pembroke, a Pembroke dormitory open house, a BCA weekend at Camp Yawgoog in the pre-war fashion, student-Faculty reception, coffee hour for students and Providence clergy, and movies fill the calendar. It will easily be Brown's biggest Freshman week, for in addition to the first year men, 200 transfers are also invited, and wives of married Freshmen will also be welcomed to most social events.

Dr. Bigelow, Recovered, to Travel

▶ **RETURNED TO GOOD HEALTH** after his serious illness and operations of last spring, Vice-President Bruce M. Bigelow resumes his work for Brown University in October, and Brunonians everywhere welcome him back. Dr. Bigelow will not be on duty in University Hall for some time, however, for he will be traveling in the interests of the alumni program and the Housing Campaign. His first trip will take him to Washington and Baltimore, and later itineraries will probably include the Middle West and Far West.

Dean Samuel T. Arnold will continue as Acting Vice-President until Dr. Bigelow has completed his work in the field.

On the Gridiron ◀

FIRST SCORE: Brown 14, Canisius 7.

▶▶ COMPETITION FOR POSTS on the 1946 Brown football team had never been so keen as Head Coach Rip Engle drove his squad of 85 through intensive double-session drills before the opening of college. There was plenty of material to work with, but inexperience was readily noted. As Dick Fales says, that's why you have coaches.

Fashioned from a squad composed of newly discharged veterans, ex-Bruins once again on the campus, a dash of 1945 lettermen, plus a few civilian newcomers, this season's team should be deeper and stronger than that of last year. The only hitch in that is that all our opponents will be deeper and stronger, too. It isn't a question of how good you are but of how much better you are than your rivals. Radio Station WEAN (790 on the dial) will carry most if not all, of the Brown games.

There have been days since Sept. 3 which have gladdened the hearts of the coaches, other days which have left them battling gloom all around their locker room after work. They seemed to feel that we would have a powerful, com-

petent line, with question marks operating in the backfield T formation. No squad has ever seemed more willing, but there was a lot to be done in a short time, for the new rules of the Ivy Group restricted the length of the pre-season practice period. Not all opponents were so limited: Canisius, the opening day attraction Sept. 28, came to Brown Field primed with seven weeks of workouts under Earl Brown, former Brown assistant, that began Aug. 8. Still, Engle and Company crammed real progress into the sessions—morning and afternoon through Sept. 21, with three evening classes as well. A game scrimmage with Connecticut gave a chance to test the squad a bit before the official kickoff.

▶ SIXTEEN MEN IN COLLEGE have earned Brown varsity letters in the past, six of them on the 1945 eleven, including Captain Jim Lalikos, an All-New England lineman who operated for the North against the South at Montgomery, Ala., last winter. A few men had experience at other colleges before coming to Brown. Five members of the 1942 team were out early—Roy Swingler, Bob Babcock, Hank Pilote and Charlie Bentley, backs, and Lou Regine, center, all veterans of military service. Other letter-men from previous lineups include: Grimshaw, Nicholas, Finn, Iacuele, and Schuster, from last Fall, and Collier, Petropoulos, Dorsey, and Heinz.

Inexperience aside, the 1946 Bruin forward wall should be big, fast, and powerful (17 boys on the squad tip the scales at 200 or beyond), with especial strength at tackle and center. Lalikos and Paul Flick seemed to have clinched the starting assignments at tackle, but there is no need for them to play 60-minute ball. Flick, a native of West Virginia, is one of the biggest boys on the squad and played both tackle and center in a year of pre-war play at the University of Maryland. He was a standout in the spring practice. Bob Rougvie, brother of the late Andy Rougvie '33, has shown constant improvement, while Bill Grocut, a rugged Amesbury boy who attended Naval Academy Prep, is another contender. Another good tackle is Stanley A. Ward, Jr., son of the Rose Bowl player in the class of 1917. Catching the coaches' eye was Don Colo, a 255-pounder who stands 6-3 from East Bridgewater. Although he played basketball in school, this is his first try at the gridiron sport.

The leading center candidate is Lou Regine, captain of the 1941 Freshman eleven. A strong offensive player, this Providence boy who came back from the armed forces last spring, is particularly notable as a line backer-up and pass defender. Until he was hurt, Regine's principal understudy was Joe Condon, a good place kicker, too, who starred at Wilbraham and Rockland High in Massachusetts. Now it's Ed Kiely, who was a high school rival at Abington, who is apparently number two of a good center contingent.

Bud Schuster, who earned his letter last fall at center, has moved back to end. With him are George Boothby, who prepped at Marianapolis; Bob Searles of Rahway, and the greatly improved Spoff Brown of Amesbury, who is one of the best pass catchers. Paul Zuber, a former Brown end, is again a candidate, too. Among the guards Bill Hair of Worcester Classical has bolstered his chances on the strength of his quick blocking reactions and down-the-field work, and another newcomer is Bill McLellan, a former yearling at Colgate, who has been transferred from the tackle squad. They contest a position well fortified with former lettermen: Bob Hambleton, Norm Iacuele, John Petropoulos, and Alan Collier, erstwhile end. Veteran Tom Nicholas was in here, too, until a broken wrist sidelined him. Alan Ross, 190-pound Ohioan, is the son of Earl C. Ross '08.

► **DESPITE THE FIRST MISGIVINGS**, the offense began to click as the rehearsals wore on. (Scrimmages had to be frequent and lengthy in order to appraise the large squad in a short time.) And the reports carried more than a few names, as each man seemed to have his good days. It will be consistency which will settle the argument for top quartet. Ed Finn is the only holdover from last year, the passing and dropkicking quarterback from Bethlehem, Pa. Preston Barry, southpaw passer from Weymouth, and the fast improving Red McLain also will see use in running the team and handling the ball in the Engle Wing-T.

The pre-war lettermen, returned from the armed service, should be in the front of the scrap for starting nominations. Dorsey, who played at Coast Guard Academy during the two seasons between his year at Brown, has recovered his old agile power, while the elusive Swinger has also hit his stride after taking off some weight. Henry Pilote is bigger and heavier than when he came to Brown originally and is one of the leading punters. Charlie Bentley, chunky Negro who was a dependable blocker before the war, dropped off 35 pounds of unnecessary weight during the summer and looked very fit in the opening workouts; but he has lost his zest for football and may not stay out. The same is true of Bob Babcock, a versatile pre-war operative. Connie Karambelas is back after Navy wanderings, and

Mannie Costa of last year's squad reported late. John Heinz was a letter-winning back while here with the V-12, and Clark has worn a Brown uniform before, too.

Among the new faces are those of Joe Paterno, Brooklyn halfback, Marty Bissell of New Rochelle, and Bill Gresh from Wilbraham, all better than average carriers; Ernest Lyons of East Providence, a rugged line-bucker and hard runner and Bob Shaughnessy, a 195-pounder from Brooklyn Prep, two promising fullbacks. Dave Taylor from Peddie broke loose at times in scrimmage, while Gaffney of St. John's Prep and Arnold Green from Worcester are breakaway runners, the former compact, the latter a bigger boy. Roger Young of Bay Shore, L. I., was going well when he hurt his shoulder. Poirier is another Freshman who has looked good in scrimmage. Milt Hodosh, NEAUU javelin champion, played football at Hope before going into the service and has joined the backs. Sharp of East Providence is a scrappy lightweight whose spirit Engle likes.

Nothing is fixed in the backfield situation, and all need conditioning in the Engle offensive, so that you'll probably see many a replacement during four quarters. "They're all eager to learn," Engle says, "and they're easy to coach." Squad statistics appear elsewhere in this issue.

Two other veterans whom the Brown boss would like to see in uniform are Roger Williams, former captain, and Joe McMullen, V-12 linesman. They are back to get their regular degrees, but they probably won't be on the approved grid list since they were awarded the special degree of Bachelor of Naval Science when they were commissioned from our Naval unit. They are out helping handle the huge squad.

No admission will be charged. Worcester will play either the Jayvees or the Freshmen, leaving the decision to us, and it had not been determined which when we went to press. ▶ THE TWO NEW ASSISTANT coaches will be seeing their first season of Brown football this fall—Wilber E. Ewbank, former three-sport star at Miami University, Oxford, O. Weeb will be head coach of Varsity basketball this winter and is in charge of the backs under Engle. He reported at the opening of spring practice and has made a fine impression with his drive, teaching ability, knowledge of the game, and his friendliness. His previous professional experience includes the teaching of physical education at his Alma Mater, where he also coached, before entering the Navy in 1943. While stationed at Great Lakes Naval Training Center, he was assistant coach of football and coach of basketball.

Also popular is the new line coach, Gregory Zitrides of Manchester, N. H., who was the star guard on Dartmouth's 1936, 1937, and 1938 elevens. Gus went to Cornell in the year after his graduation to serve as head Freshman coach and Varsity assistant until 1942. During the war he was an officer in the Navy physical fitness program and in 1943 was coach of football at Chapel Hill, N. C. In addition to his football duties, Gus is serving as an instructor in Brown's physical education program.

John McIntyre, star center on Notre Dame's 1938 champions, is back for a second straight season as assistant line coach. He was captain of the North team in the inter-sectional game with the South in 1940 and, as skipper of the night fighters on the Hornet, earned himself a flock of medals.

Two Brunonians will have the Freshmen in hand. Paul A. O'Brien '45, former Varsity quarterback and track star, was discharged from the Navy last spring after destroyer and comes back to the campus to take charge of the yearling squad, in addition to serving as instructor in Physical Education. Assisting Pat is Arnold M. Soloway '42, outstanding tackle on the 1939, 1940, and 1941 teams. A veteran of Coast Guard duty in the Pacific, he will boss the first year line.

A Bequest from Dr. Marsden

▶ A \$2500 BEQUEST for scholarship purposes was left in the will of Dr. George Marsden '00 of New Bedford, who died after a year's illness May 20, 1946. Prominent as a Physician in that city for 40 years, he had also been active and loyal on Brown's behalf. Born in Berkley, R. I., in 1878, he lived in New Bedford from boyhood, and was educated in its schools before coming to Brown. He took his medical studies at Johns Hopkins. Dr. Marsden was a member of the American, Massachusetts, and New Bedford Medical Societies, the Star of the East Lodge of Masons, the First Baptist Church, the Executive Club, and the Masonic Square and Compass Club. Mary Boardman Marsden, whom he married in 1909, survives him, together with his brother Alfred.

▶ Mackesey Returns

▶▶ "BACK ON THE SQUAD" was the heading on Lanning's cartoon in the *Providence Journal* when Brown announced the return of Paul F. Mackesey '32 as Associate Director of Athletics. The Lynn lawyer, outstanding in two sports as an undergraduate, reports for duty Oct. 1 to work with the present Director of Athletics, Dr. Walter H. Snell '13. The first of the year Mackesey will succeed the latter, who will be relieved thus of the double burden which he has carried during the war years and will be able to devote full time to his responsibilities as Stephen T. Olney Professor of Natural History and Chairman of the Department of Botany.

Mackesey, recently out of the Army, was inducted as a private in 1942 and discharged as a Captain in 1946. He served overseas with the 100th Bomb Group, 8th Air Force as an intelligence officer. He attended Officers Candidate School at Miami receiving his commission in the same class with Clark Gable.

Prior to entering the service from 1938 to 1942 Mackesey conducted his own law practice in Lynn, Massachusetts. He was graduated from Boston University law school with an L.L.B. degree in 1935 and was admitted to Massachusetts and Federal Bars. Between 1936 and 1938 he was connected with the Works Progress Administration recreational program in Essex County, Massachusetts, and Lynn.

▶ PROF. SNELL HAS BEEN a member of the faculty since 1920, prominent in Brown athletics since his undergraduate days, and for 19 years coached in various sports including football, basketball and baseball. He has been doing a yeoman job as Athletic Director during the war years following the resignation of Thomas W. Taylor in 1943. He adapted himself readily to the heavy demands of the post under abnormal conditions and won Brown many new friends.

"I look forward to welcoming Paul Mackesey to the Athletic Office at the Marvel Gymnasium," Dr. Snell said in August. "He was one of Brown's finest football players

and was a prominent and popular undergraduate. He has been a very active alumnus. He knows Brown athletic traditions and policies and he has had executive experience. He has the qualifications to make the kind of director of athletics which Brown needs in the difficult coming years."

Mackesey came to Brown from Lynn Classical High School in 1928 and shortly became active in campus affairs. He was president of his class as a Sophomore, an officer again in his Junior year, and First Marshal of the Seniors in 1932 when he received his Ph.B. as an economics major. He received honorable mention on several All-American football teams for his play as a tackle and captained the varsity in 1931 which won seven and lost three games. He played four years of lacrosse as well, being chosen captain of the freshman team.

Mackesey sang in the Glee Club for three years, was chairman of the Junior Prom Committee, a member of Brown Key, Owl and Ring, the Senior Ball Committee, and the Cammarian Club. He served on the Undergraduate Athletic Council and was chairman his Senior year. His fraternity is Delta Tau Delta.

► AFTER GRADUATION he played both professional lacrosse and football. He was for a time a member of the champion Les Canadiens lacrosse team in Montreal and toured with the club in this country after the season. Entering Boston University Law School in the fall of 1932, he was assistant coach of lacrosse at Boston University and played tackle on the Pere Marquette eleven which won the New England professional football championship.

Mackesey is a member of the Association of New England Football Officials and the Eastern Intercollegiate Association of Football Officials. He is a former president of the North Shore Brown Club and a member of the Boston Brown Club as well as a class agent in the Brown Alumni Fund.

Married to Sara L. O'Donoghue, a graduate of Manhattanville, he has one daughter Susan, two and a half years old. The new Associate Director of Athletics is the son of Mr. and Mrs. Frank P. Mackesey of Lynn, Massachusetts. His brother, Thomas W. Mackesey, is Professor of City Planning and Assistant Dean of the College of Architecture at Cornell University.

ASME Choices ◀

►► PRESIDENT of the American Society of Mechanical Engineers and one of his principal vice-presidents for 1946-47 will be drawn from the Brown Class of 1919. Nominations tantamount to election were listed in the August issue of *Mechanical Engineering*, with Eugene W. O'Brien, for 10 years vice-president of the W. R. C. Smith Publishing Company of Atlanta, Ga., indicated for the top post. Alton C. Chick was presented as the candidate for regional vice-president, renominated from New England for a year.

Mr. O'Brien became a member of A.S.M.E. 25 years ago while a member of the Brown Engineering faculty. He had taken his B.S. in electrical engineering in 1919 and received his ScM. in mechanical engineering in 1921. After teaching at Brown for four years, he accepted a similar post at Sheffield Scientific School, Yale University, where he also earned the M. E. degree. He spent much of his time in consulting engineering, including some independent commissions in the fields of mechanical, electrical, and power design and construction. In 1927 Mr. O'Brien became editor-in-chief of the *Southern Power Journal* and

in 1933 its managing director (later it became *Southern Power and Industry*).

He has served the A.S.M.E. in many capacities: as manager 1931-34, as vice-president 1934-36, and on a number of committees. A member of the American Institute of Electrical Engineers, he is chairman of their national Committee on Student Branches. During the war he was engineering consultant to the War Production Board and War Manpower Commission. He holds membership in the Newcomen Society of England, Society for the Promotion of Engineering Education, Pi Tau Sigma, Tau Beta Pi, and Sigma Xi. At home he is chairman of the Fulton County (Atlanta) Planning and Zoning Commission, director of the Atlanta Athletic Club, East Lake Country Club; national director of the American Society of Planning Officials; charter member of the Georgia Engineering Society, and member of the Society of American Military Engineers. He has contributed frequently to the technical and business press.

► THIS IS ALSO the 25th anniversary of Mr. Chick's association with A.S.M.E. He, too, was an instructor at Brown, in addition to getting two degrees in the Engineering Division. His service in World War I included assignment to the U. S. Naval Steam Engineering School and sea duty. Employed by the Associated Factory Mutual Fire Insurance Companies, he became principal assistant to its president, John R. Freeman, in 1922 and worked on a variety of problems in water supply, earthquake damage, and two 900-page books. Upon Mr. Freeman's death 10 years later he became engineer with the Manufacturers Group, later merged to become known as Manufacturers Mutual. Since 1938 he has been assistant vice-president and engineer, applying engineering principles to fire prevention and plant protection. His duties also involve the underwriting and rating of fire-insurance risks valued at more than \$5,-600,000,000.

In A.S.M.E., Mr. Chick has been a member of the national executive committee for three years, chairman of the Providence section and chairman of the national committee on relations with the colleges. He has been president of the Providence Engineering Society, treasurer of the Associated Alumni of Brown, vice-president of the Brown Engineering Association, and treasurer of the Eastern section of the Seismographical Society of America. He now serves the City of Providence as member of the Law Revision Committee to help draft a new building code. He was deputy director of the utilities division of the Providence Civilian Defense Council and member of the State's CD utilities branch. (Photos on page 51) ◀

► THOMAS J. WATSON, JR., '37 was elected a Vice-President of the International Business Machines Corporation at the meeting of the Directors early this summer. He had previously been assistant to the Executive Vice-President.

He joined IBM in New York on graduation from Brown and in his first 14 months as senior sales representative twice qualified for memberships in the Hundred Per Cent Club, the company's sales honor organization. He was in military service from 1940 through 1945, returning to IBM on Jan. 1 this year. Mr. Watson rose to the rank of Lt. Col. in the Army Air Forces and holds the Air Medal and Commendation Ribbons in addition to service ribbons for the American, European, and Asiatic-Pacific Theatres, the American Defense and Philippine Liberation. ► ► They All Have a Room, Somewhere

► ► **WE'VE ALWAYS MAINTAINED** that town-and-gown relationships between Providence and Brown were unusually happy. This fall we've just had impressive proof of this fact, at a time when it would have been tragic to learn the contrary. The University made an appeal to the community, and the community responded splendidly, to meet a critical need.

To be sure, there was another motive in that response, for the appeal was not primarily on behalf of Brown but on behalf of several hundred students, most of them war veterans, who were without dormitory accommodation on the Brown campus. Nevertheless, the point is that, when Brown asked the home-owners of Providence and nearby towns to share their houses with students, room was found and a welcome extended.

With dormitories and fraternity houses reserved to capacity, 500 unmarried students were without rooms. In addition, 60 married veterans and their wives—over and above those to be housed in the transplanted buildings near Marvel Gym—had to be provided for. The University presented its case to Faculty members, to alumni, and to the public, with superb co-operation from press and radio. Before College opened, more than 1000 offers of rooms, apartments, an makeshift quarters had poured into the Veterans' Emergency Housing Office in Faunce House. And a grateful University announced that every student had been cared for.

► **PRESIDENT WRISTON**, who asked for "A Square Deal for the Veteran" in a radio plea over Station WEAN Sept. 11, believed in practising what he preached. He has opened his home on Hope St. to five veterans, one of them married, bringing to 11 the number of persons who will be in the presidential house this fall. Other officers of instruction and administration joined in making every possible space available, and there were Corporation members who did likewise.

"Even with the close of the war, universities can not enter upon large projects for housing married students," Dr. Wriston pointed out over the air. "The reason is that

the crisis, in this particular respect, is temporary. Large university projects are exceedingly expensive and have to be adapted to long-term needs. At the end of three or four years this crisis will be past and the percentage of married students will again become negligible. By the time large projects for the accommodation of married students were complete, they would not be needed.

"The Federal Government recognized both the acute character and the transient nature of this problem," he continued. "Therefore it made temporary housing available from surplus Quonset huts, abandoned barracks, and so forth. Brown University, like most other institutions in the nation, is engaged in such temporary dwellings for married veterans.

"In our own case, long delays in permitting their construction led to a loss of many units so that the number, which was inadequate to begin with, became acutely inadequate. Moreover these delays mean that the project will be unfinished when College opens; therefore even those veterans who are to be housed in the emergency buildings must find temporary accommodations for six or eight weeks. It was anticipated that the converted barracks would take care of 160 families. The delay led to the loss of accommodations for 60 families; they must find homes for a year elsewhere. The 100 families who will have quarters in the temporary housing units must be taken care of for a period ranging from six to eight weeks. We need, therefore, rooms for 60 married veterans throughout the year and for 100 more through this temporary period."

Harvest Season for the Campaign ◀ ◀

BULLETIN: *A total of \$1,355,000 had been reached before the end of September in the Brown Housing and Development Fund Campaign.*

▶▶ "AUTUMN IS THE TIME for harvest. Let's find out where we stand," said a message from Col. G. Edward Buxton '02 to his hundreds of workers in the Brown Housing and Development Campaign in August. The summer's end saw the completion of the widespread organization in which more than 2000 Brown men are committed to a program of personal interviews with the remaining 12,000.

The campaign as September opened stood \$45,000 away from one-third of the goal of \$4,000,000, with the general phase of solicitation just about to open. The \$1,290,000 total included 96 gifts of \$500 or more, while the first memorial designations were also reported. Exercising their privilege of choosing units in the new buildings, donors have offered contributions in memory of individuals and families. Instances include: a classroom building, \$200,000; a lounge for Beta Theta Pi, \$25,000; a library, location to be determined, \$15,000; three double student rooms at \$6000 each, one for Alpha Delta Phi, one for Theta Delta Chi, one with location to be determined; two student rooms for the Freshman unit at \$3500 each, and a similar room for Pembroke. One of the first memorials—to a boy whose life was lost in the war was the designation of a student room to bear the name of Howard Seth Young, Jr., '46, Ensign USNR.

When the new refectory rises, a prominently placed plaque will give a permanent record of those friends and alumni who will have contributed \$500 or more to the housing program. Nearly 100 names already appeared on the preliminary roster of such benefactors at the end of the summer:

► THE MARRIED VETERAN is not the only one who needs help: "Through the years Brown University has been acquiring temporary dormitories and enlarging its housing facilities until it proved possible to construct new accommodations," President Wriston explained. "That work has now begun; the first two units of our great development program are already well under way. A dormitory for 246 students has been under construction for many months, and a new classroom building, begun only last June, is being completed at record speed to take care of classes even this first semester.

"If the College had remained at its normal size, such measures would have been adequate. But to have remained comfortably at normal pre-war size would have denied the veterans the opportunity to achieve the education for which they are ready and which they ardently desire. In an effort to meet their reasonable demands we have strained every facility of the University, using every unit of classroom, laboratory, library, and dormitory space to the saturation point.

"No help is forthcoming from the federal government to provide housing for unmarried veterans at Brown. There is no recourse, therefore, other than to appeal to the citizens of Providence to make room for them. I do not ask this on behalf of Brown University, toward which the citizens of this community have for more than a century and three-quarters shown such a generous, kindly spirit. I ask it as a square deal for the veteran himself. It is through no failure of effort on his part, it is through no want of energy on ours that he cannot be housed in the College dormitories.

► "THESE MEN for whom I am now appealing are a picked group. Brown had over 4000 applications for admission from new students. Because we could not take any such numbers, but had to select only one out of five of the fully qualified applicants, it means that never in the history of the University have students been selected with so much care for intellectual capacity, willingness to work, and firm traits of character. As you open your homes to them, therefore, you are giving hospitality to a democratically selected group of veterans. They were chosen not on the basis of their income, but of their talent, industry, and moral fibre.

"All these young men have had their lives profoundly dislocated by the exigencies of war. I have to remind myself that a year or two before we entered the war, a metropolitan newspaper asked me to write a piece explaining why the college students of America 'seem to hold to a belief that no ideal is worth fighting for.' I replied that the request was predicated upon a false premise—that our young men would fight as loyally, as determinedly and as effectively as their fathers in World War I and their

grandfathers in the Spanish-American War and their great grandfathers in the Civil War and along back through all American history. I was interested to see that the same newspaper later referred editorially to that correspondence and expressed its happiness at having been wrong in its estimate of American youth. We can express our appreciation of what they did by hospitality toward them in their hour of acute need."

▶ **THOUGH IT FELL** far short of the needs of the year, residential capacity was up about 50% at Brown. Two new dormitories were open for men—Adams House, at 10-12 George St., with 32 boys; Hopkins House at 53 Waterman St., the old "Arsdale", with 53 boys. Pembroke had returned from the Brown campus, yielding George House, Warren House, Edwards House, Horace Mann, the Delta Phi, Delta Tau Delta, Beta Theta Pi, and Lambda Chi Alpha houses, which it had occupied last spring. Four new buildings had been opened as Pembroke dormitories to make this possible in September, but 50 new students had to seek accommodation in private homes in town.

Rooms available at Brown would account for 1073 boys, 759 in dormitories, 314 in fraternities. For this space there had been 1700 applications filed from a potential student body of 2700 (students within a 30-mile radius were being asked to live at home or find their own quarters). Eight hundred boys who had been on College Hill last spring or summer had already made arrangements for campus living; the remaining 273 rooms were set aside to house the youngest new students, those coming straight from high school or prep school, for it was felt these would need the supervision that goes with campus residence—more than the self-reliant, more mature veteran.

The appeal went out, the response came back, and the Veterans' Emergency Housing Office went to work. With the help of volunteers from the Mr. and Mrs. Club (of married veterans) and others, properties were inspected, contacts arranged with householders, and arrangements approved. James Hunter and his staff deserve high praise for effective work. But most of all we rise up and bless the good people of Providence.

Greek Return ◀

▶ **FRATERNITY MEN** at Brown were back in their chapter houses in September as the fall semester approached, back for the first time since the war sent students into military service, on College Hill and elsewhere. All of the fraternities which owned houses before the war return to them, only Sigma Chi delayed by the complications of its lease to an outside rooming agency. Pi Lambda Phi is in new quarters on George St., next to the Beta Theta Pi House. All, with possibly one exception, will be using dining rooms in their own houses.

The fraternity houses are now all the property of the University, deeded over in response to the Corporation invitation. The members of chapters have made their room contracts with the University, and Brown collects the rent, provides the services, and has responsibility for furnishing and maintenance. The University Dining Rooms, under Director William T. Broomhead '35, will cater for meals. Although \$30,000 was spent on the chapter houses which were used as civilian dormitories during the periods when Army and Navy units pre-empted other campus space, there is further outlay in refurbishing the quarters as the chapters moved back home. About half of the "house men" will be back taking care of the houses, although now in University employ, and a number of the pre-war cooks. In this homecoming Nelson B. Jones '28, Director of Student Activities, has had the co-operation of fraternity alumni advisors.

Some of the houses have had curious histories during the war emergency. They served as Pembroke dormitories, Army headquarters, dining halls, University offices, guest house, youth canteen, and the like. Now everyone takes pleasure in the return to familiar fraternal surroundings as anticipated until the arrival of the new Quadrangles brings the new episode in the progress of student residence and fraternity life at Brown.

In Manning Hall

▶ **COMMENCEMENT** visitors to the refurbished Manning Hall were hearty in their admiration of the work done to bring back the venerable building to a proud position among Brown's best.

Manning Hall was built in 1834, as the result of a gift from Nicholas Brown, class of 1811, and was named after President James Manning. In the early years of its history the lower room of the Hall was used as a library and the upper room served as chapel of the University.

In 1934 exercises were held in Manning Hall celebrating its one hundredth anniversary. Dr. Clarence A. Barbour, then President of the University, delivered an address and Henry Robinson A. Palmer '90, read a poem of his own composition, commemorating the building. These exercises were combined with those of Visitors Day, at which Charles Evans Hughes '81, former Chief Justice of the Supreme Court, spoke.

Although the exterior of the building was not touched in recent renovations, the halls and classrooms have been markedly re-decorated and improved. A new tile floor has been laid in the lower classroom, while the former maple floor of the upper room has been sanded and refinished. Acoustic plaster has been applied to the classroom ceilings, while most of the walls and other

▶ **THERE WERE NEW RECORDS** all along the line as the Brown Alumni Fund closed its books for 1945-46. The total showed \$78,023.95 from 4757 contributors, with the average gift at \$16.40. The figures were gratifying, Chairman George T. Metcalf '13 indicated, particularly in view of the fact that the campaign had not been pushed aggressively in its closing weeks in view of the imminence of the Housing and Development Campaign. Normally, the June weeks provide a productive climax for the year's work.

Mr. Metcalf expressed deep appreciation of general alumni support and of the backing from the large corps of class and regional agents. The complete report of the Alumni Fund will be incorporated in an issue of this magazine later in the winter.

Gifts had been for the unrestricted use by the University for current purposes, but President Wriston gave assurance early in the campaign that every dollar would go to the service of the Brown Faculty.

Although solicitation by the Alumni Fund will not be pushed during the coming year, the Trustees will maintain their organization. Five new Trustees have been added by vote of the Executive Committee of the Associated Alumni: Raymond Buss '09, Arthur J. Levy '19, Richard A. Hurley,

Jr., '32, H. Stanford McLeod '16, all of Providence; and C. Douglas Mercer '06 of Brookline, Mass., and New York. The following terms expired in June, with the men ineligible to replace themselves after six or more years' service: Prof. William W. Browne '08 of New York, and A. W. Calder, Jr., '28, Alton C. Chick '19, Henry C. Hart '01, and Arthur L. Phlbrick '03, all of Providence.

Lewis S. Milner '02, who has also made a wonderful contribution as a volunteer worker in the Alumni Fund Office for three years, was re-elected a Trustee for another term. ceilings of the room have been replastered. Lecture platforms have become smaller and more architectural design has been applied to them. Two staircases at the west end of the hall have been removed and replaced by one at each end. The west end itself has been reconstructed of fireproof material. The Civil War Memorial Tablet and the Nicholas Brown Memorial Tablet have been hung at the west and east ends of the hall, respectively.

The basement of Manning Hall has been rebuilt and a new heating system, including modern radiation, installed. A combination of direct and indirect lighting is also new.

The money to repair Manning Hall was provided by the same anonymous donor who gave the funds for renovations in University Hall, Rhode Island Hall, Hope College and for improvements to Middle Campus.

A Decoration for Pillsbury

▶ A LIBRARIAN who turned Sergeant, Stanley R. Pillsbury '31, has received the Legion of Merit, according to an Army release from China Headquarters. It was for "extraordinary outstanding performance of administrative and training functions." He assembled and distributed to all 21 bases complete and necessary publication files, traveling the length and breadth of China. His corps had to evacuate seven air fields before the Japs captured them, so that it was no job far in the rear.

He prepared guides for standardizing the operation of bases and for transmitting information to higher headquarters in the speediest intelligible fashion. "His painstaking and accurate analysis and evaluation of reports on critical supplies enabled his Commanding Officer to plan operations efficiently. His unusual ability to cope with new problems intelligently and swiftly made him invaluable. His integrity, intelligence, and precise nature enabled his officers to place upon him with absolute confidence the responsibility for the preparation of all secret and confidential documents and radio messages of extreme importance or urgency. In each of the several commands in which he served, he continuously improved the administrative efficiency of his own headquarters and of the subordinate units."

Liking China and its people, Sgt. Pillsbury has remained there, Elmer E. Butler '03 informs us. He was formerly on the staff of the New York Public Library. His father is Benjamin O. Pillsbury '00, of Needham, Mass.

Benford's Commendation

▶ COMDR. WILLIAM R. BENFORD '27, CEC, USNR, returned to his duties in the Brown Engineering Division, has received a commendation for his "professional skill, initiative and excellent judgment in the performance of vital tasks."

The letter from the Chief of Bureau of Yards and Docks said that he wished to recognize Comdr. Benford's "outstanding services as Sanitary Engineer in the organization of the Superintending Civil Engineer, Area II from 11 October 1943 to 11 November 1945." As Sanitary Engineer in this Area and as Consultant in engineering problems in Areas I and III he assisted materially in solving important problems of water supply and sewage disposal at units of the Shore Establishment vital to the support of the Fleet during the war.

Part III.

Specific Recommendations

▶ ▶ IN FORMULATING the following specific proposals, which it has discussed at length, the Committee on the Curriculum has had the benefit of light gained from conferences with officials of Pembroke College, from interviews with representatives of the various departments concerned, and from oral or written communications, which it has carefully pondered, received from a number of individual members of the faculty. The committee has earnestly endeavored to give, to the various considerations urged upon its attention, the fullest recognition possible within the conception of a liberal education, outlined in Parts I and II, for which it was attempting to devise implementation.

SECTION 14. The numbers of semesters contemplated for each part of the curriculum.

▶ THE COMMITTEE has throughout kept in mind the desirability of providing for the abler and more earnest students a correspondingly greater degree of freedom: and at the same time of insuring that the less capable or less serious students shall not, through excessive freedom of whimsical election, be able to evade the sort of program called for by the objectives of a liberal education.

The distribution requirement the Committee now proposes would accordingly total normally 14 courses, but less than this in the case of the better prepared or intellectually more enterprising students. The portions of the student's time given to the several parts of the curriculum would then be substantially as follows:

SECTION 15. Freedom provided for within the distribution requirement.

▶ THE COURSES listed in the picture of the distribution requirement drawn in the next section total 16 semesters, but the committee proposes that the student be allowed to omit two, leaving a requirement of only 14.

Again, some students enter the university with a knowledge of some subjects substantial enough to fulfill the purpose of the distribution course in the corresponding subject. The faculty has recently voted that any part of the distribution requirement may be satisfied by the passing of a proficiency examination on the reading specified in an appropriate syllabus. The Committee on the Curriculum suggests that also the Faculty explore the possibility of accepting (a high level of achievement) in the College Entrance Examination Board achievement tests (in the subjects prescribed for distribution) as satisfying the corresponding part of the distribution requirement.

These provisions would entail that no student would take more than 14 of the distribution courses, and that the better qualified or more ambitious student would have the opportunity to take several less, and thus to gain more than the 7 normal free electives.

Moreover, it is worth emphasizing that the subjects comprised in the distribution requirement are diverse enough to include automatically most of the subjects in which the student might otherwise have wished to take a first course as free elective.

SECTION 16. *The Distribution Requirement in detail.*

THE DISTRIBUTION requirement proposed contemplates 6 semesters for the sciences, 4 semesters for the social studies, and 6 semesters for the humanities; but with the provision that in the case of the social studies group, the student, in exercising his right to omit 2 courses out of 16, only may omit one of the three semester-courses listed there.

The distribution requirement proposed is specifically as follows:

A. THE SCIENCES 6 semesters

- (1) Physical Science: 2 semesters
viz. either: a Physics-Chemistry two-semester integrated sequence
or: a Physics-Astronomy two-semester integrated sequence
or: a Chemistry-Geology two-semester integrated sequence

- (2) Biological Science: 2 semesters
Viz: A semester course in Biology (in the broad sense which includes Botany,) some sections of which would be given by the Department of Botany.
and: A semester course in Psychology.

- (3) Mathematics: 1 semester
A one-semester course in mathematics specially designed to do justice to the function the distribution courses are intended to perform.

- (4) In addition, one semester-course in any one of the above subjects, which could be:
any one of the semester courses mentioned above.
or: the first semester course in any one of the 3 year-sequences in physical science.
or: an introductory course in Astronomy or Geology not dependent on a first semester of, respectively Physics or Chemistry.
or: A course continuing one of those mentioned under (1), (2), or (3).
or: an independent course in any of those fields.

B. THE SOCIAL STUDIES: 4 semesters

- (1) History: A two-semester courses in either Ancient History or Europe since the Fall of Rome—2 semesters
- (2) A semester course in Economics—1 semester

A semester course in either Principles of Government or Principles of Sociology—1 semester

C. THE HUMANITIES: 6 semesters

- (1) Literature:
Viz.: A two-semester course in one ancient or modern literature; or a two-semester course in European literature
- (2) Philosophy: 2 semesters
A two-semester course
- (3) Art or Music: 1 semester
Either a semester course in Music or a semester course in visual art.
- (4) History of Religion. 1 semester
A semester course designed to acquaint the student with a number of the primitive and higher religions of mankind.

NOTES: (a) The committee recommends that laboratory experience be included in the science courses. It believes, however, that laboratory exercises as often conducted in elementary courses are of little value to the student. It recommends that the laboratory work in the distribution courses be so planned as to exercise the student's ingenuity in discovering facts for himself in the given field. (The facts, of course, would be elementary and not novel, except to the student.)

(b) The committee recommends that, in the other than science courses, ample provision be made for the discussion and writing, which is there the analogue of laboratory work.

(c) It is further recommended that each of the departments concerned be called upon to prepare and submit to the Committee on the curriculum a fairly full syllabus of a course of the type described in Section 13, which it would propose to give for the purpose of the distribution requirement; the syllabus to include a statement of the reading, papers, or other work, which the student will be required to do in the course.

The Functions of Concentration

AS NOTED in the report of the Subcommittee on the Distribution Requirement, the breadth provided by adequate distribution serves to enlighten and liberalize the student's perspective as to the subject matter and methods of the various fields of human knowledge. We believe that the depth demanded by the concentration requirement should give the student enough work in some limited field to enable him to have at first hand the enriching experience of participating in the winning of systematic knowledge.

Such experience is an essential part of a liberal education. Whoever misses it has obtained from his college studies little more than the externalized information which he might have acquired from judicious sampling of an encyclopaedia. On the other hand, to the extent that concentration helps a student to achieve even a modest competence as a worker within some field of systematic investigation, it tends to reward him with some or all of the following values:

Love of Knowledge. In so far as a student participates in the work of winning knowledge (new at least to him) which he can

then fit systematically in to the body of his previously acquired knowledge, he comes to know the joys of intellectual exploration and discovery and the happiness of replacing scattered bits of information by integrated understanding. Ability to Continue Study Independently. This love of knowledge will tend to motivate the student to continue to read and study in the field of his concentration long after his formal academic training has ended. He will have learned enough from his work in concentration to make possible a continuing satisfaction of his interest in that field, at least through the reading of current literature in it, if not through active investigations of his own. This sustained intellectual interest is one of the things that should characterize the liberally educated college graduate. It is unlikely to develop unless his college work has been of sufficient depth in some area to give him a modest competence of his own as a student in that field.

Adequate Preparation for Advanced Study. In the past, some 30 per cent of Brown graduates have gone on to some form of graduate or professional school study. The undergraduate concentration of students of this kind, while avoiding over-specialization, should be rich enough to obviate any need of taking typically undergraduate courses in graduate school.

Fields of Concentration

► CONCENTRATION should be conceived as concentration within a field of knowledge, which may, but need not, be coextensive with a departmental area. Departmental organization has often been determined, at least in part, by administrative rather than educational considerations. In a few cases a student's major field will be narrower than that of a department. In such cases many related courses within the department, but outside the special field, would without doubt be prescribed as essential, but the concentration would center in the specified area. In other cases, on the other hand, concentration will cut across the usual departmental lines.

So important, in fact, does the development of non-departmental Concentration Patterns seem, that we recommend the appointment of a small subcommittee of the Curriculum Committee, broadly representative of the major fields of study in the university, this committee to have as one of its principal functions working with the departments in the development of such non-departmental concentration, field majors, or topical concentrations, as they have variously been called.

Patterns of Concentration

► EACH DEPARTMENT should develop a Pattern of Concentration within its own general field. Ordinarily a Concentration

The Judge in High School

► TWENTY-FIVE YEARS AFTER his own high school graduation, Justice Andrew W. Ryan '25 of the New York Supreme Court had the pleasure of giving a Commencement address to another high school group this past June. Justice Ryan has particularly interested himself in the problems of youth, a friend wrote in August.

A member of the New York bar since 1926, soon after he had received his law degree from Albany Law School, Mr. Ryan served as district attorney of Clinton County for six years and as judge of the Children's Court and County Court for five, until his elevation to the Supreme Court Jan. 1, 1944. A resident of Plattsburgh, N. Y., Justice Ryan has been a leading and public spirited citizen.

Pattern will include a certain number of courses regarded as essential for anyone choosing that field. These courses will constitute a nucleus central to all major work in that field. They will be supplemented by additional courses or groups of courses among which students will have a limited choice in order to satisfy their special interests and needs. All Concentration Patterns should require the approval of the special subcommittee of the Curriculum Committee referred to above.

A guiding consideration in the formulation of Concentration Patterns is their close relationship to Comprehensive Examinations. An adequate Comprehensive Examination should cover the subjects delineated by a Concentration Pattern. Only such variations within a Pattern should be permitted as can be taken account of by the choices allowed in the corresponding Comprehensive Examination. If, within any field, two examinations are required, this is a sure sign that in fact two Patterns of Concentration are available.

Since the preparation of good Comprehensive Examinations is an arduous and time consuming task which must be repeated each year, it is clear that the number of Concentration Patterns available must be closely limited. We recommend that normally there be only one such Pattern for each department, save where educational reasons or unusual departmental set-ups clearly indicate the need for more. We recommend, further, that where departmental offerings are large enough to warrant it, such choice, but only such choice, be allowed within a Pattern as can be taken into adequate account by a single Comprehensive Examination.

Quality Requirement in Concentration

► A STUDENT'S WORK in concentration lies presumably within the area of one of his major interests. He undertakes most of it during his Junior and Senior years. For both of these reasons the quality of it can reasonably be expected to be higher than that of his college work in general. Furthermore, unless his work in concentration is of reasonably high quality a student will not have gained from it even that modest competence in his field which, we have insisted, is necessary if he is to realize the educational values which the requirement is designed to insure. Therefore we recommend establishment of a minimum requirement of an academic average of 2.0 for all

the courses scheduled on a student's Concentration Program. It is the hope of the Committee that this requirement will be raised at a later date to 2.5.

Quantity Requirement in Concentration

We recommend that every program of concentration comprise eight semester courses or their equivalent, excluding "distribution courses."

Barriers to Over-Specialization

In order to prevent over-specialization in a narrow field, we recommend that credit shall not be given toward an A.B. degree for more than ten courses in any one department, excluding "distribution" courses and "language proficiency" courses. By "directly related departments" is meant departments such as Ancient History and Civilization, and Ancient Language and Literature, or such as English Expression and English and American Literature.

Summary of Recommendations

► We recommend:

1. That a Faculty rule be adopted to the effect that every student Concentration Program must conform to an approved Concentration Pattern, except by permission of the Dean of the student's college in consultation with the department(s) concerned.
2. That the Faculty adopt the following regulations with regard to Concentration Patterns:
 - (a) That departmental Concentration Patterns be limited in number normally to one Pattern for each department, save where educational goals clearly indicate the desirability of additional Patterns.
 - (b) That Concentration Patterns must be approved by the Committee on the Curriculum.
 - (c) That Concentration Patterns normally include a nucleus of specified courses required of all students selecting that Pattern, and also limited options—choices to be made by the student in consultation with the departments concerned—among certain other courses or groups of courses, these options to be restricted so that choices on a common comprehensive examination can take adequate account of the differences in student preparation thus permitted.
3. That the President appoint a small but broadly representative subcommittee of the Committee on the Curriculum to assist in establishing Concentration Patterns and that this Committee be charged particularly with the tasks of:
 - (a) Initiating area or topical Patterns of Concentration, not confined to one department.
 - (b) Conferring with departments concerning the formulation of departmental Patterns of Concentration.
 - (c) Recommending to the Curriculum Committee those proposed Patterns that conform to the principles of this report.
4. That the Faculty recommend to the Board of Fellows that the concentration requirement for the A.B. degree be successful completion of a program of concentration of eight semester courses or their equivalent—excluding "distribution" and "Language proficiency" courses with an academic average of 2.0 or better, and not more

Mayhew Was Remembered

► BECAUSE THOMAS MAYHEW was born in the English village of Tisbury, England, more than 300 years ago, the aged and sick villagers were remembered this summer with food from Martha's Vineyard. Thomas became the first governor of the Massachusetts island, where his descendants today include Mrs. John W. Mayhew, whose husband was the Brown track immortal in the class of 1909, and John W. Mayhew, Jr., '43, who has returned to College after military service.

Connecticut's USO Campaigner

►► CONNECTICUT SUPPORT of the United Service Organizations is being mustered for 1946-47 by Paul V. Hayden '25 of Willimantic, the new State campaign chairman. His quota is \$471,000.

"We are very fortunate to have such an outstanding and experienced campaign leader in this critical year," said Governor Baldwin in announcing Hayden's appointment in July. A Connecticut resident since 1930, Hayden has been associated with the Connecticut Light & Power Company, first as industrial engineer and in 1940 in charge of industrial sales for the Eastern Division. He was Windham County chairman for the 1943-1945 campaigns for the Connecticut War Fund and earlier as County chairman for the USO campaign. He is a member of the New England Council Industrial Development Committee and has helped attract new industries to Eastern Connecticut, particularly. On the Chaplin School Board he sits as chairman. He is a past president of the Connecticut Badminton Association, too.

5. That the Faculty adopt the rule that, excluding "distribution" and "language proficiency" courses, no more than the equivalent of ten semester courses in any one department (as define above) may be counted toward the A.B. degree, and no more than the equivalent of twelve semester courses in two directly related departments may be counted toward the A.B. degree, in each case save by permission of the Committee on Academic Standing.

In interpreting this rule, the following are to be regarded as departments: Ancient History and Civilization, Ancient Language and Literature, Art, Astronomy, Biblical Literature and History of Religions, Biology, Botany, Chemistry, Economics, Education, Engineering, English and American Literature, English Expression (including Debate, Dramatics and Public Speaking), Geology, History, Linguistics, Mathematics, French Literature, German Literature, Italian Literature, Spanish Literature, Music, Naval Science and Tactics, Philosophy, Physics, Political Science, Psychology, and Sociology.

6. That the Faculty adopt the following administrative rules:

- (a) That complete Concentration Programs of candidates for the A.B. Degree, must be filed either during the student's fourth semester or, in the case of certain specified Concentration Patterns during his second semester. (The Deans are expected to call the attention of students to those Concentration Patterns where because of a required sequence of courses, or for some similar reason, concentration must be begun during the Sophomore Year.)
- (b) That all changes in Concentration Programs must be approved both by the departments concerned and by the Dean of the student's college.

Surgeon at the Front

►► LT. COL. FIORINDA A. SIMEONE '29 was entitled to a great measure of satisfaction as he returned to his duties as Assistant Professor in Surgery in Harvard Medical School after his military tour. He holds the Legion of Merit award for his work as consultant in general surgery in the Medical Section, Mediterranean Theatre of Operations.

"Col. Simeone personally operated upon, supervised, and observed the management of seriously wounded soldiers in the forward mobile hospitals and in fixed hos-

pitals, always combining the accurate critical appraisal of scientific research with the humane technical skill of the experienced surgeon. He initiated and conducted clinical research in the field on a succession of important and unsolved problems that surround the surgical treatment of the wounded, pointing the way in each instance to the elimination of life-endangering complications. His ingenuity and precision in making and recording observations on gas gangrene and destructive wounds of major blood vessels, contributed to the introduction of new methods of treatment that saved lives and preserved limbs. Observations on the occurrence, nature and causes of trench foot were of aid in the introduction of successful control measures. Actively participating in the work of a board to study the treatment of the seriously wounded, he brought to light new facts regarding the bodily disturbances that attend certain fatal complications of wounds."

The New Campus Landscape

► THE CHANGES are not revolutionary, but the general effect is a marked improvement in the appearance of the Middle Campus at Brown. For weeks bulldozers and steam shovels were picking up the old walks, while workmen put down new ones, usually in locations somewhat different. Most noticeable change is to move the roadway east from in front of University Hall, Manning, and Hope, providing a better setting of grass for them. Extensive planting has already brought warmth to the scene, with yews and magnolias new to the landscape. (We've relied entirely on elms in the past, which provide leaves for only a couple of months of student residence; now some evergreens and spring-bloomers as part of new sets will relieve the austerity.)

Only this spring has it been possible to employ the funds given some years ago for the beautification of the campus. An anonymous friend gave \$15,000 for re-location of a few walks, renovation of others, new plantings, restoration of the lawns, etc., under plans originally drawn up by Arthur A. Shurcliff. A supplementary gift of \$500 from a group of "friends" made possible the treating of lawns, vines, and foliage against Japanese beetles. We think you'll like the way the University has spent the money given specifically for these purposes.

Where Do Shovels Go?

► THE VERY FACT that time changes some standard tools not at all is responsible for the fact that antique collections seldom boast good old hammers and shovels, says Albert E. Lownes '20. Mr. Lownes is president of the South County Museum in Rhode Island which has a fine collection of many thousand tools, implements, utensils, vehicles, machines, and gadgets which played a vital role in the daily life of the State years ago.

The Museum has "the first primitive sewing machines, typewriters, and vacuum cleaners, check by jowl with spinning wheels and hand looms." But the curator hunted for a long while before finding a card of Portland Star sulfur matches. And the ancient shovel can still hold its own against modern competition—hence its rarity for the collector and Mr. Lownes's appeal to the public for an attic hunt for such items. ◀

He did, however, manage to send back his Phi Beta Kappa key to President Wriston just before the Germans isolated the Occupied Zone in France. He lamented he couldn't attend the 1896 reunion on the Brown campus this June. ◀
