Housing at Commencement

▶ WITH THE UNIVERSITY'S TECHNIQUE of welcome improving with the experience of each June, Brown will find nine reunion Classes occupying dormitory space during the 1948 Commencement season. In addition, accommodation is available on campus for individual alumni of other Classes, and a Pembroke dormitory will be set up as a guest house for wives.

Where possible, alumni are asked to give the Alumni Office advance notice of their need for a dormitory room. All who sleep on campus will find a registration desk established in the Trophy Room in the center of the old half of Faunce House, on the first floor. Reservations will be confirmed, rooms assigned, and keys issued at this control point. The desk will be staffed from Friday noon through the late afternoon hours of Sunday. Rooms in the woman's guest house (probably Sharpe House) will be assigned by this same agency.

The charge for dormitory accommodation is \$2.00 a night per person, which includes bedding, linen, soap, and towel. The University cafeterias will be operating for certain meals on Saturday and Sunday for the benefit of the alumni.

William G. Bradshaw '33 of the University's Buildings and Grounds staff is in charge of arrangements for alumni housing. He reports the following assignments of dormitory space: 1898—South Hope, with a lounge in Middle Hope. 1903—Slater Hall. 1908—South Littlefield, with a lounge on the first floor. 1913—North Hope. 1923—Hegeman, with lounge in No. 110. 1933—Middle Hope. 1941—North Littlefield. 1943—Middle Caswell, with lounge; wives in Sharpe House. 1947—South Caswell (Occupancy varies from one night to three.) Individuals from other Classes will be housed in Maxcy. ◀

► ► They're Coming Back for Commencement

► ► THE WORD FROM EVERYWHERE is: "We're coming back." One of the greatest of Brown's 180 Commencements is in prospect, its outline complete with final decisions and official announcements. Only a meteorologist's benediction remains to fulfill every promise one could desire.

While the University was busy with the over-all inducements, 30 Brown Classes had their own reunions plans well in hand early in May. And the third annual All-Alumni Dinner offered a large-scale attraction for everyone, ushering in the Commencement season on Friday evening, June 18. This "reunion of reunions" would be in a new setting, Andrews Hall, latest addition to the University plant.

Another traditional event, the yearly meeting of the Associated Alumni in Sayles Hall has different timing, being scheduled for Sunday evening with Dr. Alan Gregg, Director of Medical Sciences for the Rockefeller Foundation as the principal speaker, and Dr. Alexander Meiklejohn '93 as the presiding officer. This shift in programming makes the graduation the climactic final event on Monday morning.

Reunions thus far officially listed include: 1891, 1893, 1898 (the 50-year Class), 1900, 1902, 1903, 1907, 1908, 1909, 1910, 1911, 1913, 1914, 1915, 1916, 1922, 1923 (the 25-year Class), 1926, 1928, 1933, 1938, 1939, and first regular reunions for 1941, 1943, and 1947. It is of special note that 10 Classes have reserved bloc accommodations

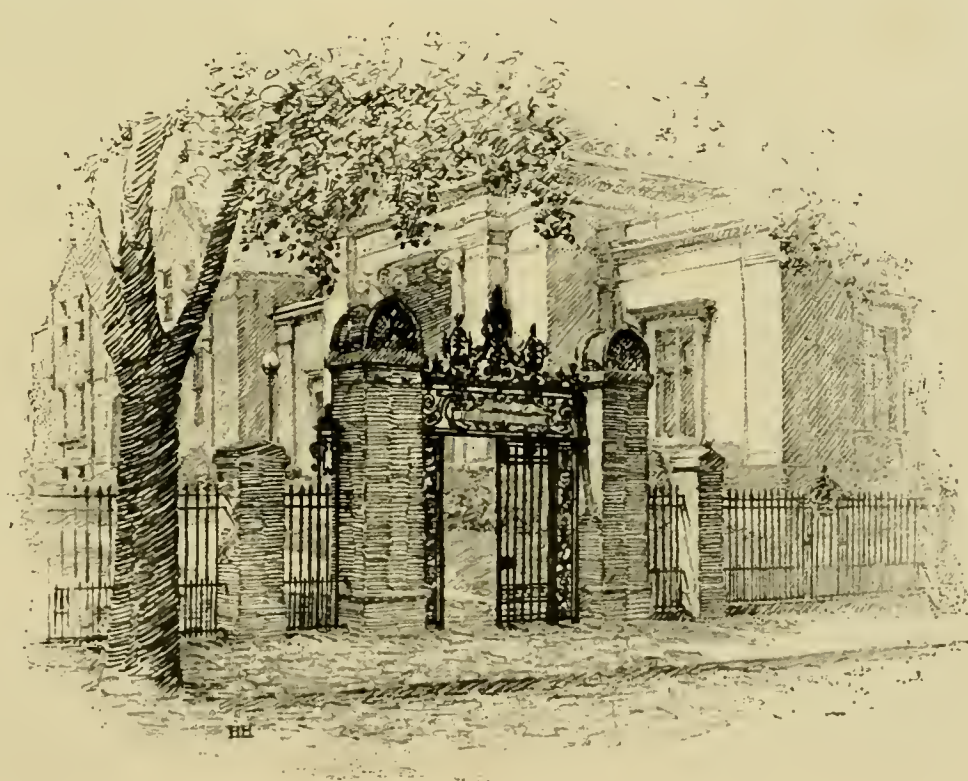
in campus dormitories for from one to three nights of the reunion period. In addition to those in the Classes above (and there will be others with later plans), the senior alumni more than 50 years out of College will have their own Commencement luncheon. Addendum: 1905, 1919, and 1932.

TOO MANY FOR THE CHURCH

► AS WAS THE CASE in 1947, there is provision for a graduation ceremony divided between the First Baptist Meeting House and the College Green. The size of the graduating class is again such that its members could not receive their diplomas in the presence of all their parents and wives, if all the exercises were to be held in the Church. Last year's compromise between traditions and exigencies proved a happy one, and in that same spirit the 1948 diplomas will be received (pray, oh pray, for a lovely day) on the College Green.

More than 700 Brown and Pembroke Seniors are eligible to receive their baccalaureate degrees this month. Since the capacity of the historic Meeting House (built for "the publick Worship of Almighty God and also to hold Commencements in") is 1244, there would not be room for even one member of the family for each graduate, let alone Corporation, Faculty, and invited guests. (Remember, too, that Seniors today often have wives and children as well as parents.)

As many of the old forms will be retained as possible. The procession will therefore form as usual on the College Green—the old name, now revived, of the Middle Campus. Commencement orders of the Chief Marshall, Norman S. Case '08, and the Chief of Staff, J. Cunliffe Bullock '02, call for the formation at 8:45 a.m. Mr. Case, former Governor of Rhode Island and more recently a member of the Federal Communications Commission, is a Washington attorney and a national Vice-Chairman of the Housing drive. Mr. Bullock, a retired Providence banker, long familiar with the complexities of mustering the procession, continues in his capacity as Chief of Staff to make all preliminary arrangements in the recruiting and briefing of aides and marshals.

DIPLOMAS IN THE OPEN AIR

► TO THE UNFORGETTABLE MUSIC of the Commencement March and with the protection of the High Sheriff, the alumni will precede the Seniors down the Hill to the Church. Since no parents will have tickets for the portion of the exercises there, there has been some talk that alumni might have the unusual opportunity of entering the Meeting House, in order of seniority and to the limit of its capacity. No announcement has been made of this, although it is definite that Senior guest tickets are for the College Green only. In the Meeting House there will be the orations by Robert A. Day '48 and David D. Warren '48 (Maurice J. Mountain '48 is alternate) and the brief formalities which are preliminary to the actual receipt of the diploma. Throughout, loudspeakers will carry the voices of the Senior orators to the College Green and outside the Church.

Reforming in the churchyard, the procession will return to the top of the Hill where, with ample seating for all, President Wriston will award the baccalaureate diplomas and confer the honorary degrees. Here on the College Green, in the area between University Hall and Sayles where several thousand persons witnessed the graduation last year, each Senior may have four guests in the reserved section.

"THE REUNION OF REUNIONS"

► DETAILS of the All-Alumni Dinner Friday evening have been announced previously. With Thomas B. Appleget '17 as toastmaster, the principal speakers will be President Wriston and John T. Winterich '12. For this popular event, the early sale of tickets indicated a full house by the time the evening arrives.

Tickets may be purchased, to the limit of the seating in the dining hall of the new Andrews Hall, through John W. Moore '16, Treasurer. Checks payable to him should be sent to Room 1124, Industrial Trust Building, Providence. Tickets cost \$3.

Always the greatest gathering of Brown men, this year's dinner has its program keyed to the gayety of Commencement time, with special entertainment and plenty of Brown spirit. Brown Bear Awards for conspicuous service to the University and its alumni will be conferred on behalf of the Associated Alumni by President H. Stanton Smith '21. The identity of the recipients is kept a guarded secret until the actual announcement. In token of the award, a Brown Bear statuette is presented. Previous recipients include: Dr. Moses L. Brown songs have always played a large part when alumni get together, and this year will be no exception. The music of the evening will be in the hands of Earl P. Perkins '12 and Earl M. Pearce '17. A highlight of the 1948 dinner, however, will be the first announcement of the results of the Alumni Song Contest, together with the first performance of the three prize-winning entries. David Laurent, Brown undergraduate who is a professional concert soloist, will sing the numbers.

Chairman of the Alumni Dinner is Robert H. Goff '24, who announces that the head table will include the following, in addition to the speakers: Dr. Alexander Meiklejohn '93, who will be the presiding officer at the Sayles Hall alumni meeting on Sunday night; Chief Marshal Case of the 40-year Class; and Arthur B. Homer '17, Chairman of the new Student Housing Board. An informal reception on the terrace of Andrews House at 108 Cushing St. at 6 o'clock will precede the dinner at 6:30.

THOMAS IS BACCALAUREATE PREACHER

► THE PREACHER at the Baccalaureate Service on Sunday, June 20, will be the Minister of the First Baptist Church, Rev. Albert C. Thomas, D.D., Brown graduate in the Class of 1908 and member of the University's Board of Fellows. The same complications as to seating pertain to the Baccalaureate Service as to the graduation exercises, and each Senior who is graduating receives one ticket for the Service. At the close of the Service, President and Mrs. Wriston will greet the Seniors and their guests at a reception on the College Green.

There will be no Alumni Luncheon this year on Commencement Day. A small luncheon will be held for the Corporation and the University's special guests of the day. As in the past the University Club, the Faculty Club, and the fraternities will hold open house for Brown men. Special exhibits are in prospect for the John Carter Brown, the John Hay Library, and elsewhere.

► In Sayles Hall

All visiting alumni are urgently requested to register as soon as possible after reaching Providence. The register will be at Alumni House, 17 Benevolent St., corner of Brown St., where information with regard to all Class Reunions and other Commencement functions is available. The Alumni Office will be open on Saturday and Sunday, June 19 and 20, as well as during the regular hours of the other days. (It will close Saturdays through the summer months.)

AN INVITATION FROM THE SENIORS

► **CLASS DAY PLANS** for the Seniors stress in 1948, as usual, the evening promenade and dance and the afternoon exercises "under the Elms," to both of which events alumni have cordial invitations. Familiar patterns are followed, particularly with respect to the dance, and it is probable that a large number of the alumni will move down to the Brown campus after the dinner in Andrews Hall. The presence of several reunion classes in the College dormitories is apt to swell the alumni attendance, too.

Hal Reeves is providing two orchestras for the dancing, one for the indoor party in Sayles Hall, the other for the open-air floor. Traditional lighting is in prospect, with Japanese lanterns, special lighting of U.H., and illuminated numerals. Classes, fraternities, and other groups are renting tables and umbrellas at \$6. each to provide meeting places for the affair. The sentimental Senior Sing at midnight may be supplemented by serenades from reunion groups. Tickets for the dance are \$2, each admitting a couple or a stag. During the evening the "Van Wickle Gates" drop curtain of Leslie Allen Jones will be on display in the Theatre.

William M. MacLeod is chairman of the over-all Class Day Committee for the Seniors and will have direct charge of the Sing. Walter S. B. Tate is chairman of the committee for the exercises "under the Elms" in the afternoon, assisted by Sidney W. Wray, Jr., and John M. Vandervoort. The program will consist of a welcoming address by the Senior Class President, William E. McAuliffe; the Class History by Robert W. Allrich; an oration by Charles H. Pinkham, III; the Class Poem by Robert A. Day; and an address by President Wriston. Instrumental music will be provided by undergraduates. After the exercises the Seniors, their families, and friends will be received by the Deans with the traditional amenities.

The Senior Dinner will be held in Andrews Hall Wednesday evening, June 16. Edward Dolbashian and Louis Regine are the committee for this. Other Senior committee appointments include: Cap and Gown—Robert G. Smith; Class Night—Donald Joseph, chairman, James Elder, Stanley Potter, Robert Conley, Thomas Egan, and Robert Potter; Publicity—Warren Carleen and Raymond Carmichael.

► **THREE PHI BETA KAPPA** events are listed for the Saturday of the Commencement weekend, June 19, all in Faunce House. In the Theatre Lounge the annual meeting of the Rhode Island Alpha at 10:30 a.m. will be followed by the initiation of newly elected members. Alumni members are invited. The Society tenders its luncheon to the initiates in the Pine Room at 12:15, tickets being available to Faculty and alumni members who make reservation before June 17 at \$1.50.

Pembroke's alumnae day comes on Saturday as well, one focus of interest being in the alumnae dinner at 7 which will take the form of a compliment to Dean Margaret Shove Morris in recognition of her Silver Jubilee at Pembroke. The annual meeting of the Alumnae Association and the Garden Party come earlier in the day. ◀

► **IN DR. ALAN GREGG**, Director of Medical Sciences of the Rockefeller Foundation, a speaker of unusual interest, has been obtained for the annual meeting of the Associated Alumni on Sunday evening of the Commencement season. The time of holding the traditional Sayles Hall gathering represents an innovation for recent years and tends to consolidate the Commencement program for the benefit of the alumni. President H. Stanton Smith '21 will call the meeting to order at 8 o'clock and announce alumni election results during the brief business session which precedes the speaking.

The presiding officer will be a member of the 55-year Class, the popular and stimulating Dr. Alexander Meiklejohn '93, one-time Dean of Brown. Governor John O. Pastore will bring the greetings of the State of Rhode Island. President Wriston will announce the year's gifts to the University.

In his post at the Rockefeller Foundation, Dr. Gregg directs its medical program, international in its scope and highly consequential in its results in terms of human health. Its story is without equal in excitement and humanity in the scientific world. Dr. Gregg has been with the Rockefeller Foundation since 1919, first as a member of the field staff of the International Health Board for three years, then as Associate Director of the Division of Medical Education and Associate Director of Medical Sciences. He was named Director of Medical Sciences in 1930.

A native of Colorado Springs, he is a Harvard graduate of 1911 who took his M.D. there in 1916. He served with the Royal Medical Corps, B.E.F., from 1917 to 1919. He is a Fellow of the American Academy for the Advancement of Science and a member of the New York Academy of Medicine, the American Philosophical Society, Phi Beta Kappa, and the Century Club of New York. ◀

For Those More than 50 Years Out

► **SUCCESSFUL** in its revival last year, the Commencement luncheon for members of the Classes more than 50 years out of College will be held Monday, June 21, at the University Club in Providence directly after the graduation exercises on the College Green. The affair is being arranged on a Dutch treat basis, according to Alumni Executive Officer William B. McCormick '23. It is sponsored by the Associated Alumni, with Dr. Edmund D. Chesebro '87 representing the "50-Plus" Class Secretaries. ◀

Carnegie Foundation Head to Speak

► **DR. OLIVER CROMWELL CARMICHAEL**, one of the great influences on contemporary education, will be the principal speaker at the Convocation of the Brown University Graduate School Saturday afternoon, June 19. Awarding of advanced degrees will take place at this time, with the meeting in Sayles Hall preceded by an academic procession of the Corporation, Faculty, and candidates at 2:30. Admission is by ticket, upon application to the office of the Graduate School, but the public will be admitted after the academic procession has entered.

Dr. Carmichael, President of the Carnegie Foundation for the Advancement of Teaching, has chosen "Some Educational Frontiers" as the title of his address. He has been the Chancellor of Vanderbilt University since 1937, is a former Chairman of the American Council on Education, and has been on the Board of the Foundation since 1938. He is a member of many educational organizations and a

former President of the Southern Association of Colleges for Women and of the Alabama Association of Colleges. He was for 10 years President of Alabama College and subsequently Dean of the Graduate School and Senior College at Vanderbilt University.

Dr. Carmichael was a member of the Advisory Committee of the War Manpower Commission during World War II, the Central Committee of the American Red Cross since 1942, and on the Board of Trustees of the Nutrition Foundation since 1943, and the Senate of Phi Beta Kappa since 1940. During World War I he served with both the American and British forces, after having been a member of the Hoover Relief Commission to Belgium during 1914 and 1915. He is a native of Alabama and a graduate of its university with an A.B. in 1911 and an A.M. in 1914. Attending Oxford University as a Rhodes Scholar, he also earned its Sc.B. degree.

After the exercises in Sayles Hall, the Graduate School Tea will be held in the John Carter Brown Library for its students and their guests.

B Plus on a Fund Theme

▶▶ A "FRESHMAN THEME" carried a final appeal for the 1948 Alumni Fund to Brown men early in June in the guise of a little essay about eight o'clock classes. It was a reminder that it was "nearly eight o'clock—time for my gift."

The piece, which went to those not currently paying on pledges for the Housing Campaign and had not yet contributed to the Alumni Fund, represented the writer of the theme as hearing the bell on U.H. ringing its warning. Virtuosity, he responds, though tempted (as he had been in the days of the eight-o'clocks) to have another catnap and let it ride. "Carrie Tower shows I have a few minutes' leeway. I'll be there, and my name will be on the roster of the Alumni Fund contributors for 1948. I can make it if I run."

On the outside of the folded "theme" in the familiar red commentary—style of the theme-reader, Alumni Fund Chairman Thomas F. Black, Jr., '19 had written: "B plus. Succinct, well expressed. Approach is novel. I applaud your decision."

That many Brunonians had already responded was apparent in the report of the Alumni Fund Trustees to the ALUMNI MONTHLY on the current status of the drive. Secretary Robert O. Loosley wrote on May 22:

"Our brief interim and partial Alumni Fund Campaign has now reached a total of 1,243 subscriptions and \$23,700. With a month to go, there are thousands yet to be heard from. The Class Captains and Agents are just starting their personal approach in preparation for the last round-up for this academic year.

"Tom Black is hoping for a total of \$40,000 by Commencement, which will be a very creditable response when one remembers that almost 2,000 who had outstanding pledges as of January 1 to the Housing and Development Fund, were not asked to give to this year's appeal.

"Needless to say, the University needs this \$40,000 and more for improvements in plant, additions to equipment, and in general, to help meet the unexpected increases in costs due to rising prices. Beyond that we need a further demonstration of interest, loyalty, and support from every Alumnus. June has always been the big month—the month on which the Trustees and Agents will rivet their attention."

Tuition at \$600 ◀

▶▶ AN INCREASE IN TUITION at Brown University averaging \$35 per student per year and effective September of 1948 was announced May 20 by Dr. Henry M. Wriston, President. The new tuition figure will be \$600, but with no additional academic fees to be levied. This replaces the former \$500 tuition charge and the general, graduation, laboratory, and other course fees which have averaged \$65 per student. The new figure applies to the College, to Pembroke, and to the Veterans' College.

Although increased costs have also affected the operation of dormitories, no change in the present \$100 per semester room rent is planned. A cut in dormitory operation costs through curtailment of some of the existing services is contemplated.

Dr. Wriston stated that the University dining rooms had been hard hit by inflation with the problem of costs in food service particularly acute in the smaller dining rooms. He said that food costs and labor had gone up in far greater proportion than have board charges. The prevailing board charge of \$11.50 per week will be in force next year.

Typical of the increased costs which have beset Brown, just as the average citizens, are the following: telephone expenses have jumped \$4,500 a year for the same service, fuel oil bills for the past three years have increased 33 per cent, and the average wages of the plant operation and maintenance staff have increased some 74 per cent since 1941. Laboratory equipment, office supplies, maintenance supplies, paint, and furniture have also increased in cost approximately 25 per cent in the past two years.

Dr. Wriston said, "One of the reasons for the University's being able to avoid a greater increase in its tuition is found in the unusually good rate of return on its endowment as managed by the Corporation Committee on Investments and the Treasurer of the University. Return on consolidated investments during the past eight years has not fallen below 4 per cent."

Recent announcements from other Eastern colleges show that comparable schedules of instructional fees including estimated laboratory costs range from \$550 to \$750—Columbia, \$610; Cornell, \$643; Dartmouth, \$600; Harvard, \$575; Princeton, \$660; Smith, \$750; Swarthmore, \$650; Wesleyan, \$600; and Yale, \$600.

ALUMNI FUNDS BREAK RECORD

▶ ALUMNI of 141 American colleges and universities contributed an aggregate of \$9,628,922, an all-time record, according to 1947 reports made to the American Alumni Council. The gifts came from 383,260 alumni, as compared with 342,720 who contributed in 1946. The 1946 dollar total was \$8,171,988, according to Allen F. Hawley of Pomona College, AAC Director for Alumni Funds.

Saunders Report Creates a Stir

▶ WIDESPREAD DISCRIMINATION exists in New Jersey, based on race, creed, color, or national origin, according to the report of the Governor's Committee on Civil Rights made public in April. The group, under the leadership of Dr. Wilbourn E. Saunders '16 of Peddie School, had been making its study since last fall. It found color segregation in 50 public schools, discrimination in hospitals not only as to admission of patients but also as to appointment of doctors and staff, and frequent violations as the result of "gentlemen's agreements" in hotels, restaurants, theatres, bowling alleys, and skating rinks.

To curb practices which violate the Bill of Rights in the new State Constitution (which Dr. Saunders helped cre-

ate), the committee recommends a program to safeguard freedom of speech and attack segregation. One proposal would call for a place of assembly for political meetings in every municipality and an informal forum like London's Hyde Park or New York's Union Square. ◀

O.B.E. to General Chase

▶ MAJ. GEN. WILLIAM C. CHASE '16 received the Order of the British Empire, Rank of Commander, at recent ceremonies in Tokyo. The award was made by Lt. Gen. C. H. Gairdner, Prime Minister Atlee's personal representative at Gen. MacArthur's headquarters, in recognition of Gen. Chase's exploit in liberating civilians interned in Santo Tomas during the Philippines campaign. ◀

Waltham Watch Executive

▶ PAUL JOHNSON '29 has been appointed Executive Vice-President of the Waltham Watch Co. in Waltham, Mass. Paul was previously general manager of the aircraft accessories division of Thompson Products, Inc., in Cleveland

and in the past five years had brought that division up to its present position as the leading factor in the manufacture of high altitude precision instruments. ◀

Heads the Overseas Press Club

Skippers Take Two Titles ◀ ◀

▶ ▶ Topping all spring sporting events in the satisfaction which it brought to Brown was a spectacular triumph by the Brunonian skippers Rick Wilson and Charlie Ill in the National Intercollegiate Championship Regatta for the Henry A. Morse Trophy May 16. The victory over the 10 top teams of the country was all the sweeter in that it revenged the Brown men for the three-point defeat by Yale in the New England title event which cost them a chance at Olympic honors.

Bill Harold and Randy Bliss, son of Prof. Zenas R. Bliss '18, Navigator on two America's Cup Defenders, were the crewmen at Annapolis. They helped their dinghy skippers hold off a late rally by the

Yale rivals, Bob Monetti and Bob Coulson, who were defenders of the 1947 title. The scores: Brown 224, Yale 219, Navy 212, Coast Guard 197, San Diego State 194, Pennsylvania 124, with Purdue, Ohio State, Northwestern, Michigan, and Denison trailing.

Brown sailed to an early lead in the first day's races, which was threatened in the later competition. Monetti was high skipper of the meeting with 121 points, followed by Ill in the A Division. With the B's, Wilson had the edge at 114, 15 more than Coulson, who will represent the collegians in the Olympics dinghy trials. He had been high man in the New England Regatta at New London for the Coast

Guard Academy Alumni Bowl, which Yale had won with 153 points to Brown's 142, though the Bears had led at the end of the first day. Other scores at New London: Coast Guard 124, MIT 101, B. U. 99, B. C. 95, Northeastern 75, Middlebury 74. A protest and withdrawal hurt Wilson's score, but he was only three points behind Coulson, the leader. Brown's second place, however, qualified it to meet the teams from the Far West, Middle West, and Middle Atlantic States in the nationals.

Curiously, although not New England champions, the Brown dinghy sailors were Eastern and National title-holders, for they also won the George Owen Trophy Regatta May 2. The races were sailed in Rhode Island waters since Brown was defending champion. The scores: Brown 194, Yale 167, MIT 158, Harvard 140½, Coast Guard 139. Ill and Wilson were first and second high scorers respectively. ◀

The Alumni Stake in Brown University ◀ ◀

▶ ▶ THERE IS NO RECORD of any college being established by its alumni. The alumni did not found Brown University.

But since that event they have had a large finger in the University pie. Precedent and practice have developed so far that alumni control is extensive.

The Corporation of Brown, the governing body of the University, is made up of two branches, the Board of Fellows and the Board of Trustees. Of 12 Fellows, 10 are alumni; of the Trustees, 38 out of 42 are alumni. Of the latter, 14 are named on alumni initiative and following general alumni balloting—they are identified as Alumni Trustees, two of them being elected each year for seven-year terms.

As President Wriston wrote in describing "The Structure of the University": "Membership in the Corporation is only one means by which the alumni directly influence the course of the University. The Associated Alumni are a completely autonomous body with a powerful influence and great responsibilities. The Executive Committee of that body and its Advisory Council affect policy at many points and help shape our course."

"The Alumni Monthly is published by the University and sent free to all alumni; it is wholly controlled, however, by a board of editors appointed by the Associated Alumni; it is, therefore, an organ of opinion and promotion under alumni direction. The Alumni Fund Trustees establish their own procedures and conduct their own campaign. The Athletic Advisory Council virtually determines the athletic program. To all these activities, and to those of the many regional Brown Clubs, large numbers of alumni give loyal and valued service."

"The reality of alumni power is apparent in all its substance and verity. The processes exist by which it may be channeled into fullest effectiveness. It is one of the primary functions of the Associated Alumni to be certain that these procedures are understood by all graduates. As each alumnus pictures clearly his relation to the College and accepts its implied obligations, he takes his place as an active and vital member of the organization of the University, formally and informally contributing to the determination and execution of policies."

"There is a large substantive control of this University by its own alumni than in any but a very small group of institutions in the entire country. In no institution is it greater."

A CITIZENSHIP

▶ Like citizenship, membership in the Associated Alumni comes unasked to all Brown men. Like citizenship, it is a privilege which doesn't mean much to the recipient unless he embraces the opportunities which membership offers. (All Brunonians are alumni when they leave—graduates or not.)

It is a two-way proposition. There are no dues for membership, and the alumnus receives plenty:

More than 50 Brown Clubs from Maine to California, from Wisconsin to Texas, offer affiliation. They are glad to have new alumni share their meetings, their fellowship, their projects. The Brown Night at the Boston Pops, the Chicago luncheon for undergraduates, the Engineers' placement program, the Glee Club concert in Albany,

A Word of Explanation

▶ ▶ IN A SENSE, this is a special issue of the BROWN ALUMNI MONTHLY. It is being put in the hands of every member of the Senior Class.

Because of that fact, we are including in our text a few articles written with the Seniors in mind, Seniors who shortly enter our alumni ranks. It is not as simple a transition as one might expect, switching from undergraduate to alumni status. And perhaps there are things which should be said to assist the newcomers.

We present in this issue, therefore, material on alumni organization and alumni opportunity—some informal orientation talks for our Freshman alumni. At the same time, we suggest that this material has interest and benefit for older grads, as a review of their program now in force and of their responsibilities. Perhaps some older eyes will be opened, too, in a painless but challenging moment of indoctrination.

We should point out, in gratitude, that a generous alumnus who wants no publicity for himself has made possible the addition of the extra pages this month. The Associated Alumni appropriated an additional amount to cover the extra run on the press.

the great annual Brown dinner in New York, the Cleveland Forum, the San Francisco Ivy League Picnic, and the Providence scholarships are typical affairs sponsored by the Clubs.

The Brown Alumni Monthly adds each new alumnus to its circulation list of 15,000 without a penny of cost for a subscription. All the alumnus has to do is to make sure that a good address is always on file with the Keeper of Alumni Records.

Alumni House at 17 Benevolent St. is the clearing house of all alumni information. What does it do for you as an alumnus? It can keep you in touch with your friends, it helps you with reunion plans (supplementing the work of the Association of Class Secretaries), it keeps you on the University mailing list for invitations and announcements concerning Brown's manifold activities. The Alumni Office helps the classes function effectively, supplementing the work of the Association of Class Secretaries. It prepares the ballots by which alumni vote for Alumni Trustees and alumni representatives on the Athletic Advisory Council, the general and regional alumni officers.

After undergraduates, the alumni are allowed to make first application for tickets to athletic events, have the privilege of using the University libraries, are eligible for the services of the University Placement Office and local alumni placement committees in important metropolitan centers.

The alumni of Brown are organized, because they like association with other Brown men, because they believe they can serve Brown well in that way. They want to serve Brown well because her seal is upon them, because their reputation is tied up with hers, because they feel a debt to her which they appreciate in full measure as the years pass.

The Alumni Fund is the financial department of the Associated Alumni, and through this medium the individual sends his gift each year as a part of a collective gift to Brown that gains strength by the widespread participation of thousands of Brown men. The last Alumni Fund total—\$80,000 in 1946—was the equivalent of two million dollars of University endowment.

AND THAT REMINDS US

▶ IT COSTS MONEY for a Brown man to go to college. Every college generation has encountered this hard fact—few in the face of such high costs as today. It also costs Brown money to have the students in college. Few Brown men have appreciated

that others have helped pay the expense of their college education. All have a sense of paying their way, perhaps with assistance from parents or Uncle Sam. But it is far from full freight that they are paying. Actually, EVERY student is on a scholarship at Brown.

In the four-million-dollar operation known as running a college each year, an important economic factor is the Brown endowment that has been built up over the decades by alumni and other friends of the University. It has permitted the University to charge only a fraction of what it actually costs to go to college.

In 1919 when Brown tuition was \$153, the unit cost per student was \$565, without figuring in equipment, maintenance, or replacement of buildings. Tuition was 27% of that immediate cost. When tuition had risen to \$350, the student cost the college \$685. With tuition at \$400, costs were \$780 per man. Last year, with tuition at \$500, each student cost Brown \$835, even without the overhead items noted. Even with the large college of the present, when numbers reduce the individual benefit each man gets from the endowment—even with next year's \$600—someone else is paying the difference, and more as costs mount. Last year the full freight per student would have been \$835, had not alumni and others been generous with their giving.

THE SQUEEZE

▶ IN AN EDITORIAL headlined, "The Cost Squeeze Is on the Colleges," *The Saturday Evening Post* pointed out a year ago issue that the situation at Brown is one shared by all colleges. "Because the G. I. Bill of Rights has brought to the doors of our universities thousands who would not have sought higher education without such help, there is a fairly widespread impression that educational institutions are crawling with money, whereas the fact is that most colleges lose money on every veteran they teach. For every dollar spent for the day-to-day instruction of G. I. Joe, only about sixty cents is paid from the Federal Treasury."

A now-famous article in *School and Society* by W. Emerson Reck of Colgate reports that the cost of running colleges and universities in 1947 had increased at least 52% since 1941, although college faculties have had only modest increases in salary. Endowment income has fallen off by as much as 8% in the same period. Small wonder that universities so anxiously turn to their alumni and other benefactors for help. Small wonder that Brown asks its

students to understand that she is making no money on them.

Why does Brown not trim its sails? She could have weathered the storm of inflation better by turning more students away at the Admission Office. (And everyone would have been more comfortable, except in the conscience.) The answer, in the face of today's duty, is obvious.

Why does Brown campaign for a great building program at such a time? The answer here is less apparent but just as logical. The operation of today's University, with so many makeshifts superimposed on the normal, is uneconomic and costly. The sooner the new buildings are in use, the sooner some of the extra expenses will be modified, the sooner the savings can be applied to advantage and with justice elsewhere.

But the undergraduate will never pay what it costs Brown to educate him. It would be undemocratic to demand that of him, for it would bar from the liberal college too many who are entitled to its benefits. That reason is one which impels thousands of loyal Brown alumni to contribute annually to the University—to extend to others the help they have received so abundantly.

The splendid gift program of The Class of 1948 is early and striking recognition of this sense of responsibility felt by Brown's new crop of alumni this June. The alumni welcome such a fine class and congratulate them.

Invitation to Seniors

▶ WITH ALL BROWN CLUBS particularly on the alert to welcome newcomers to their territories, a special invitation is extended to the 1948 graduates to join in their activities. Some of the Clubs have special privileges for alumni just out of College. The list of Brown Club Secretaries is published on the back cover of this magazine each month in order to encourage new arrivals in a city to get in touch with them and participate in local alumni activity. The invitation applies alike to graduates, non-graduates, and undergraduates.

For Further Study

Each month the ALUMNI MONTHLY offers some recommended reading for alumni who wish to continue a serious interest developed in College. Selections for these lists are made by members of the Brown University Faculty, considering both the new books and those of persisting importance. The John Hay Library sets aside the books named each month, and the University Book Store will assist in their purchase.

INTERNATIONAL AFFAIRS

▶ *The Twenty Years' Crisis, 1919-1939.* E. H. Carr; Macmillan, 1940. A thoughtful and thought-provoking account of what happened during the period between the two wars by an English publicist.

The Soviet Impact on the Western World. E. H. Carr; Macmillan, 1947. The same author gives a challenging interpretation of the influence of Communist thought and the Soviet experiment on the world this side of the iron curtain.

Britain and France Between Two Wars. Arnold Wolfers; Harcourt, Brace, 1940. An outstanding American scholar of Swiss origin gives a judicious account of British and French policy during the interwar period which has special significance for American policy today.

U. S. Foreign Policy: Shield of the Republic. Walter Lippman; Little, Brown, 1943. A book which presents a debatable thesis with great force. It has undoubtedly been a potent influence in shaping American thinking.

Britain: Partner for Peace. Percy E. Corbett; Harcourt, Brace, 1946. Formerly dean of McGill Law School, and now at Yale University, Mr. Corbett writes objectively about relations between the United States and Great Britain.

The Super-Powers. W. T. R. Fox; Harcourt, Brace, 1944. A penetrating analysis of the role of the great powers in international politics today.

China Among the Powers. David N. Rowe; Harcourt, Brace, 1945. One of the best books on China—dissipates many of the illusions which Americans have come to have through the years with respect to the immediate possibilities of China emerging as a great power.

America in the New Pacific. George E. Taylor; Macmillan, 1942. A thoughtful analysis of the new position of the United States in the Pacific area.

The United States and the Near East. E. A. Speiser; Harvard University Press, 1947. An informative analysis of the Near Eastern area and its problems and of the special interests of the United States in this part of the world.

The United States and Russia. Vera M. Dean; Harvard University Press, 1947. The Director of Studies of the Foreign Policy Association writes interestingly and with considerable objectivity of Russia and the relations of Russia to the United States. If anything, she leans over backward to be fair to the Soviets.

The Foreign Affairs Reader. Edited by Hamilton Fish Armstrong; published by Harper for the Council on Foreign Relations, 1947. A selection of the best articles that have appeared in *Foreign Affairs* from the time of its first publication. Includes the very important article by "X" on "The Bases of Soviet Conduct," which, in view of "X's" official position may be a key to official policy towards Russia.

GEOLOGY AND ANTHROPOLOGY

▶ *Our Oil Resources.* Leonard M. Fanning; McGraw-Hill, 1945. Several eminent men in various branches of the oil industry review the present status and future prospects of oil. This will influence our domestic and foreign policies for the next few years.

Glacial Geology and the Pleistocene Epoch. R. F. Flint; Wiley, 1947. This outstanding book will probably dominate the study of glacial geology for years to

come. It is not written for the uneducated public, but is very readable for those who have had some geological training.

Principles of Physical Geology. Arthur Holmes; Nelson, 1942. The members of the Geology Department at Brown have been so favorably impressed by Holmes' stimulating treatment of the broad problems of geology that they have adopted his book as a textbook for the new distribution course. It does not have the flavor of a textbook, however.

Minerals in World Affairs. T. S. Lovering; Prentice-Hall, 1943. This is a discussion of the economics and history of mineral deposits and a description of the

several geological processes involved in their origin. Emphasis is placed on the part played by minerals in international politics.

Mankind so Far. William W. Howells; Doubleday, Doran, 1944. A wise-cracking anthropologist has written an entertaining and thoughtful book on the development of man.

Apes, Giants, and Man. Franz Weidenreich; University of Chicago Press, 1946. On the basis of recent finds of giant human teeth, this anthropologist comes to some startling conclusions about our ancestry. A scientific controversy will probably result, as many anthropologists do not accept Weidenreich's conclusions.

Program by the Horns ◀ ◀

▶ ▶ THIS IS THE STORY of some loyal alumni who took a program by the horns and made it work. It is important in itself and also in that it provides an example for others who wish to offer their enthusiasm in the service of Brown. Until recently there was only individual alumni activity south of Washington along the Atlantic Coast; the men there thought they were too few. Then the "Crossley Plan" came into being, a practical scheme for organizing even small groups into a related structure, with pleasure for all and benefits for Brown. Moreover, the region had a leader who took his appointment seriously, Sidney S. Paine '08, a North Carolina mill man who is a Vice-President of the Associated Alumni. He undertook to integrate alumni interest and activity in the area which Sid adamantly refers as "God's Country." His program, with help from conscientious aides in several of the Southern Atlantic States, is off to a propitious start.

It's a chain-reaction formula which operates under the Organization Plan of the Associated Alumni. In each of the five States within this regional district, alumni groups are being formed. Chairmen have been appointed in four of these States as follows: Virginia—Walter I. Dolbeare '23 of Richmond; North Carolina—Earl W. Milligan '23 of Asheville; South Carolina—Edwin A. Briggs '35 of Greenville; Florida—Paul L. Maddock '33 of Palm Beach. Appointment of a Georgia chairman is pending.

Two new Brown Clubs located in these States have met this spring, specifically the North Carolina Brown Club and the Southeastern Florida Brown Club, the latter under the leadership of Edwin C. Bliss '47 of Coral Gables. The Virginia and George Clubs had meetings last year. Greenville, S. C., will see action shortly, as Briggs gets in touch with his Brunonian neighbors.

Sid Paine, who represented the area at the 1948 Advisory Council meeting in University Hall in February, has covered his ground well, getting to know his men by personal visits in the key centers. In Richmond, for example, he conferred with Ernest S. Fitz '11, a Director of the Associated Alumni, Dolbeare, and J. Douglas Reid '28. He called on Milligan in Asheville; on Maddock, another alumni Director, in Miami. He is in touch with the Alumni Office by phone.

The report of the Asheville meeting appears elsewhere in this issue. The Miami group had a preliminary meeting May 5 with three men present from Fort Lauderdale, two from Miami, and two from Palm Beach. Maddock reported on the monthly meeting of the Alumni Executive Committee which he attended in Providence in April.

A general invitation went to all alumni within easy driving range for the May 26 meeting when the film of the Brown-Dartmouth football game was shown at the Columbus Hotel. An air-mail message reached us two days later telling of the enjoyable time. "The new Brown Club of Southern Florida now appears launched," Maddock noted. James Doran '33 and Bliss assisted in the arrangements. It's as simple as that. More power to South Atlantic Midland!

In the larger cities and those nearer College Hill, of course, organized alumni activity is an old story. The annual New York-New Jersey dinner this spring was its 80th, for example, and you will find listed on the back cover of this magazine some 50 Brown Clubs, most of them thriving. In my yearly report to the Alumni Advisory Council I was privileged to note that 40 Clubs had held at least one meeting

in the 12 months; several had met more often, and eight hold regular weekly or monthly luncheons or dinners, all advertised in the ALUMNI MONTHLY during the lively seasons.

The meetings have taken various forms and have emphasized different purposes. Some clubs, in addition to meetings of their own membership, have organized sub-Freshman gatherings to which prospective Brown men in their areas, together with their fathers, have been invited. Others have taken advantage of vacation periods, to hold dances and other occasions with local undergraduates as special guests while they are home on holiday. Some clubs join with alumni of other colleges in co-operative undertakings; others sponsor Brown musical organizations in local appearances.

We are grateful constantly to those in the University who, by their visits and generous enthusiasm, have taken the spirit of Brown today into those communities. These men—the President and principal officers, heads of Departments, members of the Faculty, coaches in all athletics—have not only been willing but eager to serve the Associated Alumni wherever and whenever needed. And, in their turn, the alumni from even distant areas—California, Texas, Missouri, North Carolina, Illinois, for example, have come back to Brown to help plan our program.

The ultimate goal in every Regional District is to keep existing Clubs vitally alive and to establish new groups wherever there are Brown men—even when there are only four or five. By these methods of organization we believe that Brown and her alumni can be more effectively fused in understanding, in friendship, in usefulness, and in common welfare.

Gammell of Gulfport

▶ ▶ GULFPORT, Fla., had a new Council Chairman in March. Col. J. L. Gammell '15 was sworn in as a member of the Council and chosen as its Chairman immediately. He was not long in making his influence felt, as we learn from a front-page editorial in the *Gulfport Citizen*, entitled "Congratulations to New Councilman."

"The newly appointed Council Chairman, Col. J. L. Gammell showed the results of his military background, his ability to control a bad situation, and his skill as a psychologist at last night's council meeting," said the editorial. "When the situation became extremely tense, and was bidding fair to become worse, between Gulfport's No. 1 heckler and Mayor Williams, Col. Gammell restored order immediately, and quietly read a promotional folder about 'Gulfport's friendly people and quiet atmosphere.'"

"The new leader, who apparently intends to keep control over the audience participation, stated that he intended to squelch 'all personal animosities and all personal quarrels' from being aired in public at council meetings."

Col. Gammell had two other practices put into effect as well (newsworthy enough to call for an eight-column streamer on page one): one a requirement that all council business be in its hands 24 hours before its meetings, the other a press conference with the newspapermen for frank talk and advance information. "We are most grateful for this courtesy," says the *Citizen*, "and feel that the new councilman's past newspaper experience will make him invaluable to the local press."

An Active Spring

▶ ▶ VISITORS from the campus and the impulse of annual meetings spurred 24 Brown Club gatherings in various parts of the country in April and May, with all the overtones of reminiscence, good fellowship, and a common interest in the University of today.

May meetings on the schedule included two for the organization of a new South Florida group in the Miami area, luncheons in Los Angeles, a dinner in Texas, and a wind-up of the monthly dinners in Baltimore. Small Talk



▶▶ AN ALUMNUS, returned from New York, brought us this story about a friend of the family who has two sons, approaching college age. One, it seems, was content to be preparing for Columbia, the other was headed for Yale. And then the good mother paid a visit to a fortune-teller.

Our information doesn't mention whether cards, palms, or crystal were used. Whatever the material, the seer examined it: "You have a son. I see brown. Or maybe it's the name Brown rather than the color. Is there a Brown College . . . or a Brown University? This is to be a part of his life. Selah."

The client has written to Brown for catalogue and bulletin of information, has been asking questions about the University, really interested. We don't suppose we'll ever know whether anything ever comes of this, but we have a rosy feeling of security now that we know the fortune-tellers are working for us.

▶ It was inevitable that the good story about his grandfather should be told again when John de Q. Briggs visited the Brown campus recently. The distinguished headmaster of St. Paul Academy, St. Paul, Minn., is the son of Harvard's famous Dean Briggs and the grandson of George Ware Briggs, Brown 1825 (for whom, incidentally, Briggs' Beach, Sakonnet, was named).

A brilliant youngster, George was brought to Brown when he was 11 years old, and his mother saw President Messer with a view to enrolling the boy in the College. Though students were younger in those days, Dr. Messer was still taken back at the thought of this lad matriculating before he was even in his teens.

"Take him home, Madam," he said to Mrs. Briggs, "and keep him on your lap for another year."

(By a pure and pleasant coincidence, on the same day that the headmaster from St. Paul was here, Allen Clapp, headmaster of Blake School in Minneapolis also paid Brown a visit. Dr. Bigelow rounded up several of the Minnesota boys in College at noontime to be with the heads of the rival schools.)

▶ Signs of the times item: a student in Public Speaking at Brown gave a demonstration talk the other day on how to put a diaper on a baby.

▶ By now hundreds of Brown men have seen the stunning backdrop which Leslie Allen Jones '26 painted of the Van Wickles Gates and University Hall from the top of College Hill. It's a handsome thing, done on a grand scale 18 x 30 feet, true in color and alive with a late afternoon sunlight that is very real. It was a part of the set for the 1947 Brownbrokers' show, used as background for the head table at the Alumni Dinner last June, and brought out again when the Golden Oaks Quartet sang during the Sock and Buskin Alumni revival

a few weeks ago. It will be on view in the theatre at Commencement.

Maybe we've told the story before about the Brown professor who was undertaking to photograph the drop as it hung in Faunce House Theatre. He is a celebrated authority on color photography, with books on the subject to his credit. And, as he monkeyed around with meters and camera, he suddenly straightened up, laughing, to tell a good one on himself. "Do you know what I was doing, Les?" he said. "I was trying to decide whether to focus on the gates or U. H."

That suggests how realistic the painting is. But we've learned that in one detail certain liberties have been taken. You'll remember that the Brown seal appears atop the gates, and it is here on the backdrop that the artist's signature appears—inconspicuous and noticed by few, but there, for all that: "In Jones Speramus."

▶ We know of no case like it on record anywhere, but the Treasurer of the Associated Alumni reported to the Executive Committee last month that the condition of the independent alumni treasury had been improved "with the aid of mirrors." Moreover, the committee thought this was fine.

The explanation lies, of course, in the fact that the modest profits from the sale of the handsome Brown mirror go to this fund. Incidentally, several dozen of these antique reproductions with the 1825 view of the campus have been sold. (\$12.95, express prepaid.)

▶ Here's a striking index of the way costs have risen: When Caswell Hall was built, the whole construction and equipping of the building cost \$75,000. Recently when a study was made of desirable improvements in bath and toilet facilities, the sum estimated as necessary for the project was \$80,000.

▶ At the Board of Editors meeting the other afternoon we were talking about giving proper editorial recognition of alumni achievement. Like the rabbit in the famous recipe, we first have to catch the achievement, or at least word of it. We cited the example of E. T. T. Williams '17, who last May became President of the Lambert Pharmacal Company of St. Louis (Listerine, etc.). We learned of this new distinction only in February, and so confessed. There was one comment from a Board member: "Even his best friends wouldn't tell you."

▶ WE WERE thumbing the pages of the Alumnae Magazine of Meredith College of Raleigh, N. C., the other day when a name jumped out of the page at us. It was that of President W. H. P. Faunce, who was quoted at the outset of a story on their Loyalty Fund:

"I have small respect for the man who can take all a college has to offer of instruction, inspiration, and fellowship for four

years, and then ignore that college for the remainder of life."

▶ OUR COLLEAGUE, Morrie Watkins of the Columbia Alumni News notes that they've all been beguiled there with the advertising of a branch bank in the Morning-side neighborhood which "invites you to come in to start your Savings Account, buy low-cost Savings Bank Life Insurance . . . or just browse around." This was irresistible to an old bookstore haunter with the Columbia University Press: "When a teller approaches with the usual inquiry, 'Can I help you, sir?' the visitor can reply, 'No, thanks, I'm just browsing around in these twenty-dollar bills.'"

▶ WARREN CARLEEN, former editor of the Brown Daily Herald, is contemplating forming the Y.R.W.W.V.F.T.I.M.R. This is the short form for Young Republicans Who Will Vote For Truman If MacArthur Runs.

▶ THE CLASS of 1941, which is planning its Lucky Seventh Reunion for this June, has made some kind of a deal with Seagrani's (which has, we're told, a product called 7 Crown). The possibilities for this sort of thing seemed not to stop with Seven, and we mentioned the possibility of tying in a Third Reunion with Three Feathers, a Fourth with Four Roses, etc.

"Yes," said the guy on our left, "and don't forget Vat 69."

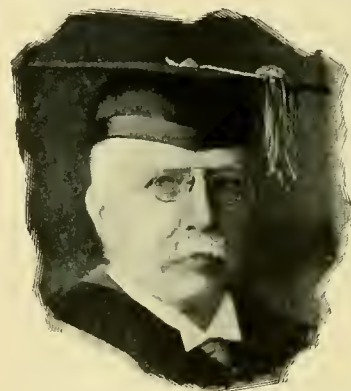

Faculty Briefs ◀

▶ ▶ DR. GILBERT E. CASE '25 resumed his duties as Registrar of Brown this semester. He had been injured last fall in an automobile accident which cost the life of his mother.

Prof. George K. Anderson will be a member of the Faculty for the Bread Loaf School of English this summer, with courses on the History of the English Language and on Chaucer.

Prof. James Morgan will give two courses in Economics in the Harvard Summer School. The Harvard session, revived after a six-year wartime lapse, is the oldest summer school in the country.

The new book, "Painting in Public," by Maurice Grosser makes acknowledgments to two members of the Brown Faculty—Charles Arthur Lynch and S. Foster Damon.

Joe Watmough, Brown swimming coach, is the President of the New R. I. Swimming Coaches and Officials Association, formed by 15 pioneers in the State.

Dr. Henry Stuart Hughes, son of Charles E. Hughes, Jr., '09 and former Instructor in History at Brown, has been appointed Associate Director of Harvard's Russian Research Center. He has been Acting Chief of the State Department's Division of Research for Europe, Office of Intelligence Research.

Prof. Walter H. Snell, formerly Director of Athletics and one-time Brown baseball coach, has been reappointed representative of the New England States on the Baseball Committee of the National Collegiate Athletic Association for 1948.

▶ PRESIDENT WRISTON became a grandfather Dec. 8 when a daughter Catherine Bigelow was born to Mr. and Mrs. Walter B. Wriston.

Prof. Chelcie C. Bosland, chairman of the Department of Economics, told the Providence Retail Specialty Stores Association that he knew no particular reason why the second half of 1948 would bring a depression, and high production, high employment, high national income and prosperity were continuing through the first six months of the year. The thing to watch was possibility of "a real flight from the dollar," in which people would give up money for any kind of goods, creating a "superficial prosperity" but bringing deflation, unemployment, and depression.

Dean Samuel T. Arnold presided over the Brotherhood luncheon in Providence Feb. 25, a feature event of Brotherhood Week, for which President Wriston was regional chairman.

Penguins at 4:30

▶ ▶ "GRACE has at last hobnobbed with her penguins," said a note from Christchurch, New Zealand, which reached us at the end of the month. Those who have read "Logbook for Grace" by Dr. Robert Cushman Murphy '11 understand the reference. Mrs. Murphy, for whom the now-famous chronicle of a naturalist's first voyage south was written, has accompanied the Curator of Oceanic Birds on his latest trip for the American Museum of Natural History.

Using the Canterbury Museum in Christchurch as a base of operations, the Murphys journeyed to the Snares Islands in a recent expedition. One photograph in a New Zealand newspaper showed Dr. Murphy studying a specimen of lepidium, or scurvy grass. It was first discovered by Captain Cook when he called at The Snares, using the grass to combat scurvy among his crew.

The Murphys had expected to land at The Snares in the morning but, on account of gales, were shot ashore at 8 p. m. with all their stores, in wind, rain, cold, and mud, and with no possibility of getting the tents up that night. The party found a castaways' depot, built and equipped about 1873, and all piled into the small shelter. The next morning the Murphys wriggled out at 4:30 to watch penguins, albatrosses, sea elephants, and the general sub-antarctic spectacle. For 17 days and nights there were no sheets, chairs, or baths, but Mrs. Murphy enjoyed fulfilling a lifelong wish to see that part of the world at first hand. ◀

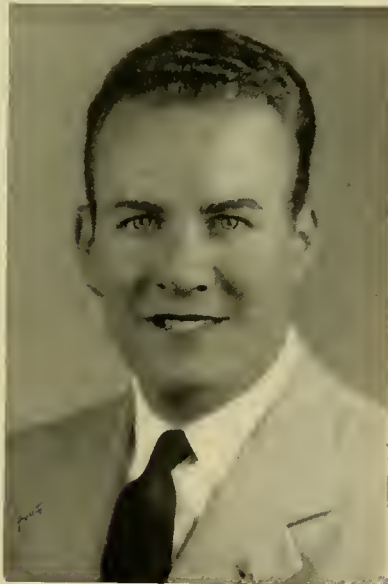

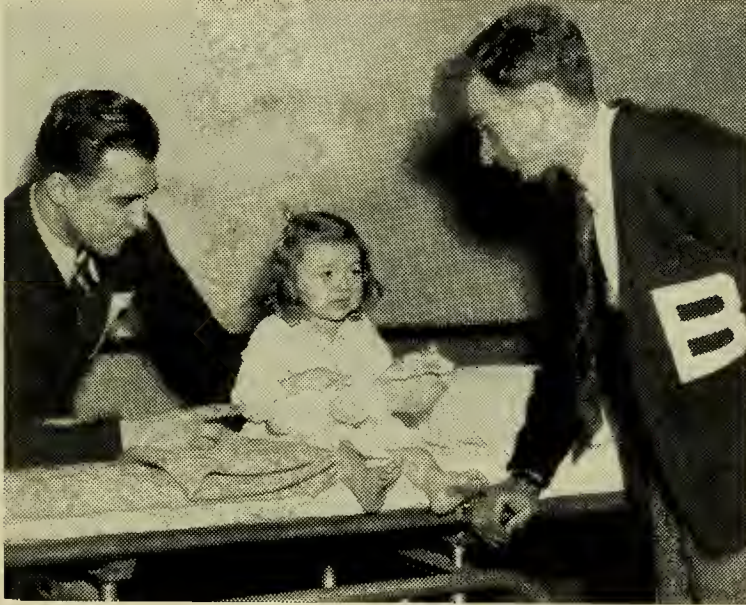
