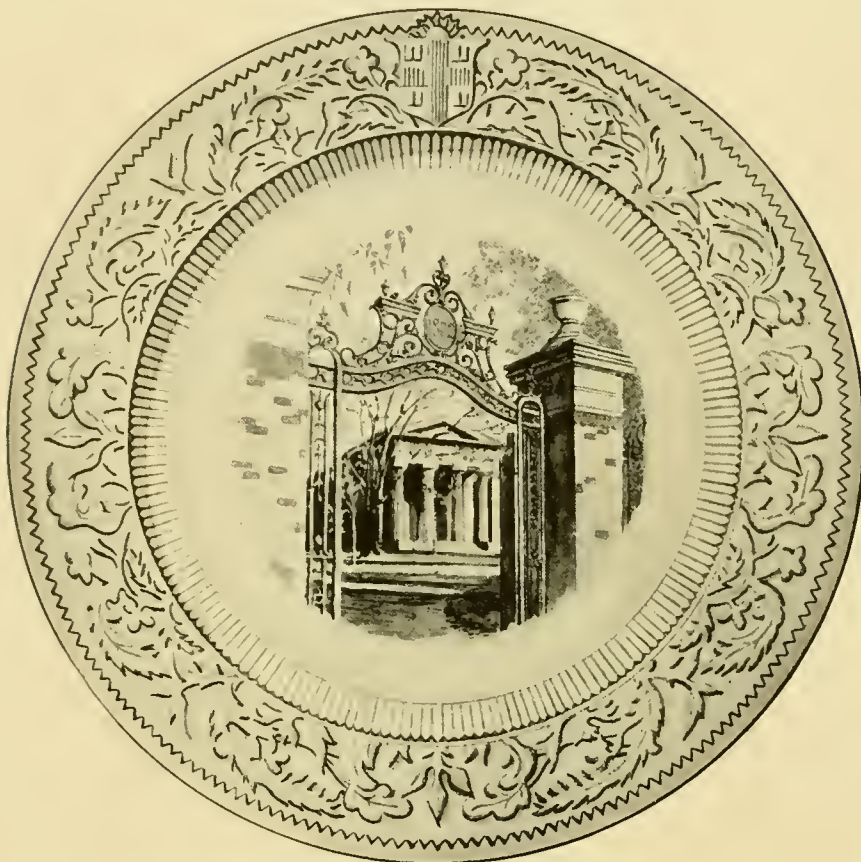

Brown Plates Available ◀ ◀

New shipments from England make Christmas purchases possible for the first time in two years.

▶▶ HERE IS THE WORD many Brown men have been waiting for: Brown University Plates by Wedgewood are available again, and just in time for Christmas delivery if orders are prompt.

The first shipment of Brown plates in 18 months has been received in this country—163 sets of six plates each. When the supply was exhausted a year ago last summer, there was a backlog of more than 60 inquiries including unfilled orders. Persons who thus expressed an earlier interest have been notified of the arrival of wares, but there is a supply adequate to take care of a considerable amount of "new business."

The public offering has been made again by Alumni Treasurer Fred E. Schoeneweiss '20, who is also treasurer of the Memento Committee which handles the distribution of the plates. The plates are currently priced at \$16.50 for six plates, with express charges from Boston COD.

The Brown plates are made at England's Wedgewood potteries, founded in 1762, two years before the University's charter was granted. Josiah Wedgewood, F.R.S., made his first Queensware for Queen Charlotte, whose portrait appeared on the original Brown seal, and named it in her honor. The Brown University plates are made from the old Queensware formula by lineal descendants of the first Wedgewood.

In continuing the sponsorship of the Brown University Queensware, the Asso-

ciated Alumni are aware that these souvenirs provide a pleasant bond between the campus and Brown families. In the standard sets of six, there are different centers which feature landmarks of sentimental and pictorial interest to Brunonians: Manning Hall, seen through the 1872 Gate; the College Green, seen through the John Nicholas Brown Gate; Hope College and the Robinson Gate; the War Memorial; University Hall and the Van Wickle Gate; and the First Baptist Meeting House. Plates are 10½ inches wide.

The centers are hand engraved in brown sepia on the ivory Queensware. Unusually attractive, too, is the fine embossed border, inspiration for which came from a diploma awarded at the first Brown Commencement after the American Revolution. In this bas-relief frame the University arms hold a dominant position.

Any profits from the sale of Brown plates will be assigned by the Associated Alumni for University purposes. Checks should be made payable to "Treasurer, Associated Alumni of Brown University" and sent with the orders to the Alumni Office at Brown (Providence 12, R. I.). Plates are shipped, express postpaid from our Boston agents, and deliveries from that point are generally prompt.

Mr. Schoeneweiss announces that he can offer for sale a limited number of single plates, although no complete sets will be broken to accommodate that interest. The

price for a single plate is \$3.00, plus packaging charges of 15 cents and the subsequent COD express. If two plates are ordered, the packaging charge is 20 cents; for three to five plates, the extra charge is 25 cents; there is no packaging charge for the full set of six. Single-plate orders should specify the center preferred and whether an alternative will be acceptable. ◀

In the Mail

E. K. Aldrich, Jr.

Sir:

Edward Kimball Aldrich, Jr. (June 16, 1879-October 20, 1947), was Providence born and bred, and a sound and substantial Brown man. After the First World War he served as Secretary of the Executive Committee of the Associated Alumni. He was Treasurer of the Associated Alumni, 1927-33; Trustee of the Brown Alumni Fund, 1925-36; and Secretary of his beloved Class of 1902 until his death. As a member of the Visiting Committee of the Department of Romance Languages, he gave time and money and equipment to the Department, and took deep interest in its growth and changing personnel. He was active, too, in his fraternity, Phi Kappa Psi, and in numerous societies directly or indirectly connected with the college. In recent years his sole recreation had been the breeding and showing of dogs, Schipperkes from Belgium first, then Salukis from Arabia. On Salukis he was an international authority.

During his busy Brown years he was almost a daily visitor to the Alumni Office, where his friendliness, his innate courtesy, his good counsel were cherished. He seldom missed a committee meeting, although it was torture for him to sit comfortably for any length of time. Deafness made him rather shy and sensitive. He disliked public dinners in particular. Yet he was always ready to do more than his share of the preliminary matters, and even to attend a dinner if he thought it the courteous thing to do. We who were his friends recall his camp car trailer, one of the first seen in Providence, and trips to Cape Cod, the Berkshires, South County. He was an excellent host.

One day as we talked, he said that he could not remember when he had been wholly free from bodily pain. Courage in the face of physical affliction was his; a strong will power kept him going quietly and valiantly to the end. Neither troubles nor trials ever completely dimmed that twinkle in his eyes, "which marked him as a spirit not to be forgotten."

► ► Why They Named It Andrews Hall

President Wriston at the Dedication Nov. 2, 1947:

► ► THERE IS A PHILOSOPHY of history which assumes that the pressures of society create events, that individuals are merely the instruments of social forces which determine their actions. There is a contrary theory that men create the conditions under which they function and that biography is therefore the key to history. Most people find that a synthesis which encompasses both is more reasonable than a mere choice between these two extreme positions. Hitler could never have achieved the position he did had not the social, economic, and political situation opened the door for such tactics as he applied. In normal times his extravagances would not have influenced more than a lunatic fringe. On the other hand there is no indication in the experience of the world that, if the circumstances had been different, Hitler would have been an admirable character. It takes both the man and the occasion to achieve a given result — good or bad.

The founding of Pembroke illustrates the validity of the synthesis of which I have been speaking. Today we dedicate a building and give it the name of a man. We have chosen the name because we think of E. Benjamin Andrews as the founder of Pembroke. But even he could not have founded this College alone. Before he became President of Brown University, the social pressures to which he responded had already been felt. The Corporation had considered the matter sympathetically; the Faculty had made suggestions as to how to achieve the goal. President Robinson had approved the idea in principle, had seen only practical difficulties as a barrier; but for his age, he would have

been willing to undertake the project. He knew that it would take vigor, imagination, and courage even to "co-operate with the inevitable."

It is difficult after half a century to see what made the decision so hard. As one reads the arguments against the proposal to admit women they seem unreal. There was, for example, the legal and literal idea that the word "youth" in our Charter referred to men only and that the admission of women might void the Charter. Dictionaries and literature were searched to justify or overthrow that argument. There were discussions as to the propriety of using certain classrooms; in retrospect these discussions seem to magnify small obstacles. There were questions of finance which daunted some of the most courageous, but which, as time went on, solved themselves.

► PERHAPS WE CAN DRAW one lesson from this perspective upon the founding of Pembroke. Sooner or later women will be elected to the Corporation of Brown University. There is no question of their ability, of their interest — or of their financial resources. In a day when so much is said against discrimination, the exclusion of women is surely an anachronism. Our successors 50 years hence will be amazed at the hesitation and the doubts which have so far precluded their election.

I am reminded that the appointment of women to the Faculty and their assignment to teach men as well as women happened so gradually, so naturally, that it passed unnoticed even by those who made the change. Only a review of the historical sequences, occasioned by the death of Professor Magel Wilder this fall, brought all the steps to light.

The progress by which the very limited offerings to Pembroke students were expanded until all undergraduate courses are open to them offers another illustration of the way in which barriers fall with time. It would be difficult to identify any single act, or any particular moment, when the last obstacle to free access disappeared.

In a great crisis Horace Greeley once gave some sound advice. The United States had suspended the payment of gold to its citizens during the Civil War. How to resume specie payments was discussed with much learning, and with even greater length — with some light and even more heat. Horace Greeley brought the whole discussion down to earth. Said he: "The way to resume is to resume." One day, without fanfare, his advice was taken and it was found that the resumption of gold payment presented no problem whatever. The fiscal situation had matured to a point where it required only the courage to perform the act. Perhaps Horace Greeley showed the way to elect women to the Corporation.

Even before E. Benjamin Andrews assumed office many people were willing to have women admitted to Brown University. What then was the distinctive contribution of President Andrews? It was his readiness to take the chances inherent in any new project. There were social

chances, for the segregation of the sexes in New England higher education was a fetish at the time and it was feared that the prestige of the institution might suffer by running counter to the current. There were financial chances, for the women's college might not draw support adequate to justify the outlay. There was a chance that the education of women might take a tack so radically different from that of men that there would be no economy or efficiency in having a women's college in what had been a men's university.

► **RECENTLY WE HEAR** a good deal about "calculated risk." It is the opposite of a gambler's risk, where everything is hazarded upon events wholly out of control of the person who takes the chance. A calculated risk is the kind a reasonable man accepts after considering the entire situation. He retains some — though by no means complete — control over the consequences. Bennie Andrews was no gambler, but he knew the meaning of risk and freely accepted the hazards.

What manner of man do we memorialize in this building?

By inheritance, by taste, by training, and by experience he was passionately interested in education. His idea of education was a union — indeed a fusion — of intellectual and moral elements. He saw no point in knowledge without purpose and no reason to train the mind unless its impulses were controlled by moral principles.

He was a man of vast energy and force of character. He suffered all the handicaps of poverty; in our day he would be regarded as one of the underprivileged; it would be said that with his resources he could not possibly go to college. He was injured as a child, so that he had to be out of school for long periods. His preparatory work was interrupted by service in the Civil War, which cost him an eye, so that he might have been considered permanently handicapped. On the other hand he had all the advantages of the underprivileged. In the fight to get ahead he developed a zest for life which made all experience a great adventure. He learned to earn his living — meager from some points of view, but rich from others — without fear. Self-reliance carried him serenely through severe trials; he surmounted hardship without a trace of self-pity. In short, the disciplines of adversity made him a man whom nothing could daunt. When hardship, or ill health, or defeat blocked the road, he mustered what patience he could until he was able to resume the course of action upon which his mind was determined.

► **ANDREWS LACKED** a deep attachment to any particular region. If his father was not an itinerant minister, he was certainly peripatetic, and Benjamin had no permanent home. He had no single preparatory school; he went to at least three. He had one college and one theological school, but between college and theological school he taught and was principal of an academy; after his schooling in divinity he had a brief pastorate. Only six years out of college he became a college president at the age of 31, and spent four years as the dynamic leader of Denison University. There followed three years as Professor in Newton Theological Seminary, then five years as Professor at Brown, one as Professor at Cornell, nine years as President of Brown, two as Superintendent of Schools in Chicago, and then eight as Chancellor of the University of Nebraska.

If his background and youthful experience gave him no strong geographical attachments, the roots of his personality grew deeply into an intellectual and moral idea. He fully exemplified the familiar scriptural passage: "The zeal of thine house hath eaten me up." He pursued that idea wherever the best opportunity for effectiveness appeared at

any given moment. So deep was this devotion that it seemed inflexible; superficially it might make him appear to have lacked institutional loyalty. That was far from the case. He knew that the survival power of institutions was greater than that of individuals; he never overestimated the essentiality of his own contribution to a particular situation. Moreover he perceived that sometimes a man can render the greatest service to an institution by forcing it to face a vital issue, even if it involved his own displacement.

► **IT CANNOT BE SAID** that President Andrews succeeded in everything he undertook. Like Wayland before him he reshaped the intellectual and moral life so vigorously, he reformed educational practices so zealously, he concentrated upon student progress so wholeheartedly that he did not find money in quantities sufficient to establish firmly what his love and labor achieved. His successes were the kind of successes essential to lively educational progress; he knew that kind of work would ultimately draw support. But for Andrews, as for Wayland, it came too slowly.

E. Benjamin Andrews made mistakes, but he was the first to proffer candid acknowledgment when he received more light. Of the issue of the free coinage of silver in a 16 to one ratio with gold, which occasioned the difficulty at Brown, he said five years later: "I have to admit that it was an astounding mistake and that I was in great and inexcusable error." That was a remarkable expression; it reflected the sincerity which was the key to his character. He could have changed his mind and remained silent; he could have said the circumstances had altered, as indeed they appeared to have; he could have weaseled his expression, but he scorned to soften his own responsibility. He would never be as severe with anyone else as with himself.

Inflexibility in pursuit of an ideal did not in the slightest degree reduce his personal charm, his geniality, his lively, comprehensive interest in every phase of student life. No Professor, no President was ever more dearly loved; none inspired deeper or more permanent respect and affection. All knew that he was without personal ambition and devoted to the welfare of those committed to his charge. He evoked hero worship from a multitude of students — and never let it go to his head. He never played for their approval, and was never inflated by it.

How he remained solvent is a mystery; he was forever

loaning money, much of it never repaid. He understood, sympathized with—and officially suppressed—student ebullience. He shared it fully until it got out of bounds; but he set the metes and bounds with a hand so firm and a skill so sure that his decision was beyond challenge. He loved sports and games; for personal problems, or difficulties of whatever kind, he had a ready and sympathetic ear, a sensible and strong suggestion. Without losing anything of the dignity that then hedged his office, he exhibited an informality which has left memories replete with anecdote.

► ANDREWS WAS A TEACHER. He knew all the arts—not just some of them. He was an ardent and omnivorous reader. He amassed great quantities of information, and reflected upon it to reduce it to order, searching out meanings. Lucid in exposition, eloquent in expression, original in illustration, racy in the use of words, resourceful in the construction of phrases, he inspired, he led, he stimulated, he amused, and he irritated. In short, he took whatever course was necessary to produce an intellectual response. The profound sincerity that characterized his instruction led to appreciation even when it did not bring agreement or conviction.

Andrews was a Professor at Brown for only five years, and while he held the office of President for nine years, he was on leave of absence one of those years and part of another, so he was actually in residence not more than seven and a half years. Yet no one holding a responsible post in this University, even 50 years later, can help realizing that his administration was a turning point:

Under Andrews, Brown ceased to be a small New England college and embraced the idea of a university. With him the ideal of scholarship, which must dominate a modern university, came to fruition. Graduate work was put upon a solid basis. The thorny problem of the accommodation of women was solved in a manner both statesmanlike and tactful. The principles of academic freedom were dramatized and justified not only for Brown, but for all universities and colleges. It took unique strength so to infuse this institution with so many ideas in so short a time as to set it upon a course from which it has never deviated.

As for Pembroke, his conviction and his courage were so profound that for the first few years he carried personally the financial responsibility for the venture. In retrospect the hazards do not appear overwhelming, but in prospect they would have daunted a less doughty warrior. Pembroke Hall was constructed during the year when he was on leave from the University because of overwork and exhaustion; it was dedicated fifty years ago this month. Its completion brought to attainment one of his principal objectives. Until that time the Women's College had been "an adjunct." That did not satisfy him. As he expressed it "no mere 'annex' is desired or intended. The College must be part and parcel of the University, giving women students the full university status." With the dedication of Pembroke Hall that goal was fully achieved.

Is it any wonder that the largest building on the Pembroke campus is now named "Andrews Hall"? ◀

Gratitude in the Hour of Dedication ◀ ◀

▶▶ "TO MANY YEARS of usefulness and inspiration," Pembroke College on Nov. 2 dedicated its new dormitory Andrews Hall before a company of 1500 friends who filled Alumnae Hall. At the conclusion of the exercises, which also commemorated the 50th anniversary of Pembroke Hall and took note of the 600th anniversary of the founding of Pembroke College in Cambridge, England, the first "open house" displayed the quality of this edifice named for the man who established the Women's College at Brown. Sharing in the pomp of the day were officials of that English College whose short-wave messages were recorded by the Mutual Network and played to the audience from transcriptions, and later over the Yankee Network.

Later the cornerstone of the dormitory was sealed, a box therein containing copies of the Pembroke College charter, a *Providence Sunday Journal* feature story, and *Pembroke Record*. Mortar for the stone was laid with a gold-plated trowel by Dean Margaret Shove Morriss, President Wriston, Chancellor Henry D. Sharpe, Architect Thomas M. Shaw, and Contractor Thomas F. Gilbane '33.

With the rise of the College, so quietly and steadily grown, Dean Morriss found it an appropriate occasion for recalling the generosity of its benefactors:

"Who can think of Pembroke through the years without making mention of the Society with the long name, the Rhode Island Society for the Collegiate Education of Women, that remarkable group of women who came together more than 50 years ago to build Pembroke College and who have shared mightily in every project Pembroke has ever undertaken. I cannot even begin to enumerate their gifts, material and otherwise, in this brief summary.

"The list of large individual donors to Pembroke College includes Mr. Frank A. Sayles, who gave the College its gymnasium; Dr. Horace G. Miller, the donor of Miller Hall; the Aldrich brothers, whose gift of their home to Brown with the hope that it might be used for Pembroke College made possible the Field and the Field House; and above all our beloved patron and constant friend, Mr. Stephen O. Metcalf, who built Metcalf Hall for us, and whose magnificent offer to double all funds raised by the alumnae for a student building galvanized the young Alumnae Association of Brown University into the heroic efforts which resulted in the building of Alumnae Hall, within whose gracious portals we are now gathered. Mr. Metcalf's generosity to the College cannot be measured by buildings alone. For many years he gave unstintingly of his time and interest in serving as a Corporation representative on the Advisory Committee for the College.

▶ "INDEED PEMBROKE COLLEGE is indebted to many generous-hearted men and women in this community. Not the least of these are the quiet host of Brown alumni and alumnae. It is they who have best sensed the needs of the College and who have planned continuously with the administration for its future. We had for several years been talking of the need for a new dormitory to house suitably the increasing number of students from outside Rhode Island, but it was the alumnae who started action. In the summer of 1937, at the meeting of the American Alumni Council at West Point, three of the Pembroke College alumnae were so thrilled by the opportunities which alumnae have for service to their colleges that they came back from that meeting with a full-fledged plan to raise \$100,000 from the alumnae as a gift to the College at its 50th Anni-

versary. In 1942, therefore, 50 years after the beginning of the College, \$200,000 was secured, \$100,000 from the alumnae and a similar amount from a group of generous friends. Surely, we thought, \$200,000 was almost enough money to build a proper home for sixty young women.

"During the war, however, Pembroke College, like the artillery, was forced to 'lift its sights,' with results you will soon see for yourselves. To alumnae, friends, and the many Brown alumni, who supported the Housing and Development Campaign in whose plans the Pembroke College dormitory was generously included, we pay tribute. And especially I want to include the President of Brown University, who visualized the needs of Pembroke College so clearly that the first building projected and second one completed under the campaign is Andrews Hall. To all of you, and I hope you are all here today to see the results of your gifts and labors, we say thank you with all our hearts."

THE VOICE FROM ENGLAND

▶ The audience was stirred to hear the voice of Sir Ellis Minns, President of Pembroke College in the University of Cambridge, bringing greetings: "Among Pembroke men," he said, "a distinguished place is held by Roger Williams, who was so moved by the love of liberty while with us that he could not endure the discipline even of his own pastors, and was the first from our company to migrate to America. But he found no peace in Salem; guided by a divine Providence (whence comes the name of your city) he sought the good Rhode Island with the purpose of founding there a state which should not presume to limit the faith or thought of any citizen. Small wonder is it that in such a state there should have arisen a distinguished university, and one free from every prejudice.

"We have long known," he went on, "that within Brown University there was a second Pembroke College bearing a like name with our own; the younger Pembroke rejoiced in the flower of her age, and to her now 50 years after her founding, as a grandmother to a beloved grand-daughter, with deep affection our own Pembroke, this day 600 years old, sends her warm congratulations." Sir Ellis was presented by Sir Montague Butler, The Master at Pembroke College, Cambridge.

Visitors to Andrews Hall saw there the handwrought sterling silver scroll box in the style of a medieval reliquary which Pembroke College in Brown is presenting to Pembroke College in Cambridge. Designed by J. Russell Price and executed by craftsmen of the Gorham Company, it bears appropriate engravings. Within the reliquary is a hand-printed sheepskin scroll which reads: "Pembroke College in Brown University sends filial greetings and felicitations from Providence that city long since planted in the New England wilderness by Roger Williams, to Pembroke College in the University of Cambridge in her six hundredth anniversary year. Esto Perpetua."

This exchange, in the opinion of Dean Morriss, is "a delightful evidence of reciprocal friendship with one of those English colleges from which all our liberal arts undergraduate colleges stem." She found it significant of the long history of higher education that "the 600-year-old English college for men should claim a friendly relationship with a young American undergraduate college for women." In dedication of the new building, Pembroke is renewing, she said, "its implicit promise that it will continue to foster the kind of liberal education best expressed by the two

words which had so much meaning for Roger Williams—Freedom and Enlightenment."

The principal address of the day, President Wriston's, was a heartfelt tribute to Dr. E. Benjamin Andrews, for whom the new dormitory is named. It was no glib, casual appreciation but rather showed a close familiarity with the life of the Pembroke champion. The text of this appears upon another page in this issue.

► DR. WRISTON had warm praise for those who had made Andrews Hall possible. "First," he said, we should thank the officers and alumnae of Pembroke, who launched this project so long ago and pursued it with conviction and faith. We are grateful to the leadership of Mrs. Swain, then of Col. Buxton, and to the donors, whose generosity turned a modest enterprise into a great one. The building committee had views and expressed them with pithy decisiveness, yet conflicting ideas were brought into harmony by the light of reason. There is a distinguished alumnus, who in the midst of a thousand other pressures, nonetheless took pains to see we were never short of steel when deliveries were difficult and could be assured only by his personal attention. Mrs. Sonntag worked diligently to achieve excellent interior decoration.

"There was the good nature and skill of Tom and Bill Gilbane and their associates in the Gilbane Building Company. They seem able to waken suppliers right out of a coma and to galvanize moribund sub-contractors by a forceful, yet genial, word. Lastly there is Mr. Shaw, a man of distinguished taste, wide experience and unsurpassed skill, who added to all the technical proficiency of a first class architect receptivity to amateur suggestions. Unlimited patience and deep devotion to the interest of his clients; his talents and his personal qualities far exceeded mere professional requirements. To all these and to others whose names are legion, I express the gratitude of Brown University, and particularly of Pembroke College in Brown University."

A Share in Mrs. Beckwith's Estate

► BROWN UNIVERSITY is a major beneficiary under the will of Lydia Owen Beckwith, widow of Daniel Beckwith '70 who died in Providence Nov. 16 in her 98th year. A real link with the city's past, she had enjoyed a long, active life, with a wide variety of civic and social interests.

From an estate estimated at a value of more than \$200,000, a \$10,000 bequest is made to the Providence Athenaeum, of which Mr. Beckwith was long Librarian. In addition to some personal cash and property bequests, a trust fund is to be set up to provide annuities for several relatives and friends. Upon the death of the latter, Brown University, the Rhode Island Hospital, and the Providence Public Library will share equally in the distribution of the terminated trust fund. "It is estimated that each of their shares will be substantially greater than the \$10,000 bequeathed by Mrs. Beckwith to the Athenaeum," says the news story which reported the filing of the will for probate.

Mr. Beckwith, who died in 1917, was at one time assistant Librarian at Brown.

Dean Arnold's Father Is Dead

► REV. HENRY ARNOLD, father of Dean Samuel T. Arnold of Brown, died Nov. 20 in Fall River where he had been pastor of the Bogle Street Christian Church for 26 years until his retirement in 1942. A native of Manchester, England, he went to Fall River as a child and entered the ministry in 1902. Another pastorate was that he held for 14 years at the Corrina Christian Church in Corrina, Me. Other survivors are Miss Grace L. Arnold, Pembroke '27, Mrs. John Sample of Millbury, Mass., his daughters, and another son, Arthur H. Arnold of Saylesville, R. I., and his widow, Annie Tomlinson Arnold.

Hibbert Chosen Honorary Alumnus

► G. BURTON HIBBERT, Treasurer of Brown University, was elected to honorary membership in the Associated Alumni at the October meeting of the Board of Directors. The Providence banker is the holder of an honorary degree from the University as well.

Honor to a Team That Never Gave up ◀ ◀

▶▶ IT DOESN'T LOOK like a great deal on the record book: football victories over Yale, Holy Cross, Rhode Island, and Connecticut; a tie with Colgate; and defeats at the hands of Princeton, Dartmouth, Harvard, and Rutgers. But anyone who saw Brown's 1947 football season knows it was a good one. A team, strong on the forward wall but lacking in speed and heft in the backfield, responded to painstaking instruction and lifted itself with high morale to great possibilities. Fortune, outrageous in snatching away victory at Hanover, was never lenient, and a few critical plays turned the tide in every defeat. We could have won them all; we could have lost the big games we won.

Favored only once in the seven major games, the Bear came up scrapping every time. And the rousing play against Yale and Holy Cross gave ample satisfaction to the team's followers. The College gave strong backing to a squad which never gave up and must look ahead confidently to 1948, with pride in '47.

Seven men, five of them ends, were in Brown football uniforms for the last time on Thanksgiving Day. All are war veterans who won letters in other Brown sports as well: Captain Lou Regine, center; George Boothby, Don Campbell, Bud Schuster, and Dick Pretat, ends; Paul Flick, tackle who played at end most of the year and was adjudged a "Lineman of the Week" after the Yale and Holy Cross games; and Paul Gaffney, lightweight back, who had the distinction of making the longest scoring run of

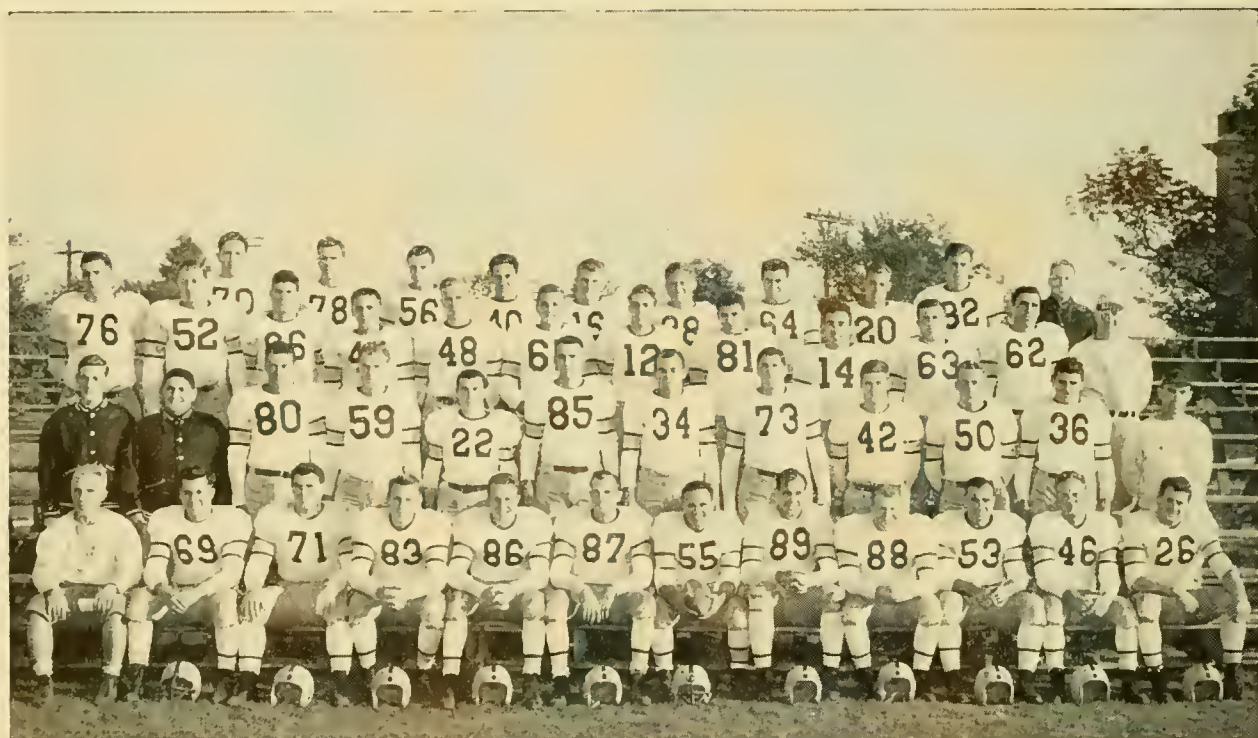
the season — 90 yards on a kickoff return against Rhode Island.

The precision backfield, therefore, should be virtually intact for 1948, plus reinforcements from the Freshman squad. Regine will have replacements in Condon and Scott, who saw plenty of action this year. The principal rebuilding will have to come in the end squad, obviously, with Searles, Crooks, Hendricks, and Smith remaining to fight it out with some Sophomore likelihoods. A well-balanced Freshman team, incidentally, defeated all comers except Harvard. It will contribute further depth along the line and in the backfield, which was one of the elements of strength in a squad which took full advantage of new allowances on substitution.

BROWN 20, HOLY CROSS 19

▶ TWENTY THOUSAND HATS were off, some literally, all figuratively, as Brown upset a heavily favored gridiron foe, Holy Cross, by coming from behind three times and winning 20-19 Nov. 1. The Brunonians had beaten only Connecticut and Rhode Island and were meeting one of the heaviest elevens in the East without any of the experts matching the confidence on the Brown bench. And for a quarter it looked as though the Crusaders would have no trouble.

After the Cross had scored its first touchdown, on the second play of the second quarter, however, the thrills

The 1948 Football Schedule

► THE TRADITIONAL Brown-Yale encounter, up to the present a November fixture, will be the 1948 opener for both teams, according to the Brown football schedule announced by Paul Mackesey, Bruin Director of Athletics.

Next season the Bruins will open on Sept. 25 with the Elis at New Haven and close with Colgate at Brown Field on Thanksgiving Day morning. On the road the Englemen will meet Yale, Princeton, Holy Cross, Rutgers, and Harvard, while they will play host to Rhode Island, Connecticut, Western Reserve and Colgate. 1948 marks the first appearance of Western Reserve on a Bruin football schedule, inaugurating a home-and-home exchange.

The complete Brown football schedule for 1948 follows: Sept. 25—Yale (New Haven); Oct. 2—Princeton (Princeton); Oct. 9—Rhode Island; Oct. 16—Holy Cross (Worcester); Oct. 23—Connecticut; Oct. 30—Rutgers (New Brunswick); Nov. 6—Western Reserve; Nov. 13—Harvard (Cambridge); Nov. 25—Colgate.

began. One of Kozak's brilliant quick kicks went 56 yards and rolled outside on the five. When Brown held, the return punt was carried back to the 26 by Kozak, and five plays later he sliced over to tie the score. Condon gave the lead to his team with a perfect conversion.

The lead was to change six times in all that day. A fumbled punt gave the Purple its next chance, and a ruled interference on what was otherwise a no-good pass beyond the end zone on fourth down set up the 12-7 lead that prevailed at halftime. Again the Bear came roaring back, this time on a relentless 71-yard advance, ground out with short gains, Campbell scoring on a Finn pass from five yards out. It was Brown 13-12 as the fourth quarter opened. With fortune switching once more, Kissell of H. C. romped a flawless 53 yards and put his team ahead, with Nolan's placement, 19-13. A weaker heart than the Bear's would have been broken by that sudden flash, but Kozak roused his men again with a 26-yard kickoff return. Slowly the Cross line was forced back by Kozak, Gresh, Finn, and George Paterno, until a first down was earned on the four. Green made it on the fourth try from there, and Condon's reliable toe produced the extra point that meant victory. Two pass interceptions halted the last Purple essays, and the game ended with Brown on the move again at midfield.

As Frank Matzek, veteran student of the game, wrote in the *Providence Journal*, "the engagement followed the old Bruin-Crusader pattern — tight and explosive at one and the same time." Statistics reflected the even matching of the teams for Holy Cross outrushed Brown 206 yards to 200, while Brown's shorter gains gave 16 first downs to 10. But the Bear completed seven of 17 passes for 79 yards, and intercepted two of Holy Cross's 12 attempts, only two of which succeeded for a total of 28 yards. Kozak's brilliant kicking showed a 37-yard average for the day.

BROWN 20, YALE 14

► AGAIN IT WAS an under-dogged Brown team which faced Yale, rated as one of the East's leaders, especially with Jackson back in the line-up, the Jackson who had helped grind us down 49-0 in 1946. But Engle's men were "up" for this game and bowled over the Eli for the fifth time in eight years in a heart-stirring triumph that made the football world sit up and take notice. No rain, even the tor-

rents that were dashed down on the Bowl, could wipe out the high elation of that 20-14 achievement.

How it rained! The memory of that remains with all who were there. The description of it was unmistakable as it came over the air. You felt soaked as you read the rousing tributes in the press. But what a ball game it was, too:

The issue was doubtless settled in the battle of the lines, where Brown's forwards outcharged their rivals, lifting them out of the way at crucial moments and providing the holes for the light backs to punch out their yardage. But there was superb generalship, too, intelligent play, deceptive handling, even of a sodden ball. On the technical side, an interesting maneuver was Engle's use of a four-man line at appropriate spots.

Brown struck first, cheered by a great 32-yard runback of Finn's on Yale's first punt. Nine plays and 40 yards later, Kozak burst over the goal line, and Condon's kick added the seventh point. The lead didn't stay on the books long, for Jenkins caught Furse's aerial behind the Brown safety for a 43-yard score on the seventh play of a sequence. It was 7-7, and the experts recovered some of their poise. Still, the Bruins kept Yale penned deep in Blue territory, aided by the now-favoring gale and even penetrated themselves to the Yale eight only to fumble.

After the rest and dry-out between the halves, Kozak set up the major break of the game with a quick kick to Yale's six, and DeAngelis recovered an Eli fumble at the same stripe. It took four tries to go the six yards, but Green made it on the last attempt, and the Brown stands shouted into the rain.

The delight of the Brunonians was to reach a new height soon after. Thanks to a Kozak runback of 25 yards, they had the ball on Yale's 22, fourth down, as the last period opened. Out trotted the ace place-kicker, Joe Condon who despite an earlier failure from the 39, was known to be a menace. Yale was completely fooled when Finn received the pass from center and, instead of holding it for Condon, heaved it to Nelson on the five-yard line. The halfback lazed along to provide the game-winning touchdown, though the Blues were to march 98 yards for a second counter.

Some statistical honors went to Yale with 11 first downs to 8 for Brown; 89 yards gained on passing from eight completions out of 13 tries to Brown's single, game-winning completion in five attempts. The Bulldog was outrushed 150 yards to 106.

HARVARD 13, BROWN 7

► AFTER TWO SUCH TRIUMPHS, Coach Engle knew there would be trouble ahead in keeping his team at the peak of the previous fortnight. And the team was in the unfamiliar role of favorite as it journeyed to Cambridge for the Harvard game. Dick Dunkel even ranked it eighth among Eastern teams at that stage of the season, having boosted its point index each week. But Harvard, too, reinforced by the return of injured operatives, had reason to look forward to the game more happily than it had on any since the Virginia debacle.

Dick Harlow, aided by the former Brown star, Bob Margarita, and the former Brown coach, Hal Kopp, was ready with a defensive strategem to spring on his former player and pupil, Rip Engle. This was an unorthodox eight and even nine-man line, which balked Brown's running plays, and for the first time this fall Kozak was unable to gain. The only option was to pass against this set-up; and Finn actually was passing well, only to have his receivers disappoint again and again. In fact, Brown's

attack netted only 11 yards in the first quarter, as its line failed to power the opposition out of the way. Harvard seemed more at home in the slippery going.

This was not a game to be conceded to the Crimson without a scrap. But those who had seen the team the week before at New Haven knew that the old boost was not in evidence. We failed to profit even when the breaks all seemed to be coming our way (for the only time this season, as it happened), and there was no score to reward a dogged clash of lines in the first half. One of the high spots had been Kozak's 56-yard quick kick that stopped on Harvard's two. Another thrill came as Brown strung a few first downs together and moved deep into Crimson provinces. Gannon, however, intercepted a pass on the 16. (He ran 84 yards only to be reminded that he had put his knee to the turf right after catching the ball.) On another occasion Brown reached the Harvard 25. In the third period, too, Brown approached glory but missed a field goal from the 15.

When Jawn engineered a touchdown in the third quarter on those reverses that always seem to work for Harlow against Brown, Brown retaliated. In some measure it was a gift, like an identical play which lost Harvard the Yale game the next Saturday. Brown had moved some 50 yards from the kickoff only to be held on the Harvard 40. Brown would have lost the ball on a fourth-down punt, but for a

roughing-the-kicker penalty which gave Brown 15 yards and a first down. After that break, Finn passed twice to Nelson, George Paterno went 12 yards and then two more for the touchdown.

With the score 7-7, the game might then have gone either way or been a justified tie. Nine minutes later Harvard had pressed to our 27, but here Nelson intercepted a forward on our 10 and might have gone all the way had he not skidded among his blockers at midfield. (Harvard's trained crew of cleat-scraping assistant managers did yeoman work effectively.) At this point anything or nothing might have happened, though Brown seemed set to roll. But Harvard had its chance on a fumble, was held on our 35 and failed on a field goal. Not content to settle for a tie, we moved 24 yards then, only to lose the ball and the ballgame on a pass interception at the Harvard 35. An over-the-shoulder catch by Moffie shortly took the pigskin to the threshold of victory, reached two plays later with less than two minutes remaining.

"Whether we're up or whether we're down, we'll fill up the cup and drink to Brown." This day we were not up. (Statistics? First downs: Harvard 16, Brown 15. Yards gained rushing: Harvard 198, Brown 121. Passes: Brown 12 completed out of 22 for 140 yards, Harvard completed 4 of 16 for 93. Punting averages: Brown 42 yards, Harvard 39.)

Dr. Chambers Dies ◀

▶▶ PROF. ROBERT F. CHAMBERS '09, Chairman of the Chemistry Department of Brown University, died at Jane Brown Hospital Nov. 17, 1947. He had been stricken ill earlier in the afternoon shortly after he had conducted a staff meeting at the University.

A native of Providence, Dr. Chambers had been a member of the faculty since 1915 and head of the Chemistry Department since 1929. He held membership in numerous scientific and learned societies. His home was at 254 Irving Avenue.

Prof. Chambers was born Oct. 8, 1887, a son of William S. and Annie A. (Foster) Chambers. After graduation from Brown, he continued post-graduate study there, receiving the degree of Master of Science in 1910 and that of Doctor of Philosophy in 1912. He was employed as a research chemist at the Pittsfield plant of the General Electric Co. in 1912 and 1913 and studied in Germany the following year.

Named an instructor in Chemistry at Brown in 1915, he became an Assistant Professor the following year and an Associate Professor in 1922. After becoming head of the Chemistry Department he was named Newport Rogers Professor of Chemistry in 1932. He was a member of the Library Committee of the University and had served a number of terms on the Athletic Council and its subcommittees.

Dr. Chambers was a member of the American Chemical Society, a councilor of that Society and a past chairman of the Rhode Island section. He was also a member of the American Association for the Advancement of Science, the American Association of University Professors, of Deutsche Chemische Gesellschaft, the Providence Engineering Society, Sigma Xi, Phi Beta Kappa, and Delta Phi.

An enthusiastic stamp collector, he owned a large stamp collection and had exhibited at stamp shows in New York and elsewhere. He was curator of the Knight Stamp Collection at Brown and was a past president of the Rhode Island Philatelic Society. Prof. Chambers was a member of the board of governors of the Society of Colonial Wars and of the board of governors of the University Club in Providence, and was a member of the Sons of the American Revolution, the Rhode Island Historical Society and the Providence Art Club. He was a Mason.

He married Helen N. Peirson of Pittsfield in 1915. After her death, he married Nettie M. Sumner of Attleboro who survives. He also leaves a daughter, Mrs. William H. Wesson.

The American flag on the campus flew at half mast for him, and his death, a real loss to Brown and his friends, was widely, sincerely mourned. ◀

Health Aspects of Atomic Energy

▶ ROBERT H. ALBISSER '30, Safety Director of Merck & Co., Inc., manufacturing chemist, has been appointed to the health advisory board of the Atomic Energy Commission. He is one of a 10-man group studying the commission's health, accident, and fire protection measures. The safety specialists are engaged in a survey of plants and laboratories at Oak Ridge, Los Alamos, and elsewhere.

Mr. Albisser is chairman of the New Jersey Chapter, American Society of Safety Engineers, and former chairman of the industrial safety division of Eastern Union County's Chamber of Commerce. He is a member of the Manufacturing Chemists' Association's general safety committee and the executive committee of the National Safety Council. ◀

His Old Masters Move Again

▶▶ THE RETURN of the San Diego municipal art gallery to its permanent home in the Fine Arts Gallery Building in Balboa Park this month is an event which Reginald Poland '14 has awaited impatiently. "I don't suppose there is another Gallery in the United States which has had to move, and move everything twice, since Pearl Harbor. Now we make a third move back to our own building in the Park," Mr. Poland said recently.

The Navy, which dominates the San Diego scene, used the Balboa Park Gallery for hospital purposes from the Spring of 1943 to December, 1945. The Park, including the Fine Arts Gallery Building, has been restored following the payment of the necessary costs. During the war selections from the treasures of the Gallery have been on exhibition, with special shows and art classes, at the temporary gallery on Sunset Blvd., where the editor had the opportunity to visit last summer.

The permanent collection is a tribute to Mr. Poland, son of Brown's famous Prof. William Carey Poland '68, who has been its Director for more than 20 years. Many regard it as the finest all-around art collection on the West Coast, including Old Masters, Asiatic arts and contemporary arts, with emphasis on the American. There are more than 100 important paintings by the Old Masters, for which a catalogue is shortly to appear (with 11 color facsimiles). As an instance, Venetian painting is represented by more than a score of examples, from the 14th century to around 1800. From a collection valued at not more than \$50,000 in January, 1926, acquisitions have built its value to an estimate of more than \$2,250,000.

The Fine Arts Gallery building is in the Spanish renaissance, 16th Century style. It was given to the city by Mr. and Mrs. Appleton S. Bridges and opened Feb. 28, 1926. Mr. Poland, who had gone to San Diego as Director of the Gallery shortly prior to that event, has continued in office since.

Host to the First Symposium

▶ "YOU CAN CALL IT 'another Brown first,'" said the Professor, who called our attention to accounts of the first annual Symposium in Applied Mathematics, held on the campus last summer under the auspices of the American Mathematical Society. An article in the Society's *Bulletin*, attesting to the quality of the meetings and the University's hospitality to 265 men and women of science, appeared earlier in the fall and is now distributed in reprint.

The allocation of the Symposium to Brown was partly a recognition of the University's leadership in promoting Applied Mathematics in this country, many felt. Co-sponsors were the American Institute of Physics, the American Society of Mechanical Engineers, and the Institute of Aeronautical Sciences, in co-operation with the Brown Graduate Division of Applied Mathematics. The subject which dominated the three days was "Non-linear problems in mechanics of continua."

The roster of those who attended read like a "Who's Who" of scholarship in the field. Prof. William Prager, Secretary of the A.M.S. Committee on Applied Mathematics, was secretary of the symposium, in charge of arrangements, and contributed a paper. Other members of the Brown Faculty took a further active part in the program, including Dean Samuel T. Arnold, Prof. G. F. Carrier, and Prof. C. C. Lin. On the social side, the participants and their wives were pleasantly entertained on College Hill and at Rhode Island summer resorts. But it was essentially a scientific event of precedent-setting importance, and incidentally a high compliment to Brown. ◀

Alumni Headliners ◀

The Building Bears His Name

▶▶ A DISTINGUISHED BROWN GRADUATE in the Class of 1901 has been honored by the recent designation of the student health center at the University of Washington in Seattle as the David C. Hall Building. He has been at that University since 1908 as Professor of Hygiene and University Health Officer, with interruptions for war service and for research. (See photo on page 15.)

One of Brown's most celebrated track athletes, Dr. Hall was also middleweight boxing and wrestling champion, novice fencing champion, and captain of the track squad. He went to Paris in 1904 as a member of the American Olympic team. He coached track at Washington for several years with marked success, in addition to his other duties.

After graduation from Brown, Dr. Hall took his advanced studies in Chicago, with degrees at the University in 1903 and at the Rush Medical College in 1907. A year of practice in Oklahoma preceded his departure to the West Coast. There he made a number of scientific inquiries into goitre, with widespread preventive work in the schools through the prophylactic use of iodine. He is today also regarded as an authority on chest and lung diseases. He served the Board of Basic Science Medical Examiners as chairman and the King County Medical Society as President.

During World War I, Dr. Hall organized the ambulance unit from the University of Washington, was mustered into service, and saw duty in Italy for nearly a year. For his skill in handling the 33 ambulance companies under his command during the last big drive in 1918, he was made a Chevalier of the Italian Order of Saints Maurice and Lazarus at a special ceremony in 1922. He has on occasion represented Brown University at academic ceremonies, including the inauguration of President Spencer of Washington. His fraternities are Kappa Sigma and Sigma Xi.

For Notable Service to Boyhood

▶ THE SILVER ANTELOPE Award, highest within the power of the Boy Scouts of America to confer, was given this fall to Albert E. Lownes '20 of Providence. A former President of the Narragansett Council, he has held a number of national and district posts, including that on the editorial board of *Scouting*. The award, "for distinguished service to boyhood," was presented at the annual regional meeting of the New England District at Swampscott. Mr. Lownes is a Providence textile manufacturer who was once a Scout in the ranks.

The citation read: "Business man, outdoorsman, scholar, author — a man of wide interests and varied talents who is thorough in approach and firm in convictions. Entering Scouting as a Tenderfoot and advancing through the rank of Eagle, he has exemplified the good turn in his services as scoutmaster, President of his local Council, member of several national committees, and a Vice-Chairman of Region One."

Mr. Lownes was in the news again this fall when the South County Museum, of which he is President, received the old steamer fire-fighting pumper T. Jefferson Coolidge, one of the largest ever built in New England. Prof. J. Walter Wilson of Brown's Biology Department recalls it well: "It was a wonderful machine, and we boys carried hose for it in the old days in Manchester. We took turns exercising the horses in the smaller 'coal-carrying' wagons. It was a sort of legend in Manchester."

A New Book by Alexander Meiklejohn

▶ DR. ALEXANDER MEIKLEJOHN '93, a campus visitor in November, has just completed a new book, "Free Speech and Justice Holmes." With such a subject and such an author, the work will need little further recommendation when it reaches the bookstalls.

Returning to his home at 1525 Laloma Ave., Berkeley, Calif., the former Brown Dean was to give the Howison Lecture at the University of California on Nov. 21 (the University's annual philosophical lecture) on the subject "Inclinations and Obligations." While in the East he lectured at Dartmouth, Yale Law School, St. John's, and the University of Chicago. At Hanover, where he once taught, he was the first visiting speaker in the section of the much-publicized "Great Issues" course devoted to Modern Man's Political Loyalties. On Oct. 20 he spoke on "Government by Consent vs. Government without Consent" and led a discussion the following day.

Dr. Meiklejohn expects to return to Brown next June for the 55th reunion of his Class.

▶ WHEN THE STATE of Rhode Island reorganized its Division of Aeronautics this fall, Robert M. Howard '30 was named manager of the Hillsgrove Airport. He had been serving as air transportation manager of the Rhode Island Port Authority and will continue to do consulting work for the Authority on his own time.

During his two years as air transportation manager, Mr. Howard led the fight for more air service for Rhode Island, in hearings before the Civil Aeronautics Board. He also took the lead in proposing before the New England Council that it organize a campaign to promote regional air line service. He has actively promoted the use of air service by Rhode Island industry.

Hillsgrove, one of the largest in the East, is the principal airport for Providence.

New England's Outstanding Amateur

▶ BOB BENNETT '48, National champion in hammer and weight throwing, was nominated this fall for the Sullivan Award, which goes annually to the person voted the outstanding amateur athlete in the country. Bennett, who starred on the Brown track team last spring, was the regional nominee from New England, having been selected by the New England Association A.A.U. as the champion of champions in that area.

Build the Balance, When? ◀ ◀

►► BUILD JUST AS SOON as finances permit and good plans are ready. That was President Wriston's recommendation to the Corporation of Brown University when that body met for its autumn meeting this year. As background for his urging, he pointed to Andrews Hall, new Pembroke College dormitory, and Whitehall, classroom building whose value was demonstrated a year ago and without which the increased enrollment could not have been accommodated. He was therefore an adherent of the group which believes in starting the balance of the building program at the earliest feasible moment.

Three new Trustees took their engagement: Roger T. Clapp '19 and George T. Metcalf '13, both of Providence and nominated as Alumni Trustees in the voting of last June; and John G. Peterson '17 of Minneapolis.

In his report to the Corporation, President Wriston praised the Brown Faculty as "remarkable for its co-operative spirit, the absence of cliques, and its loyalty to the University." The problem of faculty recruitment, of course, had been made enormously difficult because the surge in the size of the University had come at the same time when like surges were hitting all other institutions and when graduate study had been curtailed or suspended. Nevertheless, "members of the Faculty have shown exceptional understanding of our situation."

The size of Brown's student body was abnormal, President Wriston pointed out, primarily because there was such a large Sophomore Class—1200. This year the Senior and Freshmen Classes are of normal proportions, and the glut is temporary. "It is clear that when the present Sophomore Class graduates in 1950, our enrollment will be substantially back to normal."

The condition of the buildings and grounds is better than at any time in his memory, Dr. Wriston said. "This is due to the fact that more money was spent on both grounds and buildings in the past year than in any other year during the past two decades. The expenditures were partly deferred maintenance, for which there were some reserves; partly they involved the use of revenues not urgently needed for balancing the budget and which will not be readily available again."

Dr. and Mrs. Abram Le Grand of 65 Hazel Ave., West Orange, N. ▶ ▶ INTERESTED in inflation?

Tien Chi Chen is an undergraduate at Brown. His father, Dr. Theodore H. E. Chen, was recently Acting President of Fukien Christian University in Foochow, China. He writes in *School and Society* of the "Plight of the Chinese Professor."

Before the war, he notes, a college professor in South China received a monthly salary of \$200 a month, of which 5% went for rice. By October, 1946, 30% of his salary of \$250,000 went for rice alone. In June of this year his salary went to \$1,000,000 a month, but 46% was spent on rice. Even if he could afford to devote all his income to food, he would not be able to eat as well as he did before the war. He notes the effect on health, and the obvious temptation to take on more than one job at a time. He knows of one professor who teaches full time at three colleges and at two on a part-time basis, for a total of some 45 classes a week.

Dr. Chen is particularly concerned with the deterioration of scholarship which must result from such a situation. No one can afford books, private study, or sabbaticals.

Back on the Ice

► ► HOCKEY RETURNED to Brown this winter, and the players had several weeks of work and a few practice games under their belts as the season opened against Harvard Dec. 4. They face a man-sized schedule in meeting Harvard twice, Yale twice and Princeton, Dartmouth, Army, Colby, and others. That would be rugged competition in any year but especially ambitious for a sport resumed after a 10-year lapse.

In the preliminaries, the combined Varsity and Freshman squads had fared well. In fact, Coach W. E. S. Moulton is quoted as saying, "If we could use our Freshmen,

we might not do too badly." It is depth which bothers the coach, for he feels his first team will acquit itself well. "We'll have replacement troubles. We'll be out-manned five or six good players in about every game, and in modern hockey, the fastest of all sports, that isn't so good."

The nucleus of the Varsity team this year will be found in the group of players who competed for the Providence Clippers last season, an informal team made up of Brown undergraduates without official recognition and actually denied the use of the College name even in a creditable battle against Dartmouth. These are Bob Davidson and Walt Walworth, centers; Fred Nelson, Larry Copeland, Ed Vincent, and Larry Shepard, wings; Charlie Bryant, Charlie D'Ewart, and Ned Dewey, defensemen; and Larry Groth, goalie. Newcomers who break into the picture are Charlie DeLaittre, goalie from Minneapolis who will probably be first-string; Bob Rinfret, an able, big defender from Melrose, Mass., who sweep-checks well; Joe Pridmore, another defenseman from Wakefield, Mass.; George Ball, a center who reported after the soccer season along with Groth; John Kimball, a goalie who played at Andover; and Warren Howard, former Hope High goalie. The brightest prospect for the revival year has been lost to Brown for this season inasmuch as Chuck Johnson is taking his Junior year at the University of Stockholm.

Drills have been held at the Rhode Island Auditorium, where home games will be played. The ice there is subject to many demands for the use of the Rhode Island Red professionals, schoolboy teams, and amateur groups, so that there is a limitation on the amount of practice and skating the squad has been able to get. With cold weather, however, the outdoor rink just north of the Marvel Gym will again be in use, considerably improved over last year. A gift from the Providence Brown Club made this available to the team.

Early in the season the Freshmen beat

Basketball Prospects

▶▶ IF BOB MORRIS were easily discouraged, he would not have looked forward to the 1947-48 basketball season at Brown, his first as Varsity coach on College Hill. His best prospect declared ineligible, he had not too much inheritance from last year to build upon. "We're really a year away from any strength," he says, "but we'll win more than most people expect. I've never seen a bunch of fellows more willing to work or more eager to learn. Because of those factors, we've made a lot of progress."

Behind him Morris has nearly 20 years of success with schoolboy teams in Pawtucket and a good season as coach of the Providence professional entry in the Basketball Association of America. He needs his optimism, for his schedule is a toughie, opening against Harvard Dec. 6 and featuring a Mid-Western tour during Christmas vacation.

The most talented performer on the Brown Varsity in the second semester last year was Moe Mahoney, who was brilliant as pivot and playmaker in the great victories over Rhode Island State and Providence. But his skills don't qualify him for a basketball uniform this term, and he'll be missed.

In November, before the football season had quite expired, Morris seemed to have concluded that he had two regulars and three wide open jobs. The regulars are Ernie Corner, former All-New England star while a schoolboy in Pawtucket, and Jimmy Cooney of Cranston, holdovers from 1946-47. Others on the squad who played more or less last year are Dutch Schultz and Jim Tyrrell, both pre-war lettermen, Jack Lynch, Bob Muste, who began his basketball at Wesleyan, Bob Smith, and Bill Falk. Smith, who has shed 18 pounds of the weight which handicapped him last winter, is making a determined bid for a berth. Lynch, who saw little service a year ago, is improving fast.

No ball-of-fire was the Freshman quintet last season, and yet some of its operatives should be useful in Varsity ranks, including George Sotiropoulos, who has speed and marksmanship—both qualities in which the squad is not outstanding. Other second-year men are Harvey Lapiques, Harry Lane, Bruce Senior, Tom McCleary, Ben Patrick, Dave Reid, and George Tyrrell. Among the taller players are Al Kovachik, six feet two, Patrick, Muste, Smith, and a late-comer Ken Provost, who finished his Jayvee football in November and reported to Morris. George Jones is another new recruit.

The football men will have a long way to go to catch up with the court squad which has been practicing since October. But they include a number who reported for duty last year: Paul Flick, Joe Paterno, Vin D'Angelo. Among other conditioning chores, they must familiarize themselves with a brand new system.

Ordinarily, a coach would still be wondering what he could do without a star of such ability as Carl Paulson, national intercollegiate breaststroke champion. But men do graduate, as is their intention on coming to College. Fortunately, in this case, Watmough has another swimmer groomed to take Paulson's place in the line-up—Milt Brier, who was a national champion as a schoolboy and undefeated as a Freshman.

In the sprints, there are again such reliables as Ralph Gossler and Jim Phelan. The entries in the 220 and 440 are improved, Wilson, a Sophomore having sliced off nearly two minutes from his time, and Bob Pendleton also shaping up better. Jack Avery, Bob Vivian, and Alex Hindmarsh are also pushing for a place, accord-

ing to the *Herald* man who has been covering workouts. Backstrokers include Pattrell, Holiday, and Sobolewski, of last year's squad, and a Sophomore John Welchli, who took many yearling points.

A year ago the team had no diver for most of its meets, but there are four this year: Val Gates and Jerry O'Donnell, who performed for the Freshmen; and Harry Brown and Earl Shaw. They have yet to prove their mettle in competition. Gerry Sanford and Ivan Laric, breaststrokers, are other hopefuls.

All-in-all, there appears to be balance and depth for a season against MIT, Tufts, Yale, Harvard, Williams (at home, Jan. 17), Dartmouth, Connecticut (at home, Feb. 21), Army, and the championships.

▶ WITH AN OCTOBER START, the wrestlers were much farther advanced this year for their second season in the mat revival on College Hill under Ralph Anderton's coaching. Three of last year's lettermen are back, augmented by several likely grapplers who wore Freshman uniforms in 1946-47.

RUTGERS 27, BROWN 20

► HARVEY HARMAN brought Rutgers' best gridiron team to Providence for the Thanksgiving Day fixture, but the Scarlet came closer to defeat than at any time since the opening game with Columbia. It was a clean, bruising collision which saw more Brunonians injured than in the rest of the season, with consequent loss of effectiveness as the minutes wore away. Even so, the Bear, by matching courage and wiles against speed and strength, nearly brought off a coup. It was a good ball game in any man's league, with credit enough for two fine elevens.

Brown didn't seem to appreciate that it was playing an overwhelming favorite. It took a first-period lead by returning the ball 95 yards on seven plays. The seventh was a sparkling 51-yard run by Kozak, with the Rutgers line faked out of position and the back racing brilliantly after hitting the secondary. But it was his last chance of the day, for his arm was hurt early in the second period, and he was sent in thereafter only to punt, which he did brilliantly on all but one occasion.

The men from New Jersey had their poise again in the second period, when they built up an adequate lead with three touchdowns, one a 75-yard explosion through the line by Hering, and another by a passing combination of Burns to Hatchett which looked invincible. The first opportunity came on a freak play when a Finn pass from midfield was tipped into the hands of a second Rutgers defender. Despite a Kozak punt which forced them back to their eighty-yard line, the visitors broke loose again after the score had been tied. Then a Brown fumble on the Rutgers 45 reversed the direction of another promising march, and it was shortly 20-7.

But the second half was Brown's, and with more heavily weighted fortune might have provided a sensational upset as the Brown reserves had their chance. In the line the Bruins had suffered the loss of Iacuele, Hodosh, and DeAngelis by now (Rougvie was also out), and Gresh and Nelson were also lost to the backfield. (Nelson's concussion left him unconscious until 30 minutes after the game, but he recovered enough to eat his turkey in Andrews House later with his schoolboy friend, Rossides of Columbia.)

The first score of the second half followed a fumble recovery and a 44-yard advance. Finn was handing off beautifully to Green most of the way on a confusing series of traps, and crossbucks. Houston, up from the Jayvees earlier in the year, scored the touchdown. With the score 20-14, it seemed the time to gamble. A forward pass from behind the goal-line seemed beautifully set up with a receiver and blocker waiting, but Malekoff intercepted for Rutgers, and the daring move backfired on our 15. Had it succeeded, it would have been superb; instead it was Rutgers 27, Brown 14. The issue was still not decided, even so, for the Bear received the kickoff on the six and took six plays to go the rest of the way, scoring on a picture-play pass from Joe Paterno to Don Campbell. There was still time for another touchdown, and the Brown stands roared approval as an official ruled a pass interference by Rutgers deep in her territory. But there was another call, back where the

The Spirit at Brown

► VIC WALL of the Springfield Union had a fine column on Brown football and the Yale series, particularly, on the eve of that upset in the Bowl on Nov. 8. He recalled many of the Brown heroes of past encounters, including Pollard, Mayhew, Regnier, Sprackling, Randall, and Smith as well as the whole Iron line-up.

"Should Brown spring the unexpected tomorrow," he wrote in *All Angles*, "there wouldn't be too many eye-brows lifted because Brown has done it before. In the whole brilliant history of Brown football, against Yale and other teams, Brown teams have displayed a tendency to come back 'when most everyone was willing to count them out.' They have spirit at Brown." ◀

play started, and Brown was adjudged guilty of illegal interference instead. It was the coup de grace.

Brown had 14 first downs to Rutgers' 10, outrushed the enemy 272 yards to 214; but Rutgers completed five of 11 passes for 110 yards, while Brown's two out of 10 meant only 37 yards, although one forward was a touchdown play.

Split in Soccer

► IN THEIR FIRST SEASON under Coach Joe Kennaway, famed goal-tending internationalist, the Brown soccer team posted a 50-50 average for the second year in a row. The victories were over WPI, Clark, and MIT, while defeats came at the hands (or toes?) of Yale, Harvard, and Connecticut, Tufts being tied.

Johnny Swanton, who followed the team for the *Herald*, speaks of a strong defense and a lack of scoring power up front. On the attack the Brunonians tallied 13 goals in seven games, seven of them by Gray Michael, a converted goalie, who had a hat-trick triple against MIT. Al Bellows accounted for three of the other six goals.

Backfield honors for the season go to Jack Schaller, captain and center halfback, Herb Wieboldt, right halfback, and Rod Scheffer, goal-tender. Wieboldt was a veteran of the 1945 team which lost only to Yale. Schaller graduates after two fine seasons. Swanton commented: "With early practice next year, the Bruins should be able to field a stronger passing team when the squad depth will be considerably increased by the addition of this year's highly commendable Freshmen."

Let Swanton introduce the subject of the Yale game: "Despite the support of their avid soccer followers (a handful of relatives, two bus drivers, a Yale-Cornell banner vendor, and a group of boys listening to the Yankee-Dodger game on portable radios), the Brown Varsity booters succumbed to the more masterful play of the Eli kickers, 2-1." Yale scored in the first two minutes and was in offensive possession of the ball most of the day. The winning score came in the third period, with Brown's score coming on a boot by Jim Leach which Ed Ross headed into the nets in the last quarter. Scheffer's brilliant work in goal enabled the Bear to make a game of it, even against a Yale club which

boasted seven lettermen from last year and the 1945 All-American from Paris, Fran Brice.

Against Tufts, Brown had the decided edge but could score only once—when Al Bellows tallied with three seconds left in the second period. Tufts tied the score when the Brown fullback miskicked 15 seconds from the end and sent the ball into his own nets, spoiling the shutout which the defense would otherwise have earned with ease. Ross was lost to the team after this game, because of scholastic pressure. Three goals in the first 10 minutes of the WPI game settled that issue, the final score being 4-1 in Brown's favor. Connecticut kept its victory streak intact, although Brown jumped into an early lead. But the Uconn attack, never before this season held to less than five goals, kept hammering away and won a 2-1 edge. Clark sustained its fourth shutout, 2-0, in a sluggish game that saw many scoring opportunities missed by the Brown men, but Wieboldt provided enough tallies to win. Harvard's 3-0 victory was more one-sided than the score indicated, and Scheffer had to make more stops than he had made all season. But MIT, which had held Harvard to a 2-1 margin, was beaten to end the year on a bright note.

The Freshmen, too, produced a star goalie in Herst, but there was punch on the attack to balance. They showed promise even in defeat against Yale, 2-0, beat New Bedford, Tabor, and Bradford-Durfee with the loss of a single goal in the three games, nosed out Nichols Jr. College, 2-1, and lost a heart-breaker to Harvard 1-0. The Cubs had dominated the latter game and even had a shot bounce off the crossbar without being able to break into the scoring on a muddy field.

Cubs Defeated But Once

► A VICTORY over Harvard would have given the Freshman football team an undefeated, untied season, the first in Brown gridiron history. But a slippery field at Cambridge was the scene of the Cubs' only downfall this fall, a closer battle than the 20-6 score would have led you to believe. The other scores: Brown 32, Leicester Junior College 7. Brown 34, R. I. State 13. Brown 26, Andover 0. Brown 7, Holy Cross 0. Brown 6, Yale 3. The totals: Brown 111, Opponents 43.

A big, fast, and alert line gave the backs every opportunity under the Engle Wing-T, which Coaches Arnie Soloway and Ernie Savignano employed. Nine linemen hit the 200-pound mark, 13 of them more than 190, 16 are over six feet tall. The backfield performance was the more creditable in that three of the four starting backs had played little high school football and needed seasoning. According to one informant, not many of the Freshmen will make the transition to the Varsity in one easy hop next autumn, but look for them in 1949 and 1950, particularly if Jayvee football is given the same emphasis and morale again next year for such prepping.

It took a long time for the Freshmen to beat the Holy Cross Freshmen at Worcester Nov. 3, but an 83-yard drive paid off in the final seconds when Leon Beaulieu, 200-pound fullback from Exeter, drove over for the game's only touchdown from the one-foot line.

The Freshmen had threatened at the outset by moving to the Crusader 22 after the opening kickoff, and HC efforts in the third quarter were checked by pass interceptions on the Brown 32 and 15. Otherwise, until the winning march, the game

had been a deadlocked affair. Over all, Brown made 11 first downs to Holy Cross's 6, outgained the Crusaders 105 to 60 yards on the ground and 120 to 65 in the air.

Walt Pastuszak, formerly of Wilbraham Academy, completed three important passes for Brown to his former schoolboy teammate, Franklin Powers, and to Bill Altieri, once of Mt. Hermon. Lenker, another Mt. Hermon product, supplemented the air attack with accurate tosses to Ken Rich, from Chicago's New Trier High, and Gil Borjeson, from Worcester North High. Don Teel, once of Tilton School, Bill Savoye, once of New Jersey's Westfield High, and Dennis Sullivan, once of Western Reserve Academy in Cleveland, were ground-gainers with Beaulieu. On defense, the standouts were Lloyd Hill, a Brockton boy who prepped at Wilbraham, Herb DeSimone, from LaSalle of Providence, Powers, and Ray McInnis from Brewster Academy.

The Yale Freshmen were leading 3-0 as the result of a first period field goal when Pastuszak pitched to Florio for a 48-yard touchdown play in the second quarter. The second half was fairly even except for two Brown marches which faltered on the Eli 18 and 25 respectively. The Cubs built up a 12-6 margin in first downs and outgained their foes 225 yards to 120 on rushes. It was no day for passing, but the winning play couldn't have been improved upon in the sunshine. Yale's score came after a fumble on the opening kickoff, but the New Haven eleven didn't threaten again seriously.

The Freshmen had slogged along on even terms at Cambridge and was marching into Harvard territory when a fumble gave the ball to the Crimson on its 39. The 61-yard advance which followed to the Bear Cub goal line was the only score of the first half. After a scoreless third quarter a Harvard pass interception and a 15-yard penalty brought the ball to the Brown five-yard line, and the second touchdown followed. The Cubs retaliated with two post-kickoff passes by Pastuszak, the first for 12 to Savoye, the second for the remaining 50 yards to Altieri; but, after Brown failed to convert, Harvard came back with a sustained touchdown offensive of 85 yards and the 20-6 clincher.

Jayvee Football

▶ THE JUNIOR VARSITY football eleven wound up a gallant season with a 14-13 heartbreaker against Harvard. The Crimson took advantage of nine fumbles, including one on the one-yard line, to set up its two touchdowns. Otherwise the statistical advantage was all in Brown's favor, and the Jayvees came within a hair of tying the game. In two other November contests, Brown beat Leicester Junior College 33-0 and lost to the claimants of the New England prep school title, undefeated Romford Prep, 20-6. Earlier scores reported: Brown 13, R. I. Freshmen 13. Brown 26, Tufts 20. Yale 47, Brown 13.

It's the Jayvee's lot to spend most of his time scrimmaging the Varsity, running through plays of future Varsity opponents, and not often looking out for his own interests. A ragged offense is bound to be a consequence, and team play also suffers as men are promoted to the Varsity for promising work. But Coach Joe McMullen built up high morale, and no team ever fought harder for less glory. The best back was easily Ned Dewey, a consistent, battling type of plugger on offense and de-

fense. Hebden and Driscoll also showed flashes of power and speed, with long break-away runs to their credit. Don Stobel quarterbacked the team and did most of the passing after Powell was hurt. Armstrong, Kako, and Provost were work-horses in the line, while Roth and Crooks may move up as ends another year.

Return of the Harriers

▶ CROSS-COUNTRY was restored to the Brown sports curriculum this fall, not with any expectation of any summa cum laude team performance but wholly in the interests of conditioning for a miscellany of track men who will have business this winter and next spring. Coach Ivan Fuqua felt the modest schedule was well worth while, although the Varsity was defeated by

Rhode Island, Connecticut, and New Hampshire.

Two solid runners carried the burden for Brown—the Tobey twins. Josh took third against State and set a new course record at Storrs, topping all this off with a good sixth in the New England Intercollegiates. Jonathan was 13th in that championship field, where Crimmin, Thompson, and Walsh contributed to the 217 points that took 10th place.

The Freshmen took a creditable fifth in the New England's with 129 points by Joel Tobey, a third Barrington brother, Roy Bailey, Garry Lotz, Dave Whitson, and Randy Dunbar. A dual meet was dropped to Rhody, but by a far closer score than in the Varsity encounter.

Too much credit cannot be given our Executive Secretary, Mrs. Gertrude Allen MacConnell, for her selfless co-operation. We are proud that our college produced so many self-sacrificing graduates to know the joy of giving.

"Our gratitude to Miss Morriss for her zeal and vision in this effort cannot be measured. She saw the need and courageously set out to meet it. We are not only grateful to her, we are grateful for her, for her leadership through these last 25 years.
