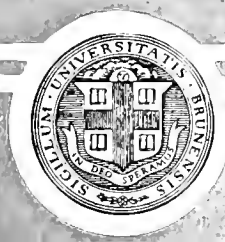

For Further Study

►► THE EXPERIMENT seems to be a popular one. We've already had a good response to our publication in the last issue of two reading lists "for further study," and the feature will continue. Members of the Brown University Faculty have made selections in their fields of books which will be helpful to alumni who wish to carry on or resume a serious interest developed in college. This recommended reading will include new books and others of continuing value, compiled under the general direction of Prof. I. J. Kapstein '25, of our own Board of Editors.

We have been pleased at the reception of the project not only by Brown men but by others. The Brown News Bureau sent our first lists to a selected list of libraries, where in many instances they have been posted as recommendations from our Faculty. The John Hay Library each month will set aside the books named, and the University Bookstore also plans exhibits and will assist in the purchase of the works.

We renew our invitation to tell us of what lists you want. This month the selections are in Music and Biology:

BIOLOGY

- *What Is Life?* Erwin Schrödinger; Macmillan, 1946. A discussion from the point of view of modern science. Not easy reading, but well worth a try.
- Human Destiny.* P. LeCompte DeNöuy; Longman, Green, 1947. A scientist tries his hand at speculation.
- Insects and Human Welfare.* C. T. Brues; Harvard University Press, 1947. Highly readable; man versus his greatest competition.
- Picturing Miracles of Plant and Animal Life.* A. C. Pillsbury; Lippincott, 1937. Entertaining guide-book for the amateur photographer, with striking pictures.
- Black Widow: America's Most Poisonous Spider.* R. W. Thorp and W. D. Woodson; University of North Carolina Press. Vivid, popular natural history.
- Beneath the Surface: The Cycle of River Life.* Towner Coston, Harry Ernest; Scribner's 1938. Plants and animals of fresh-water life; written from the point of view of both the scientist and the sportsman.
- Ourselves Unborn: An Embryologist's Essay on Man.* G. W. Corner, Yale University Press, 1944. Well-written discussion of man's pre-natal life.
- Naturalist at Large.* T. Barbour; Little, Brown, 1943. Autobiographical account by one of America's great naturalists.

MUSIC

- *Koussevitzky.* Moses Smith; Allen, Towne & Smith, 1946. Dr. Koussevitzky went to court and got an injunction against this book. Now on the counters again, it appears to be the closest to an objective treatment of a glamorous life and career available to us.
- Adventures of a Ballad-Hunter.* John A. Lomax; Macmillan, 1947. America's most famous discoverer of the songs of the people (100,000 now on records in the Library of Congress, where Duncan Emrich '32 is Chief of the Archive of American Song) writes of his travels and experiences.

Hearing Music: The Art of Active Listening. Theodore M. Finney; Harcourt, Brace, 1941. There are a number of books on music for the beginning listener to concert music. This one is based on the experience of a recognized college teacher who does not avoid the problems in training the ear but states that "it is a mistake to make the beginner feel that his ignorance of the technical vocabulary of music is a handicap." Many compositions are discussed thoroughly and entertainingly.

Music in Western Civilization. Paul H. Lang; W. W. Norton, 1941. Extensive, as is the subject, but brilliantly written and arranged. Art, Literature, and Politics are handled with the same ease as Music. Single chapters can be enjoyed as separate essays.

Florestan: The Life and Work of Robert Schumann. Robert Haven Schauflier; Henry Holt, 1945. Schumann is now the subject of a major Hollywood film. The music fares well in it, but those interested in the life and career might better read Schauflier, who is a generally trustworthy enthusiast.

Mozart, His Character, His Work. Alfred Einstein; Oxford Press, 1945. Alfred

Einstein is one of the most distinguished musical scholars of our time. He has written about Mozart the Man and the Musician and devoted chapters to the various types of composition—the Symphonies, the Piano Concerti, the Operas, Divertimenti, and so on. Not often does one encounter such a balance of fact, complete understanding and literary felicity.

Our New Music. Aaron Copland; Whittlessey House, 1941. Sometimes composers are not adept writers and speakers. But

TRANSFERS FROM THE VETERANS COLLEGE. 194 men were welcomed to the regular undergraduate College (and one woman to Pembroke) when the second semester started in February. The largest group thus shifted since the Veterans College came into existence in September, 1946, the men had earned their right to transfer on their academic record. In all, 467 students have been shifted on the basis of quality grades and accumulated academic credit since the first group a year ago.

The Veterans College has attracted wide attention in higher education circles as an experiment designed to give veterans who lack the usual entrance credits a chance to prove they can handle work of college level. Newly admitted this term to the Veterans College are 81 more men.

A Fannee House reception to the February transfers provided not only a welcome but orientation at the opening of the term. Pictured informally during the evening were: James A. Cunningham, Jr., Director of the Veterans College; Gustav R. Johnson '51, John Ladd Smith '50, and Vice-President Bruce M. Bigelow, principal speaker of the evening.

▶ ▶ A Story of Brown in Three Tenses

▶ ▶ THE BIGGEST and, many feel, the best reunion apart from Commencement is the annual dinner of Brown alumni of New York and New Jersey. For 80 years these evenings have brought together their legions of Brunonians to visit with old friends and to hear the news from College Hill. It is a heart-pleasing tradition, which the 1948 dinner on March 18 at the Hotel Pennsylvania in New York City further enhanced. It was notable, too, that so many of the recent college generations were on hand, as well as the elders of whom Judge N. S. Dike '85 was senior.

The program at the head table had been interestingly contrived so that the three principals dealt in three tenses: Vice-President Bruce M. Bigelow '24 dealt engagingly with "Brown Yesterday." Dr. Robert W. Kenny '25, Dean of the College, provided an amusing survey of "Brown Today" with the point and pungency he employs. In speaking of "Brown Tomorrow," President Henry M. Wriston first set the stage of the educational world, with particular controverting reference to the findings of the President's Commission on Higher Education ("the Zook Report"). It was a brief, searching analysis of the liberal arts college in the light of its challenges. The amenities at the head table were dealt with by H. Linus Travers '27 of Boston, Vice-President of the Yankee Network, a toastmaster who practices his art with wit, grace, and control. The program was opened by Robert C. Litchfield '23, President of the Brown University Club in New York.

▶ THE HISTORIAN in Dr. Bigelow was happily employed for his talk of "Brown Yesterday," and he turned to three great figures from the chronicle of Brown: the first President, the first member of the Faculty, and one of the first students, Dr. Samuel Drowne whose diary has lately come to the University. It was full of human interest and humor. He also had a striking survey of college costs from Colonial days to the present:

"Records show that even in Colonial days, the Brown student was always having his financial troubles in spite of what appeared to be unbelievably low rates," he said. "Before the Revolution tuition was \$12 a year and room rent \$5 a year. Board in Commons was \$1 a week. Incidentally, the room then used for Commons is now the office of the Dean of the University.

"Parenthetically, I may say that wars have always worked a hardship on colleges and college students, and the history of Brown demonstrates this in a most striking way. Every major war has brought about the necessity of a rise in tuition fees. Before the Revolution tuition was \$12 a year, and after the Revolution it was changed to \$16, a rise of 33⅓%. Before the Civil War the annual tuition fee was \$36. During the war it was forced up to \$50, five years after the war it went up to \$75 and in seven more years to \$100." In conclusion Dr. Bigelow noted that "just prior to World War I tuition was \$175. It was up to \$200 in 1919 and then came a rise of \$50 every other year—from \$200 to \$250 to \$300 to \$350 in 1925. This was just double the tuition charge of 1917. At present it is \$500 for the same basic

service offered in Colonial days. No one dares predict the future."

▶ TOASTMASTER TRAVERS countered with some cost figures of his own. When University Hall was built, he said, it cost only \$9340, with the President's House thrown in. There was also the expense of good West Indian rum at 85c a gallon, for the workmen whenever a floor was completed. "Progress," he quoted from the record, "was much more rapid than had been expected."

Travers felt he should make reference to athletics, not wishing to break any precedents. He wanted seriously to concur with the sentiment of the Chicago columnist who found that "in these days when football coaches jump from college to college as though on pogo sticks, it was refreshing to have the Brown Coach visit Yale, discuss matters, and yet decide to be consistent with the tradition of loyalty at Brown and remain there." This compliment to Rip Engle drew warm applause.

"Brown," said Dean Kenny, "is not the college you knew, you like, or we desire." It was too big, but by 1951 it would be just under 2000, he predicted. Of course, it was difficult to anticipate the effect of U.M.T. on the college population of the country. This year 71% of the undergraduates (2150) were veterans, while there had been 80% veterans last year; the non-veterans were mostly in the Freshman Class.

Most recent of all happenings had been the end of the annual "tong war." The Hip Sings and the On Leongs had all pledged their delegations. He felt that, in main, they had picked a more serious, scholarly type of boy. One house had pledged a delegation of Freshmen whose academic standing at the moment was a full grade higher than that of the active chapter. He would be interested in seeing which group influenced which from here on. "It isn't actually insisted that the houses be intellectual today," he remarked, wryly, "but it is thought they should not be anti-intellectual."

▶ EVERY GREAT WAR has been followed by reaction, President Wriston told the alumni at the dinner. The vast financial, physical, and moral effort gives way to a disillusionment which is all the keener after the spiritual exaltation attending sacrifice in a great cause. And especially when the victory appears to be futile, frustration over peace is normal, the ordinary experience. Ideals, non-material things are harshly judged. It is so with education. There, too, the cry is to do something.

The five-volume Report of the President's Commission on Education is an attempt to meet this demand. It is conceived in an atmosphere of "crisis," which alone would make it suspect. When danger should evoke prudence, it is instead a surrender to fear. It is dominated by fear—fear of Russia, fear of the atom, and fear of ourselves—and fear makes one frantic. And so, in urging people to "do something," the Report says: "It will help little . . . to have our colleges and universities turn out a generation of impractical visionaries."

A time of crisis, said Dr. Wriston, is never a good time to make long-range plans. Crisis generates a mood which grasps for expedients, ignoring good perspective. And when the sense of crisis approximates panic, the programs are sure to be unwise. Miracles are called for, not education—which is a slow and indirect attack. The call is also for speed—"do it quickly." The Report says that we must "find ways quickly of making the understanding and vision of our most farsighted and sensitive citizens the common possession of all our people." Apparently the deadline is next Tuesday, President Wriston remarked.

Moreover, the Report insists that education act with social purpose: "Teaching and learning must be invested with public purpose." Some people have never read the Brown Charter or other charters, Dr. Wriston surmised. And we must not only do something quickly but do it directly: "Effective democratic education," says the Report, "will deal directly with current problems." There is no argument, no evidence, no experience—just pathetic wishfulness.

▶ IT IS LIKE BARNABY'S fairy godfather, Mr. O'Malley, picking up a hammer "to smash the atom," said President Wriston. "Science is wonderful—it says so—but some things it cannot do directly. There is such a thing as a catalyst—a mediator in chemical reactions. So, in setting off the most devious of all reactions, those in the human mind, the whole process of education constitutes an indirect attack on issues. But, with Mr. O'Malley's hammer-technique, legislation asks for more and better State universities and community colleges in Oskaloosa, Penn Yan, and way stations. It is off chasing 'quick, direct, tangible, public results.'"

If we do not follow along with the Report and its panic demands, Dr. Wriston said, we are accused of escaping into an Ivory Tower, "as though that were the only alternative to the Agora." How about the Church, the family, and the field? Don't let us be confused by the false alternatives of semantics, he urged, for the Ivory Tower provides strength. What if the student can be withdrawn there for a moment? His experiences are real. Moreover, some shelter is essential, and a college must shield its students from some storms. The Greek meaning of "school" was "leisure." And in leisure the student cultivates his powers so that he may meet tensions with an alert mind, calm spirit, and a courageous heart. To study, you had better withdraw from Times Square, Fifth Avenue at 42nd St., and the Grand Central.

"The colleges," Dr. Wriston continued, "are the servants of tomorrow, not of today. Liberal education has not been extemporized; it was developed over the centuries. In time of calm, the colleges have prepared for crisis. We suspended much in the period of crisis, but liberal education survives because it was not jerry-built by some commission scared by the atomic bomb or Russia. It is a mature concept, not hasty, not panicky, not transient.

"How did the fruits of education show up in crisis? The colleges met the test. Did we lose the war? Mistakes were made, but the greatest have been made in Moscow—miscalculations against all experience and against all data. Never did society so reorganize as ours with such speed and do so well as in winning the war. We were adaptable, resourceful, imaginative. In time of crisis, the program shaped in calm worked amazingly; the evidence of the Ivory Tower was conspicuous by its absence.

"One cannot make peace after fighting a war. One is out of the mood. And amid new alarms and frustrations, it is no time to make a change in educational philosophy, especially when it has just met the test. Why tear up the structure which has proven itself? The peace is not yet lost; the

worst predictions have not come to pass. We must take strength from the past. We must call up again our intelligence, faith, and courage. We must continue with steadiness and serenity till the storm abates and then, in calm, set our course.

"Brown will meet the new and fiercer public competition. Many forms of education will be legitimate, but from intelligent people will always come the demand for the liberal arts, based on the experience of the past and unchanging human nature. Wisdom dies with each generation, and must be reborn anew. But we build on the great disciplines of the past to make the great decisions of the world for the future."

At the head table, in addition to the speakers, were: Thomas B. Appleget '17, Trustee; Dean Samuel T. Arnold '13, who was greeted with a special warmth, it seemed to us; Dr. W. Randolph Burgess '12, Fellow; Edward J. Gorman '23, General Chairman of the Dinner Committee; Robert O. Loosley, Secretary; C. Douglas Mercer '06, Trustee; Arthur W. Packard '25, Trustee; Dr. Charles C. Tillinghast '06, Trustee. Serving under Gorman were Joseph N. Miceucci '31, in charge of arrangements; Howard F. Weeks '25, in charge of promotion; and William L. Dewart '20, Austin N. Volk '41, and John B. Appelgate '23, attendance.

Is That Song of Yours Ready?

▶ ▶ THE DEADLINE approaches for filing the new Brown songs in competition for \$200 prize money. All entries must be in the Office of the Associated Alumni, Brown University, Providence 12, R. I., by May 1, 1948.

The response to date has been good, according to Prof. Arlan R. Coolidge, chairman of the Alumni Song Committee. But, for the benefit of writers and composers still at work, he asks us to repeat the conditions of the contest, open to any student of Brown University, past or present:

"The text must be original and have special Brown appeal. Words with romantic or historical interest are preferred. The music also must be original, rhythmic, distinctly melodic, suitable for group singing and not necessarily a marching song. Contestants are asked to present a harmonized version of their songs in an arrangement for voice and piano. The composer's name should not appear on the manuscript but should be placed in an accompanying sealed envelope bearing on its face some distinguishing pseudonym. The words 'Song Contest' should appear prominently on the cover."

The results will be made public at the earliest opportunity but not later than Commencement in June of this year. Brown University reserves the rights to control reproduction and first performances of the winning song or songs.

From Lincoln Downs Charity Week

▶ THE BURRILLVILLE Racing Association, which operates Lincoln Downs track, conducted a charity race week last October. Allotments of the \$37,760 proceeds were made in March, including \$5000 to the Providence College Gymnasium Fund, \$1000 for the Brown University Building Fund, and \$500 for the War Memorial Fund of R. I. State College.

▶▶ JOHN T. WINTERICH '12, whose "Another Day, Another Dollar" provided good, sound amusement to many a Brunonian and the public in general, will be a featured speaker at the annual Alumni Dinner June 18, the committee in charge announces. This now well-established "reunion of reunions" is the opening event of the 1948 Commencement Weekend. The engagement of Mr. Winterich is in line with the committee's policy of arranging a program that will be informal and light-hearted.

President Wriston will be the other principal speaker, while the mantle of toastmaster falls congenially on the shoulders of Thomas B. Appleget '17, Vice-President of the Rockefeller Foundation. Mr. Appleget has done the honors gaily on many a Brunonian occasion, most recently as master of ceremonies at the annual dinner of the Brown Engineering Association in New York.

The dinner, as previously noted, will be held this year in the refectory of Andrews Hall, the new Pembroke dormitory, where 600 diners can be accommodated. This restriction on numbers has prompted some early reservations, including blocks for a few of the major reunion classes. The tickets are attractively priced at \$4.00, since some of the expense of other years in the Marvel Gym has been obviated by the move to the new scene.

▶ "ANOTHER DAY, Another Dollar" has served to remind the public of the humor of the versatile man-about-books, John Winterich. It embodies his recollections, as you know, of the various jobs he took and often held as a boy in Providence and as a student at Brown. The idea of writing the book came to him when, at the beginning of his service in World War II, he was confronted by an Army form which called for a "complete" list of his civilian occupations. One memory leading to another, the result was a blithe catalogue of such money-making adventures as house-to-house salesman, meter-reader for the Providence Gas Company, trolley-car conductor for the R. I. Company, census-taker of horses and people, and valued employee of the cleaning room of the Providence Public Market.

Whatever his distinction in the Second World War, it is likely that the first was more fun for John Winterich. He was a member of that talented crew which staffed the original *Stars and Stripes* and took a flyer with the *Home Sector* in 1919 with Winterich as editor. He moved over to become managing editor of the *American Legion Weekly* in 1920 and editor of the *American Legion Magazine*, its successor, in 1926.

The credentials, as you see, are becoming more serious. "A Primer of Book Collecting" showed him in a more scholarly role in 1927, with several other works to follow in the realm of the bibliophile which stress the charm and intoxication of the hobby rather than the pedantry, for all his knowledge of it. He edited *The Colophon* and is an associate editor of *The New Colophon*, continuing to write for the *New Yorker* as a staff member, and the masthead of the *Saturday Review* carries his name as contributing editor. Of late he has thrown himself heart and soul into a Cause as President of the Society for the Retardation of Revolving Doors. In all else, he has been effective.

▶ OTHER HEADLINERS booked for the Reunion of Reunions include Earl P. Perkins '12 at the piano and Earl M. Pearce '17, song-leader. It is likely that a new prize-winning Brown song will be introduced during the evening.

Robert H. Goff '24, Chairman of the committee, has set a record for completing major arrangements early. John W. Moore '16 has accepted the post of Treasurer for dinner committee, and it is not too early to send reservations to him at Room 1124, Industrial Trust Building, Providence. Checks should be made payable to John W. Moore, Treasurer. The committee in charge has been fully constituted with the appointment by Mr. Goff of his aides: John A. Gammons '98, Lewis S. Milner '02, Samuel Temkin '19, W. Chesley Worthington '23, William B. McCormick '23, Paul F. Gleeson '32, William J. Gilbane '33, Foster B. Davis, Jr., '39, William Davis, Superintendent of the Brown Dining Rooms, and Messrs. Pearce and Perkins. Mr. Gleeson is in charge of publicity, Mr. Gilbane in charge of arrangements, and Mr. Moore of tickets.

When Mr. Winterich heard that he was going to be a speaker at the Alumni Dinner, he wrote Chairman Goff a few words of warning: "Don't let the tickets get in the hands of speculators." We, too, think it's going to be a popular evening. ◀

Meiklejohn Lectures in May

▶ DR. ALEXANDER MEIKLEJOHN '93 will return to the Brown campus for a series of three lectures on May 11th, 13th, and 17th. Dean Samuel T. Arnold announced this month. It will be a treat to have this stimulating speaker back on College Hill.

Full details about the lectures, including the designation of the hall and the exact title, remain to be made public. However, it is believed that his thoughts arise from his short book, recently completed, on "Free Speech and Justice Holmes," in which Dr. Meiklejohn discusses critically the Clear and Present Danger theory, "as advocated by Holmes and explained by our good alumnus, Zach Chafee (Prof. Z. Chafee Jr. '07)." Dr. Meiklejohn gave the argument in three lectures at the University of Chicago and at the Yale Law School, but he feels it particularly appropriate to develop his ideas at Brown "not only because it is my own college, but also because the American tradition of Free Speech has its roots in the home of Roger Williams."

"The problems arising out of that tradition," he added in his letter to Dean Arnold accepting the Brown invitation, "are, I think, our most significant question just now." ◀

Agreement for 8 ◀

▶▶ EIGHT MAJOR EASTERN COLLEGES have entered into a compact designed to relieve the successful candidate for admission from the necessity of making a hasty judgment of the educational opportunities open to him. Under the agreement, the prospective freshman will have until June 15, of the year of entrance, to accept admission or financial aid, irrespective of when he receives notification of his admission. The colleges signing the agreement are Brown, Columbia, Cornell, Dartmouth, Harvard, Pennsylvania, Princeton and Yale.

Commenting on the Ivy Group Admission agreement, Dr. Bruce M. Bigelow, Vice-President of Brown University said, "Brown is glad to continue to co-operate with the other colleges of the Ivy Group in regard to admission and scholarship aid policies. Our practice at Brown has been to make the bulk of admission decisions after the applicants have taken the College Board Scholastic Aptitude Test. The majority of the students write this examination in April. Scholarship decisions at Brown are usually made in May after the Board of Admission has made its selections. Brown has not in the past required a deposit when an applicant is accepted for admission or when he is offered scholarship aid; and such a deposit will not be required this year. Heretofore, most students have notified the colleges of their choice before June 15, and they will want to do so in the future. The main point of the agreement is that there is no obligation on the part of the student to do so before that date."

The dates for notifying successful candidates that their applications for admission have been accepted have varied in the past, among the eight colleges, from early April to late May. Under that practice acceptance of admission was required regardless of whether or not the candidate had received the decision of all the colleges to which he had applied for admission.

▶ THE NEW AGREEMENT was drafted at a recent conference of admission and scholarship representatives of the eight institutions held at Princeton, and subsequently was ratified by the individual Admissions and Scholarship Committees. It was announced simultaneously on March 8.

The conference was called because of the considerable divergence in notification dates and procedures which has tended to confuse candidates for admission and, in some instances, has led to unfortunate competitive activity. Most of the conference discussion dealt with admission and scholarship problems. Areas of discussion for future meetings include: use of college entrance board examinations; the criterion for renewal or retention of scholarships, and personnel organizations. It is planned to hold similar meetings annually.

An exchange of information showed that the average economical Freshman budget at these institutions runs from \$1,400 to \$1,600. All the representatives reported a budget inflation of 30 per cent since 1940. The eight institutions use three forms of financial aid in the solution of undergraduate problems: scholarships, loans and employment opportunities. It was found that administrative procedures in this field are at wide variance.

The number of recipients approved for financial aid at the eight institutions ranges from 25 per cent to 35 per cent, and the average budget deficit is in the neighborhood of full tuition. Scholarship awards are available in amounts ranging from \$100 to \$1,400 provided from general and endowed funds. Some institutions reported a system of

long-term loans with a maximum up to \$1,200 for four years. Four of the group reported that their institutions required a fee on acceptance; the others said they simply urged a prompt reply.

▶ THIS AGREEMENT, as finally approved by the different Admissions and Scholarship Committees states: "The institutions listed below have, by common agreement, bound themselves not to require any candidate admitted as a Freshman to give notice before June 15, 1948, of his decision to attend one of these institutions or to accept financial aid from it."

An explanatory paragraph states that the decision was reached in order to give candidates an opportunity to consider all available opportunities without undue pressure. It is emphasized that whenever a student can reach a decision before the June 15 date, he may with propriety notify the institution.

Those attending the conference at Princeton were Dr. Bruce M. Bigelow, Vice-President of Brown University; Nicholas M. The truth is that no one ever had enough education to be a good newspaperman."

Editor & Publisher paid high compliments to Mr. Lister's methods and results. ◀

A Cue from Homer ◀

▶▶ REPORTING to Brown alumni for the first time since he accepted the chairmanship of the Student Housing Board, Arthur B. Homer '17 made a preliminary statement March 27 to describe the present work of the board, its inquiry into the building program, and some early conclusions. In a letter sent to all alumni, he expresses the belief that the second phase of the Housing and Development Campaign will not be undertaken until the autumn of 1948. He therefore urges wide and wholehearted support of the Brown Alumni Fund undertaking for this spring.

"The Student Housing Board and its various Committees," Mr. Homer wrote, "have been working steadily for the last three months in an attempt to reappraise the quadrangle and refectory proposal in terms of the numerous uncertainties that face all construction projects today. The Board is wholly in accord with the objectives originally outlined. We are confident that we will successfully achieve the basic educational purposes, and at the same time maintain a standard of quality which will have lasting influence upon the educational, social, and cultural achievements of the University.

"You will readily appreciate the many complicated decisions which have to be made before we can present a detailed report to the Corporation and the Alumni. We must estimate the future trend of construction costs and come to some conclusions regarding the availability of land. While we have land enough to carry out the original scheme, and enough to make some marked improvements in it, we can do much better if we are successful in our present efforts toward further acquisition. Accordingly, it is worth the time, energy, and skill now being given to this phase of the program. Availability of land is one of our key questions upon which the drawing of plans and the development of sketches and block layouts will depend. Some additional time will be required before we can come to a final conclusion on this matter. Furthermore, we are attempting to accomplish economies, but at the same time obtain a more pleasing and efficient building layout both as to construction and operation.

"We do not think it wise to launch the second phase of the Campaign until we are able to complete the reassessment of this program and express ourselves in detail as to our best estimate on cost, on location, on the amount that can be

financed by loans, and on the remainder which must be procured from contributions from Brown men and friends of the University. As it is unlikely that we shall be in a position to make such a report before Commencement, it has been agreed that *we should not permit this academic year to pass without giving Brown men an opportunity to maintain their regular support of the University.* The Alumni Fund Trustees will therefore be undertaking an annual campaign as heretofore, and Brown men will be asked to give for unrestricted purposes as they have in the past.

"This Alumni Fund Campaign is of utmost importance, and all of us on the Student Housing Board hope that you will respond promptly and generously. It in no way conflicts with the Housing and Development Campaign, which we believe will be reopened in the Fall. The Chairman of the Alumni Fund Trustees is a member of our Campaign Steering Committee, and we have been in the closest touch with officials of the Fund during the last three or four months. In fact, we have hopes that when the Housing and Development Fund is reorganized, the Alumni Fund will play an important part in the Campaign structure.

"In the meantime, I feel sure that you will want to continue or increase your gift through the Alumni Fund, as an expression of your confidence and faith in the future of the College." ◀

Meeting in the Pentagon

▶▶ IT WAS A GREAT MEETING—Carl Sandburg and General Eisenhower: the poet, the biographer, the singer of songs and the man who commanded. And the man who arranged the meeting, Duncan Emrich '32, went along to listen and remember. Emrich was formerly chief American historian at General Eisenhower's SHAEF headquarters in England, France, and Germany; he is now with the Library of Congress as chief of its folklore section. Of the meeting he wrote for the March 20 issue of the *Saturday Review of Literature* a memorable, moving account.

They talked of many things, Emrich reports; of the fact that few American generals failed to measure up to their responsibilities in the war and why; of the book that Eisenhower will some day write—entirely from memory; of his disinterest in the Presidency; of his diffidence in approaching academic duties; of the gamble to commit the American airborne divisions on the Cherbourg peninsula over Leigh-Mallory's alarm; of how an army feels; of the Marshall Plan as simple and obvious; of England's Socialism; of nicknames; of the necessity of being strong and prepared.

And, finally, at Emrich's request, Sandburg went across the room to get his guitar to sing the General a song. He picked "a genuine antique," a song by Dr. Warren, who died at Bunker Hill, of free America and her coming greatness. And the two men shook hands, respecting, friends.

As they left the Pentagon, Sandburg said to Emrich, "Him and Niagara Falls." ◀

National City Creates Office

▶ DR. W. RANDOLPH BURGESS '12 was named Chairman of the Executive Committee March 9 when the National City Bank of New York created the office at a meeting of the Board of the bank. The move followed the death of Gordon S. Rentschler, Chairman of the Board, and the appointment of William Gage Brady, Jr., President of the bank, to succeed him. Howard C. Sheperd, Senior Vice-President, succeeds Mr. Brady as President and Director. Dr. Burgess was Vice-Chairman of the Board.

Dr. Burgess went into banking in 1920, the year he received his Ph.D. from Columbia. He joined the Federal

Reserve Bank of New York as statistician and editor, rose to Deputy Governor, a title that was changed to Vice-President under the Banking Act of 1935. From 1930 to 1938 he was in charge of the open market operations in Government securities and served as executive officer of the System Open Market Committee. He went to National City in 1938 as Vice-Chairman.

Dr. Burgess is also Vice-Chairman of the Board of the National City Safe Deposit Company and the International

Banking Corporation, as well as Director of the City Bank Farmers Trust Company, the Royal Liverpool group of Insurance Companies, and the International Telephone and Telegraph Corp. He was President of the New York State Bankers Association in 1940-1941; President of the American Bankers Association in 1944-1945; and recently a member of the President's Committee on Foreign Aid, the so-called Harriman Committee, which made many of the preliminary studies to E.R.P.

Basketball

▶▶ THE BASKETBALL PICTURE, which which looked pretty grim over most of the season, brightened appreciably toward the end as the Varsity won five of its last eight games. Bob Morris, installing a new system in his first year at Brown, found himself with very little in the way of good material left over from last season. Faithfulness in practice began developing fair floor work, but there was not much height for the critical play off the backboards, and there was no marksman who could hit the basket reliably. The team won its second game—over Worcester Tech 53-51, but it was the only victory in the first 12 encounters, of which a number were dropped by one-sided scores.

Late in the year, however, the Coach's efforts brought reward, when the University of Massachusetts team from Devens, Amherst, Colby, Providence College, and— notably—Rhode Island State were set down. That last game has already been reported—a dramatic upset of a team which had lost only three games in 15 and was expected to provide a tournament entry. It was one of the sweetest triumphs ever, and a capacity crowd in Marvel Gym howled its delight as the Brunonians caught fire.

Ernie Corner, only squad member to play every game, was awarded the Woodie Grimshaw trophy at the end of the schedule, a valiant veteran who kept trying no matter how hard the going—and some of it was pretty tough. High scorer was Ken Provost, who scored 122 points in 17 games, with Corner one point behind. Bob Smith had 119 points in 14 games, 21 of them during his great exhibition in the State contest. Jim Cooney and George Tyrell had 110 and 99 each. Joe Paterno, who moved up to the Varsity after the first half of the campaign, George Jones, Al Kovachik, and Harvey Lapides were the others who played 10 times or more.

Leading the attack during the brilliant season for the Freshmen were Ezra Creswell (229), Dave Thurrott (201), Charley Whelan (167), Bill Hayes (162), and Dave Tillinghast (162), while the principal replacements were Jim Braye, Dave Holmgren, Denny Sullivan, and Al Gauthier, although 19 numerals were awarded because of squad spirit and the fine record.

Hockey

▶ For a sport just re-established at Brown, hockey did as well as could have been expected—even better, for several of the defeats were close ones. The high spot came in triumphing over Yale, 8-7, after an earlier 5-4 loss.

Coach Weckie Moulton's year-long problem was to hold his team at top-speed for a full game without real hockey skill down under his starting line-up. His first string was able to hold its own with nearly all the

season's competition, but the second and third lines were not equal to their job. This meant overworking the starters or risking matters with the reserves, a dilemma for which there was no good solution. His real need was for more boys who can skate. (There are several among the Freshmen.) Several games were lost in the last period.

Moulton led off with Larry Copeland, Fred Nelson, and Bob Davidson, his three high scorers, as forwards, and Bob Rinfret and Charlie D'Ewart and Goalie Warren Howard on defense. Between them the starting forwards accounted for 49 of the team's 115 goals and assists. It was notable that, with one exception, all the men who received letters came from Rhode Island, Massachusetts, and Connecticut. George Menard and Don Rawson, who joined the team in the second semester, further strengthened the team, with Menard packing one of the hardest shots on the squad.

The Freshmen, led by two Canadian stars, lost only to Yale in a nine-game campaign. John Casey scored 20 goals and 12 assists, Anthony Malo 15 goals and 12 assists, while Warren Priestley from Melrose chipped in 18 points. Ray McInnis, who played in four games scored eight goals.

After the regular season was over a Varsity-Freshman combination offered a preview of next year with success against local amateur competition. Hockey has a good foundation on which to base its revival, and the sport had strong student backing in the stands.

Track

▶ TRACK was a matter of individual achievement during the indoor season this winter, but the individuals came through! As a team, the outstanding feat was to gain the N.E.A.A.U. championship in Boston in February, when Dick Phillips won the high jump, Josh Tobey the mile, and Royce Crimmin the 600. Other points were picked up by Henry Barksdale, second in the dash, Jonathan Tobey second in the 1000, Paul Flick second in the shot, Bob Sleicher third in the pole vault, and Jim Bartlett third in the shot. Leeth was fourth in the hurdle after slipping at the start. Bob Bennett, erstwhile Brown performer, was second in the weight throw and gained the National AAU title in the event with a heave of 56 feet 1 inch. He is the ICAAAA and AAU champion in the hammer, nominating himself for Olympic consideration.

Over some of the going, Philips was handicapped by an injury, but he was bracketed all winter long with the best high jumpers in the biggest meets. He won early prominence with his surprise win at the Knights of Columbus games in Boston when he leaped 6 feet 7. He tied for first in the BAA Games, won at the Christian Brothers Centennial Relays, and broke a record with a vault of 6:6 $\frac{3}{4}$ at the Cleveland K. of C. meet. He was third in the ICAAAA meet and tied for second in the National AAU meet when he cleared at the winning height of 6:7 only to graze the bar on the way

down. He is a great prospect, whose work will be watched outdoors.

Royce Crimmins has also had a lot of competition around the major circuit. A fast man but one who dislikes elbows, he did not have the best of luck in jamming at the corners of the indoor tracks, but he gained his share of credit in speedy company. Winning only rarely, he did place second consistently in close races: runner-up in the ICAAAA 600, runner-up to McKenley in Washington and Guida in Boston, runner-up in the Christian Brothers meet, and fourth after a shove in the K. of C. race in New York all at his favorite distance. After the BAA meet he was awarded the Roy Phillips Memorial Trophy in its initial presentation—to the meet's outstanding New England college competitor. He was also a key figure in the Brown two-mile relay which beat Villanova, Yale, and MIT in the BAA games with a good time of 7:56.9.

Josh Tobey gave Ted Vogel of Tufts his first defeat at home in three years of college running with a 4:25.3 mile; a record for the Coussins Gym. His winning time in the Christian Brothers meet in Providence was even better—4:21.1. His twin, Jon Tobey, was second in the 1000-yard race under Christian Brothers auspices, while a third Tobey ran in a winning Freshman relay quartet that beat Springfield and Boston College in the BAA meet. Leeth hurdled to second place in the Christian Brothers Relays, while Schleicher was tied for third in the vault that night. Paul Flick was fifth in the ICA meet when Brown was tied for ninth place with eight points in all.

Wrestling

▶ IN ITS SECOND YEAR as a re-established sport, wrestling gained a lot of ground, winning five of eight meets and numbering Dartmouth, MIT, Tufts, and Springfield among its victims. Brown was elected to the Eastern Intercollegiate Wrestling Association, a recognition of the work of Coach Ralph Anderton and his men. Entering their first Eastern championships, three of the men gained the semi-final round after earlier victories: Alex Marshall, 155; Frank Manchester, 128; and Gray Michael, 136. Other entries were Dick Ferenbach, Sandy Beachen, Tony Trivison, Bill O'Donnell, and Pete Fuller. The campus gave good backing, and squad morale was high. There is good material coming up from the Freshman divisions.

The Varsity record might have been even better but for two mishaps: Dick Moody broke a finger in the Coast Guard meet and had to default. Graham Michaels, a steady winner, cost a similar five points when he failed to make weight at Harvard. Michaels was New England 136-pound titleholder, while his younger brother, now a Freshman, took the national prep school championship while a student at The Hill School. Both went undefeated through February.

Swimming

▶ BROWN MEN tallied 27 points for a fourth place in the New England Intercollegiate in March after a dual meet season in which they had won four of nine meets. Milt Brier, the season's star, established a new Brown record and MIT Pool record in winning the 200-yard breaststroke in 2:26.7. (The old mark on the Brown books set by George Gibbons in 1939 was .9 seconds slower.) Another record went to Brown in the same meet when the medley relay trio of Ollie Patrell, Brier, and Jim McKelvey swam their distance in 3:4.7. The previous record had been set by Bowdoin only the day before in the trials, and the

Freshmen Break Records

▶ PAUL MACKESEY called our attention to it—the extraordinary record of Freshman teams in all sports thus far this year. He says it's the best in history. Here's what the Class has done: football—won 5, lost 1; soccer—won 4, lost 2; cross country—won 9, lost 1; basketball—won 16, lost 3; hockey—won 8, lost 1; wrestling—won 5, lost 3; swimming—won 8, lost 3. All sports—won 46, lost 14.

The football team was undefeated until its final game on a muddy field against Harvard. The basketball five dropped its first game, then won 12 straight; each of the three defeats was balanced by a victory over the same opponent. The hockey players took their first six games, then lost to Yale. The Herald said the basketball season was the best of any Freshman club on record.

It's pleasant to look on the achievement of the Class as an achievement; it's encouraging to regard the players as Varsity material for three more years, too.

ink on the book was hardly dry before the Brunonians had a time better by a half-second. An attendant satisfaction was the shading of Williams, whose medley relay teams had beaten Brown in the dual meet.

Williams, defending champions, won the New England meet with 53 points. Springfield had 31, Bowdoin 29. Ralph Gossler, swimming his last race for Brown, was third in the 50-yard final which was clocked at 24.2 seconds, although Gossler had won his qualifying heat in 24.1. The 400-yard relay team took a third, Wilson was fifth in the 440, and Patrell fifth in the backstroke. A Freshman relay team was second in its class.

Brier was Brown's only scoring entry in the Eastern Intercollegiate, with a fifth place in his specialty behind Verdeur of La Salle, who broke the world's record. Swimming the 150-yard breaststroke in Colgate Hoyt Pool in the New England AAU meet, Brier was only a tenth of a second off of the American mark of 1:43 in winning. In the same meet Ollie Patrell was a surprise winner of the NEAAU Junior 150 backstroke, establishing record time at 1:43.8. Win Wilson won the State 440 title, while Duncan Grey, Jim McKelvey, and Jack Leeming swept the 50.

One of the season's novelties came Feb. 21 when Brown won three dual meets on the same afternoon. Connecticut, whose Varsity lost to Brown 43-31, also brought along its Jayvee swimmers through a misunderstanding, although the Brown Freshmen were already swimming the Tufts yearlings. The Cubs took on both opponents in turn. The Freshmen freestyle relayers set a new Freshman pool record at home against Moses Brown, displacing a mark made in 1939. Duncan Gray, former Hun School star, a consistent winner all season, swam with Hoover, Barlow, and Allen in 3:52.4. The Varsity medley line-up of Chuck Willoughby, Milt Brier, and Jim Phelan, won the New England AAU championship in February in a Pawtucket meet. Winner of the Brown Interscholastics (the 28th annual swimming) was Portland High of Maine; New York Military and Pawtucket West were deadlocked as runners-up.

Sports Miscellany

▶ TWENTY-THREE battery candidates, including 18 pitchers, reported to Coach Eddie Eayrs for the first baseball workout of the year. The nine will be in League competition this year against the Ivy Group teams and the two major service academies. . . . The Brown rifle team, with a good record in dual meets, took second place in the national ROTC competition, losing to Ohio State 893 to 891; UCLA was third with 881. . . . Lehigh's 1949 football schedule shows a game with Brown in Providence on Oct. 22, first meeting of the two brown-and-white teams since 1926. . . . Anton Sobocinski, whose fencers had a fair season, is now the senior member of the Brown coaching staff; he's been conducting the sport on the Hill since 1938. . . . Sectional championships of the Eastern Intercollegiate Golf Association will be held in Providence May 7 and 8 at the Wannamoisett. . . . Continuing where they left off last fall, Brown's Yacht Club won its first regatta when it was host on the Seekonk to Northeastern, Rhode Island, Williams, Bowdoin, and Worcester Tech; the Eastern Intercollegiate will be held at Brown May 1-2. . . . That sensational shot at the end of the first half of the Providence College basketball game was measured immediately: Corner was found to have scored from 58 feet 7 inches out, the longest shot Coach Morris had seen in 25 years' association with the game. . . . Highlight of the outdoor track season will be the New England Intercollegiate at Brown Field May 21 and 22. . . . The Brown Ski Club defeated Columbia and Stevens Tech at Manchester, Vt., early in March. . . . Some 30 students who played lacrosse in prep school have organized the Narragansett Lacrosse Club and will play an informal schedule. (A similar team brought about restoration of hockey as a Varsity sport.)

Speaker of the evening was Rev. Gordon Bigelow '24, of Beverly, who described his impressions of Europe as he saw it in the summer of 1947 when he visited nine countries. His trip to the international religious convention in Copenhagen was also illustrated by colored slides. No one, he said, can make such a journey without being "filled with a deep gratitude for his American heritage with its traditions of freedom of speech, worship, and competitive enterprise, without state or government control."

Listen, Brunonian

Copland, in addition to being an important American composer (symphonies, ballets, music for violin, piano, film scores) expresses himself in lively fashion. In this book he calls American creative musicians "Composers Without a Halo" and dares to devote more pages to himself than to any other individual.

Great Modern Composers. Oscar Thompson, editor; Dodd, Mead, 1941. Thirty-three composers of our time ranging from Bartok to Shostakovich and Villa-Lobos are represented by chapter and listing of works. Just what you wish you had after you have read a typically unsatisfactory program-note or heard a half-minute fill-in announcement on the air.

Stravinsky: An Autobiography. Simon and Schuster, 1936. A composer never presented a more candid account of his artistic creed than Stravinsky does here. Throws light on his music and the century in which we live.

America's Musical Inheritance. Anna E. Schoen-Rene; G. P. Putnam's Sons, 1941. Mme. Schoen-Rene was until her death a leading (many would say the leading) teacher of singing at the Juilliard School of Music in New York. Her European training included association with the famous Garcia family of musicians, but her devotion to American students was keen and her ideas on music in the United States are often a revelation.

When Rushing Ended ◀ ◀

Fraternity Pledges

▶ ▶ RUSHING at Brown ended March 12 with the pledging of 326 students to the 17 chapters on the Hill. Rushing and pledging were deferred until the second semester this year "to permit the fraternities to know more about the men and the men to know more about the fraternities than was possible last year when rushing was held in November."

The quotation is from the *Brown Daily Herald*, which noted that the new pledge group includes 261 second-semester Freshmen, 52 Sophomores, 12 Juniors, and one graduate student. Earlier in the winter the men in their second and third semesters received fraternity information and were asked to fill out cards as to whether they were interested in joining a fraternity. Of

the replies, 272 said yes, 302 no, 10 undecided, with 70 not answering. By agreement of the Interfraternity Governing Board, the Freshman delegations were limited to 20—a total of 340. Men ineligible for initiation because of low grades number 228, the *Herald* reported. A minimum average of 1.75 (about a C minus) is required by the University before initiation is allowed.

There are in Brown 817 men previously initiated or pledged, making a total of 1143 fraternity men with the addition of 326 new pledges. The percentage of undergraduates pledged or initiated approximates 38%.

Fraternity statistics are given in the nearby table, based on information provided by the chapters and printed in the *Herald*.

► THE FRAMEWORK for a lively biography of a great editor, Alfred Mason Williams '60, was shaped with understanding admiration by George W. Potter '21 recently when the Pulitzer Prize winner began a series of columns in the *Providence Journal*.

(The indication that a word was needed which used B and R for its first two letters made the choice simple.) I, of course, selected the name BROWN, and so the name of Alma Mater was heard far and wide across the island and even to Italy.

"This sign board hung outside the telephone office during that time, and so it gives me great pleasure to present it to the University as a souvenir."

▶ ▶ DO YOU KNOW who owns the name "Brunonia"? According to the American Kennel Club, it is Coburn A. Buxton '34 of Dallas, Tex., who has registered the name of his Brunonia Kennels. If the University "behaves itself," however, Brown may still make use of its derivative name, he assures us.

The specialty of Brunonia Kennels at 10025 Meadowbrook Rd., Dallas, is German Shepherds, of which the most famous is a female, Champion Susan of Flowdale, whose picture has appeared in *Dog World* and elsewhere. She has been handled by Peter Patterson, who assisted in her showing debut at the age of eight months Nov. 11, 1945, when she went Winner's Bitch. There were other victories at Tyler, Temple, Dallas twice more, Fort Worth, and College Station, concluding her championship with four more than the needed 15 points in 1946 and early 1947. Included were five Best of Breeds and two placings in Groups. (The gentleman on the right in the picture, with the ribbons in his hand, is Anton Korbel, AKC all-breed judge who is also a breeder of German Shepherds.)

Buxton, son of Col. G. Edward Buxton '02 was elected first President of the German Shepherd Dog Club of Dallas when it was organized last summer, and a similar club for the State of Texas has been incorporated. Every fourth Sunday the Dallas group meets at Brunonia Kennels, and seven Dallas Shepherds, including four from Brunonia, went to the Oklahoma City Show last fall. Buxton looks on a young female, Brunonia's Countess Paula, as a true successor to Susy. Several new owners (the average pup sells at \$125 at seven weeks of age) have nick-named their dogs Bruno, and Buxton believes that a Yale bulldog wouldn't make more than one good meal for a 90-pound Shepherd. The day after Brown beat Yale last fall, Brunonia's King Michael licked a class of eight at Oklahoma City.

► EXCAVATIONS for the new Providence Washington Insurance Company building directly across North Main St. from the First Baptist Meeting House have interested the town for months as the foundations have been prepared. Nine old foundations, some on top of older ones, have been removed. An ancient wooden water pipe was found to be made of hollow tree trunks joined together, apparently laid some time after the cove, which once split Providence, was filled in. It connected with ancient springs. Still farther down the power shovels began to unearth wooden piles by the hundred, which must have provided mooring for shipping in the town's early days. One wooden wharf was found, while there was also a little garden wall of stone and brick with a gracefully arched gateway near North Main St. Substantial heaps of clam and oyster shells indicated the early presence of shellfish.

Don't Forget the Rabbits

► IN OUR FEBRUARY ISSUE we referred to the pedigreed mice at Brown, their importance in cancer research, and a grant received to support the studies in nuclear phenomena in the mouse liver.

Dr. C. C. Little, famed leader in the work on cancer, said something recently which reminded us of another royal family in the animal kingdom which Brown University shelters. Speaking of the great need of inbred strains of rabbits, Dr. Little said, "Investigation of the interests and problems of many of the larger laboratories of experimental medicine has shown that the existence of genetically uniform strains of rabbits would greatly accelerate progress and stabilize results obtained."

There are, he noted, "at least two good strains of rabbits at Providence and nuclei of other strains at the Rockefeller Institute in Princeton. . . . It is hoped that with the rabbits from Brown University and the beginning of inbred strains which have been made at Bar Harbor (the Jackson Memorial Laboratory), a strong foundation can be laid to which other stocks can be added as occasion arises." ◀
