

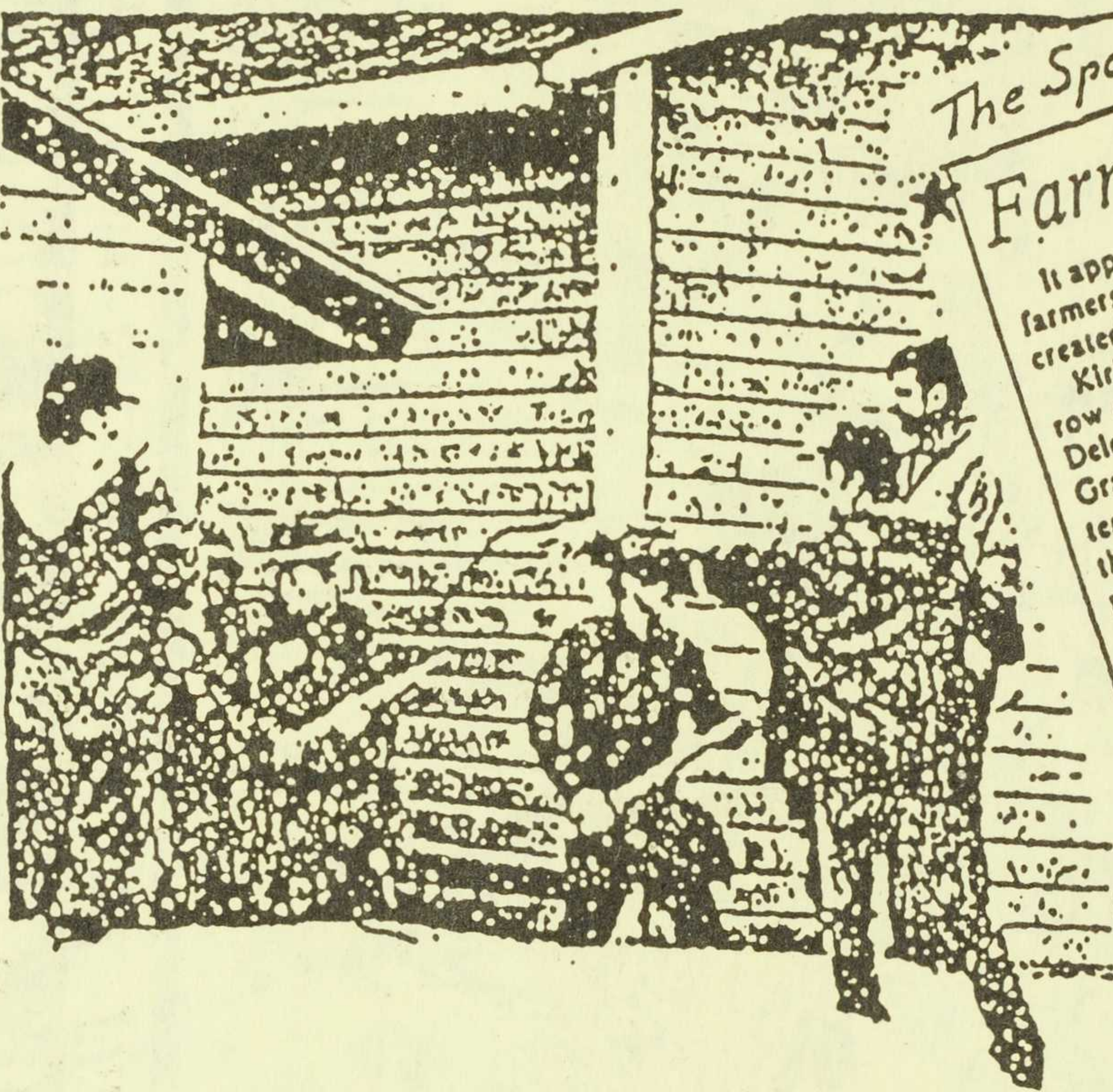

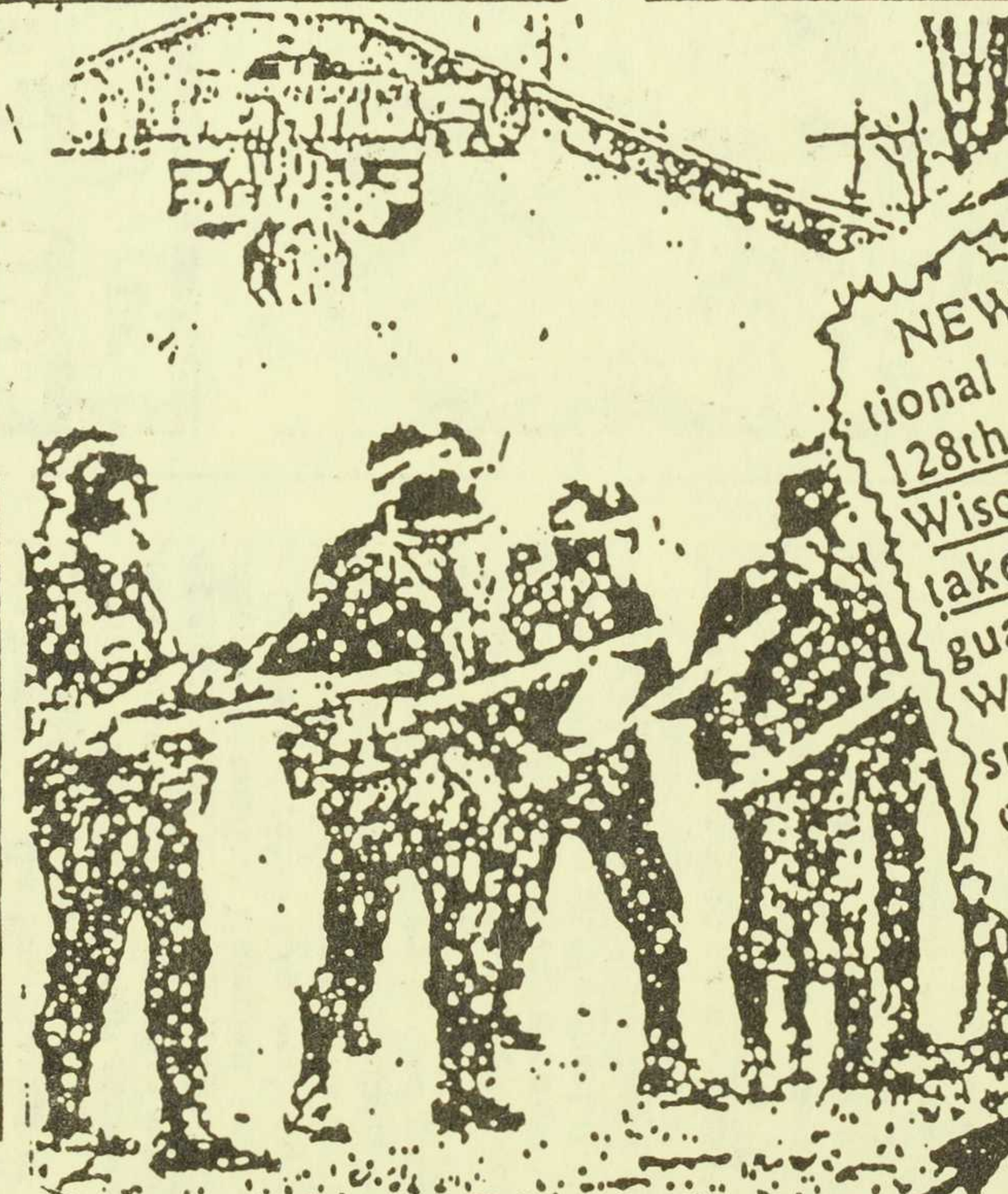

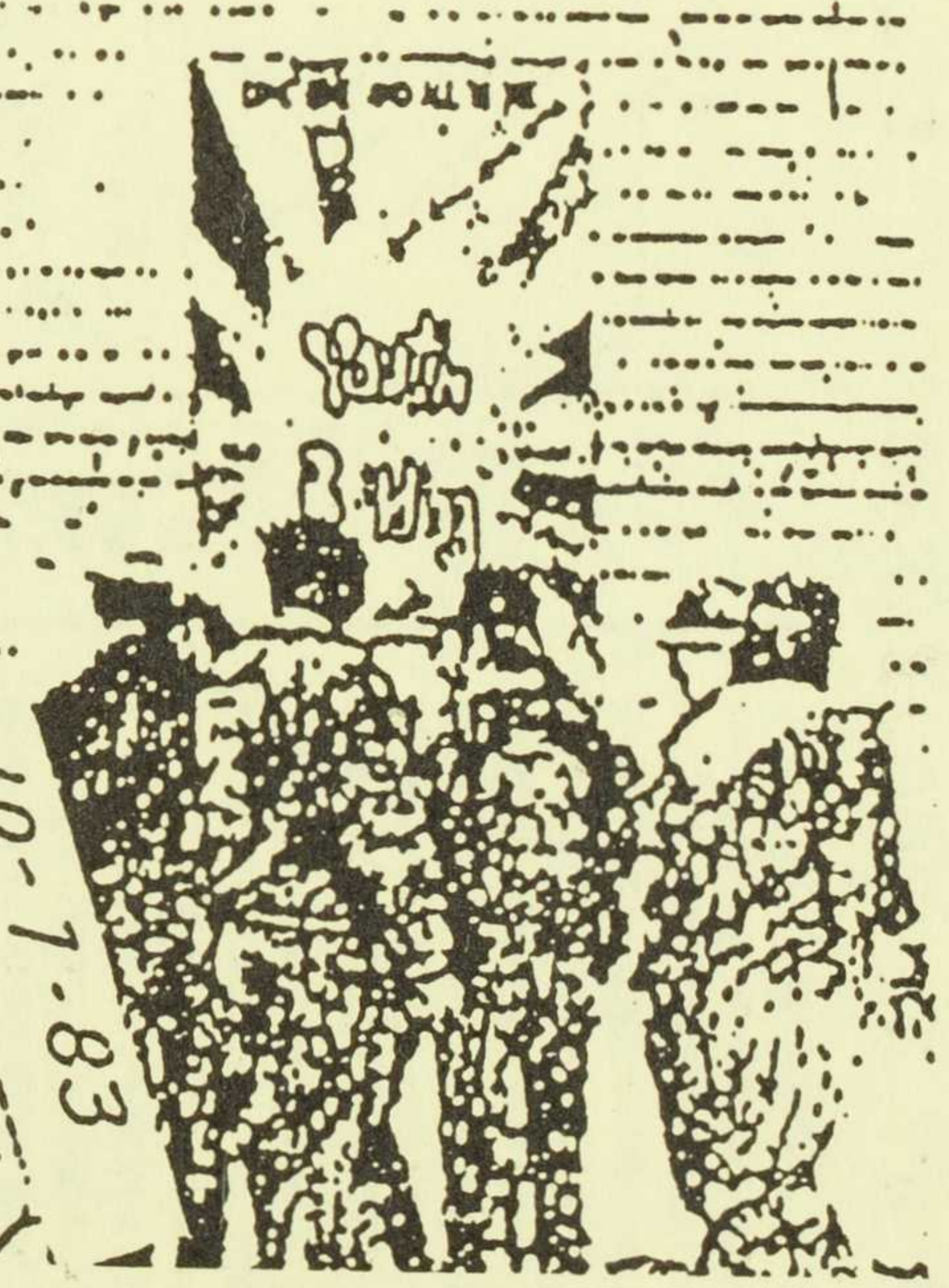

Farmer Singled Out as an Example
 It appears that Arthur Kirk was singled out to be a victim—an example to other farmers of what happens if you don't make payment on a debt that has been created out of thin air at a high rate of usury.
 Kirk was a hardworking, honest Christian man who farmed 2,000 acres, mostly row crops. Kirk was not a criminal. I had the opportunity to visit with Art and Deloris Kirk in September, 1984, during a break period at a legal seminar in Grand Island, Nebraska. I had gone to Grand Island to speak to the group in attendance in behalf of the Populist Party. Kirk and his wife were cheerful and thankful that they had become affiliated with a group of people with similar problems.
 As sad as this episode was last fall, much can be, and is being, learned from it. More and more farmers and ranchers all over this country are being made aware of their legal and Constitutional rights. Lawsuits are being filed against banks at an ever-increasing rate.
 Let's hope and pray that lawyers and judges will honor their vows to uphold the Constitution of the United States of America and that the people will turn this country around. We must have law and order; we must get back to the Constitution, abolish the Federal Reserve System, abolish the 16th Amendment (namely, the "progressive" income tax) and establish an honest money system.

RIOT TRAINING WAS the program for the day Saturday for members of the Rice Lake National Guard unit. The scene was the Rice Lake Fairgrounds where the "bad guys" made up a group protesting the take over of a member's farm and had gathered and attempted to hold onto the buildings. The "rioters" were members of the Combat Support unit from Eau Claire, also part of the First Battalion

of the 128th Infantry. Above, the guardsmen are confronted by the sign carrying protesters while below, the guardsmen, moving steadily in formation, force the protesters back. Another part of the program involved the Rice Lake police and Sheriff Wally Larson who manned a roadblock. About 90 local guardsmen took part in the training.
