ARRANGE LECTURES RIO, SAO PAULO, AND BRASILIA. BRAZILIAN
FONOFF SPONSORSHIP PROBABLY BEST IF THAT WILL PROVIDE
BANERJEE FARE TO BRAZIL AND EXPENSES THERE.

2. IF FARE TO BRAZIL IS PAID, BANERJEE WOULD BE INTERESTED
IN STOPPING OFF FOR LECTURE AT COLEGIO DE MEXICO INSTITUTE
