1. I HAVE GIVEN COSTA E SILVA A LETTER REPEATING THE SENTENCE AS AUTHORIZED BY DEPARTMENT. COSTA E SILVA WAS OBVIOUSLY DELIGHTED TO RECEIVE THIS OFFICIAL WORD THAT HE WOULD HAVE THE OPPORTUNITY TO CALL ON PRESIDENT JOHNSON DURING HIS TRIP TO UNITED STATES. I SUGGESTED THAT ALL OTHER PLANS FOR HIS VISIT IN THE US BE HELD IN OBEYANCE UNTIL TIME FOR HIS CALL ON THE PRESIDENT COULD BE DETERMINED. HE IS, OF COURSE, PREPARED TO ALTER ANY OF HIS PLANS WHILE IN THE US IN ORDER TO ACCOMMODATE PRESIDENT JOHNSON.

2. HIS PLANS CALL FOR HIS ARRIVAL IN HONOLULU ON JAN. 19 AND TO PROCEED TO LOS ANGELES ON JANUARY 21. HE PLANS TO LEAVE LA ON JANUARY 24 FOR EITHER WASHINGTON OR NEWYORK AND

TO DEPART NEW YORK BY SHIP FOR BRAZIL ON FEBRUARY 1.

3. COSTA E SILVA POINTED OUT THAT HE WAS PLANNING TO SPEND THE WEEKEND OF JANUARY 21 AND 22 IN LOS ANGELES, BUT COULD OF COURSE LEAVE EARLY

(LIER IF THAT WERE MORE CONVENIENT FOR PRESIDENT JOHNSON. HE PLANS TO MEET IN NEW YORK WITH DAVID ROCKEFELLER ON JANUARY 30 BUT THAT ALSO COULD BE CHANGED.

4. COSTA E SILVA ASKED WHETHER HE WOULD BE SEEING PRESIDENT JOHNSON IN TEXAS OR IN WASHINGTON. I REPLIED THAT I DID NOT KNOW. HE POINTED OUT THAT, IF IT WERE TEXAS, THEN HE WOULD PREFER TO FLY DIRECTLY FROM LOS ANGELES. HE COULD BE IN TEXAS ANY TIME FROM JANUARY 22 ONWARD. HOWEVER, IF CALL IS TO BE IN WASHINGTON ON ANY DAY JANUARY 25 THROUGH 27.

5. I WOULD APPRECIATE BEING ADVISED AS SOON AS PRESIDENT JOHNSON DECIDES UPON A SPECIFIC TIME AND PLACE. TUTHILL
