1. 11TH MFM HELD OPENING SESSION YESTERDAY EVENING (24TH),
CONFINED TO FORMALITIES.
2. SESSION THIS MORNING UNANIMOUSLY APPROVED BRAZILIAN
RESOLUTION ON MULTILATERAL NATURE OF INTER-AMERICAN MEETINGS.
OPERATIVE PART READS AS FOLLOWS:

RESOLVES:

1. TO AFFIRM THAT ATTENDANCE AT MSTINGS OF THE PERMANENT
ORGANS OF THE ORGANIZATION OF AMERICAN STATES OR AT
CONFERENCES AND MEETINGS PROVIDED FOR IN THE CHARTER IS IN
ACCORDANCE WITH THE MULTILATERAL NATURE OF THOSE ORGANS AND
DOES NOT DEPEND ON THE BILATERAL RELATIONS OF ANY MEMBER
STATE WITH THE GOVERNMENT OF THE HOST COUNTRY.
2. TO URGE THE GOVERNMENTS OF THE MEMBER STATES TO OBSERVE

3. QUESTION OF MEXICAN PACKAGE (STATE CIRCULARS 123955 AND 122086) REMAINS UNRESOLVED. WILL BE CONSIDERED FURTHER IN PRIVATE MEETING TOMORROW.
