QUOTE:

THE GENERAL ASSEMBLY,

RECOGNIZING THAT THE PROBLEM OF THE PALESTINIAN ARAB
REFUGEES HAS ARISEN FROM THE DENIAL OF THEIR INALIENABLE
RIGHTS UNDER THE CHARTER OF THE UNITED NATIONS AND THE
UNIVERSAL DECLARATION OF HUMAN RIGHTS,
RECALLING ITS RESOLUTION 2535 B (XXIV), IN WHICH IT
REAFFIRMED THE INALIENABLE RIGHTS OF THE PEOPLE OF
PALESTINE,
BEARING IN MIND " THE PRINCIPLE OF EQUAL RIGHTS AND SELF-
DETERMINATION OF PEOPLES" ENSHRINED IN ARTICLES 1 AND
55 OF THE CHARTER OF THE UNITED NATIONS AND MORE RECENTLY
REAFFIRMED IN THE DECLARATION ON PRINCIPLES OF INTERNATIONAL
LAW CONCERNING FRIENDLY RELATIONS AND CO-OPERATION AMONG
STATES IN ACCORDANCE WITH THE CHARTER OF THE UNITED NATIONS,

1. RECOGNIZES THAT THE PEOPLE OF PALESTINE IS ENTITLED TO
" EQUAL RIGHTS AND SELF-DETERMINATION", IN ACCORDANCE WITH
THE CHARTER OF THE UNITED NATIONS;

2. DECLARES THAT FULL RESPECT FOR THE INALIENABLE RIGHTS
OF THE PEOPLE OF PALESTINE IS AN INDISPENSABLE ELEMENT
IN THE ESTABLISHMENT OF A JUST AND LASTING PEACE IN THE
MIDDLE EAST.
