SUBJECT: VIET-NAM WEEKLY HIGHLIGHTS

1. MOBILIZATION DECPEE. LOWER HOUSE PEBATE ON MOBILIZATION DECREE MORE CRITICAL OF SUBSTANCE OF DECREE THAN UPPER HOUSE, ALTHOUGH SEVERAL DEPUTIES DESCRIBED IT AS UNCONSTITUTIONAL, ILLEGAL, UNJUST AND UNNECESSARY, MOST CRITICISM WAS MODERATE. OTHER DEPUTIES DEFENDED DECREE. FINALLY, HOUSE CALLED FOR GOVERNMENT TO PRESENT EXPLANATION OF DECREE, BOTH AS TO ITS SUBSTANCE AND FEASON FOR ISSUANCE BY GOVERNMENT AS DECPEE RATHER THAN ENACTMENT BY ASSEMBLY.


2. LOWER HOUSE MEMBERSHIP VALIDATED. TOTAL 137 MEMBERS LOWER HOUSE VOURDATED, COMPLETING FORMATION OF NATIONAL ASSEMBLY UNDER CONSTITUTION. AND PAVING WAY FOR DISSOLUTION OF CONSTITUENT ASSEMBLY WHICH OCCURRED ON DEC. 5.

- 3. COMMUNIST PROPAGANDA. COMMUNIST RADIOS CLAIMED SECRETARY MCNAMARA WAS "DISMISSED", DEPICTING HIM AS "STRONGMAN" WHO HAD PLAYED LARGE ROLE IN ESCALATION OF WAP. PADIOS PREDICTED THAT WAR WOULD CONTINUE TO ESCALATE IN NORTH AND BECOME INTENSIFIED IN SVN.
- 4. SAIGON PRESS. PRESS FOCUSED ON MCNAMARA'S RESIGNATION, SPECULATION ABOUT LANDINGS IN NVN, AND REPRISALS AGAINST VC BASES IN CAMBODIA. MANY PAPERS SEE ESCALATION LIKELY. THIS REPORTED WITH APPROVAL BY MOST PAPERS.
- 5. ECONOMIC SITUATION. SAIGON RETAIL PRICE INDEX STEADY FOR THIRD WEEK AS INCREASES IN RICE PRICES WERE BALANCED BY LOWER FISH PRICES. IMPORTED COMMODITY INDEX FELL BY ONE POINT.
- G. ALLEGED US MEETINGS WITH VC REPPESENTATIVES. AP AND SAIGON PRESS CARRIED STORIES ALLEGING THAT PROJECTED MEETING BETWEEN AMBASSADOR BUNKER AND HIGH-PANKING REPRESENTATIVE OF NLF HAD BEEN THWARTED RECENTLY WHEN VC EMISSARY WAS ARRESTED BY GVN POLICE ENROUTE TO MEETING. STORIES ALSO ALLEGED MEETING TOOK PLACE BETWEEN HIGH-LEVEL US OFFICIALS AND VC REPRESENTATIVES IN "NEUTRAL EMBASSY" IN SAIGON. COMMENT: EMBASSY PRESS STATEMENT CHARACTERIZED ALLEGATIONS ABOUT PLANNED OR ACTUAL MEETINGS AS FALSE, AND REAFFIRMED THAT USG WOULD NOT UNDERTAKE ANY SUCH CONTACTS WITHOUT KNOWLEDGE OF GVN. STORY REPORTEDLY CAME FROM MID-LEVEL VC EMISSARY CAPTURED IN SAIGON.
- 7. NLF AND UNITED NATIONS. THERE WAS EXTENSIVE PRESS DISCUSSION OF NLF'S REPORTED CONTACT WITH UN SECRETARIAT IN OCTOBER IN BID FOR INVITATION TO UN GENERAL ASSEMBLY PRESUMABLY TO LOBBY FOR OWN INTERESTS.

US ATTITUDE ON PARTICIPATION OF VC IN UN SECURITY COUNCIL DISCUSSION WAS EXPRESSED BY AMBASSADOR GOLDBERG IN HIS TESTIMONY TO THE SENATE, WHERE HE SAID WITH RESPECT TO GROUPS SUCH AS THE NLF, RULE 39 OF THE SECURITY COUNCIL IS THE APPLICABLE RULE AND THE US WOULD NOT STAND IN WAY OF GROUPS, INCLUDING NLF BEING INVITED UNDER THAT RULE.

FYI: IN CASE OF MEETINGS IN SECUPITY COUNCIL INCLUDING REPRESENTATIVES NVN AND SVN, US WOULD SEE NO CAUSE FOR BARRING NLF ALSO FROM PARTICIPATING UNDER RULES FOR HEARING NON-GOVERNMENTAL PARTIES. US INTRODUCED RESOLUTION CALLING FOR DISCUSSION OF VN IN FEBRUARY 1966. OPPOSITION OF USSP AND FRANCE ABORTED DISCUSSION THEN AND SUBSEQUENTLY. SHOULD NLF BE OFFICIALLY INVITED TO UN. UNDER RULE 39, AS HOST NATION TO UN UNDER HEADQUARTERS AGREEMENTS, WOULD ISSUE VISAS TO NLF REPRESENTATIVES. PROSPECTS DIM, HOWEVER, SINCE HANDI AND NLF AS RECENTLY AS SEPTEMBER 12, DENIED THAT UN HAD ROLE IN VIET-NAM. END FYI.

8. MILITARY. US, FWMAF, AND RVNAF FORCES CONDUCTED 126 OPERATIONS DURING WEEK. ENEMY-INITIATED AMBUSHES/ATTACKS INCREASED. ENEMY KIA DECREASED FROM 1826 TO 1358. ALLIED OFFENSIVE OPERATIONS MET SCATTERED LIGHT TO MODERATE CONTACT IN I CORPS. ENEMY ARTILLERY

FIRE NEAR BMZ INCREASED SOMEWHAT. FIGHTING IN DAK TO AREA II CORPS DIMINISHED AS NVA UNITS WITHDREW TO BORDER AREAS. VIETNAMESE ARVAN UNITS ACCOUNTED FOR 189 ENEMY KIA WHILE LOSING 13 MEN IN HEAVY FIGHTING IN KONTUM PROVINCE. CONTACTS IN III CORPS WERE SCATTERED. VC MORTARED AND ATTACKED DISTRICT HEADQUARTERS AT BU DOP AND CIDG (PARAMILITARY) CAMP AT BU DOP.

9. US PACIFICATION ANALYSIS. AMBASSADOR ROBERT KOMER, GENERAL WESTMORELAND'S DEPUTY FOR PACIFICATION, HELD PRESS CONFERENCE IN SAIGON TO EXPLAIN HAMLET EVALUATION SYSTEM (HES). HES DEVELOPED DURING IHIS YEAR TO REGISTER GROWTH OF GOVERNMENTAL INFLUENCE AND PROGRESS IN PACIFYING, THEN DEVELOPING VIETNAMESE HAMLETS. (SEE VIPELESS "CLEAR SIGNS OF PROGRESS").
