The Honorable John J. Rooney, Chairman, House Subcommittee on Appropriations for State, Justice, Commerce, The Judiciary, and related agencies, departing November 13 aboard S.S. Brasil to visit South American posts. Mr. Rooney will be accompanied by his wife; Jay B. Howe, staff assistant to the Appropriations Subcommittee; Mr. Raymond F. Farrell, Commissioner, Immigration and Naturalization Service and his wife; Mr. William J. Crockett, Deputy Under Secretary for Administration; and Mr. Michel Cieplinski, Special Assistant, State Department.

Mr. Rooney will be interested in all activities State Department and will probably review some activities of USIA. Have suggested agenda prepared for his stay at your post to be reviewed immediately upon arrival by Mr. Crockett. No repeat no appointments to be made with members other governments. Entertainment not repeat not desired.

Group will have sufficient dollar funds for all expenses other than personnel which will be paid by individual members of group.

Congressional travel fund 19FF510 not repeat not authorized.

Local transportation to be provided by posts.

Assign control officer, meet, assist through customs and provide all other services.

BUEENOS AIRES: Secure same type accommodations above at Plaza Hotel. At same time discuss with Mr. Crockett possibility of flying Santiago, Chile and onward destination to meet ship. If this trip desired, Embassy must secure necessary visas for Santiago.

If at any time during the trip a change of schedule is made, please inform Department and onward posts of change.

All posts confirm receipt of this message by wire soonest naming control officer and confirming hotel reservations.
